

Tuesday, March 8, 1808.

AGREEABLE to His Excellency the Lieut. Governor's PROGRAMATION, the House met.

Mr. James Robertson, late Clerk of this House being absent from the Island, Mr. Thomas Describe, Junior, was unanimously appointed to fill that Office, and accordingly took the usual Oaths.

On Motion of Mr. Stewart, Jun. Ordered, That a Committee he appointed to revice the Journals of the House each Day immediately after the Adjournment, that the same when revised he delivered to the Printer, and that a proof sheet thereof he laid on the Table for the inspection of the Committee and the House, the third day at farthest.

Mr. Stewart, Jun. Mr. Holland, and Mr. Margowan, were accordingly appointed.

A Message from His Excellency the Lieus. Governor requiring the attendance of the House immediately in the Council Chamber.

The Floure accordingly attended, and having returned the Speaker reported, That Fris Excellency had been pleased to deliver the following Speech to both Houses, viz.

Mr. President, and Gentlemen of His Majesty's Councily with the day of the

Mr. Speaker, and Gentlemen of the House of Ropresentatives,

IT would have afforded me great pleasure to have been enabled to felicitate you on the efficacy of the very enteresting objects of your humble representation and Petition, which at the close of the last Session I had the honour of transmitting to His Majesty's principal Secretary of State for the Colonial and war departments, praying he would be pleased to lay the same at the feet of our most Gracious and beneficent Sovereign... interesting objects, the promoting surprebenesits and public importance of which so animated the characteristic gen-

eresity of the illustrious personage whose name this Island bears, as to induce His Royal Highness to step forward and condescend personally to intercede for their attainment. And Gentlemen, it is your happy lot to contemplate the exhibition of this admirable trait of princely condescension and generosity towards the good people of this Island and their posterity. I see in it an inexhaustible source of animation, which, as well as to gratitude must prove to be a most powerful and irresistible incitement to merit, and cheer our hopes of an happy result to our expectations, when His Majesty's Government at home, engaged under the pressure of arduous circumstances in noble efforts to check the career of rapine and desolation of the Universal Enemy on the Continent of Europe, shall have leisure duly to investigate and deliberate upon the concerns of this Island.

I have also to inform you that His Majesty has graciously been pleased to confirm an Act passed in the last session of this General Assembly, "Intituled "an Act to repeal an Act passed in the forty-first Year of his present Majesty's "Reign, Intituled an Act for the better regulation of Elections and to regulate "Elections for Members to serve in General Assembly in future". And that His Majesty's Secretary of State, communicating the Royal Confirmation of this Act, was also pleased to signify that the two sollowing Acts had been considered, and did not appear liable to any objection, viz.

"An Act to alter and amend an Act made and passed in the forty-second year of His present Majesty's Reign, Intituled an Act in addition to and amend. "ment of an Act made and passed in the thirty-sistent year of his present "Majesty's Reign, Intituled an Act to alter and amend the High Road Laws", "An Act for rasing a fund for the purpose of defraying contingent Ex. "pences of the General Assembly."

I have also the satisfaction of acquainting you, that (in conformity to arrangements calculated for promoting the security, property and happiness of the King's extensive North American Dominions, by unifing the relative interests, strength and means of Defence of all the parts thereof and rendering the same subservient to the exigencies of each other, as eventual occasions may require) His Majesty has graciously been pleased to appoint Lieutenant General Sir James Henry Craig, K. B. to be His Governor General and Military Commander in Chief in and over His Province of Nova Scotia, and His Islands of Prince Edward and Cape Breton, as well as in and over His Province of Canada, &c. &c. and that

upon intelligence of the arrival at his destination of this highly meritorious Officer, I thought it my duty faithfully to represent to him our situation, circumstances and means of desence, particularly our wants and desiciencies (to the equipping and rendering efficient for service our Militia, Infantry, Light Horse, and Artillery) of fire Arms, Accourtements, Mountings, Field Pieces, Ammunition, &c. and that I am led to hope, he laudably will afford the neacessary aid, of which we now stand in the most absolute need.

As it obviously must appear to you (whether in time of Peace or War) to be my absolute duty to exert every practicable means for ascertaining, against all eventual hostile attempts, the security of this Island, together with the lives and property of His Majesty's Loyal and beloved Subjects therein, I trust you will of course be pleased to allow me to rest a due share of my best hopes on the effects of the zeal, industry and wisdom of your deliberations and proceedings, and on the energy of the measures you may judge proper to a dopt for evincing the sincerity and ardour of your invariable attachments to the sacred person of our most Gracious Sovereign, His just, equitable and mild Government, and our Glorious Constitution.

And Gentlemen, permit me now to move your attention, and to recommend to your particular care, the expediency and necessity of judiciously concerting and enacting such Laws and regulations as may seem requisite or conducive to the promotion of the public welfare—of reviving, altering and amending others now in force, or improving and extending their benefits and advantages and of continuing and reviving such as have proved to be salutary and are in the course of expiring.—The Militia Law I servently hope, will particulary attract and captivate your attention, and its desirable improvements, afford an ample field for the exercise of your talents, abilities and laudable solicitude.

Gentlemen of the House of Assembly,

The proper Officers shall forthwith lay before you the public Accounts of this His Majesty's Government, and I beg leave to recommend to your consideration the necessity of some Provision being made for meeting the expence which must unavoidably be incurred for rendering efficient the service of our Militia Forces for repairs and outsits of our prisons and other public exigencies.

Mr. President, and Gentlemen of His Majesty's Council,

Mr. Speaker, and Gentlemen of the House of Affembly,

Reposing a perfect considence in your Loyalty to the King and His Royal Family, and in your Zeal to promote the good of His Service, I beg you will

receive the cordial affurance of my readiness to co-operate with you on all occasions, and in all things tending to the prosperity, Harmony and Happiness of His Majesty's faithful subjects in this his Island.

Ordered, On Motion of Mr. Holland, That a Committee be appointed to prepare an Address in answer to His Excellency's Speech. Mr. Holland, Mr. Macgowan, and Mr. Stewart, Jun. were accordingly appointed:

On Motion of Mr. Stewart, Jun.—Ordered, That the Committee appointed to correspond with the Colony Agent do lay the proceedings of the said Committee before the House to-morrow.

On Motion of Mr. Holland, Ordered, That the Revd. Theophilus Desbrisay, Chaplain to this House do attend at 10 o'clock each Morning during the Session to perform divine Service, and that he be notified by the Clerk thereof.

On Motion of Mr. Holland, Ordered, That no private petitions be received after Thursday, the 17th instant.

Mr. Holland Moved that leave he given to bring in a Bill "Intituled an Act for appointing and empowering Philip Codd, Esq. of Kensington, Colony Agent for this Island, leave granted.

The House then adjourned.

Wednesday, March 9, 1808.

THE House met according to Adjournment.... PRAYERS.

On Motion of Mr. Holland, a Bill intituled an Act for appointing and empowering Philip Codd, Esq. of Kensington to be Colony Agent for His Majesty's Island Prince Edward, received a first and second reading.

On Motion of Mr. Stewart, Jun. Ordered, That a Committee be appointed to examine into the several Acts of the General Assembly which expired at the last session and to report those that appear necessary to be revived and re-enacted Mr. Stewart, Jun. Mr. Brecken and Mr. Macgowan, where appointed for that purpose.

On Motion of Mr. Macgowan, The Bill Intituled "An Act for afcertaining laying out and fixing the Lines and Boundaries of three Counties and of the different Townships into which this Island is divided and for more readily adjusting all differences between Parties, when it appears that a settlement or improvements have been made by mistake on one Township for another, and

also for raising by assessment a sufficient fund out of which to defray the expences" of ascertaining laying out and fixing the said Boundary Lines" received a first reading.

And Ordered on Motion of Mr. Holland, to be read a second time to-morrow.

- Mr. Murray, Presented a Petition from the Inhabitants of the Settlement of Bedeque, praying that the above Bill might not pass into a Law---on Motion the same was read and Ordered to lie on the Table.
- Mr. Holland, Brought down from His Excellency the Lieutenant Governor the following Letters and Correspondence between His Royal Plighness the Duke of Kent, Lord Castlereach, Philip Codd, Esq. Colony Agent and Mr. Knox, the late Colony Agent, viz.

- No. 5. Note from His Royal Highness the Duke of Kent, to Lord Castle-REAGH, 4th May.
- No. 6. PHILIP CODD, Efq. to WM. KNOX, Efq. 30th April.
- No. 7. In Original, WILLIAM KNOX, Efq. to PHILIP CODD, Efq. 5th May.
- No. 8. Philip Codd Esq. to His Excellency the Lt. Governor inclosing a Letter from His Royal Highness the Duke of Kent, with Lord CASTLE-REAGE'S Note in answer to No. 5. When the same were read and ordered to lie on the Table.

The House adjourned till it O'Clock to morrow.

On Motion of Mr. Holland, It was unanimously Ordered, That the thanks of this House be voted to Philip Codd, Esq. the Colony Agent, expressive of the very high sense the House entertain of the activity and zeal he has already manifested in the performance of his duty as Colony Agent; and that the Speaker do by Letter signify the same to him.

The Committee appointed to prepare an Address in answer to His Excellency's Speech, reported the same.

On Motion of Mr. Holland, The House went into a Committee of the whole House to take the same into cosideration (Mr. Macgowan, in the Chair) after some time spent therein the Speaker resumed the Chair and the Chairman reported the same with amendments, which being read and agreed to, was Ordered to be engrossed.

On Motion Ordered, That Mr. Holland, Mr, Stowe, and Dostor M. Aulay, be a Committee to wait on his Excellency the Lieutenant Governor to know when he would be pleased to receive the same.

On Motion of Mr. Holland, The Bill Intituled an Act appointing and empowering Philip Codd, Esq. to be Colony Agent for His Majesty's Island Prince Edward, received a third reading was passed and ordered to be engrossed.

The Committee appointed to examine into the Acts of the General Assembly which expired at the close of the last Session and to report their opinion as to those that may be sit to be revived and re-enacted, reported, That the following Acts expired at the close of the last Session, viz.

An Act for appointing William and Thomas Knox, Esquires, to be Colony Agents for this Island.

An Act for granting a Bounty for growing and cultivating Hemp in this Island for the purpose of Exportation.

An Act for the better preventing accidents by fire, and for appointing Firewards in Charlotte Town and the suburbs thereof.

An Act to enable the Inhabitants of Charlotte. Town to meet annually on the first Monday in August to rate and affess themselves towards making and repairing the Pumps and Wells within said Town.

An Actin addition to and amendment of an Act made and passed in the 35th year of his present Majesty's Reign Intituled an Act to alter and amend the high Road Laws.

An Act in addition to and amendment of an Act passed in the Twentieth Year of His Majesty's Reign Intituled An act for the better establishing and regulating a Militia.

An Act in addition to and amendment of an Act made and passed in the 20th, year of his present Majesty's Reign Intituled an act for the establishing and regulating a Militia, also an Act made and passed in 35th, year of His present Majesty's Reign Intituled an Act in addition to and amendment of of an Act made and passed in the 20th, year of His present Majesty's Reign intituled an Act for the establishing and regulating a Militia.

And the Committee reported as their opinion that the whole except the Act first mentioned ought to be revived and reenacted.

On Motion, Ordered, That Mr. Holland, Mr. Macgowan, and Mr. Brecken, be appointed a Committee to prepare and bring in the heads of a new MilitiaLaw.

On Motion, of Mr. Stowe, Ordered that Mr. Stewart, Jun. Major M. Donnéll and Dostor M. Aulay, be appointed a Committee to prepare and bring in the heads of a new High Road Law.

On Motion of Mr. Macgowan, leave was given to bring in the heads of a Bill Intituled "An Act to alter and amend an Act made and passed in the 26th.

- year of the Reign of His present Majesty Intituled an Act to empower the
- "Governor Lieutenant Governor or Commander in Chief for the time being to
- appoint a theriff or theriffs for this Island, also to regulate the Office of ther-
- "iffs and the manner in which they shall return and pass their accounts of all
- "fines and forfeitures levied by them for the use of the Crown."

Adjourned until 11 o'clock To-morrow.

Friday, March 11, 1808.

THE House met according to Adjournment.... PRAYERS.

The Committee appointed to wait on His Excellency the Lt. Governor to know when he would be pleased to receive the Address of this House in answer

to His Excellency's Speech at the opening of the Session, reported, That his Excellency was pleased to appoint, half past 'Two o'clock, this day.'

On Motion of Mr. Macgowan, The Bill Intituled "An Act to alter and a"mend an Act made and passed in the twenty-ninth year of the Reign of His
"present Majesty, Intituled an Act to empower the Governor, Lt. Governor or
"Commander in Chief for the time being, to appoint a Sheriff or Sheriffs for
the Island; also to regulate the Office of Sheriffs, and the manner in which
they shall return and passther accounts of all sines and forseitures, levied by
them, for the use of the Crown," received a first and second reading.

On Motion of Mr. Macgowan, Ordered, That a Committee of this House be appointed to join a Committee of His Majesty's Council to examine into such Laws as are near expiring, and report thereon to this House, and that Messes. Holland, Macgowan, and M. Aulay, compose the same.

Ordered on Motion of Mr. Holland, That a Committee of this House be appointed to meet a Committee of His Majesty's Council, to prepare the drast of a joint Address of both Houses, to Field Marshal His Royal Highness the Duke of Kent, expressing in terms of the most profound respect and veneration the high and grateful sense they entertain of His Royal Highness's marked goodness manifested on every occasion towards this Island, and more particularly for His Royal Highness's late condescending efforts in our favor as communicated through the means of the Colony Agent.

The House waited on His Excellency the Lieut. Governor with the following Address in answer to his Excellency's Speech, viz.

We should have experienced great pleasure and satisfaction, if your Excellency had been enabled to acquaint us that the interesting objects pointed out in our humble representation, and Petition, at the last Sossion had been attained; but we trust that His Majesty's Ministers, when the Business of the Colony shall come under their consideration, will see the utility and propriety of acceding to our request.

We beg leave to assure your Excellency, that we are deeply affected by the princely mark of goodness which this Island has experienced, not only in this instance, but on every other occasion, at the hands of that illustrious personage whose name it has the honour to bear—the condescending aid which his Royal Highness has benignly manifested in our behalf, inspires our hearts with the sincerest sentiments of gratitude, and animates our hopes of ultimately attaining the object of our solicitation.

We defire your Excellency will be pleased to receive our best acknowledgments for your obliging communication of His Majesty's Royal confirmation of the Election Law of last Session, as also that the other Bills of the same Session had not been found objectionable.

We return your Excellency our warmest thanks for the communication of His Majesty's paternal care, in the arrangments which he has been graciously pleased to make in the Government and military command, in his Dominions in North America, and we considently trust that your Excellency's communication with General Sir James Henry Craig, K. B. the Commander in Chief will be productive of those advantages and benefits to the Island, of which it stands in such absolute need.

We thank your Excellency for the earnest solicitude which you are pleased to express for the security of this Island and the lives and property of His Majesty's subjects therein, against all eventual hostile attempts, affuring your Excellency that our deliberations shall be directed to such measures as may be most conducive to our General, as well as domestic, safety and tranquility.

We shall duly attend to your Excellency's recommendation, in enacting such Laws as may appear requisite for the public welfare, in amending and reviving such others as require amendment and revival; which is now become doubly essential in as much as the High Road and Militia Laws have expired.

When the public Accounts come before us we shall pay due attenton in making provision for the public expences pointed out by your Excellency, as far as the situation and circumstances of the Colony will admit of.

The confidence which your Excellency is pleased to place in our Loyalty and attachment to our most gracious Sovereign, and His Royal and illustrious Family, as also of our zeal to promote the good of His Service, we beg leave gratefully to acknowledge a due sense of---assuring you, Sir, of our earnest defire at all times to afford our best efforts for the good of His Majesty's Service. in general, and the prosperity and happiness of His Subjects in this Island.

Mr. Holland, Presented a Petition from the Inhabitants of Charlotte-Town, praying that the Boundary Bill may not pass into a Law.

On Motion the same was read and ordered to lie on the Table.

Doctor M'Aulay, Presented a Petition from the Inhabitants of the Vernon Ri. ver Settlement against the said Bill.

A Petition from the Inhabitants of Cherry Valley Settlement, against the said Bill.

A Like Petition from the Inhabitants of Bay Fortune Settlement, praying that the faid Bill may not pass.

A Like Petition from the Inhabitants of East Point Settlement, against the said Bill.

On Motion the same were read and ordered to lie on the Table.

Mr. B. Coffin, brought in a Petition of the Inhabitants of St. Peters Bay, Sa. vage Harbour and the Head of Hillsborough River, against the said Bill, which was also read and ordered to lie on the Table.

A Petition from John M'Donald of Allifary, against the said Bill, which was also read and ordered to lie on the Table.

Ordered, On Motion of Mr. Holland, That from the number of Petitions, presented to this House from every part of the Island, praying that the Boundary Bill may not pass into a Law, that therefore it be not taken into consideration until this day three Months. The House divided;

A Message from his Majesty, S Council with the Bill Intituled an Act for emitting certain Bills or Debentures within this Island, not agreed to.

Dollor Me Aulay, Moved that no Bill do pass this House unless it lies three Days upon the Table after the first reading. On the question being put, The House divided.

Howe, and Harry Compton, a Committee to meet a Committee of the House of Assembly on the subject of printing the Laws, and the same do meet at the Council Chamber to morrow at 11 o, clock."

His Mejesty's Council have sent down the Bill Intituled "An Act to revive, alter and amend an Act, made and passed in the 42d year of His present Majesty's Reign, Intituled an Act in addition to and amendment of an Act made and passed in the 35th year of his present Majesty's Reign, Intituled an Act to alter and amend the High Road Laws," with certain amendments, to which they pray the concurrence of this House, And then the messenger withdrew.

On Motion The House went into a Committee of the whole House to take into confideration the amendments proposed by his Majesty's Council to the said Bill, Mr. Speaker left the Chair (Mr. Holland, took the Cair) Mr. Speaker resumed the Chair, and the Chairman reported as the opinion of the Committee, that a conference be requested with his Majesty's Council by Committee on the subject of the amendments.

Ordered, on Motion, that the faid Report be agreed to.

Adjourned till 10 o'clock formorrow.

A Message from his Majesty's Council, viz.

On Motion The Bill Intituled "An Act to alter and amend an Act, made and passed in the 30th year of His present Majesty's Reign, Intituled an Act to oblige the respective proprietors of Lots or Townships of Land, or parts of Lots or Townships of Land, and who have contributed nothing towards the Settlement or improvement of this Island, and whose Lands lie in a waste and uncultivated State, to pay their proportion of the Public Charges for the making and repairing the High Ways and Bridges of this Island," received a third reading, and on the question being put whether the said Bill do pass, The House divided.

The said Bill accordingly passed, and was sent up to his Majesty's Council for their concurrence.

On Motion the Bill Intituled "An Act to revive two Acts lately expired, viz. an Act for granting a Bounty for growing and cultivating hemp for Exportation." and "An Act for the better preventing accidents by fire," received the third reading, was passed, and sent up to His Majesty's Council for their concurrence.

"Mr. Speaker, His Majesty's Council have sent down the Bill Intituled "An Act to revive two Acts lately expired," agreed to," and then withdrew.

Adjourned till half past six o'clock this Evening.

On Motion, The House went into a Committee of the whole House, to reconsider his Excellency the Lt. Governor's Mossage for granting a sufficient supply for the expences which must unavoidably attend the subsistence of the Militia, in the event of their being required to perform Military duty, and softhe other purposes pointed out in his Excellency the Lt. Macgowau, Stewart, Jun. and Brecken, be a Committee for the above purpose, who having withdrawn, returned and reported the same, which on Motion, received the first and second reading.

On Motion the House went into a Committee of the whole House on the said Bill.

Mr. Speaker left the Chair, Mr. Macgowan, took the Chair, Mr. Speaker refumed the Chair, and the Chairman reported that they had gone through and made several amendments to the same, which they defired him to report to the House, and he delivered the said Bill and amendments in at the Clerk's Table.

On Motion, that the faid Report be agreed to, The House divided.

For the Motion, Messrs. Brecken, Holland, M. Aulay, Montgomery, Murray, Stewart, Sen. Stewart, Jun. Macgowau, Rankin, B. Cossin, and Greed.

Against it, Mesfrs. Stowe, and E. Coffin.

Adjourned till half past six o'clock this Evening.

For Mr. Holland's Motion, Mestrs. Holland, Stewart, Sen. Stewart, Jun. Bag. nall, Murray, Montgomery, Creed, Rankin, B. Coffin, and Macgowan.

Against it, Messrs. Stowe, E. Coffin, Brecken, and M. Aulay.

The said Bill was then sent up to his Majefty's Council for their concurrence.

A Message from his Majesty's Council by their Clerk.

Mr. Speaker, His Majesty's Council have sent down the Bill Intituled an Act for raising a fund for defraying the expence of printing the Laws of this Island, and for other purposes therein mentioned agreed to, and then withdrew.

Mr. Macgowan, communicated to the House the answer of his Excellency the Lt. Governor to the Addresses of the House on the subject of certain Items in the Public Accounts.

On Motion of Mr. Bagnall, the House thereupon Resolved, That the answer of his Excellency the Lt. Governor to the Addresses of this House, respecting the monies charged in the Public Accounts, allowed the Post Office, Adjutant General of Militia and Thos. D. Cowdell, &cc. is highly satisfactory, and evince the strongest proofs of his Excellency's ardent desire of meeting the wishes of this House on all occasions.

On Motion of Mr. Holland, Ordered, That the House do enter upon consideration of the Bill establishing the Limits, Bounds and Meets of Townships in this Island," the next Session.

Adjourned until 12 ,o'clock to morrow.

On Motion Ordered, unanimously, That an Address be presented to his Excellency the I.t. Governor, praying he would be pleased to grant (out of the Treasury of this Island) an allowance of Twenty Pounds per annum to the Widow of the late Chief Justice Stewart, during her life.

Messer. Holland, Montgomery, and Rankin, were appointed a Committee for the above purpose, who having withdrawn, returned and presented the same, which being read was approved of.

The same Committee presented the said Address to his Excellency, returned and reported, That his Excellency was pleased to say he would do all

in his power to meet the wishes of the House.

On Motion Ordered, That an Address be presented to his Excellency, praying that the sum of £80 out of the Public sunds be expended in the necessary repairs to the Gaol at Charlotte-Town, and for the erecting a sence around it.

Messrs. Holland, Rankin, and Montgomery, were ordered to present the same, who on their return reported, that his Excellency was pleased to say he would comply with the desire of the House.

 - " MAY IT PLEASE YOUR EXCELLENCY,

HE House of Assembly having taken into their consideration, the necessity of making provision for immediately printing the Laws of this Island, have pasted a Bill intituled "An Act for raising a fund for defraying the expence of printing the Laws of this Island, and for other purposes therein mentioned," which I humbly present for your Excellency's assent.

His Excellency was then pleased to give his assent to the said Bill, after which His Excellency was pleased to deliver the following Speech to both Houses.

Mr. President, and Gentlemen of His Mujesty's Council,

Mr. Speaker, and Gentlemen of the House of Assembly,

WHEN upon ensideration of the existing conjuncture of national affairs, I had the honor of suggesting to you the necessity I felt of raising such a sum of Money as might enable me in case of need to resist and repel any hostile attempts which eventually might take place against this his Majesty's Island, I trusted that the Justice and expediency of my recommendation would have appeared to you sufficiently obvious, important, and forcible to prompt its successful result.

Persuaded after the long continuance of this Session, and at an approaching season of the year, when your attention to your domestic concerns is deemed to be more essentially requisite than at any other, that it must be highly designable on your part to be released so soon as practicable from the public Duty on which you have been engaged; I have therefore thought sit to close the current Session of this General Assembly by prorogation.

Wishing you health, and cordially thanking you for the good you have done, or may have intended to do...allow me, Gentlemen, to entreat that on your return to your respective homes, you laudably and wisely will both by your examples and precepts, inculcate and softer the seeds of industry, morality and virtue among your constituents, and by all persuasive means in your power, stimulate and promote a desirable prevalence of that harmonious spirit of loyalty and concord, which cannot fail to ensure the paternal kindness, protection and support of our beloved Sovereign, the security and prosperity of this his valuable Island, and permament comforts and happiness of his faithful subjects therein.

The President of his Majesty's Council, by his Excellency's Command, then said—Gentlemen, it is his Excellency the Lieutenant Governor's will and pleasure, that this General Assembly be prorogued to Friday the Twentieth Day of May next, to be then here holden, and this General Assembly is accordingly prorogued to the Twentieth day of May next.
