MR. TOWNSEND'S ADDRESS TO THE PEOPLE OF ANNAPOLIS COUNTY.

On Saturday afternoon last, the Court House of this town was filled with what was pleased to say, was a large representative gathering of the farmers of this county, who had assembled to hear the address of John F. They shipped their fruit in these large steamers which were compelled to lay down in the docks some ten or twelve apples from the fruit in the large amount of handling that this entailed on the fruit, as called in its being placed on the market in a very inferior condition; he sides causing the lots to get mixed up. Small steamers like the Septimo, properly ventilated, the latter most of the proper carriers, as they went close to the market as it was possible for any vessel to go. Great care should be taken with the putting up of fruit, as apples should be packed carefully in crates. All wormy bruised and ill shaped fruit should be carefully picked out, as a few of these ill-conditioned apples in a barrel had a marked effect on the whole in the buyer's estimation. The importance of properly sorting even sizes was then dwelt upon—that it did not look well at all to see a barrel of even No. 1's of different sizes. The fruit compared unfavorably. The reason why well colored apples were readily increasing, and he had no doubt that there would be any difficulty in procuring a fair price for well packed fruit throughout the season.
