





The prosperity of the order,-the success of the cause of Temperance -the present and future happiness of our country, and the glory of our Creator, depend in some measure upon our deliberations. P. C. Prov. Bros, let us lengthen our endless chain by incorporating our newly made brothers, as additional links.

beloved order. Heavy indeed are the responsibilities which you are about to assume. Weigh well their importance. Permit me briefly to specify some of the duties of your respective offices.

Bro. Prov. Sentinel. It is your duty to guard the door and see that none enter or retire, except those duly authorized. You will also perform such duties as may be required of you in the working of the Club.

P. P. S. O. Bro. P. S. O. It is with extreme pleasure that I invest you with this badge of your office, and proclaim you S. O. of the Prov. Club of Temperance Watchmen of Nova Scotia. You are now our Prov. Chief. Prove yourself a worthy guide and a master workman. You will now at once assume the duties of your office.

The Prov. S. O. takes his station, seats the Club, and before proceeding with the regular business addresses a few words of counsel and encouragement to the members of Prov. Club.
