

MEETINGS

The Regular Meetings of the Society are held quarterly, on the 25th March, or Lady Day; 24th June, or Midsummer Day; 29th September, or Michaelmas Day; and the 26th December.

FIFTY-SEVENTH ANNUAL REPORT

OF THE

Committee of Management of the St. George's Society

FOR THE YEAR 1892.

The Committee of Management have the honor to submit the following report of their proceedings during the past year, being the 57th since the foundation of the Society:—

Owing to the lamented death of their late esteemed. Patron, the Right Reverend Dr. Williams, on the 20th April last, the customary anniversary service was not observed last year. The revenue has therefore been diminished to the extent of the offertory on such occasions.

Donations at \$50 each have been made to the Finlay Asylum, Ladies' Protestant Home, Women's Christian Association and Jeffery Hale Hospital. 200 0

It affords the Committee great pleasure to announce that the financial affairs of the Society continue in a prosperous state, the funded assets now amounting in value to about \$14,800.

who have respectively been life members for the long period of 47 years; and of Mr. C. W. Wilson, a life member of 21 years standing.

We deeply regret also having to record the death of our highly revered Patron, the late Right Reverend Dr. Williams, Lord Bishop of Quebec, who for nearly thirty years filled that position, ever a warm friend of the Society, and who frequently appealed in aid of its funds at anniversary services, contributing also of his own means to its charitable work. The Society attended his funeral in large numbers last St. George's Day, thus testifying to the love and esteem in which our good Patron was held.

Five new members have been added to the roll, three life and two ordinary. The resident membership now stands at 132, of whom 59 are life members. Four of the new members are non-residents of Quebec, showing that much interest is taken in the Society by Englishmen residing in other parts of the Province. Your Committee would again urge upon all, the need of securing new members to fill up losses by death and other causes. We receive very few members voluntarily, by some exertion on the part of present members many might be obtained. We are much pleased to note a larger attendance at the meetings of the Society than formerly, thus showing increased interest in its work.

The directors of the Mount Hermon Cenetery have, since the last report, accepted the Society's offer of \$200 for the the vacant lot and path adjoining the Society's lot, this amount to be paid in four annual instalments, the first of which has already been paid, as shown in the Treasurer's statement.

Your Committee wish to place on record the valuable aid rendered at various times by the Revd. A. J. Balfour, Miss A. Healey and Miss Latimer, whose kindly offices have been much appreciated by the Sub-Committee of Charity.

The Right Rev. George Jehosaphat Mountain, D.D., D.C.C., Lord Bishop of Quebec, was the second son of Bishop Jacob Mountain, the first Anglican Bishop of Quebec. He was born 27th July, 1789, at Norwich, England; came to Canada with his father, 1793, and died after a brief illness at Bardfield, his country seat, on the 5th January, 1863. He was nineteen years Rector of Quebec, and was

consecrated Bishop of Montreal 14th Febuary, 1836, and of Quebec in 1850. He was a dil gent visitor among his flock, and in the dreadful visitations of cholera in 1832 and 1834 he literally lived night and day among the dying and the dead while in 1847, when the province was visited with the plague of typhus fever, and the poor immigrants were dying by thousands, at the Quarantina Station, the Bishop took his turn at Grosse Isle regularly with the rest of the clergy; and again when the cholera visited Quebec in 1849 and 1854 he was diligent in visiting the hospitals. During many years and up to the time of his death, Bishop Mountain, besides his life membership, contributed regularly to the Society a donation equal to four annual subscriptions, and at all times took a great interest in its proceedings.

place on St. George's day and was largely attended by the members of the Society.


