NEW BRUNSWICK FINANCES.

Speech of the Provincial Secretary.

MR. BLACK'S REPLY.

On Tuesday the 7th, Provincial
Secretary Wedderburn delivered his
Budget speech. He said that he
had been any one of the four pre-
vious occasions that he had per-
formed this duty, had felt the pleasure that
he did this time. Previously he
was obliged to report depression of
business. To-day, however, he
had a different report. "We would
begin by giving the estimate of last
year and showing how far they had
been realized. The estimates for
last year were \$581,291, and the
actual expenditure was \$568,843.70.

The expenditure thus exceeds the
estimate by \$12,446.70.

The estimate for the administration
of Justice was \$13,000, and the
expenditure under that head \$13,
866.17. The cost last year was
greater than the previous year by
\$1,279.76 owing to jury fees and
reporting decision of the second
division of the Supreme Court.

Agriculture showed an estimate of
\$22,518.19 and an expenditure \$750
higher. The account was thus made
up:

Grants to Societies \$11,381.00
Board of Agriculture, 301.31
Sec. to Board, 1,000.00
Importation of Stock, 10,000.00

\$23,682.31

Bear bounties fell below the
estimate. Bounties were paid for
the killing of 172 bears against 5,565
the year before. Since 1877 3,584
bears were destroyed at a cost to the
Province of \$10,742.00.

The estimates have usually been
estimated at \$10,000, but this year
they were 4,486.23 above that sum,
of which however \$2,000 were
chargeable to the preceding year.

The normal expenditure under this
head is \$12,000. The grants to poor
districts were \$20,000 extra had been
given for the Douglas gold medal at
the University. Legislature cost
\$330 less than the estimate and the
amount expended under the free
grants act was \$750.00 on the same
scale.

For Public Health the estimate

MR. BLACK'S SPEECH.

Mr. Black then resumed the de-
bate on the motion to go into sup-
ply, and said:

Mr. Speaker,—In asking the at-
tention of the House to a matter of
such vital importance as was pre-
sented by the hon. the Provincial
Secretary yesterday afternoon,—a
matter which I may define as the
financial condition of the Province,
the management and the result
of that management—I feel, sir,
that I am, comparatively, to do
justice to the question. But, sir,
that hon. gentleman is always elo-
quent, and I like to hear him speak.
Yet I feel that in this instance the
result depends more on the innate
merits of the question under dis-
cussion, than on the eloquence
of the advocate. I noticed that on
this occasion the hon. gentleman ad-
dressed the house in a tone more con-
fident than heretofore—the expec-
tation of victory seemed to animate
him as he asserted that the Gov-
ernment had turned a deficit into a
surplus, and that never before had
he such great feelings of plea-
sure in moving the house into sup-
ply. If there are substantial rea-
sons to justify his bright showing
of the financial situation, no one,
sir, on the Government benches will
rejoice more heartily than I, for I
am not one of those who believe
that the Province is on the verge
of bankruptcy—though because of
my criticisms of the manner in
which the public accounts have
been kept, such an accusation has
been more than once hurled at me
across the floor of this House, I
entertain no such feeling, sir, but I
hold it to be the duty of the Gov-
ernment to look to the future as well
as the present, and, profiting by the
experience of the past, so conduct
the affairs of State that there may
be no cause to look back with feel-
ings of censure on those who now
hold the reins of Government.

Honest words of advice are, I hold,
sir, always appropriate and in place,
and I wish to-day to be understood
as dealing with the conduct of pub-
lic affairs in no narrow spirit, or
captious mood. I take it, sir, that
there may be something in the sur-
roundings here that tended to
summarily the hon. Prov. Sec'y to
such a confident pitch. With some
trifling exceptions, our surround-
ings must call up pleasant and en-
couraging feelings. This, sir, is the
first budget debate in the new build-
ing—the first session in the new
building—the last session of the
present House, and have in the
records of the Parliamentary history
of the Province will be written
from a new standpoint. You, Mr.
Speaker, and the hon. gentlemen
present, will, I trust, pardon me, if I

Now, Mr. Speaker and gentlemen, I shall ask your attention for a few minutes, while I discuss the change, which the Prov. Secty. claims has taken place in our finances from 1879 to 1881, by which the deficits have been transformed into surpluses. Taking his figures, the net revenue in 1880 was \$615,284, other expenditures, \$609,561, leaving a surplus of \$5,613. If this were so, it is a subject of congratulation. But it is not so, and it is the contrary. In order to make his presentation of the figure correct, he should have stated that \$8,078 towards his surpluses was obtained from insurance on the bare Parliament buildings. The net revenue account, though not balanced but merely the result of an accident. Again, in the same year, \$17,000 was obtained from the sale of public lands (though none were sold in 1879) and included in the revenue. So that instead of a surplus there was a deficit of \$19,465. These are facts which the Provincial Secretary would do well to take into his serious consideration. The gist of my argument is, that the House of Commons do not funds enough, but that the true statement of affairs is not made public. The Secretary also claims a surplus in '81 of \$22,815. It is to be remembered that the increased per capita subsidy gives \$15,000. An additional \$7,815 is added to the word in no personal or offensive sense) is to place the \$4,312 premiums on debentures as annual revenue, when it should have gone against the public debt. Then the real sales of which the House is proud in 1881 were \$19,222. This year the mining houses were exceptionally large, adding \$4,000 in excess of former years to the general revenue, and making in all \$40,748.

Now, again place the balance on the other side of the account. Now, sir, the facts that have been presented, gathered from such papers as have been obtained, but which, mark you, are not down in the public accounts, lead me to believe that the change from deficits to surpluses of the public department of the country—that the resources of the country should be husbanded—that the management of the different departments should be more economical, such as to present of accounts, such as would be given to the business men of the country. There should be no diversity of accounts. This system should be such that whenever a balance was asked for, it could be given in full. There should be one and simple the accounts, the more will the Government commend themselves to the confidence of the people. We know that the blue books and accounts are deceptive; that the blue books are not an account or bank account—no showing of our financial relations with the Dominion—nothing to show where came the money for the new Parliament building—nothing to show the full account of our managing revenue to October 31st.

We know they are not. The facts, sir, establish that no matter how expert an accountant a man may be, he cannot pick up the accounts and see what is the state of the country. To the detriment of this is not in keeping with the utilitarian spirit of the age. These accounts are a mass of useless rubbish, so far as information is concerned, and it would be better to have the accounts simplified and appropriated to a more useful purpose. A new department in book-keeping is now appearing that I feel sure the House would cheerfully sanction and uphold. Now, sir, it is not my mission to attempt to evolve any kind of balance sheet, but to show a mass of returns and blue books before the House, for the simple reason, sir, that it would be impossible to do so.

While I have called attention to the House of Commons, I do not doubt, I would like to refer to one document. A newspaper published in St. John by a gentleman on the staff of this House, who speaks for the Government, referred on 15th March last, to a number of the House of Commons, and about to take the matter of each hire, stating that heretofore bills of this nature

Recently qualified to explain their proceedings and practice more intelligently than I could hope to do. And in pointing to the condition of my own department, I do not wish to be thought that I take any special credit to myself therefor. I have simply done by duty, and in it I have been assisted by the gentlemen who compose the Government, and in some instances by the gentlemen who oppose it. I have been treated with great fairness on both sides and my official and personal relations with the members have been, I am happy to say, characterized by the best of good feeling. Far be it from me to say, dear sir, that the management of my department is above criticism. I care not how capable a man may be, but at the head of a department and in the conduct of affairs would not be impervious to the criticism of an impartial observer. Therefore, sir, I will not pretend to say that the Public Works Department is free from criticism; but I do say, sir, that whenever criticism arises, no matter from what quarter, I will be able to show that no accidental or fortuitous connection with it or any other of my department is responsible. I am prepared to defend the acts of those under me in the department, since 1878, as freely as I am prepared to support the policy of the Government. With a well-regulated revenue, or nearly so, when we can manage to keep close to it and expend the money for the benefit of the people—when we can do that, they are doing all that the people expect us to do as their trustees. If the public do not consider it the Government's duty to board up the leveues of the Province, and in this I take common ground with the people—they look for an intelligent administration of the yearly income, in its application to the general public services. I would ask, sir, has it been pointed out in one particular where the people's money has been misappropriated by the Government?—unless we can so interpret his strictures on the stock law.
