YORK MUNICIPAL COUNCIL.

JULY SESSION, 1881.

Reported for the Board by Mr. L. C. Macnutt.

THE OPENING SESSION.

The York Municipal Council assembled in July Session at 10 A. M. on Tuesday, the 5th inst., Mr. Warden Rutherford in the chair.

After roll call, Sec'y-Treas. Rutherford reported to the Council the death, since last session, of Councillor Foster, of North Lake, and the election to the vacancy of Mr. W. W. McGee, who had filed the necessary qualification papers.

The Sec'y-Treas. next read the minutes of the January Session, which on motion of Coun. Nelson, seconded by Coun. Hoyt, were adopted.

The Warden said that since the last meeting of the Board, Coun. Foster had departed this life. He knew he expressed the feeling of the Board, when he said that Coun. Foster was an honest, upright, and well meaning man, and that all would regret to hear of his death. He hoped that what was the Board's loss, was Coun. Foster's gain.

The Warden also called the attention of the Board to a Bill, which had passed the Legislature, protecting County rights against the City.

The Sec'y-Treas. submitted a communication from the City Clerk, O. W. Beckwith, Esq., relating to market affairs, and asking for action of the Council to make an amicable arrangement.

Coun. Pinder, seconded by Coun. March, moved the request of the City Council be complied with, and a committee be appointed to meet the committee from the City Council.

Coun. McCormick moved in amendment that the communication be laid on the table. He did not think the City authorities had anything to do with the County Market House.

Coun. Colter did not understand the object of the City Council in asking for a conference on the market question.

Coun. Pinder thought that it would be only a matter of courtesy to appoint the committee.

Coun. Calhoun expressed a similar view. He favored a free county market, which also had the effect of making the city market free.

The Sec'y-Treas. considered the market question already settled, and if this Board appointed a committee, it would be virtually appointing a committee to do nothing.
