**An Act to extend the Municipal Loan Fund to certain local improvements.**

**W**HEREAS it is desirable that the Municipalities in Lower Canada should profit by the Municipal Loan Fund constituted for their use; Preamble.  
Therefore Her Majesty, &c., enacts as follows :
