The Committee on Religious Publications beg to report as follows:—

Your Committee highly approve of the manner in which our Organ, the Christian Messenger, has continued to be conducted. We are happy to learn that an enlargement of the paper is contemplated after the close of the present year, without any increase of the price. We would urge all baptists to interest themselves in its circulation. It should be introduced into every baptist family and as much farther as possible.

Your committee cannot refrain from commending the kind and conciliatory spirit manifested hitherto by the Christian Messenger towards those who differ from us in points of doctrine and practice, while at the same time our distinguishing views, have been maintained with unflinching firmness. REPORT.

BIBLE CAUSE.

Your Committee on the Bible Cause beg to report as follows :-

On the general subject of Bible distribution nothing needs here to be urged. We would refer, however, to some special points connected with the present position and claims of the American and Foreign Bible Society.

That Society, since its formation, fifteen years ago, has distributed one million copies of the Sacred Word, at an expense of more than \$240,000, in its foreign fields alone. How much of this work would have been done apart from its labors?

Those labors, still keeping the foreign field before us, are needed more than ever. In Burmah, where the British sword has opened a wider avenue for evangelical labor of every kind, and especially for the circulation of Dr. Judsons Bible. In Germany, and the neighboring countries, where brother Oncken and his twenty colporteurs are working in their day, not knowing how soon their night of constrained inaction may come. In various other spheres, in Asia, Europe, Africa, whose varying claims cannot here be presented.

The American field is assuming an aspect of sill deepening interest, arising from the continual influx of German emigrants; of whom ninety thousand are to be found in New York city alone, and some five millions in the United States at large. To these the attention of the society has been particularly called, and for their wants they are making special provision.

In view of these considerations we recommend the passage

of the following resolution :-

That we cherish a growing attachment to the American and Foreign Bible Society; are glad to hear of the high esteem in which it is held in these provinces generally; and feel assured that the churches in this association will still, as heretofore, respond to its appeals for help.

REPORT.

The Committee on Union Societies report :-

That they have for some time observed the operations of the Union Society and with much pleasure have marked its great utility in all cases where it has been worked. At the same time, they must state, that they have been unable to discover in it, any particular charm by which funds could be raised to sustain the various benevolent objects embraced by it, without an effort being made either by active Pastors and deacons or by an efficient Agent appointed for that purpose.

And your Committee would beg to state that in all cases where this Society has not energetically worked they have failed to discover its usefulness, as the money collected by the ordinary exertions made, while, if devoted to one object, say home missions, or indeed any other, would be a great aid, but when divided between home missions, foreign missions, ministerial education fund and infirm ministers fund, the amount is so small

that it is of little use to any one of them.

Your Committee would therefore suggest to the Pastors and deacons the necessity of making greater exertions than have been made, and further your committee are of opinion that the Pastors and deacons do need the help of a suitable Agent in order that this society may supply the demands of the various benevolent objects which it embraces.

The report on Sabbath Schools presented and adopted.
REPORT.

The Committee on Sabbath Schools beg to report :-

That nearly all the Schools that are reported appear to be in a flourishing condition, they regret, however, to say, that of the 30 letters presented to the Association only 10 speak of their Sabbath Schools; your committee would however indulge the hope that efficient schools exist in many other places though not reported.

Only six schools have reported their numbers—these contain 235 scholars and 37 teachers. The Committee would urge upon the Churches the importance of sending their returns as fully as possible,—as to the number of scholars and teachers, the average attendance, the state of the Libraries, and the period which the school has been kept, if it has not been main-tained during the whole year.

Three of the schools report as to having Libraries.—Your Committee would strenuously urge the importance of furnishing a Library to every Sabbath School, as a meens of introducing religious reading into many families who cannot be induced to attend the preaching of the Gospel.

It is doubtless very difficult, in some localities, to maintain a Sabbath School during the winter season, but your Committee would urge the Churches so to do where it is at all practicable, hs, in addition to the general advantages to the rising generation, it furnishes the members of our Churches suitable and profitable employment for the sacred hours of the Lord's Day, and compensates in some measure, for the more public means of grace.

The value of Sabbath Schools can scarcely be overrated: many of our pastors, as well as active members of our Churches, are living illustrations of the blessings resulting from Sabbath School instruction. It is, however, a matter of deep regret that many of our youths leave the schools just at the period when their minds, expanding into maturity, are capable of appreciating the value of divine truth. Your Committee would urge the formation of Bible Classes for young men and young women, under the care of experienced teachers, whose leisure may enable them to make suitable preparation for their important work; they would further suggest that the youthful members of our Churches be recommended to join such classes, who would thus receive such instruction as would "build them up in their holy faith," while their attendance would give confidence and encouragement to young people to attend also, who might be "halting between two opinions," and by the blessing of God, keep those within the precincts of the Sanctuary, who might otherwise be led away by the seductive influences that surround them.

The importance of maintaining our Sabbath Schools steadily, might be further urged, from the fact that the population of the Province is so far divided into religious Denominations, as to prevent the teachers of day schools from giving religious instruction to any extent, from the fear of being charged with proselyting—it is, therefore, the more incumbent on the Churches to take care that this important branch of Christian effort is not neglected.

Your Committee hope that it is not necessary to enforce the necessity of a careful and prayerful preparation on the part of the Teacher, for the efficient discharge of his duty. The Teacher should avail himself of all the leisure at his command and every facility that may be within his reach, that may enable him to explain with simplicity the word of God to his youth-

ful charge.

In conclusion, your Committee are glad to learn that in many of the schools the exercises are concluded by familiar addresses to the whole school. They believe that this is an important branch of Sabbath School labour: opportunity is thereby afforded to make such appeals to the pupils as, by the blessing of the Holy Spirit, may result in their conversion to God, while the exercise may be a blessing to the Teacher and to the whole

The Committee on Colportage beg leave to report:-

That your Committee are of opinion that deeper impression is made upon the mind of the churches by colportage than by any known agency, at the same amount of expense and labor.

That it happily unites the preaching of the Gospel in its most substantial form, and the practical piety with which the church in past ages has been blessed; and while it also affords efficient aid to the living ministers by replenishing their libraries, it also gives interest to Sabbath Schools, and is a most efficient agency for the circulation of cheap religious periodicals.

That our churches are recommended to give aid to the colportage by their liberality, and that while it will ultimately clear expenses your committee would recommend that a more general application thereof be made where Baptist sentiments do not largely exist.

Your Committee have much pleasure in expressing, for a information of such as may need to be informed on this pointheir hearty approval of the satisfactory manner in which to Academy is conducted, by its judicious and able Principal, M. J. W. Hartt, with the aid of his valuable Assistant, Mr. H. W. Johnston. They strongly recommend to Baptist parents, and other to send their sons thither for instruction.

While your Committee are likewise indulged with the sal faction of hearing the most unqualified testimony to the abilical, and diligence with which the worthy President of Aca College, the Rev. Dr. Cramp, and his invaluable coadjutor, late deeply lamented Professor Chipman, have discharged onerous duties devolving upon them, and to the extensive usual fulness of the instructions which have been imparted in that attution, they cannot fail to be aware, that in order to the accomplishment of all that is contemplated and desirable, an increof teachers is indespensable. For the attainment of this object, and the sum of £10,000, as proposed at a meeting held at Wolfe in December last be carried into effect. "That however desirable it may be, for various reasons to ptain support for the College by Annual Subscriptions, it has en found by experience that the funds derived from that source e precarious and insufficient, and that the uncertainty of colction, and consequent irregularity in the receipts, produce anifest inconveniences, which are seriously detrimental to the there for occessful working of the Institution; while it is manifest, that rend ut seenlarged income required for an increased number of Prossors cannot be reasonably looked for without a change in the t vast in scuniary arrangement.

"That in order to place the College on a permanent foundaon by procuring an adequate amount of annual support, it is this poi sirable to raise the sum of not less than £10,000 for an Enwhich to when, to be vested in approved securities; the interest of cipal, M hich, £600 per annum, together with tuition fees, the proceeds the Union Societies, applicable to Theological Education, and and other by voluntary subscriptions which may continue to be realized, ill suffice to provide for the appointment of a suitable number.

REPORT.

The Committee appointed to prepare a Memorial with reference to departed brethren present to the Association the follow-

ing expression of their views and feelings.

The strokes of death have fallen heavily on our Denomination in these Provinces during the past year. The brethren Elder and Very have been taken from service in New Brunswick; and here, in Nova Scotia, we mourn the loss of Professor Chipman, and of the four students of Acadia College, who died with him and brother Very on the 7th ult. That sad catastrophe has spread unexampled distress throughout the land.

Brother Elder was greatly beloved by all who knew him. His gentleness of spirit and amiable deportment endeared him to his brethren, while his intellectual qualifications and varied attainments added lustre to piety, and fitted him, in the opinion of

competent judges, for extensive usefulness.

Brother Very was distinguished by solidity, and comprehensive views of truth, perspicuously and forcibly expressed. He was an active and devoted pastor. He was a wise-heartef friend of knowledge. His labours on behalf of the denomination, in connection with the Christian Visitor and circulation of useful books, were of the highest value. His memory will be lon and affectionately cherished by the Baptists of these Province

The four students referred to above were young men of gree promise. They were all members of Baptist Churches. Two of them were candidates for the Christian ministry, and one William E. Grant, was already known as an acceptable preach er of the gospel. All were industrious in their studies, correct in conduct, and apparently destined to occupy no meant in society. Their early removal is among the inscrutable things of God, of which he will be "his own interpreter," in his own time.

Carefully estimating the mental and moral characteristics of every student, he was ever prepared to advise and aid, in order to secure the progress which he so earnestly desired. His success as a Professor is recorded in the history of those who were from time to time under his care.

In the cause of education he was enthusiastic. His views were of the most enlightened and enlarged character, and admirably adapted to promote the advancement of our Denomination.

He was a whole-hearted Baptist, and he cared for our interests as if they had been entrusted to his special guardianship. Every day bore witness to his labour, his deep concern, and his forethought. Every project was viewed by him in all its bearings and pursued to all its consequences. Every Institution shared his anxieties.

Early converted by divine grace, he gave himself up to the service of God in the spirit of unreserved consecration. Though he did not often speak of his religious feelings, it was manifest to those who best knew him that he felt intensely. Piety was with him a principle—a well sustained habit—an all-pervading power. He was "a man of God,,' and he has doubtless joined the spirits of the "just men made perfect."

The removal of these valued brethren cannot but be contemplated with mingled feelings of grief and astonishment. As yet, we walk in darkness. God's "way is in the sea, and his path in the great waters, and his footsteps are not known." But he is wise, and just, and good—infinitely so. Let us bow before him with meek submission. Let us trust in him with entire confidence. Let us labour for him with all our might, working "while it is day," since "the night cometh, when no man cen work."

REPORT.

The Committee are happy to learn that bro. Arthur Crawley, who has just completed his studies in the Newton Theological Institution, is now ready to proceed to the Missionary field, wheresoever he may be appointed.

The Foreign Missionary Board, as your Committee are in-

formed, decided, some time ago, that it would be entirely inexpedient in future, to send out any single Missionary, judging it of the greatest importance that two or more brethren should be united in the work, for sympathy and mutual counsel and aid. The Committee fully concur with the Board in reference to that decision.

But there is at present no second candidate for Missionary service, and bro. Burpe, as is generally known, though very desirous of returning to his labours, is not yet sufficiently restored in health, to render such return prudent or safe. It is manifest, therefore, that bro. Crawley's appointment must be indefinitely postponed, unless some other arrangements can be made, whereby the difficulty may be met. Your Committee learn that the Foreign Missionary Board have entered into correspondence with the Secretary of the American Baptist Missionary Union, with a view to ascertain whether Missionaries from these Provinces can be sent out under the auspices of the Union, receiving their support from our Funds, and communicating to us, from time to time accounts of their proceedings.

It appears to your Committee that this is a very desirable arrangement. It will prevent grave inconveniencies, and secure great advantages. Separate and independent action will still continue, while the benefits of junction with a larger Body will

be enjoyed.

Your committee recommend that the action of the Foreign Missionary Board be sustained, and that the Convention be solicited to confirm it; and feeling assured that the Churches of these Provinces are able to support two Missionaries, they beg to suggest the importance of obtaining the services of a second Missionary as soon as possible.
