**Mass-American Telegraph Company**

New difficulties are being developed, greater than a telegraph across the Atlantic had to contend with. And now that the line across that ocean is a fixed fact, it is not improbable that this enterprise may for the present be abandoned, and the remaining capital of the Mass-American Company devoted to the construction of another line of telegraph across the Atlantic. Two million dollars have been already expended in the purchase of the department of Massachusetts routes at Petropolis, and usually employ the tour of his province, men hounded miles in extent on a dogleg. Only a single mail per year is allowed them. This mail leaves Petropolis on December 25th, and is carried on sledges the entire distance across the continent—*Solo Francisco Herald.*

**Fell Among Thieves.**

**The Case of Admiral Fermano.**
