



JANUARY SESSION.

WELLAND, January 24th, 1888.

Pursuant to the Municipal Act, the Reeves and Deputy Reeves of the various Municipalities, composing the County of Welland, met at Council Chamber, Welland, for the purpose of organization, election of Warden, and the transaction of general County business, at 5.30 p. m.

The Clerk announced that it would now be in order to proceed with the election of Warden by ballot, and read, for the information of Council, clause one of the standing rules, referring to the election of Warden by ballot, after which the following nominations were received:—

REPORT OF SPECIAL COMMITTEE ON HOUSE OF INDUSTRY.

To the Warden and Councillors of the County of Welland, in Council assembled:

Your Special Committee on House of Industry for the year 1887, beg leave to submit this their report, respecting the construction of the buildings and other matter therewith. Upon the 10th December last your Committee authorized the Warden to issue his cheque in favor of the contractor for the sum of \$1,700, less 20 per cent., being the second payment on account. At the same time they iustructed H. D. Suess to prepare full plans and specifications for the barn in accordance with the alterations approved of by the Council.

A contract in duplicate for the building of the barn was subsequently prepared and has been signed by Mr. Bald, a copy of which was annexed, (a).

Mr. Baid nominated Messrs. Lamont and Morwood as his sureties, and bonds were prepared and signed by him and them, in the penal sum of \$1500, for the due and satisfactory completion of the above work on or before the 1st day of June, 1888 (b).

The entire brickwork of the building was completed on the 20th day of December, 1887, and has been done, as your Committee believe, in a very sat sfactory manner, the weather having been almost as favorable for that kind of work as midsummer.

The Inspector of the building having filed his certificate that work had been done in a satisfactory manner, the Warden's cheques was issued for the sum of \$1400, less 20 per cent., being the third payment as per terms of contract.

Owing principally to the severity of the weather, some delay has been experienced in roofing the building, but we have the satisfaction to announce that the roof is now nearly completed.

Your Committee have not been satisfied with some of the flooring which had been laid in the building, and have instructed the Inspector to have the same removed at the contractor's expense. Also some lumber that had been used in the ventilator, as being unsound and defective.

Mr. Jacob Trumb, contractor for building fence on North side of farm, having satisfactorily completed his job, has been paid by Warden's cheque.

Your Committee also engaged Mr. Trumb to draw the balance of rails left after building fence, and distribute them across the farm tor an interior fence, broken rails to be piled for fire-wood at house, for the sum of \$5.00.

Your Committee beg to submit the following statement of expenditure in connection with Industrial Farm, from the purchase thereof up to date.

AGREEMENT "A."

This agreement made in duplicate this 23rd day of December, 1887, between David Bald of the Township of Thorold, in the County of Welland, and Province of Ontario, Farmer, of the first part, and the Municipal Corporation of the County of Welland, hereinafter called the Corporation, of the second part.

Whereas the said Corporation has declared it necessary and expedient to erect buildings upon the Industrial Farm, for the better protection of the Insane Destitute of the County, and all necessary By-laws and other preliminary proceedings having been passed and taken for the proper execution of such work, and the party of the first part having been awarded the contract for the erection of a certain barn upon the said Industrial Farm, and having undertaken and agreed to do the said work,

Now, this agreement witnesseth, that the said party of the first part, in consideration of the sum of one thousand one hundred and ninety-nine dollars of lawful money of Canada, to be paid to him as hereinafter mentioned, doth hereby for himself, his heirs, executors, administrators and assigns, covenant and agree to and with the said Corporation, that he, the said party of the first part, his heirs, executors, administrators and assigns, shall and will execute and perform all the work of every kind required in the erection and completion, in a good and workmanlike manner, of such barn, and to furnish all material therefor, the said barn to be erected on that part of Lot 250 of the Township of Thorold, in the said County, marked out by the Inspector in charge of the said work, appointed by the said Corporation.

The said barn to be erected according to certain plans and specifications prepared therefor by H. D. Suess, Esq., and signed by the Warden of the said County, and the Committee upon said House of Industry, and by the said party of the first part.

Which said plans and specifications are hereby expressly declared to be incorporated in, and to form part of this agreement, as if the same had been embodied herein, and the said work shall in all things be performed and completed according to the aforesaid plans and specifications, after the manner therein set forth and explained, and shall be in all things to the entire satisfaction of the said Inspector, or other person, who may succeed him in charge of the said work, and that the said party of the first part, his heirs, executors, administrators and assigns, and each and every one of his or their workmen, agents and servants, shall in all things concerning the performance of the said work, obey, abide by, keep and perform all the several conditions set forth in the said plans and specifications.

And the said party of the first part, and the said Corporation, do hereby covenant and agree, the one with the other of them, that all differences which shall or may, during the continuance of this contract, arise as to the meaning or intention of any part of the plans, drawings or specifications, already or hereafter to be provided, which shall or may in any wise arise or be caused between the said parties by reason of this contract during the continuance thereof, when and so often as the same shall happen, shall be referred to the award, order and determination of the said Inspector, or other person who may succeed him in charge of the said work, whose award in writing, under his hand, concerning all matters so to be referred, shall be final, and the said party of the first part further covenants and agrees to commence the erection of said barn not later than the 1st day of February, 1888, and to have the same fully completed in accordance with the aforesaid mentioned conditions, and to the approval of said Inspector or his successor, on or before the 1st day of June, 1888, under a penalty of five dollars per day, which is hereby mutually agreed to be taken and considered as liquidated damages for every day beyond the said first day of June the said work shall remain incompleted.

And the said party of the first part agrees to furnish on or before the 10th day of January, 1888, security in the sum of \$1,500 for the ns and ned by House

And for the consideration aforesaid, the said Corporation agrees to pay the party of the first part the said sum of \$1,199.00, payment to be made by instalments as such work progresses, less 20 per cent. of the amount thereof, as follows:

When all excavations, drains, and drain pipes are completed, with the stone walls of basement, brick piers, door and window frames, set sills and first tier of joists laid, the sum of \$300.

When the frame work is completed, roof on and building enclosed, the sum of \$400.

When the building is completed, the sum of \$499.

No such payments to be made except upon the written certificates of the Inspector, that such above specified portions of the said work are fully and satisfactorily completed.

And it is agreed by the said party of the first part, that 20 per cent. of the above mentioned payments may be retained by the said Corporation for thirty days after the entire completion and acceptance by them of said work.

In witness whereof the said parties have hereunto set their hands and seals, and affixed the corporate seal of the said Corporation.

D. 1888.

Now the condition of this obligation is such that if the above bounden David Bald shall erect and build such barn in accordance with the plans and specifications mentioned and referred to in said written agreement, in good and workmanlike manner, and furnish all material therefor and have the same fully completed to the satisfaction and approval of said Inspector in charge of such work, on or before the first day of June, 1888, and generally abide by, perform and carry out all the terms, covenants and conditions in said agreement referred to, mentioned and set out according to the true intent and meaning of the same, and protect and save harmless the said Corporation, of and from any and all loss or damage sustained by reason of any default, neglect or failure of himself, his workmen, servants, or agents, in or about the erection of such barn, or in the complete carrying out of said agreement as aforesaid, then this obligation to be void, otherwise to be and remain in full force, virtue, and effect.
