EXPLANATION.

The arrangement of the following records is in the main the same as has been followed by the New-England Historical and Genealogical Society and the object in compiling the same is to enable the present and future generations to have a more complete knowledge of their ancestors. The aim has been to procure the names and data of every descendant of Colonel Samuel Embree who came from White Plains, N. Y., and settled in Amherst in the year 1775. Documentary information, whenever it could be found, has been embodied in the work and many of the descendants, now widely separated, have been corresponded with, every effort having been made to get the information at first hand.

The difficulties naturally encountered in compiling such a work as this have been many, but were immensely lightened by the extremely generous and hearty assistance given by so many members of the families interested when the writer laid the objects of the work before them. This record is brought down from the year 1775 to the present year 1919.

The records have been divided into sections, each of the three sons and the daughter of Colonel Samuel Embree being given a section for all his or her descendants. In each section the different generations will be found to follow each other from the oldest to the youngest of the present date.

The names in parenthesis, following the descendants name, show the line of descent from the original ancestor, Samuel Embree; the figures following the names denoting the generation. Many words not absolutely necessary in a sentence are omitted entirely. Abbreviations: b. for born, m. for married, unm. for unmarried and d. for died.

The reference mark § denotes that further particulars appear on the same or closely following pages.

EARLY EMBREE ANTECEDENTS IN AMERICA.

The history of the Embree Family goes back to the earliest settlement of Flushing, on Long Island, U. S., and there is reason to believe that it was of French Huguenot origin, and tradition reports that they came from Normandy, the original form of the name being d'Embree. As the name appears in the United States many years before the Huguenot immigration in 1686, they were probably among the large number of families who fled from France to Holland to escape persecution, and thence came to America with the Dutch.

Their first settlement was in Westchester, N. Y., from whence they removed to Long Island, N. Y. One of the earliest mentions of the name is in the will of Nicholas Percell or Parcell dated March 10th, 1689, -90. In this he leaves a legacy to Robert Embree, son of my daughter Sarah. She was probably the wife of John Embree whose name appears at an early date. About the same time appears the name of Moses Embree, probably the brother of John, these two seem to be the progenitors of the race.

Robert Embree was probably the father of John Embree who married Sarah, daughter of Francis Doughty. She was born September 1703.

Her grand-father, Rev. Francis Doughty, is inseparably connected with the founding of the towns of Flushing and Newton. His sons Elias and Francis were very prominent in the early annals. Francis Doughty married Margaret, widow of Rev. John Moore, of Newton. She was a daughter of Edward Howell, whose name must ever be famous as the founder of Southampton, the first English town in the Province of New York, and the ancestor whose descendants may be numbered by the thousand.

Among the children of John and Sarah Embree, was a son, John Embree, who married Elizabeth, daughter of Richard Lawrence and Hannah Bowne. She was born April 15th, 1720. Their son, Effingham Embree was born September 24th, 1759, and died December 3rd, 1817. He married his cousin, Mary Lawrence, (daughter of John Lawrence and Ann Burling.) She was born October 17th, 1763, and died September 16th, 1831. They were married December 26th, 1780. In the early part of the last century few men in New York were better known or more prominent than "Effingham Embree, Gentleman", as his name so frequently occurs in the records of those days. Shortly after the Revolutionary war he was appointed by Congress to bring up the standards of the Gold and Silver coin, then in circulation, which had been badly sweated and clipped during the war. In 1817 he purchased a large tract of land in what is now the heart of New York City, but then in the suburbs. This was a part of the Ancient Bayard Farm and extended from "Meadow Street" and from Broadway to the land of Trinity Church. By the purchase of this tract he became one of the largest land owners in the City, and while its value is now immense, it cost then but a few hundred pounds. While a resident of the City, he maintained a country place at Flushing, Long Island, and the Mansion built by him remains an interesting relic of the past. He was also the owner of many thousands of acres of land in Kentucky, Pennsylvania, and the northern part of New York State.

The children of Effingham and Mary (Lawrence) Embree were: John Lawrence, Effingham L., Lawrence Effingham, Hannah and Cornelia.

John Lawrence Embree born February 21st, 1783. He married Deborah Lawrence, and had a son George W., born in 1844. His son Frank L., is a resident in New York.

Effingham L. Embree, born October 12th, 1791, married Eliza Hartman, and had two sons, George and Edward. The latter lived in Fairfield, New Jersey, and died in 1905. The former is now living in South Carolina.

Lawrence Effingham Embree, born July 9th, 1794, died November 2nd, 1849. He married Sarah Robinson, daughter of Walter Franklin, July 9th, 1821. They had eight children, all of whom died in infancy except Robert Cornell Embree, born January 22nd, 1825, in the old family mansion at Flushing, and died September 14th, 1902, in the same town.

Mary Ann, born January 24th, 1829. She married Charles Townsend of a famous Long Island Family, and had two daughters, Sarah Franklin wife of Dr. Richard Seaman, and Mary Embree who died at an early age.

Hannah Embree, born February 19th, 1896, married Gilbert Hicks. Robert Cornell Embree married Phebe Seaman Birdsall, daughter of James F. Birdsall, July 8th, 1852, at New York City. She was born July 4th, 1830, and died December 10th, 1904. Their children were Caroline, born June 1st, 1853, died January 30th, 1860; Lawrence Effingham, born May 17th, 1856; James Robert, born May 23rd, 1859, died March 21st, 1892. He was a graduate of the college of Physicians and Surgeons, Columbia University and Charity and New York hospitals, and until about a year before his death was actively engaged in the practice of his profession. The present representative of Effingham Embree, is Lawrence Effingham Embree of the firm of Finch, Embree and Cobb, 31 Nasua Street, New York City.

Cornelia Embree, born July 11th, 1851, is now living at Flushing. She married Francis H. deRaisnes, April 4th, 1883, and has four children. Francis Embree, Robert Embree and Embree de Raisnes and Edith Franklin.

Lawrence Effingham Embree, the present representative of the name went with his parents to Flushing, about the year 1860, and since that time made that place his residence. His father, Robert Cornell Embree, began life as a civil engineer, and helped to build the old croton reservoir on Fifth Avenue, and was also associated with Captain Blunt on the United States Coast Survey. He afterwards studied law in the office of Peter Augustus Jay and Hamilton Fish. After the death of Mr. Jay, and as Mr. Fish had been made Secretary of State, he formed a partnership with Walter Rutherford, who was his fellow clerk, under the firm name of Rutherford and Embree. This continued until the death of Mr. Rutherford. He was counsel for many distinguished men, and as executor settled many estates of great value. His son Lawrence Effingham Embree, obtained his early education at the famous Flushing Institute, and later was in the class of '78 in Columbia College, graduated from the law school in 1879, and was for some years in the office of Moore, Hand and Bonney, of which the learned genealogist, Charles R. Moore was the head. In 1888, he joined his father, their office being at 135 Broadway, where he still continues, the personnel of the firm being

Finck, Embree and Cobb. Mr. Embree is a member of the Association of the Bar of the City of New York, the New York State Bar Association, Queens County Bar Association, the Union Club, New York Yacht Club, St. Nicholas Society, Dwight Alumni Association, and Oakland Golf Club, at Bayside, Long Island. In religion he adheres to the principles of his Quaker ancestors, and in politics he belongs to the Republican party, but has never sought to be what is known as a politician.

William Embree, now residing at Topeka, Kansas, traces his history back to Moses Embree of Little Egg Harbour, New Jersey, probably the father of Samuel Embree, who was born September 16th, 1717. This family removed to Pennsylvania, near Reading. Samuel Embree became a Minister of the Quaker faith, but died aged 44, leaving two sons Moses and James, who settled in Reading. After some years Moses moved to Virginia. James Embree married Phebe Star, and four children were born to them, Samuel, James, Merrick and Phebe.

Phebe, the wife of Moses Embree died, and he married a second wife Rebecca Kirk, and eleven children were born to them. William, Davis, Hannah, Jesse, Daniel, Sabbile, Rebecca, Elisha and Ann. Some of these settled in Philadelphia, some in Westchester, Pa., and others went west. James remained on his father's place, and his children settled in the neighbourhood. Elisha married and removed to Ohio, and there is no further record concerning him. James Embree was the grandfather of William Embree, now of Topeka, Kansas, and Samuel Embree was his father. Samuel Embree removed to Morgan County, Ohio, with his family.

Samuel Embree was born March 7th, 1772, and died November 15th, 1837. John Embree, the father of William was born September 7th, 1803, and died November 15th, 1837. William's mother was Ava Morris, born September, 18th, 1801, died August 4th, 1832. John Embree married again and had by this second marriage, two sons and a daughter.

William Embree removed to Topeka in April, 1878. He has two daughters and one son, John William Embree, No. 3500 Center Avenue, Chicago, Ill., of the firm of Crutchfield and Embree. This family also claims to be from France, and of Huguenot origin, and all are Quakers. While it is certain that all these families were of Huguenot origin, it is difficult to collect the links, and prove the exact relation one to the other.

THE FAMILY IN CANADA.

The writer is unable to prove the exact relation between Colonel Samuel Embree of Revolution fame, but believes he was of the same family as John, Moses and Samuel before mentioned. While Lawrence E. Embree, now of New York, traces his family back to 1686 and in fact to the first Mayor of New York City, Thomas Willett, 1665, those who went to Nova Scotia, cannot definitely trace back further than Col. Samuel Embree, Commander of the Kings Light Horse Guards, who left White Plains, and settled in Amherst, Nova Scotia, in 1775.

Tracing out the line of descent from William Lawrence, who came from England to the United States in 1635 in the ship "Planter" and married Elizabeth Smith, of Smithtown, U. S. A., it would appear that Colonel Samuel Embree was:

(1) A son of John Embree, born in 1697 and died in 1769, who married Elizabeth Lawrence.

This John Embree was born in Flushing and is said to be the son of a French Huguenot who settled in New Rochelle, Westchester county, N. Y., shortly after the revocation of the Edict of Nants by Louis XIV in 1685, subsequently removing to Flushing, Long Island, N. Y.

In the history of Westchester county, N. Y., are to be found the names of Stephen Embree, Samuel Embree, John Embree, Sr., and John Embree, Jr., from Westchester farms and the Manor of Fordham, who were summoned to meet at Westchester and who petitioned for the organization of a new company and who were its first members when organized. The above names were mentioned in the same book in connection with the Revolutionary War. In 1785 the Loyalists received large grants of land at Cobequid (Westchester), and Ramshad (Wallace) Among the grantees were Samuel Embree and Joseph Embree, Jr.

Colonel Samuel Embree was born October 21, 1716, and died at Amherst, Nova Scotia in the year 1800, his remains and those of his wife Sarah Hyatt, born July 14, 1753, and died in 1828, aged 72 years, lying side by side in the Old Burial ground on the Amherst Point road,

almost opposite the spot on which he erected his, the original Embree, home dwelling. His wife's two brothers, Nathaniel Hyatt and Elisha Hyatt also came and located in Amherst, the farm of the former being next to that of his sister Sarah.

Col. Samuel Embree had a Sister Sarah who married an officer named Jeffrey or Jeffries, who came from France with Lafayette. He also had a brother Joseph, born August 4, 1760, who also came to Nova Scotia and settled at Westchester, from whom are descended the present Embree families at Wentworth. When residing in what was then known as America, Colonel Samuel Embree was the owner of valuable estates, all of which he forsook sooner than renounce his loyalty to the British Crown. He subsequently was awarded a yearly pension and a grant of land by King George IV, both of which he enjoyed to the time of his death. In the General election in February 1793, for the Nova Scotia General Assembly at Halifax, which met first on March 20, 1793, and which was dissolved on Oct. 11, 1799, Col. Samuel Embree and William Freeman were the members elected for Cumberland County, and Thomas Lusby for the Township.

ELISHA² EMBREE (Samuel¹) was born Nov. 24, 1771, and died June 30th, 1842, aged 70. His wife was Deborah Purdy of Washadamoak N. B., who was born Feb. 1, 1773, and died March 28, 1841, aged 67. The old homestead on which they settled at East Amherst, then known as Warren, Cumberland County, is where Burton Freeman now lives. Elisha first built a log house on the extreme back portion of the present farm, but finding he was not correctly located on the road between Amherst and Pugwash he built another log house within 100 feet of the present site and in what is now the old orchard. Later he built another log house on the present site, adding a frame dwelling later on. This house was burned in about 1895, supposedly by a tramp.

ROBERT³ EMBREE (Elisha², Samuel¹) was born Dec. 2, 1796 and died Dec. 10, 1863, aged 67. He married Jan. 1, 1823, Sarah Bent, born Sept. 27, 1800, died Feb. 21, 1858, aged 58, daughter of the late Ebenezer Vose Bent, a farmer, born March 3, 1771, at Fort Lawrence where he died in June 1855, aged 84. He married Oct. 23, 1799, Lucy Miner of Horton, N. S. She died aged 73. ROBERT EMBREE and his wife settled on a part of his father's farm at East Amherst, that portion now owned by Edgar Atkinson, the original house now standing, and they owned a mill for getting out ship building material.

JAMES WRIGHT³ EMBREE (Elisha² Samuel¹) was born at Amherst, now known as East Amherst, on Oct. 8th, 1804 and died on June 14th, 1886, age 82 years, his last resting place being in the Baptist burial ground at that place.

His father, Elisha Embree, eldest son of Colonel Samuel Embree, whose original homestead was on the farm now occupied by William W. Embree at West Amherst, secured a grant of land on the South side of the Main road, running Westerly along the Main road from near the junction of the Hastings and Main road, the Baptist church now standing on part of the land. Elisha Embree erected his first home in the then virgin forest some distance from the main road, but very shortly afterwards erected another home for himself, later destroyed by fire, on the site of what is now known as the Thomas Embree home, now occupied by George

Lowther. Elisha Embree secured additional lands running westerly along the main road, his lands finally embracing all those of the late George Embree, now occupied by his widow and son Ernest; Robert Embree's farm — the old George Embree homestead; the grandfather Robert Embree's farm, now owned by Edgar Atkinson; the Thomas Embree farm, now owned by George Lowther and James Wright Embree's farm which passed to his son David Embree, who farmed the the same until the year 1891, then disposing of it to Wilson Beattie. The original home erected by James Wright Embree was destroyed by fire. Lands across the road, owned by Elisha Embree, were those occupied by William B. Embree, now owned in part by David Trenholm and Hibbert Smith. James Wright Embree was married on June 1st, 1836 to Amy, born March 14th, 1803, died June 14th, 1892, aged 62 years, dau. of John and Amy Davis of Horton, N. S.

LILLIE JANE⁵ EMBREE (David⁴, James Wright³ Elisha² Samuel¹) was born February 5th, 1866, at East Amherst. On June 29, 1898, she was married by the late Rev. D. McGregor to Joseph Henry Froggatt, born near Manchester, England, on May 23rd, 1862. He was the eldest son of the late Joseph and Hannah Froggatt and grand-son of Benjamin Froggatt and Thomas Stockwell of Manchester, England.

Crossing the broad Atlantic, Mr. Froggatt became a resident of the town of Amherst, June 29th, 1890, and became organist and choirmaster of Christ Church (Episcopal) having held a similar position in the Old Country for several years. Shortly after his arrival, having done occasional reportorial work on the Manchester, (England) Guardian and other papers, he joined the staff of the Amherst Daily Press, the first daily newspaper published in Amherst, and became the Amherst correspondent to The Halifax Daily Herald and St John Sun, his articles occupying a liberal space in almost every issue. In the year 1894, Mr. Froggatt having severed his connection with the Daily Press, purchased and became owner and manager of the Daily News, published in Music Hall Block, next to the Terrace Hotel, which newspaper was first issued on December 5th, 1893. The facilities for the publishing of the Daily News were greatly improved and additions made to the printing plant, a telegraphic news service was secured and the Daily News soon found a good circulation among the homes in Amherst and surrounding country. A few months later a weekly edition of the News was first issued for circulation in the country districts of Cumberland County. Subsequently the weekly edition was changed to a semi-weekly, thus giving the subscribers in the country two papers a week. Other improvements, among which was the installing of type setting machines and a newspaper press capable of printing and folding an eight page paper, were made, until the News, soon forging to the front, became the leading newspaper in Amherst and Cumberland County. In the year 1896, Mr. Froggatt purchased the plant and good-will of the Maritime Sentinel, the oldest weekly paper published in the county, and amalgamated it with the then semi-weekly edition of the News, under the name of the News-Sentinel. In the year 1902 he purchased the plant and good-will of the Amherst Daily Press and Semi-weekly Press, the paper on which he was first employed, and also amalgamated them with the Daily News and Semi-weekly News-Sentinel. In the year 1908 he purchased the Standard, a weekly paper published first in

Springhill and later in Amherst. After the purchasing of the Maritime Sentinel, the office of publication of the News was removed to the Fillmore building on Victoria Street; opposite Royal Bank of Canada. In the year 1907, to meet the requirements of the increasing business, Mr. Froggatt purchased the site and had erected on it the large four storey brick building on Havelock Street to be the publishing home of the Daily News and News-Sentinel. In the year 1912, owing to ill health, he sold the Daily News and News-Sentinel to a company called the News-Sentinel Limited. From the above it will be noted that to Mr. Froggatt belongs the credit of being associated with the first daily newspaper not only in Amherst but in the County of Cumberland, and starting from small beginnings, by careful and watchful management, the Daily News has now a very large circulation and is a paper of fame and influence in the County. The next year he, with his wife and two sons, spent the summer at his old home in England. The following year he opened up another business in Amherst for job and commercial printing, which, with his son Norman, he is carrying on successfully. In the year 1916 he was appointed a Justice of the Peace.

Soon after the commencement of the great war, and at the age of sixteen years he left High School and went to Acadia College, Wolfville, N. S. where he enlisted in the 219th Batt for service over seas. Owing to his young age he was transferred to the Chief Recruiting Office and for some time was associated with Major (Rev) George B. Cutten in Halifax. During this time he rose to the rank of Sergt. He was afterward transferred to the Railway Troops Depot at Charlottetown, P. E. I., with the rank of Sergt. Major. In February 1918 he succeeded in getting Overseas to England. Early in March he went over to France with the 12th Can. Rly. Troops, and was in the Motor Service, taking supplies to the firing line. While at Cambrai he was taken seriously ill with pneumonia, and after receiving the usual Hospital care was transferred for further hospital treatment in England. He returned to his home in Amherst in Sept 1919. He entered the printing business with his father, taking charge of the mechanical work, and at the present date is still in the business. He is prominent in musical circles, is a church organist and occupies that position at Christ Church (Episcopal), Amherst. On October. 19, 1920, he was married by Rev. Dr. Steele to Miss Lois Estelle Barnes, only daughter of Clarence M. and Mary E. (Snowdon) Barnes of Sackville, N. B.
