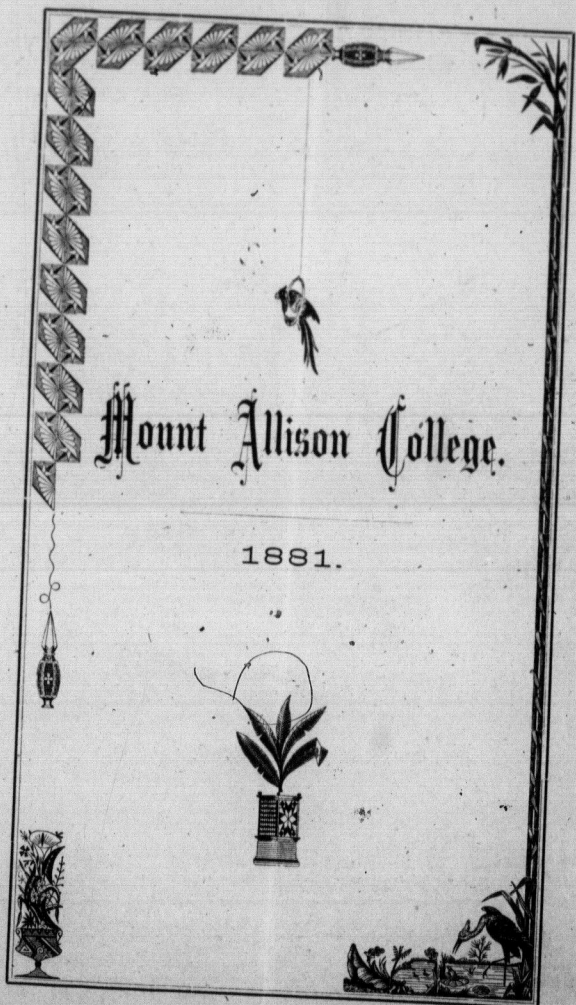

**GENERAL CIRCULAR.**

THE MOUNT ALLISON WESLEYAN COLLEGE was organized in July, 1862, under a Charter obtained from the Legislature of New Brunswick. By virtue of this Charter it possesses full University powers.

The College is conducted on strictly non-sectarian principles. The general denominational control under which it is placed, furnishes a sufficient guarantee that sceptical license will never be allowed within its walls, but does not imply the existence of a purpose or a wish to interfere with the conscientious convictions of any. The fullest recognition, however, is given to the truths and claims of the Christian religion. The Bible is publicly honored as the Word of God, and no pains are spared that the education imparted may be suitably leavened with religious principle.

Students may enter the College either as regular Undergraduates, having passed the Matriculation Examination; or as Specialists who do not look forward to a University Degree.

For Undergraduates two complete Courses of Study are provided, viz :

1. The regular Arts Course for the B. A. Degree.
2. A Special Course for those who prefer to substitute, in whole or in part, Modern Languages for Greek and Latin, and who may desire a greater number of elective studies than the Arts Course permits. The Degree of Bachelor of Philosophy (Ph. B.) will be conferred on Students who shall have completed this Course.

Special Students are admitted to any Class or course of Lectures for which, in the judgment of the Faculty, after due examination, they are deemed prepared; and upon leaving the College, they will be entitled to receive Certificates bearing the College Seal, and specifying the particular branches of study in which they have received instruction and passed satisfactory examinations.

## MATRICULATION.

The Matriculation Examinations are held on the second and third days of the first Term of the Collegiate year. Supplementary Examinations for special cases may be held at other dates.

### DEPARTMENT I.—ENGLISH.

Grammar, Analysis, Outlines of English and Canadian History, and General Geography.

Books prescribed by the Councils of Public Instruction of New Brunswick, Nova Scotia, and P. E. Island.

### DEPARTMENT II.—CLASSICS.

Latin\*—Cæsar, Gallic War, Book VI.; Virgil, *Æneid*, Book VI.; Latin Grammar, *Harkness'* or *Bullion's*. Easy sentences of English to be translated into Latin. Questions in History and Geography arising out of the books prescribed.

Greek†—Xenophon, *Anabasis*, Book III.; Greek Grammar, *Hadley's*.

[Instead of the Classical selections prescribed, satisfactory equivalents from the same or other authors will, for the present year, be accepted.]

### DEPARTMENT III.—MATHEMATICS.

Arithmetic—*Sangster*: Proportion, Interest, Extraction of Square Root, Vulgar and Decimal Fractions.

Algebra—*Hamblin Smith*: Addition, Subtraction, Multiplication and Division of Algebraical Quantities, Simple Equations and Surds.

\*The Latin subjects for 1882 are Cæsar, Gallic War, Book IV.; Virgil, *Æneid*, Book I.

†The Greek subject for 1881 is Xenophon, *Anabasis*, Book III.

MATHEMATICS—*Continued.*

Geometry—First and Second Books of Euclid, or the subjects thereof, and the solving of easy geometrical exercises.

Candidates for the Ph. B. Degree will be allowed to take Natural Philosophy and French or German as an equivalent for Greek and Latin, viz:

## FRENCH.

Students who shall have passed satisfactory examinations on all the ~~above~~ studies in the above course (those marked with an asterisk), will be entitled to receive a special Honorary Certificate in addition to the usual Diploma.

The required Course of Study for the Bachelor's Degree may be completed in three years by such students as can prepare well for nineteen or twenty hours recitation weekly; but all who can afford to do so are earnestly advised to devote the full period of four years to their undergraduate Course of Study.

### Examinations, Degrees, etc.

At the close of the first term, all the Classes will be examined by the Faculty, both orally and by means of written papers. The Annual and Degree Examinations at the close of the second term are conducted in the same manner by the Faculty and duly appointed Examiners.

The Degree of Master of Arts may be taken in course by any Bachelor of Arts of three years standing who shall have prepared and forwarded a satisfactory thesis to the President at least three weeks before the Annual Convocation, and who shall satisfy the College Board that his course, subsequent to graduation, entitles him to this distinction.

### Prizes.

The Matriculation Prize of \$40, offered by J. L. Black, Esq., M. P. P., was won by Mr. Charles N. Jeffery, of Avondale. The prize of \$25, given by William Elder, Esq., M. P. P., was assigned for competition to the class in Mathematics, and won by Mr. H. A. McKeown, of Saint John.

The annual prize for proficiency in English Composition of the value of \$25, given by a Halifax gentleman, was this year taken by Mr. W. B. Jonah, of Elgin. Mr. J. C. Lockwood, of Canning, received honorable mention in this competition.

The Chambers' Encyclopedia prize was assigned for competition to the class in English Language and Literature, and taken by Mr. J. R. Ruggles, of Annapolis.

The Annapolis District prize of \$25, was taken by Mr. C. N. Jeffery, of Avondale, for proficiency in Chemistry.

The Halifax District prize of \$25, was taken by Mr. W. M. Tweedie, in Greek.

The Cumberland District prize of \$30, was taken by Mr. H. V. Thomson, of Oxford, N. S., in Mathematics.

At the first B. A. Examination of the University of Halifax in July last, the first prize, \$75, was taken by Mr. W. M. Tweedie; the second, \$50, was taken by Mr. H. A. McKeown; the fourth prize, \$35, was taken by Mr. J. C. Webster. In the second B. A. Examination, a prize of \$30 was taken by Mr. S. D. Scott.

Two prizes of \$25 each, given by the Halifax and Guysboro' Districts, will be competed for at the Matriculation Examination on the 26th and 27th of August next, open to all candidates. A further prize of \$25, given by the Yarmouth District, will be awarded to the best Matriculant from that District, including the Counties of Yarmouth and Shelburne. It is expected that most of the Districts, both in the Nova Scotia and the New Brunswick and P. E. I. Conferences, will provide Scholarships to be competed for during the year 1881-2, and at the Matriculation Examination of 1882. The Halifax Alumnus prize of \$25 will be awarded for the best six original Essays on assigned subjects; competition open to all Undergraduates.

They are required to pass a satisfactory examination in all the subjects of the three years' course of study, and to prepare for delivery a satisfactory thesis on some Biblical or Theological subject, which shall be forwarded to the Dean at least three weeks before the annual Convocation.

Persons other than graduates in Arts may pass examinations in this course, and, if successful, receive Certificates to that effect.

Special facilities are afforded to graduates in Arts who wish to reside in the College while pursuing this course.

## CANDIDATES FOR THE MINISTRY.

Candidates for the Ministry of the Methodist Church of Canada, who have been appointed to attend College, will pursue the course of study prescribed on page 192 of the Discipline of the Church.

The Educational Society of the Methodist Church makes provision for free tuition, and aids in meeting the general expenses of young men appointed by the Conference to attend college.

### PRELIMINARY COURSE OF STUDY.

This Course of Study is designed to meet the wants of young men preparing to offer themselves to be received on trial for the Ministry. It embraces all the subjects prescribed for the preliminary and first year's examinations of the Methodist Conference, and may extend over one, two, or three years, according to the previous attainments and circumstances of the student.

The Theological parts of this course may be pursued in connection with Matriculation in Arts.

The English and Classical parts of this course are prepared in the Academy and College.

Students presenting themselves for admission to this course should bring with them letters of introduction from the superintendent Ministers of the circuits in which they reside. If they expect to offer themselves for the Ministry at the close of the year, they must be recommended from the quarterly meetings of their own circuits, and not from the Sackville quarterly meeting. Students bringing with them certificates of such recommendation will be exempted from fees for theological tuition. Licenses as exhorters or local preachers should also in all cases issue from the Superintendent and quarterly meeting of the circuit in which the student resides, and where his church membership and standing should be continued.

After examination at the close of the college year, all students in the preliminary course will return home in time to be presented at their own district meetings in case they wish to be received on trial by Conference.

### PRIZES.

In Elocution, a prize of twenty-five dollars was offered for competition to the Conference students of last year, by John McDonald, Esq., of Toronto. This prize was gained by Mr. A. D. McCully, B. A.

**THEOLOGICAL LIBRARY.**

Renewed efforts have been made during the past year to increase the value of this important aid to the Professors and Students of this department. Very generous assistance has been rendered by contributions of money or of books from Alexander Gibson, Esq., Marysville, S. M. Brookfield, Esq., Halifax, and Revs. D. Chapman and W. H. Heartz. It is earnestly desired that further contributions be made to the Library Fund, so that the latest and best results of Theological Science may be placed within the reach of our Students.

**SOCIETIES.**

Two Societies have recently been established, having a relation to this department. The one is designed for the benefit of the Theological Students in the college; and the other to serve as a connecting link between them and the Ministers labouring in the three Conferences of the Maritime Provinces, as well as to promote among the latter a spirit of Theological and Ministerial culture.

Among the students it is proposed, by means of Essays, Exegetical Papers, and oral discussions, to stimulate enquiry as to the best methods of Ministerial efficiency, and so to assist in preparing each other for the great work of preaching the Gospel, and feeding the flock of Christ.

The Ministers' Theological Union will meet at the close of each Collegiate year, and, in addition to the consideration of topics of interest belonging to their work, will have an annual Sermon preached, and a Theological Lecture delivered. The Rev. A. D. Morton, M. A., will preach the annual Sermon, and the Rev. Howard Sprague, M. A., will deliver the annual Lecture in 1882.

**GENERAL GOVERNMENTAL REGULATIONS, &c.**

Students, both regular and special, are expected to conduct themselves with propriety, and to observe all the regulations of the Faculty as announced from time to time. Students whose conduct or progress in study shall continue, after suitable admonition, to be unsatisfactory, will not be allowed to remain in the Institution.

Regular and punctual attendance at their classes shall be imperative on all Students. Professors will mark the presence or absence of Students immediately before commencing the work of the class, and will note as absent those who enter thereafter, unless satisfactory reasons for tardiness be assigned.

No Student shall be absent from the College after ten o'clock at night, without special permission of the President.

All Students are expected to attend Divine Service on Sunday, and to be punctual in attendance at daily prayers in the College Chapel.

No Student shall resort to any tavern or place where intoxicating liquors are sold, without special permission of the President; and no Student who is known to use intoxicating drinks will be allowed to retain his connection with the College.

The use of tobacco on the College premises is not permitted.

Undergraduates are expected to provide themselves with College caps and gowns, and to wear them at classes and lectures, at church, and at all public Collegiate exercises and anniversaries.

## LIBRARY, APPARATUS, MUSEUM, &amp;c.

In the course of the last two or three years valuable additions have been made to the Library and to the Chemical and Physical Apparatus of the Science department. During that time the Alumni Society has made an annual grant for the purchase of books. This grant has been carefully expended by a Committee composed of College Professors, in the purchase of standard books, for the most part bearing on the various subjects taught in the College.

Its special objects are the acquisition of readiness and power in debate, and the cultivation of a pure literary taste. Not a few of the Alumni of the Institution who are to-day prominent in the professional and legislative circles of the several Provinces of the Dominion, have been enrolled in its membership. It has a well furnished room in the College in which its meetings are held weekly.
