The Secretary of State for External Affairs today announced the following transfers within the Canadian diplomatic service:

Mr. D'Arcy McGreer, Canadian Minister to Denmark, will return to Ottawa later in the year as Chief of Protocol succeeding Mr. H. F. Feaver. Mr. Feaver replaces Mr. McGreer as Canadian Minister in Copenhagen and is expected to take up his post in November.

Mr. Morley Scott will be the High Commissioner to Pakistan, succeeding Mr. K. P. Kirkwood who returned to Canada in June of this year. Mr. Kirkwood has been appointed an Alternate Representative on the Canadian Delegation to the forthcoming Ninth Session of the United Nations General Assembly. Mr. Scott was, until recently, Minister-Counsellor at the Canadian Embassy in Tokyo. He is expected to assume his new duties in November.

Mr. Douglas Cole, at present Canadian Consul General in Chicago, is to become Canadian Ambassador to Mexico, succeeding Mr. Jules Léger. Mr. Léger's appointment as Under-Secretary of State for External Affairs was announced on July 1. Mr. Cole will take up his new post in November.

EDGAR D'ARCY MCGREER

Mr. McGreer was born in Montreal, Quebec, on March 8, 1898. He was educated at McGill University and the University of Edinburgh. He took post-graduate studies and received diplomas from the Institut des Hautes Etudes Internationales, University of Paris, and the Academy of International Law, The Hague. He served in the Canadian Army from 1916 to 1919. Mr. McGreer joined the Department of External Affairs as a Second Secretary in 1927, and has served in Geneva, Paris, Washington, Tokyo and Brussels. In January 1947, he was appointed Canadian High Commissioner to South Africa and in 1950, he became Chargé d'Affaires ad interim in Warsaw, with the personal rank of Minister. Mr. McGreer was appointed Canadian Minister to Denmark in 1952. He has attended a number of international conferences. Mr. McGreer is married.

S. MORLEY SCOTT

Mr. Scott was born in Saint John, New Brunswick, on September 6, 1896, and was educated at the Universities of British Columbia, Toronto and Oxford. He received a Ph.D. from the University of Michigan in 1931. He served in the Canadian Army from 1916 to 1919. Mr. Scott was an Assistant Professor of History at the University of Michigan from 1923 to 1942. He joined the Department of External Affairs as Special Assistant to the Under-Secretary in March 1942 and has served in London, Oldenburg, Berlin, New Delhi and Tokyo. From August 1949 to June 1951, Mr. Scott was Civilian Member on the Directing Staff at the National Defence College, Kingston. He has attended a number of international conferences. Mr. Scott is a widower.

DOUGLAS S. COLE

Mr. Cole was born in Ottawa, Ontario, on July 28, 1893, and graduated from McGill University. He served in the Canadian Army from 1915 to 1921, when he joined the Department of Trade and Commerce. As a member of the Trade Commissioner Service Mr. Cole served in the United Kingdom, New York and Mexico. He was appointed Canadian Consul General in Chicago in August 1950. Mr. Cole is the author of "Mexico - An Economic Review" and has frequently contributed articles to magazines. Mr. Cole is married and has one child.

H. F. FEAVER

Mr. Feaver was born at Glace Bay, N.S. on June 18, 1907. He was educated at King's College, Dalhousie University and the Law School of Harvard University. He served as Law Clerk in Nova Scotia from 1927 to 1930. Mr. Feaver joined the Department of External Affairs as a Third Secretary in 1930, and has served in Washington, Tokyo, London and The Hague. He has attended a number of international conferences. Mr. Feaver is married and has four children.
