

Report of Session.



HE session in presenting their report desire to express . their thankfulness to the Great Head of . the church for the prosperity which He has been pleased to bestow upon us this year. The Good Shepherd has taken home to himself from our midst three of our faithful elders, some of our oldest and most worthy members who were for a long time identified with us, some in the bloom of youth, and also tender lambs of the flock.

The Session extend their heartfelt sympathy to all who are bereaved and afflicted. "Now no chas-

tening for the present seemeth to be joyous, but grevious: nevertheless, afterward it yielded the peaceable fruit of righteousness unto them which are exercised thereby."

To our number were added this year 79. By certificate 41, by profession of faith 38. There were 8 removals by death and 25 by certificate, making our net gain 46 and our membership 679.

The sacrament of the Lord's Supper was observed four times as usual and baptism was administered to 32 infants and 3 adults.

We would here express our thankfulness that all the means of grace were so well sustained, also our gratitude to see the large attendance on sacramental occasions. For the Year Ending December 31st, 1893.

The Board of Managers of Knox Church in submitting their annual report for 1893 are pleased in having to state that the financial requirements of the congregation have been well sustained throughout the year.

Your Board at a meeting very early in the year, while deliberating on the annual mortgage interest charge and the possibility of its being reduced, had suggested the practicability of securing by subscription an amount that would pay off the principal and release the church of the encumbrance. The project was agreed to by resolution of the Board on condition of being assured of the active aid, support and co-operation of the Session, which having been secured most heartily a canvass was had that resulted in the bulk of the sum needed being subscribed. The money paid in on this subscription during the year as shown by our financial statement amounts to \$2,500 and the balance in donations and subscriptions we expect to receive at an early day this year. It is possible a very few who subscribed may be unable to meet their subscriptions, which will leave volunteers the opportunity of having their names enrolled among the honored list of subscribers. As showing the strength of the desire to have our church debt paid the united subscriptions from Session and Board amounted to one-third of the total sum required. The success attending the efforts of your officebearers could only be secured by your hearty co-operation with them and the duty is pleasant and the privilege great to be in a position to record and report such substantial progress. The mortgage debt, which stood in the last report at \$6,800, has been reduced during the year by \$3,000, leaving the unpaid balance of mortgage at the end of the year \$3,800. Once we had this debt off, your Board could undertake many repairs to the church property which are becoming more needed the longer delayed. From the ordinary receipts we met the ordinary expenditure, paid off \$500 of the mortgage, and increased

the balance in bank at the end of the year over that of last year by \$54.43. To make the arrears of pew rent shown in our statement worth what they represent we have written off arrears to the amount of \$211, much of which had been carried forward for a number of years, which leaves the arrears at the end of the year \$794.75, which we think much too large, though reduced since the new year by \$310, leaving the net arrears this evening \$484.75. Three special collections, one to missionary per Dr. Paton, one to the Hospital, and one to the Sabbath School, reduces our ordinary Sabbath collections to fifty. For the Hospital and the School the entire collection for the day was handed over to the object announced without any deduction.

The Board were approached with reference to the purchase of the lot north of the church, and while seeing it would add to the amenity of our property to acquire less or more of this land, we felt we had no money for this object while the church is still in debt. The roof of the church will soon need to be reshingled, slated or covered with iron, the underpinning and flooring of the basement requires renewing, and the spire repainting.

The members of the Board retiring this year are, Messrs. James Bennoch, John McMillan and Ralph Donaldson.

In submitting the annual report of the Auxiliary, it is most gratifying to notice the continued prosperity of the society during the past year. The membership has increased, three new members having been added to our numbers. We have eight members of General Society. The average attendance of members at our meetings has also increased. Instead of, as usual, sending clothing to the Indians of the Northwest, the Mission Band with the help of a few members of the Auxiliary, furnished a box, valued at \$36.82, with dolls and various useful and fancy articles, for the schools of India. Weekly sewing meetings were held during July and August for preparing the contents of this box, and to the extra efforts put forth in this line may be ascribed the decrease in our contributions.

The amount contributed during the year was \$98.19, of which \$8.20 was a special offering for supplies for the India box. A balance of \$88.03 was paid to the Pres. Treas.

Report of the D. p. S. C. E.

During the past year ten joined the society as active and three as associate members. A number of names have been placed on the absent list and there are now on the roll 4 honorary, 52 active, and 20 associate members.

not as easily obtained as it is here. The Visiting and Flower Committee have cheered many a sick bed by their visits and the flowers sent by them to the hospital and homes have been greatly appreciated.

The Relief Committee have assisted 15 families in various ways with clothing, wood, milk tickets, meat, &c. In cases of sickness medicines and dainties were provided and in two cases money was given. Of these families only five belonged to our own church, but in all cases the aid given was thankfully received. 179 articles of clothing were distributed during the year.

Our receipts for the year from the monthly free-will offerings on consecration evenings were \$37.06, which with a balance of 8 cents from 1892 makes a total of \$37.14. The expenses amounted to \$36.87 so that we have a balance on hand of 27 cents.

The proceeds of the Thanksgiving sociable for the Relief Fund were \$13.36. The expenses in connection with the fund were \$4.86 for relief purposes and \$5 for the Christmas baskets, so that there is still a balance of \$3.50 in the fund.

\$21.50 was collected at the six missionary meetings held during the year and \$37.10 from the monthly contributions of 17 members, which with a balance of \$1.81 from last year makes a total of \$60.41. Of this \$50.40 was appropriated to the maintenance of the two Bible women in India whom we supported last year, \$5 was given to the support of home missions in Algoma, and \$5 went to the French Evangelization, fund. For all purposes \$110.91 was collected during the year.

We have on the roll thirty-six members, with a good average attendance Our members have not increased much, but the interest has been unabated, until now each is working with great zeal and earnestness. Two members are now appointed to visit the Rescue Home each Saturday and sing and read to the inmates, and we are also to appoint two more to visit the hospital.

We have seven committees at work—Lookout, Social, Mission, Prayer Meeting, Music, Visiting and Flower and Scrap Album.

During the year two of our members joined the church.

We try to keep up a lively interest in missions, learn about the needs and customs of each country. When the mission band was sending the box to India, they kindly allowed us to put in a few things. The girls dressed twelve dolls and made a number of fancy articles, and also bought toys to the amount of \$2.75. We saw in the Record an appeal from Trinidad for Christmas cards. We collected about 350 cards and sent them at Christmas, also dressed dolls, made scrap books, bought toys, oranges and apples to the amount of \$2, and distributed among poor children, in the blessed assurance in blessing we would be blessed. At the end of year we have balance of \$4.10.
