4. Other members of the National and Local Councils or members of the Societies affiliated to these Councils will occupy the remainder of the body of the Hall.

5. It will be recollected that all members of Council (that is, members of the affiliated Societies of any Local Council or National Society) can take part in the discussions, but that only Delegates can vote.

6. Each Session of the Council will commence promptly at the hour appointed. Delegates are earnestly requested to be in their places punctually.

7. It is proposed that ten minutes be allowed for the mover of each resolution; five minutes for the seconder, and three minutes for all other speakers, except for the mover of an amendment, to whom it is proposed to allot five minutes.

8. A time-keeper will be appointed to strike a bell when the allotted time has elapsed, and no speaker can continue after this except by the unanimous request of the Council.

9. All who intend to speak on any subject will be requested to send up their names to the Chair at the beginning of each new discussion; and it is earnestly urged that each speaker should come to the platform, as by this means only, can the members of Council have an equal chance of hearing what is said.

(c) Apart from the value of education in Domestic and Technical Science in our Public Schools for all children, should not its importance as bearing on the problem of Domestic Service, both from the mistress's and from the servant's point of view, be considered?

(d) Does the Higher or University Education of Women injure or benefit home life?

The discussion will be opened by Mrs. Hoodless.

Each Local Council is earnestly requested to study this question in advance, and suggest any aspects of it which they desire considered, and to send up delegates prepared to take part in the discussion.

The discussion will be opened by a resolution on the lines of the above inviting and pressing careful study of the subjects referred to before any actual action is taken.

Delegates are very heartily invited to speak and to represent the views of their Councils or Societies, but papers are not required.—As above stated the Council will not be invited to take action or to express definite opinions on the important subjects thus brought before it. But it is hoped that the result of this Session will be found in a determination on the part of its members throughout the country to realise their responsibility, and study these questions systematically.

IV. RELIEF OF THE POOR AND UNEMPLOYED.

VII.—INCREASE OF CRIME AND NECESSITY FOR MORAL INSTRUCTION OF CHILDREN.

VIII—BUYING OF CHINESE WOMEN AS SLAVES.

“Whereas the British law forbids the buying and selling of human beings and the holding of the same in bondage after they land in Great Britain or any of her colonies, and whereas there is good reason to believe that young girls are sometimes purchased in China and imported into British Columbia and are sold as slaves in this Province, even to the buying and selling of the same by Chinamen. Therefore, be it resolved, that the National Council of Women of Canada do petition the Dominion Government to order an impartial investigation, and we would humbly suggest that copies of the law pertaining to slavery be printed and kept posted in conspicuous places, such as Custom and Court Houses, Post Offices and Police Stations throughout the Province, and such efforts be made as may seem advisable to put a stop to the iniquitous traffic. And further, that the Chinese be compelled to comply with our laws in regard to Coroners’ inquests over sudden deaths. And further, that wherever possible, interpreters who are men of the Anglo-Saxon race and of unimpeachable reputation be employed in Courts of law.”
