





BY-LAWS

OF THE

HURON

DISTRICT MUNICIPAL COUNCIL.

Passed February, 1847.

CHAPTER I.

By-Law to Report By-Law Chapter II. passed in May, 1846.

Whereas, by By-Law chapter II. passed in May, 1846, the sum of £20 was provided for the erection of a Bridge in the Stream between lots 5 and 6 in the 4th concession of Stanley; and whereas the building of the said Bridge has been otherwise provided for:

Be it enacted, by the Warden and Municipal Council of the District of Huron, in pursuance of the Act 4th and 5th Victoria, chap. X., and the Act 9th Victoria, chapter XL., and be it enacted by the authority of the same, that the said By-Law chapter II. passed in May, 1846, be, and is hereby declared, repealed.

2d. And be it further enacted by the authority of the same, that the sum of £20 granted by the said chapter II. for erecting a Bridge over the south branch of the

river Bayfield, he applied towards the improvement of the Road allowance between the 2d and 3d concessions of Stanley.

Whereas it is necessary and expedient for the accommodation of the Public that there should be several Surveyors of Highways for this District:

Be it enacted, by the Warden and Municipal Council for the District of Huron, in pursuance of the Act 4th and 5th Victoria, chapter 10, and the Act 9th Victoria, chapter 40, and be it enacted by the authority of the same, That Joseph Kirk, of the village of Stratford, be and is hereby appointed a Surveyor of Highways for the District of Huron, with the powers vested in Surveyors of Highways by the Statute in such case made and provided.

Be it enacted, by the Warden and Municipal Council of the District of Huron, in pursuance of the powers vested in them by the Act 4th and 5th Victoria, chapter 10, and the Act 9th Victoria, chapter 40, and it is hereby enacted by the authority of the same, That the sum of Twelve Pounds Ten Shillings currency be paid to the Warden, over and above his allowance as Councillor, as a remuneration for his services for the year 1847.

2d. And be it further enacted, by the authority aforesaid, That the Treasurer be, and he is hereby, empowered to pay the above sum to the Warden, upon his receipt, out of the rates and assessments for the year 1847.

Be it enacted, by the Warden and Municipal Council for the District of Huron, in pursuance of the powers vested in them by the Act 4th and 5th Victoria, chapter 10, and the Act 9th Victoria, chapter 40, and be it enacted by the authority aforesaid, That the Treasurer of the District be authorised, and he is hereby authorised, to raise, by Debenture or otherwise, a sum or sums of Money, not to exceed One Thousand Pounds currency, at a rate of Interest not exceeding Six per cent. per annum.

Whereas, a petition having been presented to the Municipal Council, praying for a New Road in the Township of Ellice, in the said District, between lots 22 and 23 in the said Township, which was granted; and whereas the said New Road passes through the lands of Michael Shaup:

Be it enacted, by the Warden and Municipal Council of the District of Huron, in pursuance of the powers vested in them by the Act 4th and 5th Victoria, chapter 10, and the Act 9th Victoria, chapter 40, and it is hereby enacted by the authority of the same, That the sum of Twenty-five Pounds currency be allowed to the said Michael Shaup, in compensation for five acres of Land taken up by the said new road.

2d. And be it further enacted, by the authority aforesaid, that the Warden do sign, and he is hereby authorised to sign, a Debenture on the Treasurer of the District for the above amount.

Be it enacted, by the Warden and Municipal Council of the District of Huron, in pursuance of the Act 4th and 5th Victoria, chapter 10, and the Act 9th Victoria, chapter 40, and it is hereby enacted by the authority of the same, That the sum of Fifty Pounds currency be granted for Repairing the Road through Tuckersmith, leading past Mr VanEgmond's Mills, into the Township of Stanley, on the Lake Shore.

2d. And be it further enacted, by the authority aforesaid, That when the work is duly reported as finished, that the Warden signs, and he is hereby authorised to sign, a Debenture on the Treasurer of

the District for the said amount.

Whereas it appears evident, from an Act of the Provincial Parliament passed in the 9th year of her Majesty's reign, chapter 18, that the Taxes levied on the inhabitants of this District, in 1843, were illegal; and whereas the said recited Act confirmed any com-

promise entered into between the Huron District Council and parties in arrear of Taxes; and whereas, e Road by a By-Law passed in February 1846, the Taxes mith, to were declared to be, for the said year 1843, one-fifth of a penny per acre, and one-eighth of a penny per acre, in lieu of Statute Labour; and whereas, by Byl before Law No. 1, passed in the said February Session, it he Road was ordered that the Treasurer should refund fourersmith, fifths of the amount of the Taxes paid by individuals in 1843, to the parties that paid the same; and whereas Council the great distance at which many of these parties Act 4th reside from Goderich renders the said By-Law inopera-

> Be it therefore enacted, by the Warden and Municipal Council for the District of Huron, in pursuance of the Act 4th and 5th Victoria, chapter 10, and the Act 9th Victoria, chapter 40, and it is hereby enacted by the authority of the same, That the Clerk of the Peace, in filling up the Collectors' rolls, shall deduct fourfifths of the amount paid by individuals in 1843 from the taxes of the present year, and place the balance opposite the names of such individuals.

> 2d. And be it further enacted, by the authority of the same, that the Collectors of the several Townships shall be authorised to ask and require the said balance, and no more.

> 3d. Be it further enacted, by the authority of the same, that the Clerk of the Peace be allowed one per cent. on the amount paid in 1843, to be paid out of the District funds for extra services.

certificate produced to the Warden that the Settlers have complied with the above provision, then the Warden shall, and he is hereby authorised to sign an order on the Treasurer, for the said sum of Thirty Pounds currency.



property in the District.

And be it further enacted, by the authority afore-said, That the sum of Two Hundred Pounds be raised for defraying the expences of the Administration of Justice, by a Tax of one-twentieth of a penny per acre on all lands liable to be taxed, and one-twentieth of a penny per pound on all other personal and rateable property in the District.

4th. And be it further enacted, by the authority aforesaid, That the sum of Two Thousand Pounds currency be raised for the payment of District Officers' Salaries, and the repairs of Roads and Bridges, by a
