PROCEEDINGS

OF THE

HOUSE OF ASSEMBLY,

Of the Province of NOVA - SCOTIA.

Thursday, 5th March, 1789.

ON this Day, being the first Day of the Session, twenty-three Members being met (in obedience to His Excellency the Lieutenant Governor's Proclamation) in their House.

House met.

A Message was sent to the Secretary of the Province to inform him a Quorum of the House were assembled.

George Wm. Sherlock, Esqr; returned duly elected Member for the Town of Liverpool, was sworn in presence of the Honorable the Master of the Rolls, and the Clerk, and took his Seat.

Member for Liverpool takes his Seat.

A Message was delivered from his Excellency the Lieutenant Governor by the Secretary of the Province, acquainting the House, that having appointed their late Speaker, S. S. Blowers, Esq; a Member of His Majesty's Council, it was His Excellency's Pleasure, that they should proceed to the Choice of a new Speaker, and present him immediately for his Approbation.

Message from His Excellency desiring a Speaker to be chosen.

Captain Howe named Richard John Uniacke, Esq; and Mr. Putnam proposed Major Barclay; the House proceeded to their Choice, when Mr. Uniacke was chosen, conducted to, and placed in the Chair according to established Custom.

Speaker chose.

A Message was received from His Excellency the Lieutenant Governor, commanding the Attendance of the House in the Council Chamber.

His Excellency requires the Attendance of the House.

Mr. Speaker elect, with the other Members present went up to attend his Excellency, when he spoke to the following Effect:

The Speaker elect and House attend.

May it please your Excellency,

“ The House of Assembly, in Obedience to your Commands, and according to ancient Usage, have proceeded to elect a Speaker, and I have the Honor to acquaint your Excellency that their Choice hath fallen upon me.”

His Excellency approve of the Speaker elected.

Then the Secretary of the Province by his Excellency's Command declared his Approbation of their Choice.

Then Mr. Speaker said :

Mr. Speaker's Speech to His Excellency.

“ Your Excellency having been pleased to approve the Choice of the House of Assembly, confers on me the highest Honor, and fills me with Sentiments of Gratitude, which I feel myself at a loss for Words to express.

“ The high and important Office, which I am now about to discharge, fills me with great Apprehension, lest I may not at this early Period of Life, have acquired that accurate Knowledge of Parliamentary Proceedings, as well as that quickness of Discernment, necessary to form a Speaker of the House of Assembly ; but when I consider, the very great Favor and Indulgence, which I have on all Occasions experienced from your Excellency, I am led to hope, that the Errors which I may commit, will meet on your part, a favourable Construction and gracious Pardon.

“ I cannot begin the discharge of my Duty, without assuring your Excellency, that it shall be my constant Endeavour to prove myself on all Occasions, a dutiful and faithful Subject to our most Gracious King, as well as a zealous Supporter of the British Government in this Province, and I flatter myself, with the pleasing Hope and Expectation, that the same Unanimity and Loyalty, which has heretofore on all Occasions distinguished the Representatives of the People of this Province, will continue to appear in all their future Deliberations.

“ I most humbly intreat your Excellency to pardon my Boldness in thus publicly addressing you, although I may be deficient in Words to express my Feelings on this Occasion, I trust, and hope, I shall never want a grateful Heart, to remember and acknowledge your great Favour and Kindness.

“ It is with the greatest Pleasure, and fullest Confidence in your Excellency's Government, that I proceed in the discharge of my Duty, by humbly demanding in the Name of the House of Assembly, a Continuance of their usual and accustomed Privileges, that they have Freedom of Speech in their Debates, with power of punishing their own Members, that they may be unmolested in their Persons, and when the public Good shall require it, I may by Direction of the House have free Access to your Excellency's Person.”

His Excellency's Answer.

To which the Secretary by His Excellency's further Command, said, His Excellency most willingly granted what was desired.

After which His Excellency was pleased to open the Session with the following SPEECH:

GENTLEMEN of the Council and House of Assembly.

I HAVE called you together, at the time I thought most convenient for you, to consider the present State of the Affairs of the Province; and the best Measures to be pursued for the Advantage of it.

His Excellency's Speech to the House.

These Considerations will comprehend your Engagements to discharge the Debt to Individuals: consequently the State and Ability of the Treasury to discharge that Debt; and the sufficiency of the Revenue, arising from the different Duties, now by Law imposed for that purpose, together with the means of supplying any Deficiency; if the Revenue Laws have fail'd in the Produce expected from them.

These several Matters, Gentlemen, with others that may relate to them, will require your most mature Deliberations. And I trust, that the Result of them will be beneficial and happy. The more they shall agree with the Constitution, and Commercial System of Great Britain, the more shall we be united with the Parent State; and thereby, derive every Advantage, that may follow the most intimate Connection.

The proper Officers will lay before you, all Papers necessary for your Information. And I recommend a speedy Dispatch of the Public Business to you, that a Recess may the sooner leave you at Liberty, to return to your Private Affairs.

The House being returned,

The Speaker reported, that they had attended upon his Excellency; and that he had been pleased to make the Speech before mentioned; a Copy of which being read, it was thereupon

Ordered, That Major Barclay, Captain Howe, and Mr. Day be a Committee to prepare an Address in Answer to His Excellency's Speech.

Committee appointed to prepare an Address.

Ordered, That Mr. James, Mr. Schwartz, Mr. Digby, Mr. Day and Mr. M' Monagle be a Committee, to join a Committee of His Majesty's Council, for the purpose of Examining the public Accounts and reporting thereon. And that the Council be acquainted with the same.

Committee appointed to examine public Accounts.

The House adjourned to Eleven o'Clock To-Morrow.

Friday, 6th March, 1780.

The Committee appointed to prepare an Address in Answer to His Excellency's Speech reported the following Draft, which being twice read, was unanimously agreed to and ordered to be engrossed.

“ son of the Year, and for your polite and judicious Speech on the

GENTLEMEN,

I THANK you for your loyal and affectionate Address, and am happy to find that your Sentiments of the Benefits to be derived to the Province by an intimate Connection with the Mother Country, and its Government, are formed on true Principles. I shall be ready to concur with you in every Measure of public Utility, and to assist your Deliberations to the utmost of my Power."

And thereupon moved, That an humble and respectful Address be presented to His Excellency the Lieutenant Governor, that he will be pleased to remove from his Presence those evil and pernicious Counsellors until His Majesty's Pleasure shall be known, which being seconded.

- A Bill, entitled, *An Act in further Addition to an Act made in the 32^d Year of the Reign of King George the Second, entitled, An Act for preventing Trespasses.*
- A Bill, entitled, *An Act for applying certain Monies therein mentioned for the Services of the Year 1789, and for appropriating the Supplies granted in this Session of General Assembly, and for funding the Province Debt.*
