WOMAN SUCCUMBS AT EDMUNDSTON

Death of Mrs. Martha Sullivan, Once St. Stephen Resident, Mourned.

EDMUNDSTON, N. B. — Mrs. Martha Sullivan, who has been associated with her mother and her sister in conducting the Madawaska Inn here for the last five years, died at the inn Sunday after an illness of some months. Mrs. Sullivan had a host of friends throughout the province and elsewhere and her passing will be heard of with keen regret.

She was a daughter of the late Thaddeus Hebert and Mrs. Hebert, Edmundston. Her husband, Ambrose Sullivan, who died 12 years ago, was for many years railway mail clerk and when he was on the Edmundston-St. Stephen route, for two years their home was in St. Stephen. Mrs. Sullivan had unusual musical gifts and was in much demand as a singer in her early years. By her kindly disposition and character she had won the regard and esteem of all with whom she came in contact.

She is survived by one son, Jerome at home, and one daughter, Miss Monica, who had been studying in Montreal but had remained in Edmundston since the summer holidays to be with her mother in her illness. Also surviving are her mother and two sisters, Miss Agnes Hebert, Edmundston, and Mrs. J. A. Kelly, Douglas Avenue, Saint John.

The funeral took place Tuesday morning at nine o'clock in the Catholic church. The requiem high mass was sung by Rev. A. Violette. Requiem masses were also said at the latter altars by Rev. Father Louis Cyr and Rev. Father Hilaire Daigle.



ARCHIBALD FRASER

The distinguished career of Archibald Fraser came to a sudden close on Monday, when he dropped dead while hunting at his Lodge at Nictau. He and his wife were spending the holiday at the Lodge, and Mr. Fraser seemed in his usual good health.

Through his many business activities, he will be mourned by those associated with him in friendship and industry, but nowhere more sincerely than in the town of Edmundston where he has lived, at different times, for the last fifteen years.

The flag is flying at half mast over the office of Fraser Companies Limited, and as mark of respect to the dead President, the offices and mills were closed on Wednesday, when his funeral was held in St. Paul's United Church at Fredericton, N. B., and interment was made in the family lot in the Rural Cemetery. Many of the executives and employees of Fraser Companies, limited, and personal friends, attended the funeral.

Mr. Fraser was born in Aberdeen, Scotland, on April 22nd, 1869. His parents came to New Brunswick and settled in the Scotch Colony at Kingsville, when he was quite young. Later, his father, the late Donald Fraser, started a lumber business at River de Choue, and in 1911 a partnership was formed under the name of Donald Fraser & Sons.

The present Fraser Companies, Limited, was organized by Archibald Fraser, in 1915.

Mr. Fraser was twice married. His first wife was Agnes Dunbar of Woodstock, N. B., who died in 1911. The children of this marriage are Mrs. Ann Kennedy, and Donald and Archibald Fraser, all of Edmundston. In June, 1930, Mr. Fraser married Miss Evelyn Whyte, of Edinburgh, Scotland. 
WOODSTOCK FIRE CHIEF APPOINTED


