Judges' Salaries.

The Telegraph, after referring to a statement that eighteen new judges are to be appointed in the Dominion, says:—

This provision for the better administration of justice, will, it is to be hoped, be appreciated by a grateful people.

We fall to understand, however, why Quebec judges should receive higher pay than the judges of New Brunswick and Nova Scotia.

This question of "pay" may yet lead to unpleasant complications, if we are to credit the report that the Chief Justice of New Brunswick will throw up the position unless an increase of salary is provided for.

There appears to be no good reason for discriminating against the Lower Province Judges in this matter of salaries.

Their duties are as onerous and their responsibilities as great as those of their brethren of the Bench of Quebec and Ontario.

It is not to be supposed that the time is fully occupied with severe mental labor, and nothing more can be said of the Judges of the other Provinces.

It is supposed that a Judge can live more economically in St. John or Halifax than in Quebec or Toronto.

The St. John Banks in Parliament. The Bills for the incorporation of the new Bank for St. John passed the Commons prior to the 27th ult.

A Message was brought from the House of Commons by their Clerk, with a Bill intitled: "An Act to incorporate the Bank of Saint John," to which they desire the concurrence of this House.

The said Bill was read for the first time. On motion of the Honorable Mr. Mitchell, seconded by the Honorable Mr. Atkins, it was ordered, That the said Bill be read a second time to-morrow.

This is the Bank that is founded by Messrs. Palmer, Simons Jones Nicholson, Thomas R. Jones and others.

Later in the same day the Bill for the Maritime Bank resumed the Senate. The Journal says:—

The Latest Report. The Fredericton "Head Quarters," which appears to have received special information on the School difficulty, remarks:—

"It is supposed that the difficulty has been solved without any violation of the Constitution, and that the terms are that the Dominion Parliament will renew the grant annually received by the Roman Catholic Schools from the Local Government."

The Dominion Parliament under the Union Act, is debarred from dealing with the question of Education in the several Provinces. The support of Schools is absolutely confined to the Local Legislatures; and we judge that to appropriate Dominion monies to the support of Separate Schools in any Province is an undertaking beyond the powers of Parliament.

Were such a proposition mooted at Ottawa, our representative would at once denounce and oppose it. Not one of them representing a Free School constituency could afford even to be silent.

Public sentiment is now thoroughly alive to the danger that has threatened and will make itself felt in a manner not to be misanderstood.

The Head Quarters will probably have no objection to give its authority for the remarkable statement.

Nine times has he played a three figure innings, and his average is always to be reckoned on for a long stay between the stumps. He is undoubtedly at once the quickest run-getter, and a powerful "placings" the ball is perhaps the most remarkable picture of his batting, marvelled at in his country, and well timed hitting. W. G. Grace (Gloucestershire) M.C.C. Universally admitted to be the most perfect cricketer that ever donned flannels, and each season adds to his reputation of his performance. His aggregate of 1808 runs in first-class matches is far in excess of the highest yet recorded.

Nine times has he played a three figure innings, and his average is always to be reckoned on for a long stay between the stumps. He is undoubtedly at once the quickest run-getter, and a powerful "placings" the ball is perhaps the most remarkable picture of his batting, marvelled at in his country, and well timed hitting. A medium pace bowler, but was not so successful last season as in 1869; a good batsman and a good fielder.

W. H. Hadow (Harrow).—A very good batsman, playing the game thoroughly and having excellent disposal as well as good hitting. A sure run-getter and good man to bat after a wicket. A severe left hand-batter, and a much improved fielder.

N. H. Hadow (Harrow).—Lancashire and Free Forester.
