

TUESDAY, February the 13th, 1787.

HE house having been prorogued until this day, met, and there being only twelve Members prefent, adjourned until one o'clock to-morrow.

WEDNESDAY, February 14th, 1787.

As there was only the fame number of Members prefent as yesterday, the house adjourned until to-morrow one o'clock.

THURSDAY, February 15th, 1787.

House met.-Col. Billopp and Mr. Paine, were directed to Message to the wait upon his Excellency the Lieutenant-Governor, and to ac- Lieut. Governor. quaint him that the house were met and wait his commands.

Message from his Excellency the Lieutenant-Governor to the Message from his Excellency. house, requesting their attendance in the Council Chamber.

Mr.

Housestended his Mr. Speaker, with the house attended, and being returned, Excellency. reported that his Excellency was pleased to make the following speech to both houses, of which he had procured a copy as sollows:

#### " Gentlemen of the Council,

#### " And Gentlemen of the House of Assembly,

His Excellenc.'s fpeech to the Council and Affembly. "HE arrival of Lord Dorchefter, at Quebec, with his Majefty's Commiftions of Commander in Chief of the British forces in the North-American colonies, and Governor of each province, having taken place fince your recess. It is with the greatest fatisfaction I inform you of arrangements which cannot fail to give every encouragement to this rifing fettlement. The more intimate our union becomes with our fifter colonies, and the more closely our interests are connected, the stronger shall we eventually be to encounter any. obstacles to our growth and prosperity.

" As I am perfuaded you will cheerfully adopt every mea-" fure which shall be conducive to these ends, I must call " your attention to the means neceffary for our defence, with-" out which we can fearcely hope for permanent fecurity. The " first step to be taken in this business is the establishment of " a provincial militia, it being of the highest importance that " the military experience of the inhabitants fhould not be loft a-" midif their peaceful employments. We ought carefully to " thun the danger of refting our fate on the quiet temper of " foreign states, nor should we ever rely on any but our own arm " for immediate protection. A well regulated militia will " at all times prove our furest fafeguard, and perhaps after what " we have experienced, no people would be more inexcufable " should we be found in this respect unprovided for emergen-" cies: and I am confident from the zeal you have shewn to " forward the increase and welfare of the province, you will " not delay to make use of resources within your power, for " fixing its ftability.

"The unremitted attention of government to our interefts and fituation is alfo ftrongly manifefted by the arrival of Commiffioners amongft us to examine into the loffes and fervices of the loyalifts. It is now in the power of the Petitioners to eftablish their claims without leaving the province, and numbers to whom the national bounty could not otherwife have been extended, will in confequence of this meafure, be enabled to carry on their improvements with double ardor.

" The laws passed in the course of the last fessions leave few " other subjects for your present confideration, and it will per-" haps be prudent to wait their operation, and to bring forward " only fuch bills, as may be called for from the evident con-" currence of circumftances."

Speech taken into confideration.

Upon a motion made and seconded. -Ordered, That a An address ordered. Committee be appointed to prepare an address, in answer to his Excellency's ipeech.

The Solicitor General, Col. Billopp, Capt. Lyman, Mr. Hubbard, and Mr. Davidson, are appointed for that purpose.

Ordered,-That his Excellency's speech be printed.

The Speaker communicated to the house two letters which he had received during the recess, from Sir Brook Watfon, Agent of the province, with his answer.

Upon a motion made by the Solicitor General, and feconded, refolved to confider the speech of his Excellency, in a committee of the whole house.

The Speaker left the chair, and the houle refolved itfelf into a committee of the whole.

Attorney-General in the chair.

The Speaker reaffumed the chair, and the chairman reported that the committee were of opinion, that a committee should be appointed to bring in a bill for establishing and regulating a provincial militia.

Ordered,-That the report be accepted, and that the further confideration of his Excellency's speech be deferred until next Monday.

The Attorney-General, Major Coffin, Mr. Dixon, Col. Billoop, Capt. Lyman, Capt. Vandeburgh, Mr. Hardy, and Capt. Clinch, are appointed a committee to frame a Militia bill.

Mr. W. Pagan, moved, that a committee be appointed to examine and report fuch laws as are near expiring.

Mr. W. Pagan, and Mr. M'George, are appointed for that Committee appurpole.

#### " May it please your Excellency,

"HE Affembly of the Province of New-Brunfwick, requeft your Excellency to accept their fincere thanks for your interesting and affectionate speech.

"His Majefty's unremitted attention to the welfare and profperity of these provinces, manifested in the appointment of *Lord Dorchester* to the command of the British forces in the North-American colonies, and to the government of each province, demands our most grateful acknowledgments, and we participate with your Excellency the fatisfaction derived from arrangements which must prove fo encouraging to this rising fettlement, as every obstacle to our growth and prosperity will be lessend or removed by that union of force as well as interests by which we are now fo intimately connected with our fister colonies.

"We thank your Excellency for the confidence you express in our endeavours to fecure these important advantages, which we shall not fail to justify by an immediate attention to those necesfary measures for our defence, without which no permanent security can be reasonably expected

"The importance of the establishment of a provincial militia to infure to us the benefits which may be derived from the military experience of the inhabitants, is too obvious to be overlooked, notwithstanding our present peaceful fituation. We

are fully fenfible how precarious any dependence would be on the quiet temper of foreign states, and of how much consequence it is to have the means of protection and defence in our power, and after what we have experienced, we shall be carcful to avoid the centure we should defervedly incur by being without a well regulated militia in the province. We cannot eafily express the grateful fense we entertain of the continued anxiety difcovered by your Excellency to promote every object conducive to our stability and welfare; and your Excellency may alfuredly rely on our most zealous co-operation in effecting the establifhment you now to earneftly recommend. We beg leave to return our warmest thanks for the disinterested fatisfaction we obferve in your Excellency, and the opportunity you have given us of expressing our gratitude upon the arrival of Commissioners amongst us to examine into the loss and fervices of the Loyalist, and to establish the claims of the petitioners without their leaving the province. The peculiar attention of government in the objects of this commission, and the choice of the persons entrusred to fulfil it, must too strongly effect the number to whom its henefits are thus extended and enhanced, not to encourage them with double ardor and alacrity to carry on their improvements.

"We fully agree with your Excellency in the prudence of waiting the operation of the laws paffed in the course of the last fellion, and of bringing forward only fuch bills as the concurrence of circumstances shall evidently require.

After proceeding this far with our statement, we cannot avoid approving much of the diligence and attention given by the Treasurer, to the duties of his office, as exhibited to us by the face of his accompts, and more especially when confidered as the first effort of the kind ever attempted in the province.

We must likewife add, that some inconvenience has arisen from Masters of vessels, not knowing at the Custom-House that they were obliged to make their first entry at the Treasurer's office. And in future, we submit it to the wildom of the House, how far it might be expedient to oblige masters of vessels in future, importing dutiable goods, to make entry at the Treasurer's office, previous to the naval office, which is the first branch of the customs.—We beg leave further to observe, that the act of last year for raising a revenue, has not invested the Treasurer with sufficient powers to make feizures of any vessels of vessels. who may refuse or neglect to enter all their dutiable goods at his office.
