"The sheriff shall immediately upon receipt of his copies cause one of them to be posted up in a conspicuous place in the court house; the clerk of the peace, upon receipt of his copies, shall cause one of them to be posted up in a conspicuous place in his office; every head teacher of a public or separate school shall post up one copy on the door of the school house and every postmaster, shall post up one copy in his post office."

"Where copies of the list have been sent to the secretary or secretary-treasurer of a school board instead of to the head teacher of a public or separate school, such secretary or secretary-treasurer shall act in the place of the head teacher, and shall post up one copy of the list on the door of every school house under the control of the board, R.S.O., 1937, c. 7, s. 10.
