

CHINA HAS DECIDED TO OPEN IMPERIAL FORTS AT TAKU OPENED FIRE ON THE INTERNATIONAL FLEET AND THE FORTS WERE CAPTURED AFTER A COMBINED ATTACK.

London, June 18.—(3.30 a.m.)—China has decided to open the international forts at Taku and to open fire on the international fleet and the forts were captured after a combined attack.

THE CASUALTIES WERE: KILLED, BRITISH, 1; GERMAN, 3; RUSSIAN, 16, AND FRENCH, 1; FIFTY-TWO WOUNDED—FORTS ARE NOW OCCUPIED.

London, June 18.—(3.30 a.m.)—China has decided to open the international forts at Taku and to open fire on the international fleet and the forts were captured after a combined attack.

THE HORDES ARE STUPEFIED.

The official narratives, coming by way of Shanghai, vary widely and bear internal evidence of supplementing the main facts with guess work.

THE CASUALTIES.

The casualties to the fleet forces were as follows: Killed, British, 1; German, 3; Russian, 16, and French, 1; Fifty-two wounded.

THE CHINESE TORPEDO BOATS WERE SEIZED.

The Shanghai correspondent of the Daily Mail, telegraphing yesterday, says: "The torpedoes being fitted in obedience to orders from Peking, conveyed in a personal edict of the Emperor Dowager, by the office of Kang Yi, President of the Ministry of War. Several warships were struck by shells from the 12-inch guns of the forts.

HEAVY RUSSIAN LOSSES.

The heavy Russian losses were due to the blowing up of the magazine at Nanchang. Four hundred Chinese are reported to have been killed.

THE FORTS BLOWN UP.

The Daily News has the following from the Taku: "Two of the forts at Taku exploded, blowing up 200,000 tons, and carried more than 300 guns.

MONSIEUR MOVED DOWN WITH MACHINE GUNS.

The failure of Admiral Seymour's column and its retreat to the forts, it is presumed, the shells are still isolated, although Shanghai forwards Chinese reports that the forts were captured by the German and French forces.

Copies of the resolution will be forwarded to the Premier and Ministers of the Ontario Government.

Dr. Blackstock's Charge. A deputation consisting of Dr. Roseburgh, Mr. James Masie and Mr. F. Spencer, representing the Prisoners' Aid Association, of the objects of the Association, and asked for the sympathy and support of the Conference. Rev. Dr. Blackstock, in moving a resolution commending the work of the association, accepted the opportunity to deliver a few words in reference to the police.
