



According to Mullens' story he was passing along Fountain avenue late a Saturday night when he noticed the old watchman seated in his shanty, near a small plumbers' stove, and decided to sit down and talk to him. The two men chatted together beside the stove for more than an hour, and then both began to doze. 

F. P. COLLEY GIVES HIS IMPRESSIONS

The Area He Thinks Will be Well Adapted to Mixed Farming

"Ootsa lake and the country which surcounds it is a partly open country where the best of the land is better than that in the Bulkeley valley," said E. P. Colley, a ictoria land surveyor, who has just re furned, when interviewtd by a Times reporter. "About one-tenth of the land is wholly free from trees, being covered with pea vine, wild rye grass about eight feet high, and numerous other weeds and grasses, such as red top, bunch grass and fire weed.

fire weed. "Begides the open land there is a good proportion of the land covered with small poplar, which is easily cleared, and the land is of the best possible quality. A good deal of the remainder is covered with jack pine and is rather inclined to be rocky. 

It is over fifteen months since Mr. Hartridge joined the survey service in the north. He says that prospectors, land seekers and speculators have followed closely on the heels of the sur-vey parties, over the trails which they have cut through different parts of the country, particularly up the south fork of the Telqua river from Aldermere City, which point is the center of the ranching country in this district. Mr. opper and galena prospects have been

located.

The engineer says that survey work will not be retarded during the winter. His men kept at it last winter in a temperature which registered 53 below zero and suffered no appreciable discomfort. The progress of surveying is assisted, if anything, during the winter, as it is easier to advance when the deadfalls and low brush are covered with snow. When the snow is crusted it provides a good surface to walk on, and when it is soft the men use snowshoes to get about on. At Telqua, a point at the junction of

STRUCK BY TIDAL WAVE.

Norwegian Steamship Puts Into Hono-lulu With Her Decks Swept Clean.

The Norwegian steamship Admiral Borreson, from Seattle for Taku, China, has put into Honolulu with her steel masts, stacks, rails, stanchions and upper works swept clean from her decks, most of the deck load of lumber gone and barely able to make port. When the vessel arrived the firemen were feeding their furnaces with what was left of the lumber, as the steamship had run out of fuel.

Caught in a terrific tidal wave Saturday, November 2nd, 2,500 miles northrest of Honolulu, the Borreson was hurled through space and buried in the trough of the sea for a few min-utes. When the steamship emerged, shaking, her decks were as clean as The tidal wave in which the vessel was caught is supposed to have fol-lowed a submarine earthquake, and that the vessel escaped instant destruction, or managed to make the trip of 2,500 miles to port in the dilapidated
