## BILL.

### An Act for the Removal of the Head Quarters of the County of Vaudreuil.

**WHEREAS** the Municipal Council of the County of Preamble.

Vaudreuil, and also many of the inhabitants of the said County have by their Petitions to the Legislature, prayed that the Head Quarters of the said County, as respects  
5 the Administration of Justice, the Registry Office and the sittings of the said Municipal Council should be removed from the village of Vaudreuil to that of Ruisseau Saint Hyacinthe in the said County, and it is expedient and proper to grant the prayer of the said Petitions.

10 Be it enacted, &c., That so much of the Act passed in the twelfth year of Her Majesty's Reign, intituled "An Act to amend the Laws, relative to the Courts of Original Civil  
"Jurisdiction in Lower Canada," as requires or provides that the Circuit Court shall be holden in the Parish of St.

15 Michel de Vaudreuil, be, and the same is hereby repealed, and that the said Court shall be holden at the Village of Ruisseau St. Hyacinthe, in the Parish of St. Ignace du Côteau du Lac, in and for the Circuit called and to be called the Vaudreuil Circuit, on the day and at the times in the said Act mentioned.

Circuit Court for the Vaudreuil Circuit, to be holden at the Village of Ruisseau Saint Hyacinthe.

20 II. And be it enacted, That it shall and may be lawful for the Governor in Council to order the removal of the Registry Office for the said County from the place where it is now kept to the said Village of Ruisseau Saint Hyacinthe.

Governor in Council may order the removal of the Registry Office to said Village.

25 III. And be it enacted, That the place of holding the Meetings of the Municipal Council of the said County of Vaudreuil shall be the said Village of Ruisseau Saint Hyacinthe instead of Vaudreuil, anything in the Act passed in the Session held in the tenth and eleventh years of Her Majesty's Reign, intituled "An Act to make better provision  
30 "for the establishment of Municipal Authorities in Lower  
"Canada" to the contrary notwithstanding.

Meetings of Municipal Council to be held in said Village.

IV. And be it enacted, That this Act shall have force and effect upon from and after the day of  
35 Governor in Council may at any time before that day make and publish a Proclamation or an Order in Council for the removal of the said Registry Office upon or after that day.

Act to commence on day of next, but Proclamation or Order in Council for removal of the Registry Office may be issued previously.
