OTTAWA, Jan. 18.-(Special.)-Ar-thur Meighen (Portage la Prairie) introduced his resolution calling for a reduction in the duties on agricultural implements in the house of commons to-day, thereby discounting the atti-tude of W. E. Knowles (Moose Jaw), a Liberal, whose notice on the order paper last year prevented other members from bringing up this question. Mr. Meighen made a careful and wellthought-out speech. His arguments were conclusive, and the statistics he offered were from government returns. Mr. Knowles, on the other hand, ade a weak , almost apologetic reply. It is interesting to note that after Mr. Meighen had concluded his re-marks, Hon. John Haggart, one of the Conservative old guard, left his place in the front and went to Mr. Meigh-en's desk, congratulating him with the words, "Well done, my boy, well done." There was no division, and the subject will probably go to the foot of the order paper. It is doubtful when it will come up for final disposition. An Exotic Plant.
