UNCLE SAM'S TURKEY

Appears to be to Grab Considerable More Than Cuba.

PORTO RICO AND THE PHILIPPINES IN IT

The Plan of Campaign Has Been Given Away in a Letter From Secretary Alger to the Speaker of the House—Admiral Sampson is Now in Command in Front of Santiago—Fifteen Warships Are Now There and It is Impossible for Cervera to Escape.

That a bombardment of Santiago took place is now well assured, and though no definite result is announced, it appears that the United States fleet got the best of the encounter. Spanish accounts are to the effect that Schley's squadron was driven off; thus it is claimed to have been a victory for Spain. The same claim was at first made in regard to Dewey's attack on Manila. While Commodore Schley had no such walk-over as had Dewey, he probably scored a decided advantage. Official reports are lacking, and until full details arrive the exact state of affairs cannot be learned. While greatly over-matched, Admiral Cervera had a much better fighting force than Montojo had at Manila. The United States promise to send no reinforcements to Cuba at once, but the embarkation of troops is not reported definitely yet.

SAMPSON IN COMMAND

The Admiral Succeeds to the Command in Charge of the American Fleet Before Santiago.

New York, June 2.—(Special to Toronto World).—A Washington special to The Herald says: Rear Admiral Sampson has succeeded Commodore Schley in command of the American naval force in front of Santiago de Cuba and the Spanish fleet. At the same time the number of American men-of-war cruising off that port has been increased to 15, so that it is now practically impossible for Cervera's squadron to escape destruction or capture.

A Madrid special to The Herald says: The condition of the Bank of Spain is considered more serious than any reverse of the war. Inasmuch as the responsibility of the bank to help the Government means an impossibility to continue the war.

THE PLAN OF CAMPAIGN

Not Only Cuba but Porto Rico and the Philippines are to Be Included in Uncle Sam's Conquests.

By Associated Press. Washington, D.C., June 1.—For the first time since the beginning of hostilities there appears to be something in the nature of an official statement of the plan of campaign of the United States Government.

Alger to the Speaker of the House, transmitting certain recommendations and statements of General Ludlow, which disclosed the purpose of the War Department to send 70,000 men to Cuba, 20,000 to start at once, and the remainder just as soon as they can be made ready for departure. Then there was an estimate for establishing electrical communications in connection with the army in Cuba, Porto Rico and the Philippines, showing for the first time officially an implied intention on the part of the Government to land troops in Porto Rico.

Inasmuch as the Secretary says that the second contingent of troops is to go forward as soon as they can be prepared, a great deal of interest is attached to the report that was made today at the War Department providing for the organization of the 75,000 additional volunteers called for. The order officially established the statement heretofore made in these despatches that a large proportion of the new men are to be used to fill up the existing regiments of volunteers, which are in most cases deficient in number. It is to be presumed, from three points collected under the first call, that the order has been issued in this fashion, so that the order has been bearing upon the plan of campaign.

The Santiago Engagement. The naval officers have been considerably mystified throughout the day by the report of an engagement off Santiago. At the outset there was complete scepticism and a disposition to treat the reported action as a myth. No bulletins were issued by the department during the day, and at the close of office hours it was stated that no despatches from Commodore Schley had been received during the day. There is reason to believe, however, that the department received indirect advices through the State Department, possibly not bearing out the detailed press despatches, but sufficient to indicate that an engagement of some kind had occurred at Santiago.

An additional evidence that the actual forward movement of the army and navy has begun was given in the action of the foreign naval and military observers. They have been scouring leisurely in Washington for some time, but within the last week all of them have started for Florida. The British naval and military attaches were the first to leave, and now they have been followed by the German, Austrian, Swedish, Norwegian and Japanese observers. The Government of Norway and Sweden has no less than six military and naval experts to observe various branches of the warfare.

Yesterday she again came out, venturing over a warship of the blockade squadron anchored within five miles of Havana, clearly distinguishing whole rows of lighted guns in the darkness. The commander of the warship said new fortifications were being constructed on Morro Heights. A steam donkey carrying earth and sand is running night and day.

THEY WERE MURDERED

Strong Expression Used by Mr. Bell of Pictou, N. S.

They Went to Work on the Crow's Nest Railroad, Took Diphtheria and Died Without Proper Attendance, So It is Claimed—A Commission to be Appointed to Look Into the Matter—House Proceedings Yesterday.

DAY WITH GILBERT PARKER

Canada's Own Novelist Entertains and is Entertained.

Talks to a Trinity College Audience of the Art of Fiction and is the Hero of the Hour—At Night He Was the Guest of the Canadian Club—Brilliant Literary Gathering.

The announcement that Gilbert Parker would talk on the subject of how to become a story-teller drew a large audience to Trinity College Hall yesterday afternoon.

The gifted novelist was in his happiest mood and explained everything except his own world-renowned genius. The lecturer started with a brief history of the novel. It was not a "mushroom trade," but the master of all arts for the sculpture and architecture which recorded the earliest thoughts of man were in reality narrative.

With the coming of Defoe and Fielding there was no more fable or pastoral comedy, but the story of real life. Gilbert Parker was in his element now, and fine gems of thought clothed in rich language fell so fast that before the audience had made an end of applauding one they were clapping another.

"Fiction was not a mere transcript of life, for then the photographer would surpass the artist. Not the mask, but the human face divine," was what was wanted. Nor were facts the desideratum. The story writer, while making the information drawn from the stock exchange, the blue book or the police court, must use only such as had the human significance.

The subject to be chosen might cut to the bone or uncover the gnawing heart strings, so long as it showed the spirit and significance. There must be the well-constructed story, just as in the novel, because it was known beforehand where the chief effect would be. The characters, too, must be known as the heart of the story, and their environment as well. But, above all, was the inspiration of a new idea.

Gilbert Parker's words on things to avoid were expressed in a way that would alone have made the reputation of another man.

"The emotions of the story-teller must be rationalized before he can truly study human nature." There must be no sentimental debauch. "The writer must not lead his characters, for character is a law set in emotion, which cannot be changed. The story-teller was not a social reformer, for social facts clothed in imagination were not as evidence."

The lecturer, in closing, bade the writer bear up against harsh criticism, remembering that he would be at the heart of the matter the peace that passeth all understanding.


