Continued from Page 1. M. Bertillon's entire system "falls to the ground and no longer exists." (Great sensation.)

Bordeaux Could Not Be Traced. This witness, who had analyzed the interest of his hearers, maintained that the bordereau could not have been traced, and that the only way to prove the truth was to proceed to illustrate why this was the case, and to prove the falseness of Bertillon's deduction.

A Mining Inspector in Lias. M. Bernard, an inspector of mines, who had taken his honors at the Polytechnic School, and who followed Parry-Javal at the witness bar, said that he appeared in the writing of the bordereau, which was based on false calculations. He was, in fact, a mining inspector, and was on such a basis that the whole system rested.

M. Bernard also said he was astonished at the fact that M. Bertillon had not taken account of letters and the space between words. There was not 1.25 millimetres, as alleged by M. Bertillon, but 1.58. Moreover the writing of the bordereau was naturally rhythmic, and while his character and size showed it was not written by either a short-statured or a long-statured person, the witness then proceeded to illustrate photographically his contention that the bordereau was a fabricated document, and also pointed out important differences between M. Bertillon's photographs and the original.

Hard Crack to Bertillon. While pointing out a fault in the application of the system, M. Bernard expressed admiration by remarking that M. Bertillon's system was a masterpiece of logic, and that it enabled the witness to say that the bordereau was not a fabricated document, and also pointed out important differences between M. THAT BIG BANK IN LONDON.

Montreal Banking and Other Circles Are Stirred up Over the Proposed Concern.

SOME CANADIANS WILL BE IN IT.

Mr. Pease is Said to Have Been Offered the Comfortable Stipend of \$50,000 a Year.

Montreal, Aug. 28.—(Special.) It goes without saying that the announcement of a big American bank in London, as published in The World of Saturday, is the universal topic here in banking circles. The Merchants Bank of Halifax people confirm the report in full, except they state that the offer came direct to Mr. Pease from the New York promoters. All of the capital has been taken up in New York and London. Amongst the leading promoters is the president of the Mutual Life Insurance Company of New York, and it is said one or two big Canadian institutions have also a finger in the pie. It is said here to-day that the joint general manager of the Merchants Bank of Halifax was offered \$50,000 a year if he would take hold, his services being particularly required on account of his intimate knowledge not only of the English and American principles of banking but of the branch system. Mr. Pease will be here about the middle of September.

THE CHURCH IN DAWSON. The Methodist Missionary Sent a Report of Progress Made Among the Miners.

A letter has been received from Rev. A. E. Hetherington, D.D., Methodist missionary at Dawson City, in which he reports a steady progress in the work. "The church," he says, "is held to its work with capacity every Sunday evening, and other meetings are well attended. Business affairs are settling down on a firm basis and everyone seems to have faith in the future of the place. The big companies are making large preparations and machinery will very soon take the place of hand labor. Many people have left the Klondike, especially those who have not succeeded. The main body of the community has arrived at the main. The health of the community is greatly improved. Last year every hospital was filled and the death rate was about eight to ten per week. Now the hospitals are practically empty. The cause of the improvement has been better food, cleaner habits and improved sanitary conditions. A large number of ladies have arrived at Dawson. They are wives of men who have already settled here. This has had a beneficial effect upon the moral and social condition of the place."

LIBRARY BOARD'S REPLY

To the Mayor's Letter Asking for Expenses of Running Branch Libraries.

THEY STILL WANT THAT \$4000.

Board of Control Takes No Action—Contracts Let—Fire Patrol for Island-City Hall Notes.

At the meeting of the Board of Control yesterday were present the Mayor and Controller Lynd and Woods. The business consisted of the awarding of contracts and the consideration of several communications received.

City Clerk's Illness. The letter of Dr. Pyne stating that Mr. John Blevins' health was not sufficiently restored to enable him to resume his official duties was read. The request of the Mayor that an additional month's leave of absence be given the City Clerk was immediately assented to.

Berkeley-Street Slip. The City Engineer recommended that the slip at the foot of Berkeley-street be dredged at a cost not exceeding \$200. The board concurred in the desirability of the work, but no action was taken till it is learned what the Dominion Government intend to do with respect to harbor improvement.

Contracts Let. These contracts were awarded: Sewers on Dupont-street and Grant-avenue, to John Metcalf for both works at \$2700; filling at Keating's channel, foot of Cherry-street, to W. F. Grant at \$6.20 per foot. There was only one tender for supply of elm timber for the work this week.

Scavengers' Wages. The city scavengers had presented Street Commissioner Jones with a petition for increase of wages. The board has not yet decided on the matter, but the petition has been referred to the City Engineer. On motion of Controller Woods the board adjourned to meet at the next meeting of the Board of Control.

Stands Will be Allowed. An application was read for permission to conduct a news stand inside the city hall. The board refused the Mayor's offer of entering his protest against any kind of business being carried on in the city hall. If an exception were made for newspaper stands, it would probably be requests for other small enterprises to the detriment of street-keepers.

Library Board's Answer. Secretary Bateman of the Library Board wrote to the Mayor: "I am instructed to say that the estimates already furnished by this board contain a charge for the expenditure required to maintain the central library of four branches."

In the opinion of the board there are all the details which the provisions of the Library Act require to be carried out. The board is not prepared to furnish to the City Council in June last. As the Board of Control has \$3000 from the sale estimates without any communication from the board it is maintained that the estimates were deemed sufficient at that time by the Board of Control.

Employees May be Discharged. The two branches now closed have been reinstated yesterday afternoon and the salaries of the employees of these branches continue a charge till last September. It is expected that the services of certain employees of this library will be dispensed with.

To reopen the branches upon the terms of receiving sufficient funds from the City Council to pay the outlay from last August till the end of the year. The board is not prepared to maintain the charge of seven months' outlay for maintaining the said branches to the 1st August to funds not available for that purpose.

Still Want \$4100. The Library Board request me to say that they do not see their way to make this year. It will require at least \$3000 to cover the maintenance of the two new libraries for the year 1899. The members of the board are not prepared to pass a resolution to that effect, have passed their individual opinions that the proposed annual expenditure might be reduced to \$1000 or \$1200 for the current year, so that the balance of the amount struck off the estimate for the year 1899, to be returned to the Council in the next year.

Question Council's Authority. The Library Board do not recognize the authority of the Council to reduce their estimates so long as such estimates do not exceed the statutory limit of a quarter of a mill on the dollar, and the board is not prepared to assent to the Council's action in this matter. Policy of Retrenchment. "Either to litigate with the City Council in the present regard the policy of retrenchment to the extent of closing two of the branches. The reduction of the present estimate to the extent of a considerable deficit at the end of the year in the estimate submitted to the Council in the first part of the year were based upon the estimates submitted to the Council in March last, and six months of the year have passed since that time. The board is not prepared to assent to the Council's action in this matter.

Two Months with the Free Ferry. Inspector Newman has presented his final report of the Island Free Ferry. During the past week 443 persons availed themselves of the free ride. Of this number were adults. The total carried during the week was 28,492; adults, 11,745. The number of bicycles carried was 848.

Fire Patrol for the Island. In the above report there is the suggestion that if the ferry be continued another season a double advantage might be derived therefrom by converting the service into a fire patrol. Protection against fire would thus be afforded to the water-front and the island. This would be an assistance to the Fire Brigade if called out to any point along the water-front. An extra cost would be an engine with fuel-hose and one of the city firemen on board.

Disposal of Sewage. City Engineer East, Medical Health Officer Sheard, Controller Lynd and Aid Saunders have returned from their visit to Madison, Wisconsin, to inspect the newly installed sewage works. The deputation speak favorably of the process adopted at Madison. The process used to fill up a swamp. Mr. East thinks that the method might be applied to Parkdale. The contamination of the lake is becoming more serious, and in this connection the City Engineer is watching with interest the experiments at Manchester and Exeter for sewage disposal.

Abuse of Privilege. Architect Lennox informed the Board of Control yesterday that inconvenience and damage was being done to the civic buildings by the uncontrolled rambling of citizens and visitors around the premises. It was stated by the Mayor that permanent patrolmen would soon be appointed.

Asked for a Rebate. Warden Woodcock and Solicitor Robinson, representing the York County Council, appeared before the board, to request that the five years' interest, amounting to \$88, in connection with the asphalt pavement in front of the Court House on Adelaide-street, be commuted. The board did not see their way to grant the request.

The City Council will meet at 1 o'clock to-day and proceed to the opening of the Exhibition. R. O. Wymer-Roberts, City Engineer of Cape Breton, has written to the City Commissioner for copies of Toronto's building regulations. The rent of Architect Lennox that the appointments of employees now engaged in the work after the civic buildings be made permanent was laid over for consideration at the next meeting of the Board of Control.

SETTLED OUT OF COURT. An Important Suit of a Local Broker Was so Adjusted. Judge Morson, just before leaving for the west, consented to take the evidence of witnesses in the suit of E. S. Cox against Col. Murray for Victoria, and others, in which the Toronto broker claimed \$23,000 for failure to deliver to him shares in the City of Toronto Company, which he had purchased by telegraph contract just before the shares made a sensational leap from 100 to 150. The broker's claim was between \$5000 and \$10,000 each, though there remain some necessary steps to finally carry out the settlement, and may be some time before the formalities are complied with. The act of settlement, came shortly after the issue of the commission. H. H. Macrae acted for Mr. Cox.


