

BILT.

An Act to repeal so much of the several Laws of the late Province of Upper Canada as relate to the periods for holding the District Courts and Quarter Sessions therein, and to make provisions for holding General Sessions of the Peace in each District thereof, and to alter the Terms of the said District Courts.

THEREAS it would greatly tend to the Preamble. relief of Jurors, Constables and other persons required to attend the Courts of General Sessions of the Peace and District Courts 5 in that part of this Province formerly constituting Upper Canada, were the said Courts limited to three sessions in the year instead of four, as heretofore hath been established: Be it therefore enacted, &c.,

10 And it is hereby enacted by the authority of Somuchofany the same, That so much of the several Laws Act of U.C. now in force in that part of this Province time for bold which was formerly Upper Canada, as relate ing District Courts and to the periods at which the several Courts of Quarter Sea-15 General Quarter Sessions of the Peace and stons repeated. District Courts therein are appointed to be held, shall be, and the same are hereby repealed.

Proviso: Courts may adjourn, and as heretofore.

Tuesday in July, - and the last Tuesday in November, in each and every year: Provided always, that nothing herein contained shall Petty Sessions extend or be construed to prevent the said may be holden. Courts from adjourning as they shall deem necessary, in like manner as the Courts of General Quarter Sessions have heretofore been accustomed to do, or from holding a Petty Session when and so often as the Justices shall see occasion. 10

Terms of District Courts, when to be holden.

III. And be it enacted, That the periods of sitting or Terms for the several District Courts in each and every year, shall severally commence on the Monday in the week next but one preceding the week, and at the place, 15 in which the said General Sessions of the Peace are hereby appointed to be holden, and shall end on the Saturday then next following.
