WESTON CITIZENS WILL HOLD PUBLIC MEETING

Council Will Be Given Chance to Explain Action of Week Ago—General County News.

TORONTO JUNCTION, Nov. 25.—George Nicholas of Law-street, for many years a churchwarden in St. John's Episcopal Church, was made the recipient of a purse of gold to-night by a few friends and co-workers in the church, on the occasion of his leaving the Junction to take up his abode in the west. Mrs. Nicholas was presented with a silver tea service Saturday evening by the ladies of the church. Mr. and Mrs. Nicholas are popular residents of the Junction, and their departure is much regretted by all who know them.

Frederick Gilmour, youngest child of Mr. and Mrs. Alfred Gilmour, 193 High Park-avenue, died on Sunday evening. The funeral will take place to-morrow at 2 p.m., to St. James' cemetery. Fire broke out about 5 o'clock to-night in the chimney of Mr. Pitkin's home, corner of Weston-road and St. Clair-avenue. In response to a telephone call the members of No. 2 firehall were soon on the scene and extinguished the blaze before any damage resulted.

The police were notified to-night to be on the lookout for a boy named Gauthier, who escaped from the Mimico Industrial School about 6 p.m. He was working in the steam-fitting shop and left the guard to put away his tools. No trace of him has been seen since. He was a tall, fair-haired man, dressed in brown overalls and a smock. His home is in Kenora, Ont., and the industrial school officials believe he may have gone to the Junction to board a freight train for home.

At the meeting of the board of works to-night, considerable discussion took place about the damages to the town hall caused by the fire. The hall may be subjected to an account of teams driving along the lane at the back of Bruce's hardware store, corner Dundas and Keele-streets, and destroying property.

The waterworks inspector suggested that the water mains for Whitney-avenue should be laid along Toronto Junction-road instead of the longer route by Keele-street and St. Clair-avenue, along which they are laid at present.

A brick crossing will be laid at the corner of Keele-street and St. Clair-avenue.

EAST TORONTO.

Council Met, But No Important Matters Were Considered.

EAST TORONTO, Nov. 25.—The principal feature of the adjourned meeting of the town council, held to-night, was the recommendation of the water and light committee, regarding the action taken by the Toronto Electric Light Company in erecting poles along Queen-street and stringing wires without the consent of the council.

Mayor Ross fired the first gun, asking Councillor Berry, chairman of the committee, to read the report. The committee recommended that a rental of \$1 a pole per year be charged. D. D. Mann, and that the poles and wires be removed within 60 days after notice of the council to do so.

Councillor Phelan objected to 60 days, and suggested that two days' notice would be sufficient.

Fred Richardson, representing D. D. Mann, appeared before the council and said "Cut the notice to 30 days, it makes no difference."

The report of the committee was received and adopted, only Councillor Phelan objecting.

Councillor Berry introduced a bylaw to borrow \$10,000 to make improvements to the waterworks plant. The bylaw was read the first and second time, and will go before the ratifiers in January.

The second reading of the local option bylaw was given.

Councillor Crane in a somewhat protracted address reopened the question, on extending the street railway to the waterworks plant. Mr. Grant will write the railway board of Ontario with regard to the matter.

ISLINGTON.

Solicitor Favors Submission and Council Act Accordingly.

ISLINGTON, Nov. 25.—The town hall here was filled to the doors here this morning when the question as to submission or rejection of the local option question, came up for final disposal.

Reeve Evans presided and the question was as to whether the 70 odd petitioners who had in the outset favored the measure and later recanted were to be allowed to withdraw their names from the petition.

At the last meeting of the council held last Wednesday, Solicitor Montgomery decided that withdrawal would be in order, but in the interim had sent a letter to Reeve Evans, stating that council had no alternative in the matter, but to carry out the statutory requirements in view of the fact that 25 per cent. of the qualified electors had signed the petition.

Reeve Evans stated that he accepted the statement and would support the by-law. A long discussion followed, and Councilman Garhouse submitted this resolution, which was seconded by councillor Stubbs. Acting upon the solicitor's opinion, the council decided to reject the petition. On a vote the resolution was lost, on a division yeas 11, nays 10.

The result was heartily applauded by the friends of local option present.

JUDGE CAN CONTINUE ROLE OF INVESTIGATOR

Chancellor Boyd Sees No Reason Why He Should Interfere With Enquiry.

An unexpected move in the Chambers enquiry on the part of T. C. Robinson, K.C., in appearing before Chancellor Boyd yesterday, with a request that Judge Winchester be debarred from continuing as investigator, did not prove successful. Mr. Robinson claimed that the judge would not give his decision impartially, and in a long affidavit Mr. Chambers said he felt Judge Winchester was prejudiced against him, but the chancellor decided that there was no reason for interference.

The affidavit goes back to June, 1906, when it was related that the judge had called on Lawrence Solman and Wesley Dunn, in regard to the sale of some lumber, which had been at the direction of the board of control. Referring to more recent events, Mr. Chambers says that on Nov. 15 Judge Winchester issued subpoenas for men who had had dealing with his department over a long course of years, and that E. R. French, Andrew Martin, James McDonald, W. W. Peay and L. Solman had been examined by the judge ex parte and in camera touching their dealings with the department. In one instance a witness attending on subpoena was asked for the cheque with which he paid his account to the city treasurer for lumber purchased from the department, which cheque was impounded by the judge, and the further question was asked, what cash had been paid to him (Chambers) addition.

Wants British Fair Play.

Mr. Chambers complains that books were seized during his absence; that Judge Winchester personally visited the city treasurer's department for copies of accounts relating to the parks department; that his counsel has not been present at the private examination of witnesses; that on Friday he was placed in the witness box by Mr. Haney, before one of the evidence had been taken against him; and that on Saturday he was again called, although a reference had been made to the high court in this regard and a promise made by Mr. Haney that he would not be so requested to testify.

The affidavit concluded: "All I desire is a fair play and an open public investigation, thru which the light of day may shine upon my work with the city for the last 29 years."

"I am informed that the defendant has received many letters, some signed and some unsigned, relating to myself and my management of the parks and gardens department, which would bias his judgment in hearing the evidence which will be adduced under oath as the investigation proceeds."

"I have heard many reports of the unfair methods adopted by the defendant in past civic investigations, and after careful consideration of the facts sworn to herein, I am convinced that the defendant's mind is so prejudiced against me and my department, that it is impossible for him to act in a judicial spirit and send back to the council an impartial, true and unvarnished report."

"The defendant in taking evidence ex parte and in camera was, I believe, actuated by the desire to prove some petty charges against me and convict me if possible of some crime, no matter how trivial, against the public, and he acted on the presumption that I was guilty of the crime, and abused the machinery of the court and his official prerogative to this end."

Not Supported by Court.

In arguing the motion Mr. Robinson said that not for a moment was it intended to question the honesty of the council, but the calling of Mr. Chambers to testify had not been proper. Corporation Counsel Fullerton hereupon accepted the responsibility for the calling of the chancellor, while the chancellor ruled that it was proper for the council to call the witnesses and that Mr. Chambers should not object until some specific question was asked which might incriminate.

The 1906 enquiries were in regard to the exhibition buildings investigation, said Mr. Fullerton.

Mr. Vickers, solicitor for Mr. Chambers, asked if the judge would "dream house of evidence that did not come thru the ordinary channels" if he were acting in the proper judicial spirit.

"He would get it the best way he could," replied the court.

Again Mr. Vickers protested. To try and prove something petty and trivial, returned the chancellor, "the council will take no notice of it."

Later Mr. Vickers said that the course pursued by Judge Winchester was followed by the late Judge McDougall.

Resolution to Council.

A resolution was received by the council yesterday from the Toronto Gardeners' and Florists' Association protesting against "the unfair certificate of evidence submitted by the park commissioner in reference to his practical ability in the management of the parks."

The communication, which bears the signatures of E. Dale, president, and E. P. Collins, secretary, declared that, as practical men, they considered the city's parks satisfactory.

BLAIN CONCLUDES HIS SERIES OF MEETINGS

Tribute of Honesty, Ability and Character of Hon. J. P. Whitney—Applause for Speakers.

STREETSVILLE, Nov. 25.—(Special).

Richard Blain's series of meetings was concluded with what developed into a grand rally here to-night. Hon. Dr. Pyne was unable to be present, but he had a splendid substitute in R. R. Gamney, the Oddfellows' Hall was filled to the doors with an interested and enthusiastic crowd. Mr. Blain was given a very flattering reception as he returned to some of the special legislation and some of the deals put thru at Ottawa last session.

R. R. Gamney paid a glowing tribute to the honesty, ability and character of Hon. J. P. Whitney, who he declared was administering the assets of the province for the people not for the wealthy corporations, the Sullivan and the Pritchett and the gang which controlled the Ross administration.

Hon. Frank Cochrane, he said, had made more money for the people out of New Ontario in two years than would have been made in twenty by the government. He was received with the greatest possible applause, Mayor Clatter of Brampton delivered a rousing address on the general record of the government.

METHODIST MISSIONS.

Executive Board Meet To-day re Western China Work.

The executive committee of the foreign department of the general board of Methodist Missions meets at 10 o'clock this morning. Rev. Dr. Carman will preside, and a general scheme for carrying on educational work in West China will be considered.

It is proposed to unite for this purpose four missions, Methodist, M. Episcopal, English Friends and American Baptist; and in connection with the secular education to be given, a thoroughly equipped theological department for the training of native helpers will be established. In one sense, this consolidation will mean increased expenditures; but in other directions important savings will result. Each body will contribute proportionately to the maintenance of this institution.

It is probable that a new treasurer will be chosen to replace Rev. A. C. Borden, B.A., of Tokyo, who has been compelled by failing health to resign.

BISHOP VINCENT ADDRESSES THE CANADIAN CLUB

Bishop Vincent addressed the Canadian Club yesterday afternoon. The attendance was unusually good, and a number of distinguished visitors sat at the president's table including Chancellor Burwash, Prof. Kilpatrick, E. H. Davis, 2-minister of lands and forests, etc. The bishop was received with vigorous applause, on being introduced as a life long minister, and the organizer of the Chautauquan Literary and Scientific Circles. His address on "The United States and Canada," the brief was a forceful appeal to the highest patriotic ideals and was remarkable for literary polish and ingenious antithesis.
