



COUNCIL CHAMBER,

THURSDAY February 3, 1831.

Pursuant to the foregoing Proclamation, His Majesty's Council met.

PRESENT:

Chamber, and being seated, the Gentleman Usher of the Black Rod received His Excellency's commands to inform the House of Assembly, that "It is His Excellency's pleasure that they do attend him in the "Council Chamber instanter;"—and the Members present having appeared at the Bar, the President of His Majesty's Council addressed them as follows:

"Gentlemen,

"I am commanded by His Excellency the Lieutenant Governor to acquaint you, that His Excellency does not intend to declare the cause of calling this General Assembly, until there be a Speaker of the House of Assembly; and therefore, you, Gentlemen of the House of Assembly, are to repair to the place where the House of Assembly usually meet, and there to proceed to the Election of a fit person to be your Speaker, whom you are to present to His Excellency here, immediately for his approval."

The Gentlemen of the House of Assembly then withdrew, and in a short time, the Gentleman Usher of the Black Rod, received His Excellency's

commands to deliver this Message to the House of Assembly:-

"His Excellency the Lieutenant Governor commands the immediate at-

tendance of the House of Assembly in the Council Chamber."

The House accordingly attended His Excellency in the Council Chamber; when Ewen Cameron Esq. addressed His Excellency, and stated that agreeably to His Excellency's commands, the House of Assembly had proceeded to the election of a Speaker, and that their choice had fallen upon him.

The President of His Majesty's Council then spoke as follows:

"Ewen Cameron, Esq.

"I am commanded by his Excellency the Lieutenant Governor to acquaint you, that he hath so good an opinion of your integrity, diligence and sufficiency for executing the important office into which you are elected, that his Excellency is perfectly satisfied with the choice which the House of Assembly have made, and doth allow and confirm you to be their Speaker."

The Speaker then addressed His Excellency as follows:

"May it please your Excellency:

"As you have been pleased to approve of the choice of the House of Assembly in appointing me to be their Speaker, it now becomes my duty as such, to request of your Excellency, as the privilege of the House, that

the Members thereof during the Session may be freed from molestation—that they may have freedom of speech in their debates—have the power of punishing their own members—and have free access to your Excellency on all occasions; and I do also, in their name and behalf, beg leave to claim all their ancient rights and privileges."

Then the President of His Majesty's Council replied as follows:

"Mr. Speaker,

"I am commanded by his Excellency the Lieutenant Governor to say, that his Excellency, being fully assured of the prudence, loyalty, and good affection of the House of Assembly, does most willingly grant to them all their privileges, in as full a manner as they have been at any time granted by his Excellency or any former Governor of this Island."

His Excellency was then pleased to open the Session with the following

Speech:

"Mr. President, and Gentlemen of His Majesty's Council: "Mr. Speaker, and Gentlemen of the House of Assembly:

"WITH feelings of deep sorrow I announce to you the demise of our late lamented Sovereign King George the Fourth, by which the Crown has devolved on His Most Gracious Majesty King William the Fourth.

"The late Provincial Parliament was, in consequence, dissolved, and I lost no time in directing Writs to be issued for the election of a new Assembly, and I feel much satisfaction in now meeting you in your legislative

capacity.

"It affords me heartfelt pleasure to be enabled to congratulate you on the abundance of the late harvest, and on that spirit of improvement which evidently appears dawning on the Agriculture of the Colony—a branch of industry in all ages considered the main source of wealth and individual happiness.

"I feel equal satisfaction in being also enabled to congratulate you on a

material increase in the Revenue over the receipts of last year.

"Mr. Speaker, and Gentlemen of the House of Assembly:

"The Public Accounts will be laid before you; and I rely on your good feeling and judgment in making such provision for the current year as the Public Service may require.

"Mr. President, and Gentlemen of His Majesty's Council: "Mr. Speaker, and Gentlemen of the House of Assembly:

between the several Branches of the Legislature, the true interests of the Colony are best promoted—I recommend to you a cultivation and continuance of the harmony which pervaded the last Session of the General Assembly; and I have no doubt the result of your united deliberations will prove beneficial to the country." (Signed)

J. READY."

The Speech being ended, his Excellency was pleased to retire, and the House of Assembly being withdrawn, the President reported his Excel-

lency's Speech, which being read by the Clerk-

Resolved, nem. con. that an humble address be presented to his Excellency, to return his Excellency the thanks of this House for his Speech delivered this day:

When the Honorables T. H. Haviland and The Attorney General were appointed a Committee to prepare a draft, pursuant to the above reso-

lution.

On motion, ordered, that The Honorables A. Lane and T. H. Haviland be appointed a Committee to revise the Journals of this House, each day.

On motion, ordered, that The Honorables George Wright and Charles Worrell be appointed a Committee to examine into and report upon such Laws as are near expiring.

On motion, ordered, that The Rev. L. C. Jenkins be appointed Chaplain, and that he be requested to attend His Majesty's Council to-morrow at 12 o'clock, and each succeeding day during the Session, for the purpose of

reading Prayers.

His Excellency the Lieut. Governor requiring the personal attendance of J. P. Collins, Esq. the Clerk of the Council, during the Session, Mr. John Ogle Nantes was appointed to act as Clerk, and having taken the Oath of Allegiance, and also the Oath of Office, took his Seat accordingly. Adjourned until 12 o'clock to-morrow.

"The demise of our late revered Monarch King George the Fourth, of blessed memory, filled all classes of his dutiful and loyal Subjects in this distant portion of his dominions with sentiments of the deepest regret; but whilst we deplored the loss which the nation at large had sustained, we hailed with happy auspices the accession of His Most Gracious Majesty King William the Fourth, towards whom early associations have engendered, in these his transatlantic dominions, the most lively feelings of reverence and affection.

"The late abundant harvest, with which it has pleased an all-bounteous Providence to bless the land, calls forth feelings of deep gratitude to the

Giver of all good for this beneficent mark of divine favour.

"The spirit for improvement, which seems every where to pervade this truly agricultural Colony, cannot fail to prove a source of great gratification to all who are interested in its prosperity, and especially to your Excellency, whose personal efforts have so mainly contributed to that praiseworthy emulation by which the farmer is at present actuated; and we trust, that at no distant period, the result will raise the Colony to that degree of independence, for which, by its situation and capabilities, it is so eminently qualified.

"We learn, with great satisfaction, that the Revenue has materially increased, as it affords a solid proof that the resources of the Colony are in an

evident state of improvement.

"Equally convinced with your Excellenc; that a cordial co-operation in our public labours, between the several Branches of the Legislature, is essentially necessary to the true interests of the Colony—we beg to assure you that our utmost efforts shall be directed to this desirable end; and with every confidence that a corresponding disposition exists in the other Branch of the Legislature, we have little doubt that our united endeavours to promote the welfare of the Colony will prove productive of beneficial effects."

Which Address being read by the Clerk was agreed to by the House,

and ordered to be engrossed.

On motion, it was ordered, that the said Address be presented to his Ex-

cellency by the whole House.

On motion, it was ordered, that a Committee consisting of the Honorables T. H. Haviland and The Attorney General do wait upon his Excellency the Lieutenant Governor, to know at what time his Excellency

would be pleased to receive the Address of this House.

The Hon. T. H. Haviland called the attention of the House to the mode pursued in carrying messages from the Lower House of Assembly; and moved, that in future, instead of all the Members of this House rising on the receipt of a message by a Member of the Lower House, that the President alone shall rise, and when the Messenger shall have delivered his message, that the President do go down to the Bar and receive it; as being more conformable to Parliamentary usage.
