




This Foundation is about to make an appeal to the public for funds to support Medical Research; and

The Banting Research Foundation

THE Banting Research Foundation has been organized to commemorate the discovery of Insulin by Dr. F. G. Banting and Mr. C. H. Best. This discovery is one of the most outstanding advances made in scientific medicine during the past thirty years.

Dr. Banting has received appropriate recognition from the Government of the Dominion of Canada (in the form of an annuity); from the Province of Ontario through the Governors of the University of Toronto (in the creation of the Banting and Best Chair of Medical Research, to which Dr. Banting has been appointed) and in the award of the Nobel Prize in Medicine for 1923 (with Professor J. J. R. Macleod).

From the moment that Dr. Banting realized the success of his work, and that an important step had been taken in alleviating the sufferings of humanity, he has been most anxious that his success should serve as a stimulus to other workers and he has laid stress upon this point frequently. In a measure his desires have been fulfilled and already two workers inspired by him have made substantial progress in valuable researches. Such investigations have only served to emphasize the great need of a fund from which assistance could be given to men with promising ideas but without adequate facilities. It is owing to the realization of the necessity for just this type of assistance that the Foundation has been organized.

Purposes of the Banting Research Foundation

The purposes of the Banting Research Foundation have been specifically defined to be:—

- (a) To supplement the sum at present available, in the University of Toronto, for the support of the Banting and Best Chair of Medical Research.
- (b) To establish a fund for the adequate financial support of such scientific workers as may have proposed definite problems of medical research, and for whom funds are not otherwise available. Such assistance may be given to persons working in the University of Toronto or elsewhere.

Organization of the Banting Research Foundation

All financial arrangements in connection with the collection and reception of the principal and subsequent expenditure of the income of the fund is vested in a Board of Trustees, the members of which are appointed for a term of three years subject to reappointment at the end of their respective terms of office. 





Dear Sir:-

I beg to acknowledge receipt of your letter of January 2nd, in which you request me to bring the influence of McGill University in support of a proposal to obtain the Nobel Prize for Dr. F.C. Banting of the University of Toronto for his discovery of the active principle of the pancreas, known as "Insulin", which is now used in the treatment of Diabetes.

Regarding the importance of the discovery of this principle by Dr. Banting and his collaborators there cannot be any question. This step in the treatment of Diabetes may yield results of vastly greater importance than are now dreamt of, especially if it leads to a knowledge of the chemical constitution of Insulin and ultimately to the preparation of it synthetically in the laboratory.

It is, however, certain that, apart from what may be required to obtain the ultimate results referred to, much research has still to be carried on in order to render possible the full utilization of Insulin in the treatment of Diabetes. For this research time and the labours of a large number of investigators will be necessary, and their findings will enable all who are interested in this work to reach a definite, universally accepted decision as to the value of the discovery.

Consequently, would it not be wise to postpone any such action as you propose? Dr. Banting's claims to recognition will not thereby suffer. Indeed hasty action now may prejudice these claims.

Further, I understand the Nobel prizes are awarded only periodically, and the last series of awards were made only very recently. It is to be noted also that these awards are not promoted by organized propaganda. The Nobel Trustees are keenly alive to the value of everything that is achieved in the various departments of Science, and they certainly will not be left unaware through their system of enquiry of what Dr. Banting has done. It would, therefore, be unwise to join in an agitation which may lead the Nobel Trustees to believe that an attempt was being made to force their decision.

In view of all this McGill University cannot take part in any movement which may appear hasty or which would prejudice the claims of Dr. Banting eventually to the distinction that will rightly come to him.

There is a concerted effort being made to obtain the Nobel prize for Dr. F. G. Banting of Toronto University who discovered the active principle of the pancreas, Insulin, which is now used in the treatment of diabetes.

While Dr. Banting had co-laborators in the development of Insulin, the idea was his alone and there is no one who could dispute that at all. There has been no development since Pasteur's time that means so much to those afflicted with a grave disease. We all feel that the awarding of the Nobel prize to this young man would meet with universal approval. I do not believe it has ever been awarded in recognition of so worthy a purpose. Many of the American scientists have already enthusiastically taken up the idea.

We felt that you, as head of a great university, and sister Canadian institution, might be glad to contribute your influence in this award.
