STAGE STRUCK MAIDENS

Many Toronto Girls Have Narrow Escape From a "Theatrical Agent"

A dozen or so Toronto girls, who had aspirations towards a stage career, had an experience last week which should teach them a lesson. On Monday, April 7, an advertisement appeared in an evening paper for chorus girls. Neither the salary nor the name of the advertiser was mentioned, only the number of a box was given.

On the same day a man calling himself J. E. Morton came to the house at 103 1/2 Jarvis-street and engaged the front room from the landlady for the afternoons and evenings, from Wednesday till the following Monday. He gave no address, but explained that he wanted the room and the piano to try the girls' voices for a theatrical troupe which he was collecting.

Child Suspected Something. He then notified those who had answered his advertisement that he would meet all applicants at the Jarvis-street address between the hours of 3 p.m. and 9.30 p.m. On Wednesday morning he called in a person on Jarvis-street, a 13-year-old fancy dancer, who was one of those who had answered the advertisement. Her parents were readily won by his suave and seemingly honest manner, and in spite of the fact that the child's mother had seen that there was something wrong, she arranged to go to the Jarvis-street house and look after the door for him, as he seemed to wish to hold himself aloof from the landlady.

On Wednesday afternoon and evening about a dozen young ladies called, most of them accompanied by a parent. They were taken into the room, asked to sing a few bars of a song, and a few questions were asked, apparently to ascertain that they were of the proper age and good characters. No girl under 21 years of age was "accepted" without the written permission of her parents.

To those who were accepted he had a written contract, guaranteeing them salaries of \$18 per week and up, and in return asked for \$2.00 each from each of their sleeping car berths from here to New York, On Thursday about six, and on Saturday about twenty applicants went to the house and the same formalities were gone thru with. The landlady's suspicions were aroused slightly by the perfunctory way in which he examined the voices, but he explained that he had to tell in a moment whether there was any material for training.

Applicants Were Respectable. At the girls seem to have been respectable, and to have been treated by him in such a respectful way as to gain the confidence of both themselves and their parents.

The strange thing about it was that the only person who appeared to be the little dancer, and her suspicions were so slight that they were easily quieted by a gold ring from Morton and her father.

On the evening of Monday, April 13, the girls met, according to agreement, at the Union Station to take the train for New York. Detectives Sleight and Galt were in the station, but no Morton appeared. After waiting for some time the brothers of some of the girls went to the house on Jarvis-street and found that Morton had left there on Sunday night. The New York police were communicated with, and it was learned that the Keeble-Morton Stock Company, which he had claimed to represent, was a myth, but that Morton was well known to them.

What Morton Looks Like. Some of Morton's chief dupes described him as being 5 ft. in tall, broad shouldered, thick set, but not at all corpulent. He had brown eyes, rather shifty, with clear shaven, and had brown hair, streaked with grey. Three of his upper front teeth were decayed stumps, and two of his lower front ones were equally decayed. He was rather thick, with heavy lines from a pipe, and his chin was slightly projecting. His age has been guessed from 45 to 55.

He wore a Newmarket overcoat; a top hat, and carried a cane or umbrella on the street. In the house he wore a frock coat, grey trousers, black-four-line tie and white shirt. Morton had a habit of watching people through the corner of his eye, held his lips in such a way as to hide his false teeth, was rather uneasy in manner, and had a habit of standing with his hands behind his back.

What His Desires Were. There is reason to believe that in fleeing the gullible theatrical aspirants of small means money, the representative of the mythical dramatic company only accomplished a small part of his aim, as his view. The credulous girls and their less parents may think their lucky stars that one mother at least thought it worth while to look carefully into the matter before she allowed her daughter to go to New York with a practically unknown man who gave vague promises of big salaries and dramatic fame. This woman communicated with Lawrence Hearn, an informed Inspector Stark, who made enquiries in New York which revealed the fact that Morton was a swindler-or worse.

It is the opinion of Inspector Stark and Staff Inspector Archibald that Morton's object was to lure the unfortunate girls to New York, and there, if possible, work their ruin. If he had not been frightened at the last minute by the suspicion that the police were on his trail, and had not that another made enquiries as to where his daughter was going, he might easily have accomplished his diabolical design.

Other "Fake" Advertisements. But Morton is not the only man who has been playing this game in Toronto lately. Staff Inspector Archibald of the Morality Department has been informed of several men in this city who have no occupation, business or private residence, and who have been advertising for stenographers, housekeepers, and other domestic help. Many of these men are presumably agents for big concerns, and also so far the benefits of the "fake" advertisements are incriminating evidence for an arrest, the stories of some of the girls have removed all doubt from his mind, and he is only awaiting an opportunity to make these ventures surfer.

HOUSE OF INDUSTRY.

The regular monthly meeting of the House of Industry took place yesterday, Rev. John Gillespie in the chair. The report for March shows that 12 persons have been admitted and 21 have left. There are at present 132 inmates in the home.

The annual meeting was held immediately after the regular monthly meeting. The reports are not very encouraging from a financial standpoint, but otherwise very successful. During the year 183 persons have been discharged, and 23 have died, which, with the 149 in the home on April 1 makes 355 in the home during the year. The out-of-doors poor records show that in 1227 families assisted there were 646 men, 1182 women, and 1910 children who were helped in various ways. The financial statement shows that the receipts were \$20,500, the expenditure \$24,002, leaving a deficit of \$3,502.

Floral Tributes From All Parts of Canada—Funeral To-Day.

The body of Sir Oliver Mowat lay in state at Government House last night.
