The Spring Court of Oyer and Terminer and General Jail Delivery was opened here on Tuesday the 28d April, the Honorable Justice Parker presiding. The following Grand Jury having been sworn, viz.—

They were addressed by His Honour the Judge, who expressed himself gratified at so full an attendance. He remarked that the offender was free from any criminal case, a circumstance highly creditable to the moral character of the County, and different from what might be expected, when the facilities of eluding justice afforded consequent inducement to crime by its honourable position was considered. His Honour adverted to the agreeable prospect the County now enjoyed of having a new and commodious Court House erected instead of the present ruinous building which was alike dangerous to those who were obliged to attend in it, and injurious to the ends of justice by preventing that long and arduous attention which most cases required.

The docket showed 49 suits for trial, of which number 14 have been tried 10 left for arbitration, and are deferred or in course of trial.

The Grand Jury in accordance with the wishes of the County, drew up a Petition to the three Branches of the Legislature in favour of paying Grand and Petit Jurors; we have procured a copy of that to the House, of which the following is a transcript:—

To the Honorable the House of Assembly of the Province of New Brunswick, in Legislature Session convened:

The Petition of the Foreman and members of the Grand Jury of the County of Charlotte, appointed at the Sitting of the Supreme Court in April, one thousand eight hundred and thirty nine.

**HUMBLY SHEWETH**

That under the conviction that their duty extends to the furtherance of every object which may benefit their County, especially when they feel assured that any such object would likewise prove beneficial as a general measure, to the Province at large, Your Petitioners respectfully approach your Honourable House with a prayer in favour of adequate compensation being provided by law to persons compelled to serve at the several Courts as Grand and Petit Jurors.

That however desirable it may be to assimilate the practice of this Province in this respect to that of England, yet your Petitioners conceive that in this instance an expedient cannot be carried

out; since in England population is dense and wealth abundant whereas in this Colony the inhabitants on the large scale, are widely scattered, and every one has to exert his individual industry to sustain his station in Society.

That of your Petitioners as the present Grand Jury, fifteen reside from twenty to fifty miles from the shire Town; and they have ascertained that in the present Petit Jury there are many cases of similar in-convenience and hardship.

That your Petitioners are persuaded that many persons coming from such distances (under the prevailing scarcity of money, now so severely felt) are not only urged by a desire to bear their part of public duties, but are driven by fear of being fined for dereliction, to hazard their chance of accommodation on their promise of future payment. That in support of this averment, it has come to the knowledge of your Petitioners that seed wheat has been sold to fulfil such promise, and they deem it not irrelevant to observe that it has been shewn to your Honourable House that stock has been sold by a Sheriff to meet the fine imposed upon a Juror whose avocations and indigence prevented his attendance.

That should circumstances conspire to retard applications from the other Counties of the Province, from being presented to your Honourable House in favour of the object which your Petitioners now seek to obtain, they most earnestly desire that the County of Charlotte may be favoured by the enactment of a separate Bill for the purposes herein set forth, convinced that the measure will be productive of salutary consequences which will speedily be sought for throughout the Province.

That your Petitioners confide in the justice and wisdom of your Honourable House to pass a Bill for the payment of Grand and Petit Jurors; and as is duty bound will ever pray.

9. Lady Harvey and the fair of N. Brunswick—They mock the coldness of our climate by the warmth of their affections. (5 times 5, again and again.) *Queen's March.*—On a simultaneous call from the Chair and the Society, Mr. Gray rose, and in a manner highly honorable to himself, and complimentary to the Ladies of New Brunswick, acknowledged the well paid tribute to their beauty and their worth.

*By Mr. Gray*:—Henry Bliss, Esq. the able advocate of our interests at home. In prefaceing this toast, attention was briefly called to Mr. Bliss's former residence in St. John; the high character he had at that time so deservedly gained, and his continued and persevering efforts since his removal from the Province, to promote its welfare. We need hardly say the toast was cordially received.

ented in the arms of victory, but at the same time in the arms of death: monuments have been erected to perpetuate his name in the course of ages, they will crumble and fall to decay, but the memory of Nelson will live for ever in the bosom of his grateful and affectionate Countrymen.—We will if I may be allowed so to express myself, suspend for the present the melancholy pleasure of gazing on that transparency and remove our eyes to the one on the right of the arms where we see the hero of a hundred battles, the conqueror of Napoleon, the great, the noble Arthur Duke of Wellington; the last signal thrown out by the immortal Nelson has been fully borne in mind by the noble Duke, "*England expects every man to do his duty.*" After gaining imperishable honors in the field, his services were required by his sovereign at home, and in the Cabinet he displayed the same ability as a statesman, which he exhibited in the field as a soldier. Sir, as Englishmen, we gladly view the honors with which our Country visit those heroes who distinguish themselves; but sir, we have Civil as well as Naval and Military heroes, who deserve from their countrymen the same distinguished marks of regard and who are as necessary for the support and protection of the Crown—the one I am about to name justly deserves to be ranked as such and classed with a Nelson and a Wellington: I give you sir the great conservative leader of the House of Commons, Sir Robert Peel,—received with long and continued cheering.

**THE ARMY.**—The Hercules, 74, Captain E. Bernard, arrived from Kingston, Jamaica, on Wednesday last after a passage of 24 days, with 1 major, 4 captains, 8 lieutenants, 1 ensign, 1 quartermaster, 1 surgeon, 1 assistant ditto, 51 non-commissioned officers, and 364 privates of the 57th Regiment. On Thursday afternoon they disembarked. At present the appearance of this corps betrays the effects of a service in a noxious climate, but it will no doubt soon recover the bloom of health and vigour in this garrison.

When the Hercules, left Jamaica the frigates Iique and Vernon were daily expected to convey the 8th Regiment back again to Halifax.—*Id.*

LATEST INTELLIGENCE.

From the Observer, April 30. The ship Marchioness of Bute, brought yesterday from Liverpool, papers of that town to the 26th March, three days later than received by the Great Western.
