





SIR,—The accompanying report deals with two hundred and twenty-seven (227) samples purchased as Jam by our inspectors in September, October and November of last year.

These samples are sold, for the most part, simply as Jam or Marmalade; but a considerable number are labelled "compounds" or "mixtures." This is the case with one hundred and three (103) of the samples now reported.

Some ambiguity attaches to the use of the words *Compound* or *Mixture* in the case of Jam. Section 24 of the Adulteration Act provides that adulteration cannot be charged "Where any articles of food not injurious to the health are mixed together as a compound, and sold or offered for sale as such, with each package, roll, parcel or vessel containing such articles distinctly labelled as a mixture in conspicuous characters forming an inseparable part of a general label bearing the name and address of the manufacturer."

This would apparently cover the case where sugar is in whole or part replaced by glucose; or where harmless dyes or preservatives are added to the jam.

By an Order in Council of 17th October, 1912 (published as Circular G. 1044) jam, or marmalade is defined as, "The sound product made from clean, sound, properly matured and prepared fresh fruit, or fruit pulp, and sugar, with or without spices or vinegar, by boiling to a semi-solid consistence; and conforms in name to the fruit used in its preparation."

There can be, of course, no reasonable objection to the use of two or more species of fruit in the preparation of jam; and a jam made from two or more sorts of fruit is recognized as legal, so long as the name under which such a jam is offered for sale distinctly announces the fact of compound character, as to the fruit used. Section 10 of the Order in Council above quoted, is as follows:—"When Jam, Marmalade, Fruit Butter or Jelly contains other fruit or fruit juice than that which gives its special name

to the article, the fact of the presence of such other fruit shall be stated upon the label, in lettering as large and as distinct as that used in naming the fruit principally present. This requirement does not however apply to the use of fruit juice, up to the amount of ten (10) per cent of the weight of the jam, etc., used instead of water in the manufacture of the jam, etc."

This Department has been given to understand that, in the cooking of fruit, it is usual to add a certain proportion (not large) of water. The substitution of a fruit juice (sweet cider, fresh currant, etc., juice) for this water is incontestably an improvement and enhances the value of the jam. For this reason, the manufacturer is not required to declare such addition; but as a matter of business, he will naturally do so.

Certain other additions, or substitutions, in jam-making are not so generally looked upon with approval by the public. Thus, substitution of glucose (corn syrup) for sugar; or the addition of small amounts of saccharin or other sweetening substances, in order to economize sugar, are practices which only become legitimate when the fact is stated upon the label. Section 11 of the Order in Council above referred to, reads:—"When the sugar in preserve, jam, marmalade, fruit-butter or jelly is wholly or partially replaced by glucose or by any other substitute for sugar, the fact of such substitution shall be stated upon the label in plain lettering."

Later than the date of the above Order in Council, it came to the knowledge of the Department that advantage was being taken of permission given to manufacture jams from two or more kinds of fruit, on condition that both sorts of fruits should be named on the label. Apple pulp being so much cheaper than the pulp of strawberries, raspberries, currants, etc., jams made from apples and strawberries, apples and raspberries, and other combinations came upon the market; and inspection showed that, in many of these, the apple predominated to such an extent that it became necessary to add a colouring matter to the jam, if it was to have the appearance of raspberry, or strawberry—and even to add a synthetic (artificial) flavour, in order to give it something of the taste of the smaller fruit. Yet, these jams, although they might contain 80 or 90 per cent of their fruit as apple pulp were labelled in such a way as to claim the strawberry rather than the apple, as a basis

In order to put a stop to this species of sharp practice, amounting to fraud, an Order in Council was passed in August 1913, adding a twelfth section to the Order of October, 1912, as follows: (Circular G. 1080.)

"When Jam, Jelly, Marmalade, etc., are prepared from two or more sorts of fruits, the first named fruit on the label shall be that which is present in largest amount: thus 'a jam made from Strawberries and Apples or Apple Pulp or Apple Jelly, shall be 'labelled as Strawberry and Apple Jelly' if the weight of Strawberries used exceeds the weight of Apples or Apple Pulp or Apple Jelly in the product; where the weight of Apples or Apple Pulp or Apple Jelly exceeds the weight of Strawberries used, the label shall read, 'Apple and Strawberry Jam' or 'Apple Jam flavoured with Strawberries' or otherwise, in such a way as to make clear the fact that Strawberries are not the chief constituent."

The question has been raised: May an article of jam, containing more or less strawberries, raspberries, etc., but largely composed of apple pulp (or the other cheap fruit pulp) be sold as compound strawberry, or compound raspberry jam, under Section 24 (d) of the Act—without specific statement of the different fruits present, as required by Section 10 of the Order in Council of 17th October, 1912?

I am inclined to think that, as the Order in Council derives its authority from the Act (Sec. 26), it is reasonable to give priority of force to the requirements of the Act; although a final decision in this regard, can only emanate from the courts.

A jam may therefore be compound, either as containing other fruit than that which gives its name to the jam; or, as containing substitutes for sugar or the natural colouring matter of the fruit—the artificial colouring matters being, of course, of such a character as to be harmless to health.

Colouring matters.—An Order in Council of 9th January 1915 (published as Circular G. 1167) requires that—with certain specific exceptions, not inclusive of Jam the presence of artificial colouring matters must be declared upon the label, in easily, legible type. Here the question arises: Does the use of the word compound or mixture upon the label, constitute a declaration of the kind required?

It has been the practice of this Department to accept the employment of the word compound or mixture, as covering the presence of harmless colouring matters, as well as of permissible amounts of pre-ervatives. These last are more especially defined by Order in Council of 4th April, 1914 (published as Circular G. 1111), and with exception of Common Salt, Sugar, Saltpetre, Wood Smoke, Vinegar, Acetic Acid, Spices and Alcohol, are required to be named upon the label, when they are present.

Glucose. (Corn Syrup).—It is claimed by many manufacturers that the addition of small amounts of glucose (not exceeding 10 per cent) is actually an improvement in the manufacture of jams. If this be the case, the addition of a small amount of glucose to jam would be of similar nature to the addition of fruit juice used instead of water; a practice which is specifically permitted by Order in Council of 17th October, 1912. If the claim above referred to is established, it might be proper to permit the addition of glucose to jam, without statement of the fact, and within a specified limit, as to the amount. This is a matter to be further studied.

Quantity of Fruit in Mixed Jams.—Reference has already been made to Order in Council of 25th August, 1913, which requires that, in these jams, fruit which is present in largest amount shall give its name to the jam. The quantitative determination of fruits in admixture is often a matter of great difficulty. I have referred to this in Bulletin No. 119, p. 3. Fortunately the cases in which this determination has to be made, are essentially mixtures of apple with strawberries, raspberries, currants. In strawberries and raspberries the number of achenia found serve to fix, with tolerable exactness, the proportion of these fruits present; and the number of seeds in the currant serve the same purpose. It only remains to ascertain within what degree of accuracy the method is applicable to jams; and this will be investigated during the coming fruit season.

It is, however, very questionable whether the public is effectively informed as to the composition of a jam by the order of statement of its component fruits on the label. The designation *Strawberry and Apple Jam*, means that, of the total fruit used in manufacture of the jam strawberry predominates; while a label reading *Apple and Strawberry Jam*, means that a larger amount of apple pulp than of strawberry pulp, has been used. But in neither case is any information of a definite kind furnished. Thus, the first label may mean that 80 per cent of the fruit is strawberry; while the second case may mean that 80 per cent of the fruit is apple. We have indeed, seen jams labelled *Apple and Strawberry*, in which much doubt existed as to whether as much as 10 per cent of the fruit was strawberry. Many complaints have been made by reputable jam makers, to the effect that existing uncertainty as to what constitutes legal jam, and the willingness of unscrupulous manufacturers to put on the market such goods as the present standards permit, has done serious injury to the business. Certain inferences which may be drawn from the present report appear to justify the complaints referred to. Thus, of the total number of jams (227) herein reported, 106 are sold as compound, in the sense that apple constitutes a part and usually the predominant part of the fruit used in their manufacture. In the inspection of 1912 (Bulletin 241), out of 158 samples, only 3 were labelled compound and sold as such. In that of 1909 (Bulletin 194) of 116 samples, only 22 were sold as compound. It is open to question whether the public taste demands a mixed fruit jam to the extent these numbers indicate. Jam has usually been understood to be made essentially of one fruit, and has been sold under the specific name of such fruit. This report shows that jams consisting of a single fruit, and sugar and free from preservatives or colouring, form only 93 samples out of a collection of 227 samples. Of this number 38 are imported jams, only 55 being of domestic manufacture. Even this statement does not correctly indicate the facts, as

regards market samples, for ten (10) samples were supplied, not from the retail market, but by the manufacturer; so that as regards the retail market, this report shows that, out of 83 samples of strictly genuine jam, in the sense of being made with one fruit and sugar only, 38 are imported and only 45 are Canadian made.

This is not because Canada is unable to supply strawberries or raspberries, or other fruit suitable for jam manufacture; and can only be explained in the assumption that mixed jams, in which apple pulp plays a conspicuous part, have largely usurped the market. It is impossible to say whether or not this usurpation is due to the free choice of the consumer, who is incorrectly, or at least, indefinitely informed as to the character of the article offered.

The results of the present inspection may be summarized thus:—
