Rules of the Association.

That the Association be called the DOMINION OF CANADA ARTILLERY ASSOCIATION, and have for its object the development of Gunnery skill, and the dissemination of Artillery knowledge throughout the Dominion of Canada.

2. That the annual subscription for individual members be *two* dollars, which will give the right of voting at any regularly organized meeting, other than a meeting of Council. The donor of *twenty* dollars, in cash, at any one time, or a prize of not less value than *lorty* dollars, to be competed for at a general prize meeting, may be elected a life member.

3. That any Canadian Artillery or Engineer Corps, the Royal Military College Cadets, and the Artillery detachment of the North-West Mounted Police Force, subscribing not less than *ten dollars* per Field and *six dollars* per Garrison Battery, per annum, may become affiliated to this Association, and shall be entitled to a number of memberships in the proportion of one for each two dollars thus subscribed, the officers of each subscribing Battery to select from amongst themselves the person to hold such memberships and return their names and addresses, when selected, to the Secretary, to be registered by him previous to the Annual General Meeting.

4. The affairs of the Association to be managed by a Council to consist of *ex-officio* members and such others as may be elected annually at a General Meeting. The Hon. the Minister of Militia and Defence; the Deputy Minister of Militia and Defence; the Major-General Commanding; the Adjutant-General; the Inspector and Assistant Inspectors of Artillery; the Deputy Adjutant-Generals of Districts, and Brigade Majors; All Officers Commanding, and Regimental Field Officers of Artillery Brigades; Officers Commanding Affiliated Batteries and Engineer Corps; the Director of Stores; the Commandant and Professors (being officers) Royal Military College; Military Secretary to the Governor-General, and President Dominion Rifle Association, shall, if members of the Dominion Artillery Association, be *ex-officio* members of Council. The Secretary and Treasurer shall likewise be *ex-officio* a member of the Council.

5. The Governor General of the Dominion and the Lieutenant-Governors of the Provinces shall be respectfully requested to become Patron and Vice-Patrons, respectively, of the Association; and at any General Meeting of the Association other names may be added to the list of Vice-Patrons.

6. A General Meeting of the Association shall be held annually, on the third Thursday after the meeting of Parliament, to receive the Annual Report of the Secretary and Treasurer, and to transact general business. No alteration of the Rules of the Association shall be made, excepting at such meeting. Twenty-one days' notice of any motion involving such alteration shall be given in writing by the member intending to propose it at the General Meeting to the Secretary, who shall forward it immediately to every member of the Association; and the notice shall be also published in two issues of the *Canadian Militia Gazette* prior to the Annual Meeting of this Association by the Secretary or other person authorized to act on his behalf—so long as such paper is published.

7. The office-bearers shall consist of a President and four Vice-Presidents of the Association, to be elected annually at the Annual General Meeting of the Association, and a President and four Vice-Presidents of Council and a Secretary-Treasurer to be elected annually at the firs' meeting of Council next after the Annual General Meeting. The Council shall have power to fill up vacancies occurring subsequently. There shall be also an Executive Committee to consist of the Inspector and Assistant Inspectors of Artillery, with two officers to be elected by the Council from among its members at the first Meeting of Council after the Annual General Meeting, of which the Inspector of Artillery shall be chairman, to the charge of which Committee shall be entrusted all technical artillery matters and carrying out of annual competitions, appointment of umpires and the arrangement of details in connection therewith, three to form a quorum. The members of the Executive Committee to be eligible to any office and to report to the Council.

8. At all General Meetings of the Association the chair shall be taken by the President, in his absence by the senior Vice-President present, and in the absence of all the Vice-Presidents by the President of Council, and so on. 9. At tions shal shall have

shall be resident resident 9. At all Meetings of Council, five shall form a quorum, all questions shall be decided by the vote of the majority, and the Chairman shall have a casting vote when the members are equal.

10. Ordinary Meetings of Council shall be held on the day previous to, and immediately after the Annual General Meeting.

The Minutes of all Meetings of Council shall be entered in a book kept for that purpose by the Secretary, and open to the inspection of any member of Council.

11. Extraordinary Meetings of Council shall be summoned by the Secretary when required by the President of Council, at such places as the President may direct, either at his own discretion, or upon the request, in writing, of six members of Council, of at least three different corps, duly entitled to vote at such meeting, one of whom shall be a Vice-President, notification being sent to each member of the Council at least fourteen days previous to such meeting, and the requisition for the meeting and the notices to the members must state the object, or objects, of such meetings. Members of Council shall be permitted to send a written vote to the Secretary upon subjects to be discussed at such meetings.

12. All subscriptions, other than through affiliation, to the Association shall become due on or before the 1st May for the current Association year, and the Treasurer shall be required to deposit all sums of money paid over to him on behalf of the Association, in a Savings' Bank.

13. Two Auditors shall be appointed annually to examine the Treasurer's accounts previous to the Annual Meeting.

14. The payment of money for current expenses must be authorized by the President of Council or in his absence by one of the Vice-Presidents, other payments to be made only on authority of Council.

15. The Council shall have the power of establishing such competitions as they may deem advisable. All technical details to be referred to the Executive Committee.

16. An annual report from the Secretary and Treasurer to be submitted to the Council before publication. The Council shall also make a report of the proceedings of the year to the General Association Meeting. 17. All competitions to be closed by the 31st December of each year, and all returns thereof, with list of men entitled to badges, must be sent to the Secretary by the 15th January ensuing the year for which the claim is made.

18. That members of Council, not being life members, must pay the annual subscription to remain as such.

19. That any Commanding Officer of a corps, being a member of Council, unable to attend any meeting of the same, may nominate, in writing, an officer of his own command to attend in his stead, and upon such officer delivering to the Secretary such nomination, he shall be entitled to speak and vote at such Meeting of Council, but any motion made or seconded by him shall be made by him in the name of the member of Council for whom he acts.

20. Whenever an Artillery Association is formed for any of the Provinces of the Dominion, the Secretary sha'l be required to furnish such information from the records in his charge as may be required for the issue of Provincial prizes.

Report of Council.

I. Reports of the Executive Committee and the Secretary-Treasurer, with accounts duly audited, submitted herewith. The Council has pleasure in drawing special attention to these Reports, which show, by the Efficiency Returns of both Field and Garrison Batteries, the continued and increasing good work of the Association.

2. The annual meetings for practice and competition were largely attended by both branches of the Artillery force, and a marked improvement was noticeable in the work done by the different batteries, showing the benefit of such meetings.

3. The Council have much pleasure in reporting that duck suits, promised last year for fifty per cent. of the combined Artillery force, will most probably be issued by the Militia Department this season, as the difficulty of procuring the required material (which caused delay) has been overcome.

4. The Council strongly recommend that the Presidents of the Association, Executive Committee and Council be requested to recommend to the Department the issue of "Morris" or other good armoury practice tubes for the 40-pr. B. L. and 9-pr. M. L. guns, The Council are confident that this issue if granted will greatly assist in improving the efficiency of the Artillery force in the Dominion.

5. The Council are pleased to learn that several batteries have supplied themselves with small arm practice tubes and ammunition at their own expense, for their armouries. The Commanding Officers can testify to the large attendance at these ranges during the entire year, and the marked improvement in the shooting efficiency from this practice. The Council recommend that, in future, the small arm annual practice scores be recorded (as fully as practicable) in the Annual Report of the Association.

6. The Council recommend that in future officers who compete for prizes should be life or annual subscribers of the Association.

7. An extra-ordinary meeting of Council was held in Montreal on the 3rd of December, 1890, to consider protest of Captain Oxley, Halifax Brigade G.A. See minutes of Proceedings. The Council would recommend that the foot notes on examination papers be so worded that no misconstruction of their intentions can be made by any competitor, as seems to have occurred in this case.

8. The position of President of the Association became vacant during the year, owing to the retirement of Major-General Middleton from that position. No steps were taken to fill the vacancy.

9. The Council urgently recommends that a longer period than 12 days' annual drill be allowed Artillery, and that Garrison as well as Field Batteries be drilled each year.

10. The Council desires to express its obligations to the Inspector and Assistant Inspectors of Artillery and their executive staff, also to Commanding Officers of permanent batteries for their assistance and co-operation during the annual meetings, for carrying out practice and general aims of the Association, the chief object being the improvement and efficiency of the artillery force of the Dominion.

EXTRA-ORDINARY MEETINGS OF COUNCIL.

Proceedings of an Extra-ordinary Meeting of Council held in the Drill Hall, City of Montreal, on the 3rd December, 1890, pursuant to notice issued by order of the President of Council, Lieut.-Col. Turnbull, dated 17th November, 1890.

The following members were present : Lieut.-Col. Turnbull (in the chair), Major Cole, Captains Finlayson, Ogilvy, Bissett and Lulham.

In the absence of Captain Donaldson, Captain Maxwell (Montreal Brigade Garrison Artillery) acted as Secretary.

Letter of protest from Captain Oxley, together with covering letter from Lieut.-Col. Curren and memo. of Inspector of Artillery with reference thereto, were read. The following is a copy of Captain Oxley's letter :--

HALIFAX, OCTOBER 18TH, 1890.

SIR,—Having learned from you that the Battery which I command has been beaten in the annual inspection by one point, I would say that if the Battery which has beaten us is Captain Longworth's, and it is due to the result of his examination, I must protest against his marks being allowed to count, inasmuch as he was not present at the inspection, as required by the conditions of the competition.

The following members forwarded their opinions in writing: Lieut.-Cols. Montizambert, Cotton, Macdonald, Armstrong and Moore, Major Lindsay, and Captain Gregor—all of whom were in favor of sustaining the action of the Inspector of Artillery.

On motion of Captain Finlayson, seconded by Captain Ogilvy, it was unanimously decided "That the action of the Inspector of Artillery be sustained, as it was only fair and just that Captain Longworth being absent on duty, his battery should not suffer by such absence."

It was considered advisable, however, and recommended that in future competitions the conditions for guidance of all concerned should be more clearly stated.

Proceedings of an extra-ordinary meeting of Council held in the office of the Inspector of Artillery, Ottawa, on Wednesday, the 8th April, 1891, to consider resolutions proposed by Lieut.-Col. Irwin, providing for selection of a team to be sent to England to compete in the annual matches of the National Artillery Association, Shoeburyness.

Present: Col. Powell, Adjutant-General; Lieut.-Col. Macpherson, Director of Stores; Lieut.-Col. Irwin, Inspector of Artillery; Major John Stewart, Commanding Ottawa Field Battery; Captain J. B. Donaldson.

Written votes and opinions received from fourteen members of Council unable to be present were read and considered.

It was proposed by Major Stewart, seconded by Lieut.-Col. Macpherson:

"That in view of the opinions as expressed by members of Council, and especially by those officers of Garrison Brigades whose corps are most interested in the proposed resolutions, it is not desirable that arrangements be made for sending a team to Shoeburyness this year." Carried unanimously.

In accordance with Rule 11, an extra-ordinary Meeting of Council is requested for the consideration of the subject referred to in the subsequent proposed Resolutions.

(a.) It has been suggested that, in view of the fact that more than four years have elapsed since the last team from the Canadian Artillery was sent to Shoeburyness, it would be advisable that an effort be made to send a team this year, and as a consequence that the Batteries of Garrison Artillery should perform their annual gun practice at local headquarters.

In view, however, of the fact that there is no competition at Shoeburyness for Field Batteries, and that the Annual Government Grant of \$2,000.00 is especially donated for the purpose of sending a team to Shoeburyness, or for the purpose of holding a Garrison Artillery competition at Quebec, for which latter purpose it has been mainly expended during the past four years; and also that the expenses in connection with the Field Battery Practice have hitherto been defrayed by a special grant from the Militia Department, it is now suggested that the team be composed of N. C. officers and men from the Garrison Artillery only, as being those who by their previous instruction and training are most likely to benefit by the valuable experience gained, and to whom, and their corps, such information will be of permanent benefit.

(c.) The total expenses in connection with previous teams have been as follows :

Of these amounts the Government contributed in each case the sum of \$2,000.00, the balance being raised by private subscriptions. Assuming, therefore, that the proposed team will cost about \$3,000.00, it will be necessary to collect \$1,000.00, or at the rate of \$50.00 for each competitor. It is suggested that officers commanding Brigades and Batteries should be held responsible for the collection of not less than this amount.

(d.) The following resolutions are therefore proposed for the consideration of members of Council:—

I. That in anticipation of the usual Government Grant of \$2,000 in aid of a Garrison Artillery Competition at Quebec, or of the expenses in connection with sending a detachment to Shoeburyness, the necessary steps be taken as soon as possible to arrange for the formation of a team to compete at the N. A. Association meeting at Shoeburyness this year.

2. That the Rule with reference to the selection and composition of representatives, passed by Council 18th Feb., 1886, by which the representation of Field and Garrison Batteries was fixed at six of the former and eight of the latter, be rescinded, and that the composition of the team for 1891 be as follows, viz.:

Report of the Executive Committee, 1890.

FIELD ARTILLERY PRACTICE.

I. The practice for this year was carried out on the same general lines as during 1889. The Range-finding practice being advanced to a further stage by the employment of sections, instead of subdivisions, for this purpose, and by other modifications intended to make the practice more thoroughly and practically instructive.

This practice was participated in by fourteen Batteries, the London and Richmond Batteries being the only ones unable to carry it out, the former on account of there being no safe range near the camp, and the latter not having yet drilled for this year.

The published detailed rules for this practice will be found in the Report; they have been generally well observed, and the practice itself has proved to be of increasing value to all concerned. It is proposed to further extend the scope of this practice during the ensuing drill season.

2. The annual competitive gun practice was carried out at Kingston over the same range as the previous year, and was participated in by 27 officers and detachments from twelve Batteries; the Winnipeg and Newcastle Batteries practised at local camps. The Toronto Battery was unable to send a detachment at the time, and have not since made any arrangements for practice at local headquarters.

Both at this practice and at the Range-finding practice of the several Batteries the improved sight was used; unfortunately for its success it was only manufactured in time to be issued in very limited numbers, and only at the time of using, consequently the marksmen were unable to obtain any preliminary practice in its use, and there is no doubt in many cases were rather handicapped in consequence. Subsequent practice carried out by the Royal Schools of Artillery has, however, proved its value as a great improvement upon the old open sight, to which it is an adjunct, and as sights are now issued to all Batteries opportunity will be afforded for practice in its use, 3. The arrangements made for camping, messing, transport, etc., for this meeting, by the executive staff of "A" Battery, under the general directions of the Commandant, were extremely satisfactory, and the only drawback to the entire success of the meeting, as regards its instructional value, is to be found in the arrangements made by some commanding officers, by which the attendance of their detachments at the meeting was limited to the time sufficient for firing only, and it may be noted that the time spent in camp by each detachment appeared to be inversely proportioned to the distance it had to travel to get there.

It is to be hoped that this defect will be remedied next year, and that the duration of stay in camp by each detachment will not be less than twenty-four hours; much benefit will be gained by the marksmen in carefully watching and judging apparent result of fire under different conditions of atmosphere, etc.; a visit to the range to watch the actual effect of fire will be found instructive, and the opportunity of meeting detachments from different localities, or Provinces, is not without its value in strengthening the *esprit de corps* of the Force.

4. In this connection the Executive Committee desire to impress upon commanding officers the necessity of complying in all respects with the directions contained in the circulars relative to this meeting, issued previous to it; much inconvenience and unnecessary expense has been in some instances caused by neglect.

5. Application was made for the supply of a certain number of Morris tubes for issue to Field Batteries, and, it is to be hoped, will be favorably considered.

DRILL AND DRIVING COMPETITION.

6. This competition was well and closely contested by nine Batteries, the average time made by the winning Battery (Durham) being twenty seconds less than that made by the winning Battery the year previous, and the general average of all the Batteries was also much better.

GARRISON ARTILLERY PRACTICE.

7. The practice at local headquarters was this year confined to the Batteries of the British Columbia Brigade, and two Batteries of the New Brunswick Brigade, the Halifax Brigade being, fortunately, enabled to obtain transport for detachments from each of their Batteries.

The practice was participated in by 29 officers and detachments from 24 Batteries, and the general results were very satisfactory. Gun practice on Friday, the last day of the meeting, was unavoidably prevented by unfavorable weather, and the detachments from one of the Levis Batteries and the Cobourg Battery had to wait until Monday morning before being able to complete their practice. The results of the practice of each Battery are elsewhere fully detailed.

SHIFTING ORDNANCE COMPETITIONS.

9. These competitions were entered for by detachments from the Montreal and Prince Edward Island Brigades, and by three detachments from the Halifax Brigade.

The Montreal detachment commenced with the "A" shift, but owing to the sliding of the carriage under the skids when mounting the gun, the latter fell when partly up, and the detachment relinquished the competition. The gun carriage was subsequently found to be decayed and partly broken, and was replaced by another. The detachment claimed the right to perform the "A" shift over again, but it was decided by the Executive Committee that, as their failure was not in any way due to the defective condition of the carriage, another trial could not be allowed, and the detachment subsequently withdrew from the competition for the "B" shift.

Both shifts were afterwards performed in excellent time by the detachment from the Island Brigade.

The Halifax detachments were detailed for these competitions on Friday, 11th; the weather, however, was extremely unfavorable, and the competition was postponed until Saturday morning, which, however, being equally unsuitable, the detachments were obliged to leave camp without competing.

During the following week an application was received by the Executive Committee from Lieut.-Colonel Curren, commanding the Halifax Brigade, for permission to perform the "A" and "B" shifts at local headquarters in competition amongst themselves for the second and third prizes offered by the Association. This application was sanctioned by the Committee on the condition that an officer of the Royal Artillery should act as umpire. The result of this Brigade competition will be found elsewhere.

¥

EFFICIENCY COMPETITIONS.

10. These competitions for both Field and Garrison Artillery have been exceedingly closely contested, the difference between the first and second Batteries in both not exceeding one point, and the total number of marks obtained by the leading Batteries in both competitions showing an extremely creditable state of efficiency.

A protest was received from the officer commanding the Halifax Brigade with reference to the awarding of credits for answers to questions given by an officer subsequently to the inspection of his Battery. As the question involved a decision on general principles somewhat without the lines of action laid down for the Executive Committee, it was referred to the President of Council, and was decided at an extra-ordinary meeting, details of which will be found in the Report of Council.

transport for the detachments of Garrison Artillery attending the annual competitions at Quebec. I would suggest that *one thousand* dollars of this sum be permanently invested as the nucleus of an endowment fund for the Association.

His Excellency the Governor-General, Lord Stanley of Preston, continued his donation of two cups—one each to Field and Garrison Batteries—as first prizes in the general efficiency competitions. The Hon. Honoré Mercier, Premier of the Province of Quebec, and Lieut.-Col. Turnbull, President of the Council of the Association, presented the prizes mentioned in the last Annual Report. The former, a handsome centre piece consisting of two mailed figures, and the latter a silver shield in repoussé work, with gold and oxydised tracings representing squads at gun practice and shifting ordnance. The shield was made by Messrs. Elkington and Sons of London, from designs furnished by the donor. It is suggested that photographs of the above be obtained for presentation to the Batteries holding them for the year as a souvenir of the event.

I regret to have to record the death, which occurred shortly after the last annual meeting, of Major Seeley, New Brunswick Brigade Garrison Artillery, a life member of the Association.

The former system of printing the proceedings of the Annual General Meeting and Meetings of Council at the end of the report, which was omitted in the 1388 report, was reverted to last year as being more satisfactory—the proceedings being thus distributed to members immediately after the meeting, instead of being delayed for twelve months.

A few of the General Orders, referring more particularly to the Artillery branch of the Service, which have been promulgated since the last edition of Regulations and Orders, have been collated and are published with the Report for convenience of reference.

General Orders, 1888-90.

The following extracts from General Orders for years 1888-90 published since last issue of Regulations and Orders—have been collated and are printed here for facility of reference :

General Order No. 2, 13th January, 1888.

No. 5.—FIELD BATTERIES OF ARTILLERY. Annual Allowance, Cleaning Stores, etc.

The following annual allowance of material for care of equipment, etc., is sanctioned and will be applied for by requisition through the District Staff:—

NO. 6.—ARTILLERY STORE LEDGERS.

The attention of Officers commanding Brigades or Batteries is directed to the necessity of keeping these Ledgers at all times properly posted up to date.

The present state of the equipment in all its details, and all additions thereto are to be shewn on the D₁. side, all expenditures from any cause to be noted on the Cr. side. The Ledger accounts are to be balanced on the 31st December, each year, and an abstract thereof on the Annual Store Return, forwarded to the District Staff.

The Ledger is required to be shewn at all inspections either by District Staff or Inspector of Artillery, and the Inspecting Officer is required to satisfy himself, by actual inspection, as to the correctness of the entries therein.

General Order No. 6, 29th March, 1889.

No. 5.—ROYAL SCHOOLS OF MILITARY INSTRUCTION. N. C. O. and Men joining.

Sub-paragraph (3) of paragraph 1055 "Regulations and Orders for the Militia, 1887" is hereby amended by adding after the word "thereof" in fifth line, the words "or the Surgeon or Assistant Surgeon giving the certificate of fitness for service, if such certificate has been subsequently found incorrect." The sub-paragraph as amended will read as follows:

"(3.) If any N. C. Officer or Man who is physically unfit for service, or who cannot read and write fairly, is sent to a school at the public expense, he will not be admitted for instruction, but shall be returned to his corps, and the Commanding Officer thereof, or the Surgeon or Assistant Surgeon giving the certificate of fitness for service, if such certificate has been subsequently found incorrect, will be required to make good the expenses incurred."

General Order No. 11, 14th June, 1889.

NO. I.-ORDERS RELATING TO THE ARTILLERY.

Term "Section" to take the place of that of "Division."

It has been decided that the term "Division" is no longer to be used to denote a part of a battery of Field or Garrison Artillery. The word "Section" will be substituted, but the "sub-division" will continue to be so designated.

Bridoon Bits and Reins.

The following method of carrying bridoon bits by batteries of Field Artillery, whenever bearing reins are worn, is approved and published for the guidance of all concerned:—Bridoon bits will be carried in the horse's mouth; bearing reins of the same pattern as now in use, will be substituted for the bridoon reins, the former will be secured to the rings of the bridoon bits, the centre of them being kept in place by buckling into the wither strap, the reins being passed through the throat lash.

NO. 3.—ARTILLERY STORE LEDGERS.

Adverting to No. 6 of General Orders (2) 13th January, 1888, it is to be understood that the inspections therein referred to, include the half yearly inspections by the District Staff, at which the state and condition of all Artillery Stores, Equipment, Harness, etc, is to be verified by comparison with the entries in the Store Ledger.

In firing Salutes with field guns an interval of ten seconds is to be allowed between the rounds, but should there be fewer than six guns available, no gun is to be fired twice in less than one minute. With cast iron ordnance, when the number of guns will admit of it, there will be an interval of ten seconds between each round, but no gun is to be fired twice in less than two minutes.

General Order No. 9, 11th July, 1890.

NO. 3.-REGULATIONS AND ORDERS FOR THE MILITIA, 1887.

Ammunition.

Paragraph 437 has been amended to read as follows :

437. The annual allowance of ammunition for practice by corps armed with rifles, to be drawn for each man actually effective by Commanding Officers through the Deputy Adjutant General of the District, will be:

- (a.) For city corps armed as above, 40 rounds of ball and 20 rounds of blank.
- (b.) Rural corps armed as above for any year they are trained in a camp of exercise, 20 rounds of ball and 20 rounds of blank to be expended in camp.
- (c.) Rural corps armed as above, not ordered for paid drill in any year, provided the Deputy Adjutant General of the District is satisfied it will be bona fide expended at target practice by each man belonging to the corps, 20 rounds of ball. The words "viz. twenty rounds" at the end of paragraph 430

have been cancelled.

Honours and Salutes.

The following is added as sub-section 4 to paragraph 477:

4 As a general rule no salute will be fired before 8 o'clock in the morning, nor after sunset, nor during the usual hours of Divine Service on Sundays. The same rule will apply to Guards of Honour and Official receptions.

Tents and Blankets.

The following is added as paragraph 745*a*:

745a. Before the corps marches away from the place of encampment, each Commanding Officer of a corps is required to see that all articles of camp equipment received for the use of his corps, during the training, are delivered to the Camp Quartermaster.

Circulars, 1890.

The following circulars were issued during the year :--

No. I.-Field Artillery.

I. It is notified for general information that a correction should be made in the published Efficiency return, by which six points should be deducted from the total gained by No. 2 Battery, 1st Bde., for absentees not satisfactorily accounted for at inspection.

2. Ammunition.—Batteries which perform their Annual Drill in the vicinity of an Artillery Range, will be required to bring into camp, properly packed in the limbers, the following detail of ammunition, to be taken from their reserve, viz:

Requisitions in duplicate for 100 cartridges filled, blank, 1 lb. and to complete the above detail, if necessary, should be forwarded upon the receipt of the orders for Annual Drill.

The common shell when filled, should have a "wad, papier mache G.S." inserted, and the plug screwed home.—Shrapnel shell when filled should have the primer firmly screwed in, and also the fuze-hole plug.

3. *Harnessing*.—Curb chains, or straps, are invariably to be worn with harness bridles—The bridoon bit, attached to the bearing reins, is only to be worn in draught by the off horses, and side rein by the off wheeler.

4. Artillery Store Ledgers.—As some uncertainty exists with regard to the manner in which these are to be kept posted, it is to be understood that the actual numbers of all articles on charge are to be entered on the left hand or Dr. side, together with the numbers of all articles received, in addition, from time to time,—in the latter case, the date and official number of each receipt voucher should be inserted.

All issues, expenditures, losses, etc., should similarly be shewn under their respective headings on the Cr. side, and the Annual Store Return should contain a summary of these transactions for each year. In the case of Batteries which have not received a full equipment of harness, the detail on pages 6 and 7 should only be made out with reference to the number of sets actually on charge.

5. Camping .- As detailed for 1889, viz., guns parked at half interval, tents aligned on the flank guns 30 yards apart, and an interval of 15 yards maintained between adjacent corps.

When it is necessary that the horses should be attached to a picket rope, the latter should be securely made fast not less than 2' 6" from the ground.

Batteries should bring their picket ropes to camp.

6. Accoutrements.—As detailed for 1889, viz:

No. 1, cir. valise on his horse.

Lead driver, " on trail.

" on off wheeler. Wheel "

When marching to and from camp, the drivers' valises will be carried on their own horses, and valises for spare drivers carried on the other horses, and on the trail. Dismounted men whose knapsacks cannot be carried on the gun carriage and limber as directed, will carry their own knapsacks and greatcoats on above occasions.

Batteries not in possession of the regulation number (44) of serviceable knapsacks, should send in their requisitions (in duplicate) without delay, for the required number, or to exchange for serviceable issue, and also, if necessary, for valise straps, 2 per valise.

7. Kit .- It is expected that every N. C. Officer and man will bring to camp with him, packed in his valise or knapsack, the following articles at least, viz., I pair of boots, I pair of socks, I shirt, I towel, I piece of soap, I cloth brush, I boot brush. These articles will be shewn at kit inspection.

With the exception of the Sergt.-Major and Quartermaster Sergeant, who may have one small trunk or valise each, for the conveyance of books, etc., no boxes, trunks, etc., or articles of furniture, are to be brought into camp by any N. C. Officer or man.

8. Credits for Discipline, Camping, etc., will be affected by the manner in which the Battery books, etc., are kept, and the preceding instructions observed.

9. The following corrections should be made in the printed Drill cards recently issued-Changing rounds in action-No. 2 becomes 4; 4, 9; 9, 8; 8, 7; 7, 6; 6, 3; 3, 1; 1, 5; 5, 2.

Annual Gun Practice, 1890-Field Batteries.

GENERAL REGULATIONS.

I. In accordance with G. O. (7), 30-5-90, the following instructions are issued for the Annual Gun Practice of the Field Batteries in the Dominion :—

2. Batteries which perform their drill in camp in the vicinity of which a land or water range can be obtained, will carry out the following instructional practice :

(a.) Range finding by sections.—The entire Battery will parade in drill order, with practice ammunition as detailed in circular No. I, 1890—equally distributed in the limbers, march to the practice ground and will be halted if possible under cover, but at least 100 yards in rear of the firing point—and be ordered to "Prepare for action."

(b.) The target will consist of a barrel or large cask, moored or placed at any distance between 1800 and 2500 yards. A small flag in the target will be found very advantageous. The range party will not signal any of the shells, but will keep a record of the estimated distance from the target at which each shell strikes the plane, or bursts.

(c.) Upon the command "Right (or Left) Section advance for action," the named section will advance at a trot and come into action at the firing points indicated by the Officer Commanding.

(d.) The officer in charge of the section will then give the command to load with shell and state the elevation to be given. When the guns are loaded No. I gives "Take post"—the officer will look over the sights and direct any alteration he may think necessary to be carried out. The officer superintending the practice will give the order to "commence firing." No. I gun will then be fired, and according as the shell is short or over, the elevation of No. 2 gun will be altered so as to ensure the shell falling on the opposite side of the target. Three rounds will be fired from each gun by the first (previously selected) No. I or Layer, according to the rules laid down for finding the long and short brackets. (Annual practice, 1889.)

(e.) Upon the completion of these rounds the section will be ordered to "cease firing," limber up, and retire to the original halting ground, and the other section to advance and go through the same practice and retire.

(f.) The first section will then advance, and fire a second series of three rounds of shell from each gun, taking advantage of the elevation already obtained. These rounds will be laid by the second No. I or selected Layer. The section will then remain at the firing point until the second section has completed its second series.

(g.) The whole battery will then be ordered by the Officer Commanding to fire shrapnel, the fuze being bored at the number of graduations ordered by the officer in charge of each section. The first round will be laid by the first No. I, and the next by the second No. 1, any perly mad order of th

(h.) All the above operations are to be performed with the greatest exactitude and celerity. The time will be taken from the command "Aa.ance for action" until "Take post," and again from "Commence firing" until each series is completed. Each officer should keep a record of the elevation given to each gun of his section and the result of each shot. The yard scale only will be used for elevation. Points for direction will be given by the officer superintending the practice. The only competition sanctioned in the above practice, will be between sections of the same battery. The officer commanding the artillery in camp will make the necessary arrangements for providing targets and for range duties.

3. A general meeting for field artillery competitive practice has been authorized to be held at Kingston during September, under arrangements similar to those authorized in 1889. Detailed information as to dates, transport, messing, etc., will be published subsequently.

4. Revised Rules for Practice have been published and will be strictly adhered to in all artillery competitive practice at Kingston or elsewhere.

5. Officers commanding batteries which practise elsewhere than at Kingston, will make the necessary requisitions for ammunition according to the scale authorized in G. O. without delay.

Field Artillery Competition, Kingston, 16th to 20th Sept., 1890.

Detachments will consist of four officers and eight n. c. o.'s or gunners from all Batteries except those of Winnipeg, Sydney, Newcastle and Woodstock.

Transport will be allowed from Battery Headquarters and return, and also an allowance of 75 cents per day for each day necessarily absent from Battery Headquarters.

Transport can be obtained at single fare by either the C. P. R. or G. T. R. to Kingston and return.

The number of rounds to be expended will be as detailed in G.O. (7) 30th May, 1890.

The range will not be less than 1900 yards.

The Rules for Practice will be those published by the Inspector of Artillery for 1890.

The Officers' Practice will be carried out before the competitive practice of each Battery.

Tents, blankets, camp kettles, firewood and palliasses will be issued on the practice ground by the Camp Quartermaster.

An Officers' Mess will be established, and cooking facilities provided for the n.c.o.'s and gunners.

Rations can be purchased on the ground, and each detachment must make its own cooking arrangements. Each man will be required to bring with him into camp the following articles:—tin plate, cup or canteen, knife, fork and spoon.

Officers and men will be required to contribute at fixed rates to their respective messes.

Officers commanding Batteries will communicate as soon as possible with the Adjutant R. S. Artillery, Kingston, notifying the date of arrival, duration of stay in camp, and number of officers.

Detachments must come to camp in Marching Order.

Transport will be provided from Railway Station, Kingston, to Camp.

The hour each detachment will be required to be at the guns will be notified by the Camp Adjutant in orders. Detachments must be present and complete ten minutes previously, under charge of an officer, who will remain with his detachment during its practice. The officer will hand a list of the competitors to the Umpire.

Detachments to parade in clean fatigue dress.

The Umpire will have full discretionary powers to disqualify any detachment, or to inflict a penalty of from 2 to 5 points for each irregularity or mistake at drill noticed by him.

Gun Practice 1890.

STANDING ORDERS FOR ARTILLERY CAMPS.

I. On arrival at camp the officer in command of detachments will report to the Camp Adjutant, who will detail the tents, stores, etc., to be taken over by the detachments. The general distribution will be two officers to a tent; non-com. officers and gunners, seven or eight to a tent; field officers a tent each. An officers' mess will be established in camp, and rations and cooking arrangements provided for the N. C. officers and gunners. Each man is required to bring with him one tin plate, one cup or canteen, and knife, fork and spoon.

2. All officers and men forming the camp will be liable for any duty that may be required. When detachments are paraded all officers not detailed for special duty will parade and march with their detachments to practice or drill, as the case may be One officer must be present with his detachment during practice.

3. The senior non-com officer or gunner of each tent will be held responsible for the quietness and order of the men under his charge, and for their being present in the tent at Roll Call. He will also be responsible for the general cleanliness of his tent, and will see that the palliasses are properly rolled and appointments securely placed.

4. Officers in charge of detachments will be responsible to the Camp Quartermaster for the tents and stores issued to them Should any of these stores be damaged or missing the regulation price for such damage or loss will be charged to the officer in command.

5. No non-com. officers or gunners are allowed to leave the camp lines unless properly dressed to go out. Officers and men desiring to sleep out of camp must obtain leave of absence.

FIRING REGULATIONS.

9. Every movement must be steadily and correctly performed in strict conformity to regulations; at any deviation therefrom the words "Stand fast" shall be given by the Umpire, who shall point out the error, and when the correction is made the words "Go on" will be given; the time so lost will not be allowed for. Time will be allowed for any unavoidable delay, such as a miss-fire through breaking or fault of friction tube, or anything that is not the fault of the detachment, according to the decision of the Umpire, who shall give the word "Stop." When the word "Commence" is again given, the numbers will proceed with the working of the gun.

10. The full penalty of loss of five points will be incurred for the following, viz:

a. Neglect to use sufficient force to screw up the breech of the 40-pr-gun after loading.

b. When the number whose duty it is to fire the gun, does so before the word "Fire" is given by the No. 1.

c. Sponging out or loading without the vent being properly served. 11. Lots shall be drawn for the order of firing; each No. 1 when he has fired his rounds will take the place of the next number whose turn it is to fire. The officers firing with each detachment will do so before the N. C. officers or gunners commence; and under the same rules.

3. Transport will be provided from local headquarters to Quebec and return, for not more than four detachments from the Halifax and Montreal Brigades, and three detachments from the New Brunswick and Prince Edward Island Brigades, and for not more than one detachment from each other affiliated Battery, the British Columbia Brigade excepted.

4. Each detachment to consist of two officers and seven non-commissioned officers or gunners, and those from Brigades may be composed of representatives selected from the whole Brigade.

5. Subject to the above provisions there will be no objections to detachments being sent from each Battery in a Brigade, but the number of detachments from Brigades will be deducted from the number of Batteries authorized to practice at headquarters.

6. Detailed rules for the above competition will be published subsequently.

7. Officers commanding Brigades and Batteries will make the necessary requisition, in accordance with G.O. 30-5-90, without delay, for ammunition to be used at local headquarters by Batteries which do not intend to send representative detachments to Quebec.

8. Rules for practice, as published by Inspector of Artillery, 1890. Officers' instructional practice will be carried out before the competition firing.

9. Standing orders for Artillery Camps 1889 will remain in force.

1. The prizes and badges granted by the Association for 1890 were competed for by the Cadets of the 2nd and 3rd classes at the end of last term.

2. A travelling bag and a revolver were purchased with the money (\$25.00), the former being awarded to Sergt. Van Tuyl, the latter to Cadet Dumble, as the Cadets of their respective classes most distinguished in Artillery.

3. The badges were awarded for distinction in a "Skill at Arms" competition as detailed below, the subjects forming part of the obligatory course at the College.

4. Marks were awarded for six separate subjects as follows :

5. These prizes and badges are of great value, for they do much to stimulate an ambition among the Cadets to qualify themselves as Artillerists.

6. For next year's competition the interest will be kept up throughout the whole term (September 1890 to June 1891), a contest taking place in each subject as it is completed in the course of instruction. Thus the range finding and judging distance competitions have already been decided (November 1890), with most satisfactory results, which could scarcely have been looked for after so short a course (of only 6 or 8 hours' practice) had it not been for the desire existing among the Cadets to win these honourable distinctions.

Rules for Practice, 1890.

r. At the discretion of the Officer superintending the Practice, two trial shots, common shell with percussion fuze, or solid shot, may be allowed at the commencement of each Battery Competition, or when two or more Batteries are firing together, or when target has been moved to a different locality during a competition.—Trial shots to be laid by the Umpire, on the target, without any deflection and the result signalled.

2. Before commencing, guns to be in action, time fuzes not bored, percussion fuzes may be screwed in, detachment in post at the guns or under cover.

3. Each competitor to prepare and fix his own time fuzes, and to lay his gun without verbal assistance except from the officer in command of his detachment, who may advise the competitor as to length of fuze, elevation, deflection, etc., but who must not look over or correct the laying of the gun.

4. Lots to be drawn for the order of competitive firing, and not divulged until the competitor is called out by the Umpire.

5. The Range Officer is alone responsible for points given for elevation. No appeal.

6. The danger flag will be *hoisted*, and cease firing sounded by the Range Officer when it is necessary to visit the target. When these signals are *repeated* from the Battery and the firing flag lowered, he can visit the target, lowering the danger flag and sounding commence firing when he has returned to a place of safety.

7. The Officer in charge of the marking at the Battery is alone responsible for points given for direction. No appeal.

8. On all other matters the decision of the Officer superintending the practice is final. No appeal.

9. Each competitor may be told the points given for direction, and may also select one of his Battery to judge the effects of his shot and inform him of it, but such assistant must not take up any position in front of that occupied by the guns.

10. On Land Ranges, when the circumstances of the case will permit, or when two or more Batteries are practicing together, telephones may be used for signalling purposes.

11. When the signalling is by flags, and if considered necessary by the Umpire, a *white* flag may be hoisted at the Battery when shrapnel shell are to be fired. If any doubt should arise as to the signalled value of a blind shrapnel a *white* flag is to be hoisted at the Battery, and a repetition of the previous signal called for.

12. At all competitive gun practice, with Field or Garrison Guns, the result of the trial shots, and of the shrapnel shell only, will be signalled at once by the range party.

DRILL AND DRIVING COMPETITIONS

FOR GZOWSKI CUP.

Circular Issued 4th March, 1890.

To be competed for on parade during annual drill by the four sub-divisions of the Battery. The prizes to be awarded to the Batteries performing the conditions in the shortest average time. R

CONDITIONS :

Nine-pounder gun and limber, four horses. Four detachments, each to consist of 1 N.-C. Officer (mounted), 6 Gunners, 2 Drivers. Field day order,—forage caps may be worn.

Harness bits with curb chains or straps are to be used—in very exceptional cases, and with the sanction of the umpire, a bridoon bit may also be used.

Detachments to be in order of march. No. 1 and Driversstand to their horses.

1. Gunners and Drivers prepare to mount. Mount.

2. Forward at a trot. March. Left incline. Left-shouiders. Forward. Left-Shoulders. Forward. Left incline. Halt.

The gun to be taken around two pickets, each 30 yards from the leaders, and 30 yards apart, and back again to original ground.

3. Action-front,

4. Load with drill cartridge and fire one round with friction tube.

5. Cease firing. Rear limber up.

6. Gunners prepare to mount. Mount.

7. Forward at a trot. March. Gun to be taken straight through two pickets, 3 feet high, 40 yards distant, and 6 feet 8 inches apart as soon as 15 yards clear then :—

8. Halt. Action rear.

9. Load with a second drill cartridge and fire one round.

10. Front limber up. Form the order of march. Halt.

Cartridges to be taken separately from the limber box by No. 7. Ammunition not to be carried.

For striking any of the pickets, 5 seconds to be added to the total time.

For any faults or mistakes in drill as judged by Umpire-5 seconds to be added for each.

Umpire's decision to be final. No appeal.

SHIFTING ORDNANCE COMPETITION.

ISLAND OF ORLEANS, QUÉBEC.

There will be Two Competitions (A) and (B).

COMPETITION A.—*Conditions.* Open to one officer or N.C. officer as No. 1, and 18 N. C. officers or gunners, selected from competing detachments of brigades. Independent batteries wishing to enter for this competition will be required to include their firing detachment in that for shifting ordnance.

RULES:—A 32 pr. S. B. gun mounted on common standing carriage standing on centre of ground platform in line of fire, to be dismounted over right side of carriage by parbuckling, taken round by the rear of the platform to the rear of another carriage standing parallel to the former carriage and 18 feet from it, by parbuckling, and mounted up the rear by skids and rollers. Gun to be left in centre of platform in line of fire, shifting stores clear of platform.

Mounting and dismounting to be in accordance with Drill Manual and stores as therein detailed for both operations, pages 228 and 231, sec. V. Part III., Vol. II., Manual of Garrison Artillery, ' 1887.

From two to five seconds may be added to the time at the discretion of the umpire, for each mistake at drill or other irregularity.

Umpire's decision to be final.

Prizes will be awarded to the detachments performing the operations in the shortest total time.

COMPETITION B.—Go as you please. The details of this shift will be made known on the ground.

Report of Annual General Meeting.

Proceedings of an Annual General Meeting held in No. 50 Committee Room, Parliament Buildings, Ottawa, on 21st May, 1891.

Present :--His Excellency Baron Stanley of Preston, Governor General, accompanied by Lieut. Walsh, Grenadier Guards, A.D.C.; Major General Herbert, Commanding the Militia; Colonel Panet, Deputy Minister of Militia; Lt.-Colonel A. A. Stevenson, Lt.-Colonel Macpherson, Director of Stores; Lt.-Colonel Irwin, Inspector of Artillery; Lt.-Colonel McKenzie, Gananoque Field Battery; Lt.-Colonel Smith, A.D.C.; Lt.-Colonel Macdonald, Comdg. 1st Brigade, Field Artillery; Lt.-Colonel Graveley, Lt.-Colonel Prior, A.D.C., M.P.; Major John Stewart, Ottawa Field Battery; Major J. S. Hall, jr., Montreal Field Battery; Major McLean, Durham Field Battery; Captain White, Guelph; Captain McNaughton, Cobourg Garrison Battery; Captain Bliss, Ottawa Field Battery; Lieut. Hurdman, Ottawa Field Battery; Lieut. MacNachtan, Cobourg Garrison Battery; Mr. J. E. Taylor, Mr. J. H. Beattie, and Captain Donaldson, Secretary.

Lt.-Colonel A. A. Stevenson, Senior Vice-President, occupied the chair.

I. The meeting having been called to order, the chairman, Lt.-Colonel A. A. Stevenson, moved, seconded by Major McLean:—"That the Report for 1890 as printed and distributed, be received and taken as read."—Carried.

2. It was then moved by Lt.-Colonel Irwin, Inspector of Artillery, seconded by Lt.-Colonel McKenzie: — "That the Report be adopted, and the accounts as audited be passed."

Lt.-Colonel Irwin, in moving the adoption of the Report, said he had much pleasure in stating that the proceedings during the past year had been the most successful in the annals of the Association. The meeting at the Island of Orleans for Garrison Artillery, as well as that at Kingston for Field Batteries, had been conducted with remarkable success, there having been a marked absence of protest or disagreement of any kind. The D. A. A. differed from the Dominion Rifle Association, its scope being wider than the mere encouragement of gun practice, one most important function being the promotion of

the general efficiency of the Artillery. The most interesting competition which took place during the year was that for general efficiency, which had been very much encouraged by the kind donation of cups from the successive Governors General. This competition has been productive of the best results, there being much wholesome emulation between the batteries. There was a satisfactory balance on hand, which properly speaking, was larger than it ought to have been. It was mainly attributable to the fact that the amount granted by the Government for the Garrison Artillery competition at the Island of Orleans, or as an alternative to defray the cost of sending a team to compete at Shoeburyness, had not been altogether expended on the former. It was considered that the benefits accruing from the competition at the Island of Orleans were so great that it would not be advisable to send a few men from each Brigade to Shoeburyness. The opinion had also been expressed in some quarters that as the expense of sending a team to England would amount to a thousand dollars more than the Government grant, the officers would incur a very heavy expenditure which they were not disposed to undertake. It was possible, however, that in a few years they might be able to send over a team altogether at the expense of the Government, or else invite representatives from the Imperial Volunteer Artillery to compete in this country. The motion was carried unanimously.

3. Lt-Colonel Macdonald moved, seconded by Major Stewart:— "That the thanks of this Association be tendered His Excellency the Governor General for his attendance at this meeting, for his great interest in the Association, and for the valuable prizes for general efficiency donated by him." The motion was carried unanimously, the members rising.

His Excellency returned thanks for the kindness and cordiality extended to him whenever he attended the meetings of the Association. He expressed satisfaction at having been able to attend not only the business meeting here but also the Garrison practice at the Island of Orleans, and the hope that this year he would be able to visit the Field Artillery meeting at Kingston. He was very glad to be able to corroborate what had fallen from other officers in regard to the great value of the practice carried out at the Island of Orleans. He had not the same professional acquirements as other officers and therefore could not speak with the same force, but he could say that the camp, whenever he had seen it, always looked as if it meant business. He alluded to the fact that whilst at the Island last year he witnessed a detachment, who had no 1st 1 B yea

of t wh do previous acquaintance with the 40-pr. gun, drilling with these guns while the practice with the 64-pr. was in progress, in order to be able to take part in the competition shortly afterwards. This showed that if you put weapons within men's reach how willing they were to use them (applause). Last summer he was at Halifax and had the opportunity of seeing, he believed, the only modern gun at present in use for drill in the force. Sir John Ross, who commands Her Majesty's troops at Halifax, had, he believed, on all occasions given the utmost encouragement to the Dominion Artillery force. It was Sir John's desire that Her Majesty's forces of all descriptions should be trained as closely together as possible, and he was only too willing to assist in enabling the Canadian Militia to drill with the Imperial forces now in Halifax (applause). In conclusion he hoped the Association would long continue to flourish.

His Excellency then presented Lt.-Colonel Macdonald, comdg. 1st Brigade, Field Artillery, with the handsome silver cup won by No. 1 Battery of his Brigade in the competition for general efficiency last year.

4. It was then moved by Major Hall, and seconded by Captain McNaughton:—"That the thanks of the Association are due and are hereby tendered to the Hon. Sir A. P. Caron, Minister of Militia, and to Parliament for the annual grant in aid of the funds of the Association."—Carried unanimously.

Colonel Panet returned thanks on behalf of the Minister, and announced that he had been authorised to make arrangements for the importation of a few Morris tubes, and he hoped they would shortly be at the disposal of the Militia. He also stated that satisfactory arrangements had been made for the manufacture of common shells at the cartridge factory, Quebec, and in a few weeks he thought the Department would be able to turn out shells, both 64 and 9-pr., for the practice of the force.

Major General Herbert,

Hon. Honoré Mercier,

Lt.-Colonel T. T. Turnbull."-Carried unanimously.

In reply Major General Herbert promised to advance the interests of the force to the best of his ability, and went on to remark : Nobody, whether a trained artillerist or not, can fail to appreciate the tremendous importance of artillery in every military operation. That impor-

tance is increasing d y by day, and I think that we have not as yet reached by any means the full limit of its development. It has been a very interesting subject to me-although I am not a trained artilleryman, and have not had the technical training of many of the gentlemen before me-in the position I occupied before coming here to study the views taken by other countries on this very important subject, and any little experience I may have gained in that manner I shall be most happy to place at the disposal of the Association. I think I may say that the development of artillery at the present moment is in two extremes. We have on the one side the monsters represented by the 100 ton guns, going down in a gradual scale to the siege guns. On the other hand we have the new development of quick firing guns with immense initial velocity. It is in that direction that I expect to see the most valuable advance made in artillery science. I think, myself, that we have almost reached the limit in the monster guns, and that now the smaller weapons, with powerful explosives, will come to the front. We can have no opportunity of experimenting in this country, but I think we can, to the best of our ability, follow the movements that are taking place in other countries, and when we see that certain facts are established, go to our Government and ask them if they cannot find means of enabling us to obtain such improvements as have become evidently necessary in the progress of artillery science.

ELECTION OF OFFICERS.

His Excellency then moved "that Lt.-Colonel A. A. Stevenson be elected President of the Association for the ensuing year." In doing so he said he "felt sure that the choice was one that would commend itself to all of them."

Major General Herbert, in seconding the motion, spoke of the great service that Lt.-Colonel Stevenson had rendered. His battery was one of which the Dominion might justly feel proud. Last week he was fortunate in seeing the battery in the drill shed at Montreal, and he could only say he had never seen any force of the kind so perfectly turned out (applause). There was evidence everywhere of the tender solicitude, he might say, for the welfare of the battery. Everything was done that one could wish for to make it as perfect as possible. From what he saw of the drill of the battery he felt that the non-commissioned officers and men were animated by the same spirit, and used their utmost endeavour to be worthy of their commanding officer. He regretted that Lt.-Colonel Stevenson no longer comwas and him eventhe the

Montreal Brigade, G.A." Carried.

Lt.-Colonel Macdonald moved, seconded by Major Stewart:— "That the thanks of the Association are due and hereby tendered to Lt.-Colonel Macpherson and F. E. Knight, Esq., for their services as auditors during the past year, and that they be re-elected." Carried.

7. It was moved by Lt.-Colonel Irwin, and seconded by Lt.-Colonel Prior:—" That Lt.-Colonel Stevenson and Captain McCrae be elected Members of Council." Carried.

8. It was moved by Captain Donaldson, seconded by Lt.-Colonel Irwin :—" That the thanks of the Association are due and hereby tendered to Hon. Honoré Mercier and Lt.-Colonel Turnbull for the handsome prizes donated by them for competition, and to the Hamilton Powder Co., through the President, Dr. Brainerd, for the continuance of the donation of *one hundred* dollars towards the funds of the Association." Carried.

His Excellency the Governor General, seconned by Major General Herbert, moved :—"That the thanks of the meeting be tendered the President for his conduct in the chair at this meeting." Carried unanimously.
