THE SUNDAY SCHOOL.

Annual Meeting of the Westmorland County Association.

A correspondent writes: The Sunday School Association of Westmorland Co. opened its annual convention in the Baptist church at Steeves' Settlement July 9th at 2.30. The church was well filled, President Frites in the chair. This was an inspiring half hour of Bible reading, interspersed by prayer and song. S. C. W. Chapman was chosen minute secretary. The president's address was on the great work for which all were met, but did not report his own activities in the work during the year. The next address was by Field Secretary Lucas, who dealt with the principles, methods and beneficial result of association work.

County Secretary R. D. Ward being unable to be present, his report was read by Mr. Lucas. Committees were appointed, and Charles E. Knapp spoke on the means of improving Sunday school work. Another member spoke on some points of importance in the mission of the Sunday school. This was definite instruction to church members and the workers in Sunday school.

The evening opened with a brief praise service, chery song and Scripture testimony. Mr. Lucas spoke on the Responsibilities of Sunday School Superintendents and Some Qualifications which Each May Teach Amos O. Blesia, formerly of Steeves' Settlement, now of the Fredericton city schools, gave a suggestive address on The Sunday School Teachers. Geo. J. Oulton, principal of Moncton schools, expounded the home department work, of which he has been county superintendent. The third session opened at 8.30 a. m. on the 10th with a Bible reading on the teacher's personal life. The people read the passage put on the black-board and the leader, Rev. Mr. Lucas, emphasized their teachings.

The strong point of this session was an excellent paper by Mrs. Hutchinson, wife of Rev. D. Hutchinson, Moncton, on The Importance and Methods of Temperance Army Work in Sunday School. This was followed by a conference in which many seemed interested. Frank Steeves opened a conference on Sunday school literary work. Several shared in this. A work-er's conference, led by Mr. Lucas, was a vigorous and full of practical question and answer. The president found it difficult to limit the session to its time.

A vacancy on the programme made by the absence of Mrs. Enman of Moncton was effectively filled by Miss Ada Lutz of Steeves' Settlement. President Frites read a forcible article on a closely connected subject. Rev. Mr. Hamilton addressed the conversion, representing the provincial executive and dealing with normal work and finances.

Rev. Mr. Ross of Moncton, followed on "How Should Parents Co-operate in B. S. Work?"

Rev. Wm. Harrison of Dorchester, in a vigorous speech endorsed the prime idea of Mr. Ross's address. This was vigorously combated by Rev. D. Hutchinson of Moncton, who could not accept such teaching. The children, he affirmed, are not in the kingdom. To be so, they must be converted. He would not expect a scene in a child's conversion like that in the case of Saul of Tarsus; he remembered that Jesus said to Nicodemus — not to Magdalene — "Ye must be born again."

The devotion exercises of the evening session were led by Rev. Wm. Hamilton and participated in by Messrs. Oulton, Knapp, Rev. Mr. Ross and the president. Mr. Hamilton in a brief address introduced the children, and was fittingly responded to by Mr. Frites, who for the fourth year in succession has been elected president. Rev. Mr. Hutchinson then delivered a telling address upon "What ought the church to expect from the Sunday schools?" He arranged what he said so well under the following four answers: 1-Constant additions to her membership. 2-Attendance at the church services. 3-Intelligent and appreciative hearers. 4-Eminent persons for officers.

Rev. Wm. Harrison followed in an impressive and pathetic discussion of "What should the convention, church and Sunday school do to bring best results?" He was delighted to be present.

Further Reports from the Rectors of Parishes.

Reports Submitted by Canon Richardson and Dean Partridge—Will

Meet at Fredericton Next Year.

WOODSTOCK, July 7.—At this evening's session of the Synod the time was taken up with the reports from the various parishes, which are synopsized as follows:

Andover—Rev. Mr. Bedell read the report from the parish of Andover. He is in charge of four churches. There are now two Sunday schools one at Andover with five teachers and 30 scholars, and at Four Falls one with two teachers and 23 scholars. A new pipe organ was placed in Trinity church, Andover, and is all paid for. The treasurer's report shows a small surplus.

Eastport—Rev. J. Hugh Hooper reported progress during the past year. Forthnightly services were held up at Tatamagouche and Salmon Beach. Steps were taken to clear up financial debt, and repairs have been made on the churches. At a tea given in Eastport, \$150 was raised. Hooper collected all bills there was a balance of some \$75. The church at Salmon Beach has not yet been completed, but is pretty well advanced towards completion. There is a credit balance to the parish of some \$214. The parish has become self-supporting. There is a movement on foot for the building of a church hall. Sixteen persons were confirmed during the year. New Bandon has a church population of 52 families and 40 communicants. It is possible should be ministered to.

Ladlow and Blissfield—Rev. H. Montgomery reported that 941 persons have been baptized during the past fifteen years.

Burton—Rev. H. E. Dibblee reported that there were 98 actual communicants and 11 candidates were confirmed. Financial report shows a credit balance of \$150. A considerable increase.

Blissfield and Gladstone reported healthful progress. During the year there had been four adult baptisms. A small mission church has been erected near Hoyt Station, and will soon be ready for consecration.

Ladlow and Blissfield—Mr. Durban, lay reader, reported as to his work in this mission. He reported good congregations and a thriving Sunday school at Blackville. This school is a field for good active work. The churches are entirely free of debt.

Cambridge—Mr. Scoville said that the people have shown great interest in the services, and the people, though few, are thoroughly enthusiastic. He hoped to present several candidates for confirmation.

Cathedral—Dean Partridge reported excellent work done by Rev. Mr. Bedell before he left. The Sunday school services, now connected with the Cathedral, were greatly appreciated. The Jubilee of the Cathedral will be held on the 20th of August.

Chatham—Van. Archdeacon Forsyth: All usual services have been held without interruption. Congregations good. Offerings for various local objects being the same as those of previous year. The envelope system has been extended; \$150 was contributed towards the maintenance of King's College, Windsor. The average weekly contribution has been some \$30 for local purposes. An effort is now being made to increase the number of communicants. The shutting up of a large industry and the removal of important families have made it probable that the contributions to diocesan needs will be smaller than usual.

Dalhousie—Rev. C. H. Fullerton reported general progress. The parish church had been entirely repaired. Canon Roberts reported 32 confirmations and as many communicants as last year.

Gagetown—Rev. Mr. Spencer said that the parish church had been entirely repaired. The number of communicants remains about the same. Sunday school work is actively carried on. There is an increase in the number of communicants and the teachers are exceedingly active. The rectory is to be repaired, and work is being carried on in the way of renovation of the church fabric. There are 14 members of the Women's Aid, who are doing most effective work.

New Denmark—Rev. C. Malmann spoke of the good progress of the Danish colony during 30 years. There were over 200 people. It has taken new people to come to understand the Church of England, with which the Deans connected themselves.

There is a communicant here of 70. Many of the young men leave the colony, which is a loss. Some young people who go away send offerings. Last Easter the offering was \$80, and Danes from outside contributed \$60. Repairs have been made to St. Anne's Church. He advised that the young people should all learn the English language. He used it now in the Sunday school, and had found it to work well. The obligations to the home missions have been met in full. Greenwich—Rev. Mr. Cody said 19 candidates were confirmed during the year. A new church at Spike settlement is almost completed, and it is hoped will be ready for consecration in the fall. The work of the Sunday school is most encouraging.

Hillsborough—Rev. A. Smithers said missionary work of Albert county the work of reconstruction is being pushed forward, and new work is being done with whom he came in contact. The mission met with a severe loss in the death of Thos. Wm. Church, who did so much for the work of the church at River View. Fifty persons communicated last Easter, just fifty more than when he began this new work five years ago.

Johnston—Rev. Mr. Warneford: During the year the church at Bagdad was painted and it is hoped the interior will be soon improved. Twelve or more candidates will be presented for confirmation at Kingsclear. Rev. Montgomery reported a most successful year, the best year in the

of offerings in the history of the parish. Kingston—Rev. Mr. Wainwright said that a new congregation had been opened up at Ferry's Point. The exterior of Trinity Church has been painted. Some valuable gifts have been made to All Saints Church. Improvements were also made in St. James' Chapel.

McAdam—Rev. H. M. Spilke's report was read by H. F. Perkins: Had 25 communicants at Easter. Women's aid societies were energetically for the success of the church. The church's debt was reduced by \$250, and all current expenses were paid.

Moncton—Rev. B. Hooper reported progress all along the line. Illness necessitated his taking a rest, but was now well again and expected to have a satisfactory report for next year.

Musquash—Rev. F. W. Bacon: There were all signs of progress when the calamities of the summer had passed. The people were cast in great distress. The rectory was burned. Since the fire there had been many generous contributions. Over \$1,000 for rebuilding the church. \$500 being given by James Robertson of St. John.

Derbyshire—Rev. L. A. Wood reported increased work in the parish. Younger members were confirmed during the year. A boys' guild was established open to all boys whether of the church or not. The church's work among the young. One hundred and seventy-six dollars would be contributed to the objects of the year. Nelson—Rev. T. H. Cuthbert made a brief and satisfactory report, which was read by Rev. Canon Newnham.

Newcastle—Reported by Rev. G. H. Huthbert: There had been improvements in the church and rectory. A beautiful pulpit hanging had been presented to the church by Mrs. Lee Street in memory of her husband, who had been church warden.

The families—The report said that the families of the parish were earnest in their support of the work in this mission. Norton—Rev. C. P. Hanington said that over 20 persons had been confirmed by the bishop; \$50 had been contributed to outside objects, and it was well to discuss the mission work. Prince William—Rev. Mr. Fullerton reported the Sunday school at Prince William had had a very successful year. The rectory at Dumfries was the service of the best appointed church rectories in the diocese.

Sackville—Rev. C. F. Wiggins: The Bishop visited parish, when 32 persons were confirmed. Communicants list, though much reduced, and there is always a balance on hand at the end of the year; \$300 was contributed to the diocese. Sunday school work has been faithfully carried out. Ninety persons were confirmed during the past year. A beautiful font has been presented to the parish by the Sunday school scholars in memory of Mrs. Mary Albin.

St. David's—Rev. Mr. Millidge reported progress, showing that he was going excellently in his parish. St. James' (St. John)—Rev. A. L. A. Dewdney deplored the tendency to use the Lord's Day for amusement. The fabric of the church has been greatly improved, particularly by the placing of a fine stained glass window, representing Christ knocking at the door, a memorial gift by Mr. and Mrs. P. A. Dibblee in memory of Mrs. Ivory Murray.

St. Mark's (St. John) reported that a great interest had been taken in mission work. Trinity reported excellent progress; communicants increased and a large increase in funds. St. Mary's—Rev. Dr. Raymond showed signs of progress and encouragement in the diocese.

St. Paul's—Rev. A. G. H. Dicker said that the 60th anniversary of the parish was celebrated last year. The Easter offering was \$70. A new offering of \$150 was raised as an offering for the poor.

St. Stephen—Rev. Canon Newnham reported no falling off in contributions or in church attendance, and a most encouraging outlook in the parish generally.

Upham—Rev. Mr. Bate reported quite steady and effectual work.

WOODSTOCK, July 8.—After the report of the Synod this morning, the Rev. Norman Tucker addressed the Synod in a most interesting address. He said that the church in this diocese was in a most promising condition. The financial outlook of King's was excellent. There were plenty of obsolete canons and there would be no harm in the time of the Synod to strike them off the books. Every baptized member of the church was a member of the Society of St. Vincent de Paul.

Seventy-five thousand dollars were asked for the entire mission work. The Diocese of Fredericton was asked to contribute \$10,000. The Diocese of Quebec had raised its contribution for the year from \$3,000 to \$5,000, and other dioceses had done splendidly. While the budget for the sum they were called on to raise, at first, when the people had been informed of the object and intelligently appealed to, they had risen to the occasion. He suggested that the amount be set apart in the maritime provinces, where the missionary society had been in conflict with the hierarchy of the other provinces. He suggested that Rev. S. Weston, Jones, rector of Windsor, N. S., was invited to a seat on the Synod.

The Synod then took up the report of the nominating committee. Corrections were made in the list submitted to the Synod this morning. The standing committee for Sunday schools was the name of Rev. H. Montgomery was suggested for Rev. H. E. Dibblee, Rev. B. Hooper, Rev. Scoville Neale, Rev. E. J. Wood. On the board of education committee A. H. Hanington was nominated. Dr. H. H. Huthbert, W. M. Jarvis, T. B. Robinson nominated Wm. M. Jarvis. The result of the vote was in favor of the Rev. Canon Richardson, A. G. H. Dicker, Chancelor Allen and Justice Hanington were elected. On the committee on constitution and canons Rev. W. O. Raymond moved that Canon Newnham's name be substituted for his own.—Motion carried.

On the committee of statistics, Hon. Mr. Sharpe's name was substituted for W. M. Jarvis, and Rev. S. A. Hoyt's name was added.

The report of the Board of Diocesan Missions showed an estimated deficiency of \$3,000, which will be reduced by a balance of the contingency fund of \$1,000.

Rev. D. A. Dewdney moved the adoption of the report of the standing committee on Sunday schools. The committee on Sunday schools, the appointment of Rev. Mr. Montgomery as permanent secretary. It also recommended a system of more complete organization.

Dean Partridge moved the adoption of the report of the governors of King's College, which was carried without debate.

Archdeacon Neales moved that a committee be appointed to take into consideration the establishment of a divinity school in Fredericton. He claimed that a canon had been passed so many years providing for such an institution. It would be well for the Synod to consider whether this canon should remain in force, or be put into effect or be expunged. He traced at some length the history of the canon. He himself was personally interested one way or another to the decision of the Synod. He read an opinion by the late Bishop of England most of the clergy he found were in debt. It was at his suggestion that a sum was advanced to every clergyman going into the work. When he was paid back without interest, when the bishop began his work in life he had a salary of

4564 a year, and did not get in debt. He had been in favor of the system of deferred annuity on the ground that the young clergy would start on an equal basis.—The motion was lost.

This evening a full church service was held in St. Luke's Church, which was filled with a large congregation. The choir and clergy robed and walked in procession to the church. The service was intoned by Rev. Mr. Dicker, assisted by the surplined choir, which had well practiced for the occasion. The sermon was preached by Rev. L. Tucker and was an eloquent and able effort.

WOODSTOCK, N. B., July 9.—The third day of the Synod meeting began with holy communion at 8 o'clock. At ten o'clock the regular synod proceedings opened.

Rev. A. B. Murray reported for St. Andrew's, St. John's, and St. Paul's, five persons having been confirmed.

Bay Du Vin reported through Rector G. W. Wilnot. Repairs have been made to the rectory. Bishop Kingdon confirmed nineteen persons in this parish.

Canon Richardson reported for the committee appointed to bring the claims of the Women's Auxiliary before the attention of the Synod.
