Russia and the Vatican.

ROME, May 8. - The Russian Government has advised the Pope of its intention to establish a regular legation at the Vatican. The Czarewitch Going to England. ST. PETERSBURG, May 8.-It is reported that the Czarewitch will visit shortly the British court and meet the Princess Alix of Hess, to whom he is betrothed.

The Canada-Ulster Steamer Line.

DUBLIN, May 8 .- The Irish Times an. nounces that the Uister Steamship Company is about to commence direct steamship communication between Canada and Dublin. The first steamship in this trade will leave Montreal on June 15 next. She is the Teelin Head, of 1,071 tons register.

British Cabinet Meeting. London, May 8.—The Cabinet meeting to-day was to discuss the situation of the Government. The budget proposals are meeting with serious opposition, and the Government's position is said to be very

unstable. The Conservatives assert that while the budget may pass the second reading, that it will not be carried through the committee stage.

PARIS, May 8 .- In the Chamber of Deputies to-day Premier Casimier Perriere demanded a vote of confidence on the question of prosecution of M. Soussaint. He declared he would regard the rejection of the Government's proposal to prosecute as an encouragement to Socialists and an insult to the authorities. A vote was taken, with the result that the Government was sustained-291 to 220.

Cut in Steerage Rates.

LONDON, May 8.—The International were not fired upon. The Roumanians Navigation Company (American Line) will still hold their position and the troops are hereafter take steerage passengers from London to New York for 50 shillings, and from Liverpool and Queenstown via Southampton for 60 shillings. These reductions are made to meet the cut in passage rates of the continental steamship lines from Hamburg and other ports to 50

New Order Respecting Canadian Cattle.

London, May 6 .- The Official Gazette publishesan order directing that Canadian cattle imported to England be marked at the ports of arrival and that they be isolated and killed at special abbatoirs. The carcasses of such cattle are not to be removed without the permission of the inspector of the board of husbandry. In addition the lungs of these cattle are not to be touched until examined by the inspectors. The order goes into force on May 15. Canada and the British Customs Act.

LONDON, May 8. - In the House of Commons to-day Mr. Sydney Buxton, Under Colonial Secretary, in reply to C. E. H. Vincent, said that Canada and other British colonies has asked the Government to amend the Customs Act of 1873, with a view of enabling the colonies to conclude preferential arrangements with one another. The Government, he said, was considering the matter, but had not yet decided whether it was best to accede to the

Paris an Socialists.

PARIS, May 8 .- The Socialist deputies issued this evening a manifesto which is intended to be an answer to the Chambers vote this afternoon. The manifesto says: "The intimidation attempted by the Government will not make us flinch. We shall do our duty and send our delegates to the Trignac works and elsewhere to follow the example of Comrade Toussaint. Deputies Baudin, Toussaint, Vaillaint and Miller, of the Socialist party, have started for Trignac. A Socialist demonstration is being arranged by the Paris Socialists for next

A Big Catholic Gathering.

LONDON, May 8 .- The meeting of Roman Catholics, over which Archishop Vaughan presided at St. James' Hall last week, offered several points of novelty. Cardinal Newman, while still an Anglican at Oxford, expressed great horror of the Irish Catholics because they imitated the low ways of popular religions —had teas in chapels and festivals aboard steamers-but he himself lived to preside over teas of Roman Catholics at Birmingham, and Archbishop Vaughan has contrived a variety entertainment in St. James' Hall without any taint of vulgarity. The audience was a paying one, the proceeds benefiting the Catholic society, and the company, living up to the occasion, included all sorts and conditions of men and women, from duke to an under - housemaid. Mme. Albani, who good-naturedly submitted to an encore, had a unique experience, for Archbishop Vaughan arose in all his red to offer his arm as she left the platform, making a new precedent in the annals of cardinalitial procedure, and one which the audience delightedly cheered.

An Exciting Trial. BUDA-PESTH, May 8 .- The opening of the trial on a charge of treason of 23 members of the executive committee of the Roumanian National party in Hungary at Klausenburg yesterday was attended with great excitement. The indictment against the men charges them with causing the publication of a document in several languages, and widely distributing the same, denouncing the act of union of Austria and Hungary. The circular also declares that the union of Transylvania with Hungary unjustly deprived the former of its autonomy. The beginning of the trial of these men was made the occasion of a monster demonstration of sympathy. Thirty thousand Roumanians assembled outside the town yesterday awaiting the word from their leaders to march into the town and protest against the prosecution of their compatriots. Three squadrons of hussars and three regiments of infantry were assigned to positions where they could guard all roads which would give the assemblage were commanded to disperse. This command was not obeyed, but as the crowds made no attempt to enter the town they

ORLEANS, France, May 8 .- A large number of American and English visitors have arrived here in order to take part in the Joan of Arc celebrations. Many wreaths were placed yesterday upon the statue crected in honor of the Maid of Orleans. To-day three by two and one-half inches pressing is the anniversary of the day upon which Joan of Arc succeeded, in 1429, in raising the seige of Orleans. Dr. Williams and Dr. Lucas, who made the post mortem examination, gave evidence as to the cause of death. They found only one wound, on the left side of the head, a little behind, and also a swelling below the jaw. There was a large cut of the brain. This wound was undoubtedly the cause of death.

The other witnesses examined were Everett, who, with Mitchell and McDermott he deceased, were the leaders of the "roc ing gang." Everett said he was within five feet of deceased when he was struck and fell, but could not say how or who struck him. The other members of the gang were Alex. McCaskill, Geo. Bell, Joseph McGrath and Joseph McSherry, who are from 12 to 19 years of age, and went up with the other three more as hangers-on to see the fun than as partici-

The jury retired about 1 o'clock, and after two hours and a half returned with the following verdict:

"We find that the deceased received injuries which caused his death through being hit by a stone, but by whom the stone was thrown the evidence does not show. We also find that the parties who went with the express purpose of breaking the law are accessories before the fact".

It was sworn in evidence that Allward, the prisoner, had been hit three times, one of the stones knocking off his hat. When he stooped to pick it up he found the stone and threw it, which, he said, did not strike the ground, and he had seen someone fall.

THE WILSON TARIFF.

House Democrats Not Pleased With the Senate's Changes.

WASHINGTON, D. C., May 8. - The changes made in the Senate committee on the tariff bill are not acceptable to the House. The Democratic members of the ways and means committee who framed the Wilson Tariff Bill and other leading representatives do not conceal their disappointment that the House measure should have been so materially modified. A general canvass of the House to-day disclosed no intention on the part of the Democrats to resist the Senate changes in an arbitrary spirit, but it developed the fact that the House Democrats generally were entirely satisfied with the bill as it went to the Senate and no attempt was made to conceal their regret that it should not have been returned to them in practically its original shape.

Wheat Dirt Cheap.

CHICAGO, May 8 .- The steady depreciation in prices of wheat resulted in the cereal touching the lowest point in the history of the trade to-day-56ge for May and 58te for July. There was no excitement accompanying the decline, and at the bottom the market showed recuperative above the low point.

Trial of Coxey, Browne and Jones Concluded.

DARING DYNAMITERS.

Convicts Attempt to Blow Up the Michigan State Prison.

JACKSON, Mich., May 8 .- An attempt was made last night to blow up the prison with dynamite. As the convicts who are locked in the new west cell block were being marched to their cells from an evening meeting, three of them - Edward Huntley, serving a term of twenty years for burglary, John Deeman, serving fifteen years for murder in the second degree, and Arthur Lawrence, serving fifteen years for burglary-made a break from the ranks. One of them seized the guard and another sprang up into a window and attempted to light a fuse connecting with a dynamite bomb. An alarm was given and deputies arrived in time to prevent any damage and to quell the disturbance.

MURDER WILL OUT.

Husband Arrested After Twenty-Seven Years of Immunity-Wife and Child Killed.

YREKA, Cala., May 9 .- This town is intensely excited over the arrest near here of George Dicker, one of the richest and most prominent citizens of Siskiyou county, for the murder of his wife and child 27 years ago. Last week a sheep herder in the hills near this town found the bones of a woman and child in a cave. Investigation showed that the woman's skull had been cloven and that the child was a nursing babe, as its jawbones were toothless. Detectives were put on the case and they unearthed a chain of evidence that led to Dicker's arrest.

## CANADA SEIZES AMERICAN BOATS

And Detains the Crews at Amherstburg

-A Costly Catch. AMHERSTBURG, Ont., May 9 .- The Government cutter Petrel seized two iron passenger boats-the Visitor, of Put-in-Bay, and the Le Roy Brooks, of Bass Islandand brought them here last night for violation of the Fishery Act. They had on board a party of American gentlemen, who were fishing with hook and line just east of Pelee Island. The passengers were allowed to land on Pelee Island, but the crews of both boats were brought here and kept on board the seized vessels. The Visitor is valued at \$16,000, and the Brooks at \$7,000. Capt. Dunn, of the Petrel, states he has information that the two boats fished out of season last year and defied the fish in-

## spector on Pelee Island to stop them.

FISHERMEN PULLED IN. Two American Steamers Captured by a

Canadian Patrel Boat. The Government Taking Back Its Boasted Tariff Reform.

One After Another the Old Rates Are

(Special to the ADVERTISER.)

OTTAWA, May 8 -Still further tariff changes, By the time the resolutions get through committee the country won't know where they are at. When the House met Mr. Davies moved that the expenditures which had been objected to by the Auditor-General, and in which cases his objections had been overruled by the Government, be referred to the public accounts committee for investigation.

Sir John Thompson objected to this proceeding, arguing that the Auditor General should not have made public matters relating to expenditures for the current year, and such matters should not be made public through committee.

Mr. Davies said he thought it would be a great convenience if the House was not obliged to wait nearly two years before obtaining information regarding public accounts.

Hon. Wilfrid Laurier said the public accounts committee was the proper authority to judge as to when accounts should be published.

Sir John Thompson contended that Mr. Davies should give notice of his motion, and Mr. Davies said that the Ministers were simply trying to prevent inquiry into expenditures that the Auditor-General had condemned as illegal and unwarranted.

When Dr. Bergin moved the adoption of the report of the printing committee, Mr. Foster objected on the ground that the proposed amount for printing reports of experimental farms was too large, and the motion was withdrawn.

Mr. Daly's bill to extend the ballot to the Northwest Territories was considered in committee. At Mr. Laurier's suggestion the Government agreed to insert a clause providing for a recount of the vote.

Mr. Martin protested against the proposal to have four weeks elapse between nomination and polling, as this would make the elections in the Northwest three weeks later than elsewhere. The bill also gave an autocratic power to the Government and its officials in regard to the preparation of voters' lists. Officials might prepare lists, and no one could inspect them before polling day.

Mr. Daly said he had adopted the provisions of the Local Election Act of the Territories, which was found to work well and which the Northwest approved. The committee rose without completing

the consideration of the bill. The tariff resolutions were then taken up, the iron duties being considered.

Mr. Foster moved to make cold rolled iron and steel bars dutiable at the old rate cent as first proposed; also to make the duty upon wire nails I cent per pound instead of the 3 of a cent as in the resolutions, and admitted that this duty was equal to 66 per cent.

Messrs. Davies and Laurier pointed out that the Government was going back upon all their tariff reform proposals.

Mr. Foster also moved that brass and copper nails be 35 per cent instead of 25 as first proposed, that the duty on enameled iron and steel ware be restored to the old rate, 35 per cent, and that copper wire be 15 per cent instead of 10 per cent. As regards wood pulp he proposed to make it dutiable at 25 per cent, with the proviso that if it was placed on the American free list duty would be abolished.

Mr. Laurier called attention to the statement of Sir Henry Tyler that the present Premier had renewed Sir John Macdonald's promise that coal would be placed on the Canadian free list if the American duty on coal was abolished.

Sir John Thompson said he had ascertained that Mr. Tyler had been misreported. No such promise had been given.

Mr. Foster then moved to change the duty on axles, springs, etc., from 35 per cent as first proposed to I cent per pound, and 20 per cent.

The Opposition protested that this was returning to the old duty, but the motion

INTERESTING LEGAL DECISION Affecting the London Mutual Insurance

Company and the M. C. R. TORONTO, May 8. - Judgment was given to-day in the Court of Appeal in the case of Wealleans vs. the Canada Southern Railway Company.

The case was an appeal by the plaintiffs from the judgment of the Queen's Bench Divisional Court dismissing a motion by appellants to set aside a non-suit entered by Judge Street at the trial of the action by J. Wealleans and the London Mutual Fire Insurance Company against the Canada Southern Railway Company and the M. C. R. Company to recover \$1,210 for loss sustained by Plaintiff Wealleans owing line a locomotive so faultily constructed as to emit sparks and set fire to the shed and

barn of Wealleans. It was found at the trial that there was no negligence, and the plaintiffs appealed on the ground that the defendants, the M. C. R. Company, were liable as wrong-doers. The M. C. R. Company is a foreign corporation, and not authorized by any statute to run engines over lines in Canada, but they contended that by an agreement with the Canada Southern Railway Company, they were authorized to run their engines, and were not liable except for negligence.

The majority of the court held that the agreement amounted to a lease of the road to the Michigan Central company for 21 years, and was ultra vires, not being ratified or recognized by parliamentary authority, in so far as it professed to delegate corporate powers and immunity from the consequence of their acts, and that the plaintiff was entitled to show that the agreement was ultra vires.

Chief Justice Hagarty dissented, holding that the engine was lawfully on the line with the consent of the Canada Southern Company, authorized by a statute giving power to make running arrangements. Appeal allowed with costs; new trial; costs of the former trial and in the Division Court to be paid by the respondents.

### SLIPPING AWAY!

The St. Alban Disaster Likely to be Duplicated at St. Anne la

Perade. QUEBEC, May 8. - Latest news from St. Anne de Laperade say that the water is not rising, but that the landslides and land subsidences are continuing. Five houses will be gone before I o'clock. QUEBEC, May 8 .- A dispatch from St.

Anne la Perade says: "This village is in imminent danger of destruction by land slides, brought about by causes similar to those which caused so much disaster at St. Alban, a short distance from here. Five houses have already been carried into the river and ten more are crumbling. The C. P. R. bridge is apparently weakening, and when it goes it is almost certain that the whole village will be carried away with it. Farmers and villagers are abandoning their homesteads and removing all their portable property.

Another report says: "The continued melting of snow in the mountains and the heavy rains of Sunday has again raised the waters of the Batiscan River to a dangerous height. There is no news yet as to what is happening at St. Alban, the scene of the late disaster, but at Ste. Anne De la Perade, north mouth of the river, where it entered, considerable damage has already been done. The village is flooded, and several houses have already been washed away, while many more are being undermined. The steel bridge of the C. P. R. is under great pressure. Should it go the greater part of the village would go with it. The people are in a state of alarm, and all those living in exposed situations are moving to safer quarters.

THE DISASTER INCREASING. QUEBEC, May 8.-News has been received from St. Annes at 10 o'clock to-night, and is to the effect that the disaster is increasing. Houses are falling one by one and being carried away by the stream, which is increasing by the falling rain water. The railway bridge is threatened with destruction.

C., May 9.—The news that two American steamers had been seized in Put-in-Bay by the Canadian patrol vessel Petrel did not create great surprise at the State Department, where it is explained that the seizures were made in waters wholly under the jurisdiction of Canada for violation of the Canadian fishing laws. By the treaty of Ghent the middle of the Great Lakes was declared to be the boundary line between the United States and the Eritish possessions.
