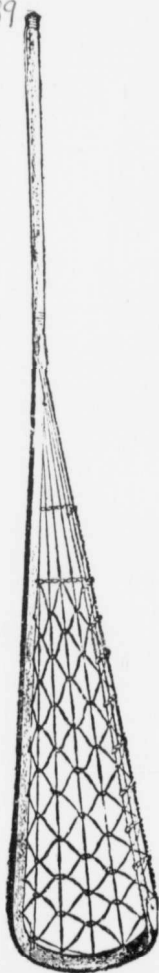

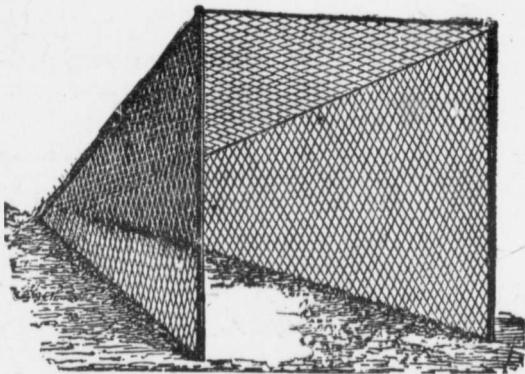

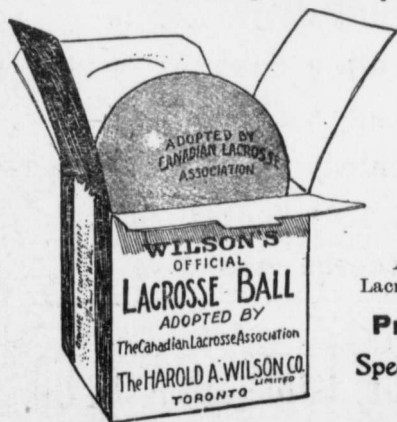

# CONSTITUTION

---

Adopted at the organization of the Canadian Lacrosse Association, Toronto, 22nd April, 1887; amended at Paris, April 18th, 1888; Niagara Falls, April 17th, 1889; and at Woodstock, April 15th, 1890. Revised and consolidated at Toronto, April 21st, 1891, by the Canadian Lacrosse Association. Amended at Toronto, April 19th, 1892; March 31st, 1893; March 23rd, 1894. Amended at Stratford, April 12th, 1895; and at St. Catharines, April 3rd, 1896. Revised and consolidated at Toronto, April 16th, 1897. Amended at Toronto, April 8th, 1898. Amended at Toronto, March 31st, April 1st, 1899; April 13th and 14th, 1900; April 5th, 1901; March 28th, 1902, and April 10th, 1903. Revised April 1st, 1904. Amended April 21st, 1905. Amended April 13th, 1906.

## ARTICLE I.

The name of this organization shall be THE CANADIAN LACROSSE ASSOCIATION.

Its objects shall be to improve, foster and perpetuate the game of lacrosse as the national game of Canada; and to carry out the competitions for the Association championships.

## ARTICLE II.

Sec. 1.—The Association shall be composed of lacrosse clubs, which shall agree to abide by and comply with the rules of the Association, and to adopt the following definition:

An amateur is one who has never competed for a money prize, or monetary consideration, or for any wage or stake bet, who has never engaged in, assisted in, or taught any athletic exercise, as a means of pecuniary gain, and who has never taken part in any competition with anyone who is not an amateur.

Exception—That amateur athletes shall not lose their amateur status, by competing with or against

professionals, in lacrosse matches, for which no money prizes are given, or in championship competitions, permitted by any Lacrosse Association.

#### ARTICLE III.

Sec. 1.—The Annual Convention of the Association shall be held in Toronto on Good Friday of each year at 10.30 a.m., and shall be composed of the past presidents and officers of the Association, and two delegates from each club in good standing. Each club shall have two votes.

Sec. 2.—No delegate shall be admitted to the Convention unless a certificate of his membership in and appointment by the club which he represents, signed by the president and secretary of the club, be filed with the secretary of the Association.

Sec. 3.—The annual subscription of clubs to this Association shall be \$5 for each club, to be paid before the annual convention.

Sec. 4.—The order of business at the annual meeting shall be: President's address, reading of secretary and treasurer's report, credential committee's report, auditor's report, consideration of amendments to constitution and rules, election of officers, election of new clubs, general business.

#### ARTICLE IV.

Sec. 1.—Its officers shall be an honorary president, president, first and second vice-presidents, secretary-treasurer and ten councillors, all to be elected annually by ballot, and who shall comprise the Executive Committee of the Association. No club shall have more than one representative as an officer of this Association.

Sec. 2.—The Executive shall have control of the affairs of the Association, and shall have power to fill any vacancies which may occur in its number, and to amend or alter the regulations of the championship competitions.

Sec. 3.—The Executive may call a special general meeting of the Association at any time, and must do so on the requisition of ten clubs of the Association. At all general meetings twenty delegates shall form a quorum.

Sec. 4.—The Executive may suspend or expel a club for notorious and continued foul play, or unfair, unsportsmanlike, or ungentlemanly conduct, individually or collectively, on the field or in any place where a lacrosse match is being played, or at any meeting or gathering in the interests of the game; negligence to pay assessments or for any persistent infringement of the laws of the game, or the rules of the Association. Any club suspended can only be readmitted by a majority vote of the whole Executive.

Sec. 5.—The president shall, when necessary for the decision of questions arising out of the regulations or rules of the game, appoint from the Executive a Judicial Committee of not less than three members in addition to himself; and the Judicial Committee for this purpose shall have the same powers as the Executive.

Sec. 6.—Nominations for the officers of the Association and three auditors shall be in the hands of the secretary not later than one week before the date of the annual convention.

Sec. 7.—The secretary-treasurer shall, before receiving possession of the funds of the Association, file with the president a bond of some guarantee company in the penal sum of five hundred dollars, for the faithful discharge of his duties, expense of said bond to be paid by the Association.

#### ARTICLE V.

Sec. 1.—The championships of this Association shall consist of the "senior," "intermediate," and "junior" championships, and shall be held from the 1st day of November in each year, for one year from that date.

Sec. 2.—The clubs entitled to play for the senior championship shall be the clubs which competed for the same in the preceding year, the winner of the intermediate championship for the preceding year, and such other clubs as may be admitted by the senior Committee of Management. No team in this series shall compete in the intermediate.

Sec. 3.—All other clubs in the Association shall be arranged by the Executive into districts for the pur-

pose of playing for the intermediate and junior championships.

#### ARTICLE VI.

Sec. 1.—No club in this Association shall play for money, or issue a challenge to play for money, under any circumstances whatever, under the penalty of forfeiture of its membership in the Association.

Sec. 2.—Any club in this Association which shall knowingly admit or retain as a member thereof any person who has been expelled from this Association shall forfeit its membership.

Sec. 3.—Clubs in this Association shall not be allowed to play matches with clubs or players that have been suspended or expelled from the Association during the period of such suspension or expulsion.

Sec. 4.—Any club refusing to accept and abide by the decision of the Executive shall forfeit its membership in the Association.

#### ARTICLE VIII.

Sec. 1.—No amendment or alteration shall be made in any part of this constitution, or in the regulations or rules, except at the annual meetings of the Canadian Lacrosse Association, and by a two-thirds vote of the members present. Notice of any proposed alteration or amendment must be made to the secretary of the Association, in writing, at least ten days before the annual meeting, and be by him communicated to the clubs in its membership at least one week prior to date of such meeting. When notice of alteration or amendment has been given as above, both the notice and amendments thereto may be voted upon at the annual meeting.

## REGULATIONS

Sec. 1.—No player shall take part in any Association match unless his field captain shall have furnished the referee with a full list of the players and their playing certificates. Certificates shall be issued in the following form: On blue paper for senior, pink paper for intermediate, and white paper for junior

series, on application to the secretary of the Association. No certificate shall be issued after Aug 1st.

This certificate must be filled in with ink.

Sec. 2.—A playing certificate may be suspended by the president of the Association for cause. A certificate so suspended must be forthwith returned by the holder to the secretary of the Association, and during such suspension the player shall not be allowed to take part in any match.

Sec. 3.—A junior certificate used in intermediate matches shall have the date and occasion of such use written across the face by the referee, and such certificate, after being used twice in this way, cannot be again used in the series for which it was originally issued.

Sec. 4.—Every player in the Junior Series of the Association must file with the Secretary a statutory declaration that the said player had not attained his 20th birthday on the first day of May in the season of which he intends competing, and

that he is and has been a bona-fide and continuous resident of the town, city, or village to which his club belongs, since the first day of May in the same season, and the Secretary, upon receipt of such declaration, shall issue a certificate entitling the said player to play with the club specified. A bona-fide and continuous resident shall include a student who may be absent from home attending a school of learning, but such student shall elect whether he will play with a club where his home is situated, or with a club where the said school of learning is situated, and shall notify the Secretary of the Association of his intention.

#### ARTICLE II.

Sec. 1.—The Senior Committee shall consist of the president of the Association, who shall be chairman, and one representative from each senior club, who shall have the arrangement of the schedule for the senior championship, subject to the general authority and rules of the Association.

Sec. 2.—Clubs competing for the senior championship must deposit before the commencement of business, at the first meeting of the Senior Committee, a fee of \$50.00, and a bond to be approved by the said committee, in the penal sum of \$200, payable to the president of the Association, for the proper fulfillment of the schedule as arranged. In the event of the condition of bond not being fulfilled, the president shall collect the same, and all legitimate expenses incurred by any other club in consequence of such non-fulfillment shall be paid out of the money forfeited, and the balance, if any, shall be handed over to the treasurer of the Association.

Sec. 3.—Matches resulting in draws shall be considered postponed matches. If, after the completion of the series, the standing of any club is affected by draws, they shall be played off on neutral grounds under order of the president. Should the president be a member of one of the competing clubs, the 1st vice-president shall order the game, and in the event of both the president and 1st vice-president being members of the competing clubs, the 2nd vice-president shall order it, the proceeds to be equally divided.



Sec. 4.—A tie for the senior championship shall be played off under order of the president, subject to the arrangements in Sec. 3.

Sec. 5.—A club defaulting any match in the series shall be debarred from further competition in the series; all scheduled matches played by such club shall be counted, all unplayed matches shall count as wins to the teams scheduled against them; the defaulting team shall pay all legitimate expenses of their opponents in connection with this match, and shall forfeit their membership in the Association, and all rights thereto, until the amount is paid.

### ARTICLE III.

Sec. 1.—Intermediate and junior clubs must deposit, at the first meeting of their District Committee, a bond to be approved by said committee, in the penal sum of twenty-five dollars, payable to the Secretary of the Association, for the proper fulfillment of the schedule as arranged. In the event of the conditions of the bond not being fulfilled the Secretary shall collect the same and pay all legitimate expenses incurred by any other club in consequence of such non-fulfillment, shall be paid out of the money forfeited, and the balance, if any, shall be handed over to the treasurer of the Association.

Sec. 2.—No district matches shall be scheduled later than the 15th day of August.

Ses. 3.—A tie in any district shall be played off under order of the president.

Sec. 4.—Sections 3 and 5 of article II., relating to senior clubs, shall apply to intermediate and junior clubs.

Sec. 5.—The club winning the championship of the senior series of the Toronto Lacrosse League (provided such club is a member of this Association), shall be entitled to play as a district winner in the intermediate or junior series, at the option of the Association.

Sec. 6.—The winners of the district championships shall play off for the Association championships under the directions of the Executive.

Sec. 7.—In all semi-final matches the home team allow the visiting team as their share of receipts their hotel expenses and four cents per mile, one way, per man, up to a maximum sum of \$100. A team to consist of fourteen men, and mileage to be calculated or distance via most direct route. Money to be paid at advertised time of match. In case the final be home and home matches, the receipts shall be divided between the Association and the home team, the Association receiving 15 per cent. and the home team 85 per cent.; subject to the provision mentioned in Sec. 17, and in case the finals be played off at one place, 15 per cent. of the receipts shall be paid to the Association, the remaining 85 per cent. to be divided equally between the two competing clubs, after the railway and hotel expenses of each team (14 men) and the necessary expenses of the match are defrayed; or in case the receipts are not sufficient for such expenses, the amount shall be divided between the clubs in proportion to the actual expenses incurred.

Sec. 8.—If any club, a member of this Association, agrees to pay expenses or give a definite sum to any other club in this Association for an exhibition match, and neglects or refuses to carry out the agreement, it shall forfeit its membership in the Association until the debt is paid.

#### ARTICLE IV.

Sec. 1.—The clubs holding the senior and intermediate championship trophies shall each file with the president of the Association a bond in the penal sum of four hundred dollars for the senior, and one hundred dollars for the intermediate, with one or more good and sufficient sureties, payable to the president for the safe keeping of the said trophies, and the club holding any of the district banners shall file a similar bond in the penal sum of twenty-five dollars.

Sec. 2.—All of the said trophies shall be delivered to the secretary of the Association on or before the 1st day of November in each year. The secretary shall examine the same, and if they have not been injured in the hands of the holders, he shall at once notify the president of the Association, who will de-

liver up and cancel the bond for the same. As soon as the president notifies the secretary that a good and sufficient bond has been filed he shall at once deliver the said trophies to the clubs entitled to hold the same.

#### ARTICLE V.

Sec. 1.—Any player who shall play under an assumed name, or who shall play on Sunday, shall be expelled from this Association, nor shall the Executive have power to reinstate such player; and the club for which he has played shall be expelled.

Sec. 2.—Any player who shall, during the season, play with any other club than the one to which he belongs, whether such club be a member of this Association or not, shall have his certificate cancelled, and the club for which he has played shall be suspended.

Sec. 3.—The playing season of each year shall extend from May 27th to November 15th.

Sec. 4.—In cases where a player has been suspended, such player must deposit ten dollars with the Association before his case will be further dealt with, which sum will be refunded to him if he proves his innocence. If guilty, the costs of meeting of Executive will be deducted from deposit, and the balance, if any, refunded to said player.

Sec. 5.—Players shall not change clubs during the season unless they be members or ex-members of a school, college or university club, in which case they shall be eligible to play for such school, college, or university club, and one other club only, or unless they be members of a junior club in amalgamation with an intermediate club, in which case they shall be allowed promotion to the intermediate team; but in no case shall any player be allowed to return to the junior team during the same season, after having played more than once on the intermediate team. Any player who has played on a senior team since the season of 1904, shall not be eligible to play on a junior team. Professional players shall not be allowed to compete in junior or intermediate teams.

## ARTICLE VI.

Sec. 1.—In all scheduled matches, the president of the Association shall appoint the referee, unless he receives notice from the secretaries of the two competing clubs, at least three days prior to the date of match, that they have agreed on a referee. Should the president be a member of one of the competing clubs, the 1st vice-president shall make the appointment, and in the event of both the president and 1st vice-president being members of the competing clubs, the 2nd vice-president shall make the appointment.

Sec. 2.—The home club shall pay the referee, before the game is called for senior matches, the sum of ten dollars, for intermediate or junior, the sum of five dollars, and his actual hotel and travelling expenses.

Sec. 3.—In senior matches each player shall have on the back of the shirt a number at least 8 inches long and 4 inches wide. and the home club shall print a list of the players on each team giving the player's name and number. The visiting club must supply the name and number of their players to the home club at least twenty-four hours before the match. For neglect to carry out these provisions the club or clubs offending shall be fined \$10.00 each, and the amount shall be collected by the referee, and the same remitted to the Sec.-Treas. of the C.L.A.

Sec. 4.—The referee may require any player to sign his name, for the purpose of comparison with the signature attached to the certificate.

Sec. 5.—The home club in all matches shall be responsible for keeping the grounds clear of spectators and for the maintenance of good order, and it shall be the duty of the referee to see, previous to the game, that what he deems proper provision for the maintenance of order has been so provided. In cases where the spectators in any way interfere with the players or the officials, so as to delay the progress of, or affect the result of, the match, the referee shall declare the match off, and report the circumstances to the Executive.

Sec. 6.—Not more than one match shall be fixed in any one place for the same day, unless with the consent of the club having the first fixture. All championship matches shall commence promptly at the advertised hour. In the event of either club delaying the commencement for more than 10 minutes they shall be fined, Seniors \$10.00, Intermediate or Juniors \$5.00, and the same paid to the Sec.-Treas. of the C.L.A.

#### ARTICLE VII.

Sec. 1.—Protests and all evidence in support thereof, signed by the president and secretary of the club protesting, must be sent post-registered to the president and secretary of the Association, and to the secretary of the club protested, within four days (excluding Sunday) from the date of match. The club protested shall be allowed three days (excluding Sunday) to file their defence, copies of which must be sent to the president and secretary of the Association, and to the secretary of the club protesting.

Sec. 2.—A club protesting must send to the secretary of the Association, along with the protest twenty-five dollars, and the club protested must send the same amount with their defence.

Sec. 3.—If no defence be received, the secretary shall notify the president of the Association, who will deal with the matter, without a meeting of the Executive.

Sec. 4.—Members of the Executive, sitting at the hearing of a protest, shall be paid their necessary hotel and traveling expenses only.

All championship matches shall commence promptly at the advertised hour. In the event of either club delaying the commencement for more than 10 minutes, they shall be fined \$10.00, Intermediate or Junior \$5.00, and the same paid to the Sec.-Treas. of the C.L.A.

## RULES

---

### RULE I.

Sec. 1.—The lacrosse may be of any length, and shall not exceed one foot in width. It shall be woven with cat-gut, and not bagged. ("Cat-gut" is intended to mean raw hide, gut or clock string; not cord or soft leather.) Metal of any kind shall not be allowed upon the lacrosse; splices must be made either with string or gut.

### RULE II.

**The ball must be the "Harold A. Wilson Association Ball," and shall be furnished by the home club.**

### RULE III.

Sec. 1.—Each goal shall consist of two poles six feet apart and six feet high out of the ground, joined by a rigid top crossbar. The poles must be fitted with a cone-shaped netting of not more than one and one-half inches mesh, which cone shall extend and be fastened to a stake in the ground at a point seven (7) feet back of the centre of the goal, and said netting shall be so made as to prevent the passage of the ball put through the goal from the front, and the bottom of the netting must be close to the ground with tent pegs or staples. They shall be placed at least 110 yards, and if the ground will permit 120 yards, from each other. In matches, they must be furnished by the home club.

Sec. 2.—The goal crease shall be a marked line, twelve feet square, and the flag poles shall be placed six feet from the front and back lines and three feet from the side lines.

### RULE IV.

Sec. 1.—The twelve players on each side shall be designated as follows: "Goal Keeper," who defends the goal; "Point," first man from the goal; "Cover Point," in front of point; "First, Second

and Third Defence Field," "Centre," who faces; players nearest the opponents' goal shall be called "Inside Home" and "Outside Home."

#### RULE V.

Sec. 1.—Field captains shall be the representatives of their respective teams, with the exception of the senior series, in which no field captains shall be allowed, the playing captains shall be the representatives of their respective teams. Field captains who are non-players shall not carry a lacrosse, nor shall they be dressed in lacrosse uniform, nor shall they in any manner obstruct the play, or interfere with an opponent during the match. They must have certificates, which shall be valid in all series.

#### RULE VI.

Sec. 1.—The referee shall not be a member of either of the competing clubs, unless agreed upon. He shall enforce the rules, adjudicate on all disputes or cases unprovided for by rule; appoint or remove goal umpires, and control time-keepers; keep the score and at the end declare the result. The ball shall be considered in play till the referee stops the game, which he may do at any time, and must do when an irregularity of play or violation of rule occurs. Play shall not be stopped for a foul, while the player who has been fouled, or any of his side, has possession of the ball. He shall have authority to suspend a player or field captain for such period of the game as he deems proper, for violation of any of the rules of the game. The referee's decision shall be final.

#### RULE VII.

Sec. 1.—There shall be one umpire at each goal. They shall not change goals during the match. They shall inform the referee when the ball has been put into the goal from the front.

#### RULE VIII.

Sec. 1.—Two timekeepers shall be appointed, one by each field captain, before the commencement of the match, whose duty it shall be to keep an accurate ac-

count of the time of each game, deducting time for stoppages in the actual play. They shall immediately report to the referee any variance in their time, and the matter shall be at once decided by him. The referee may also appoint a timekeeper, who shall keep the time of penalized players, and shall direct them when to enter the game.

#### RULE IX.

Sec. 1.—The game shall be started by the referee placing the ball in the centre of the field between the sticks of the players facing, and when both sides are ready the referee shall call "play." The players shall have their left side towards the goal they are attacking, and in every case the ball must be drawn.

Sec. 2.—A goal is scored by a player putting the ball in the goal net from the front.

Sec. 3.—The playing time of the match shall be divided into four periods of twenty minutes each, actual playing time, ends to be changed only at the conclusion of each period. In cases of championship games, the games shall be started not later than four o'clock.

Sec. 4.—In no case must the ball be faced closer to the goals than ten yards in any direction.

Sec. 5.—The goal-keeper, while defending his goal within the goal crease, although not allowed to catch and throw with his hand, may put away with his hand or block the ball in any manner with his stick or body.

Sec. 6.—Should the ball lodge in any place inaccessible to the stick, it shall be taken out, and the player picking it up shall "face" with his nearest opponent.

Sec. 7.—A ball out of bounds must be "faced" at the nearest point where it left the bounds, and all the players shall remain in their places until the ball is faced.

Sec. 8.—Players may change their sticks during a match.



Sec. 9.—If the player should be in possession of the ball when "time" is called he must drop it on the ground.

Sec. 10.—A player without a stick shall not touch the ball until he recovers his stick.

Sec. 11.—Should a player be injured during a match and compelled to leave the field, the opposite team shall drop a man to equalize the teams during his absence.

Sec. 12.—No change of players shall be made after the match has commenced.

Sec. 13.—In the event of any team starting to play what is known as "rag" the referee shall at once stop the game and face the ball in the centre of the field. Should the offence be repeated, the referee shall at once stop the game and give the opposing team a free throw.

Sec. 14.—Should a foul be claimed and disallowed, the side against whom the foul has been claimed shall be allowed a free throw or the ball shall be faced, at the option of the referee; should the foul be allowed the player fouled shall have a free throw, but in no case shall it be made within ten (10) yards of the goal. By a free throw it is understood that the player fouling and the one fouled shall be placed in the same positions as they occupied immediately previous to the foul, the player fouled having the ball on his lacrosse. At the word "play" from the referee, each shall be allowed to play in any manner allowed by the rules of the game.

Sec. 15.—The match shall be awarded to the club having won a majority of the goals. If at the end of full-time the score is a tie, the referee shall order the match to continue fifteen minutes each way, or until a goal is scored, the team scoring such goal shall be the winner of the match, otherwise the match shall be declared a drawn match.

A player shall not:

(1) Hold an opponent's lacrosse with his hands, arms or between his legs, nor hold, strike or trip him with his lacrosse; run in front of him or interfere in any way to keep him from the ball until another player reaches it

(2) Hold, strike or trip an opponent, or push him with the hand.

(3) Wrestle with legs entwined, so as to throw an opponent.

(4) Touch the ball with his hands, save as in Rule IX., or excepting goal-keeper, as in Rule IX.

(5) Throw his lacrosse at a player or at the ball under any circumstances.

(6) Move from his position when "time" is called until the ball is again faced.

(7) Go within the opponents' goal crease, nor shall he check the goal-keeper within the crease.

(8) Use the check commonly known as the "square" or "crosse" check, which consists of one player charging into another with both hands on the lacrosse, so as to make the stick meet the body of his opponent.

(9) Jump at, or shoulder, an opponent from behind while running for or after reaching the ball.

(10) Interfere in any way with another player who is in pursuit of an opponent.

(11) Kneel, lie down, or drop in front of an opponent when both are in pursuit of the ball.

(12) Attempt to influence the decision of the umpire.

(13) Use threatening, profane or obscene language to any player, or to the referee, umpires or field captains, at any time during the match.

(14) Forcibly body check any opponent into a fence.

(15) Charge into an opponent after he (opponent) has thrown the ball.

(16) Wear spiked shoes. (Rubbers excepted)

(17) Persistently throw the ball out of bounds, lie on same, or in any way try to prolong the time of a game.

(18) Check an opponent's lacrosse, or attempt to knock the same out of his hands in any way, unless both players are contending for the ball.

(19) Any player striking another on the head, whether accidental or otherwise, shall be ruled off for a period not less than five minutes, and any player striking another with the butt end of the stick shall be ruled off for not less than fifteen minutes.

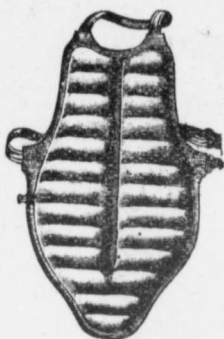

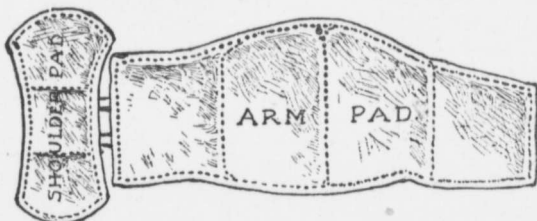

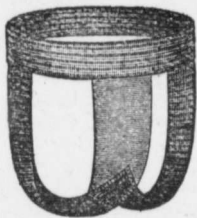
