





All the Alumni are earnestly requested to become members of this association, and assist in promoting the objects it has in view. The membership fee is two dollars per annum. The fund arising therefrom which has hitherto been small, (many of the Alumni having allowed their membership to lapse,) has been expended chiefly in the bestowment of some of the prizes mentioned in the list given herewith. It is hoped that many of our Alumni will feel it a pleasure to become donors of such of the prizes as they may select. Personal application will be made to some of them to that end. We wish also to enlarge the list of prizes. The association hold their Annual Meeting in June, at Wolfville, where they dine together on Anniversary Day. A very pleasant dinner took place this year at which a large number of the Alumni and their friends were present.

Excellent speeches were delivered by Hon. P. C. Hill, Provincial Secretary of Nova Sectia, who received part of his education at Horton Academy, Rev. A. W. Sawyer, D.D., Annual Report.

REPORT OF THE EXECUTIVE COMMITTEE OF THE ASSOCIATED Alumni of Acadia College, for the year ending June, 1876.

The Committee are glad to be able to report the association in an improved condition financially, as compared with last year. The Matriculation Prize due in June last but which was not presented for want of funds, has been paid during the year, and the generous responses which are being made to the calls of the Treasurer give us reason to hope that by the end of the year upon which we are entering the society will be entirely free from debt.

There is still due from the society, however, the sum of \$25.00 to Rev. Dr. Cramp, for money borrowed, and the sum of \$10.00 to Mr. Campbell, for balance due on Matriculation Prize of two years ago. Besides these sums the Matriculation Prize won by Adoniram Judson Denton, in September last is now due, and provision must also be made for the monthly essay prize of \$25.00 offered by the association.

Your Committee have met as business required during the year, but nothing of sufficient importance to require mention has come before them. More than ordinary efforts have been made, to render the celebration of our Anniversary successful this year; and besides the ordinary dinner, special provision has been made for after dinner exercises of a literary character which the Committee hope will add much to the interest of the occasion. Distinguished gentlemen representing the press and the Legislatures of Nova Scotia and the adjoining Province, have accepted invitations to be present to add to the Entertainment, and to give eclat to our Anniversary gathering. An account of the expenses connected with the arrangements made for these guests will appear in the report of our Treasurer which will be submitted to you.

C. Hill, art of his er, D.D., In accordance with a resolution passed at our last Annual Meeting, the Committee did not offer the usual "Alumni Essay Prize," and there has been no competition for this prize during the past year accordingly.

The resolution passed at our last Annual Meeting, in respect to the appointment by the society of some of the Governors of the College, was not carried into effect, owing to the inability of our Secretary to attend the last meeting of the Baptist Convention, and your Committee again recommend the matter to the favorable consideration of the association. Your Committee feel that the usefulness of our association would be very much enhanced if arrangements could be effected whereby the Alumni should have some voice in the government of the college, and in the conferring of degrees, especially of those purely honorary in their character.

Your Committee beg to call attention to the act founding the "University of Halifax" passed by the Legislature of Nova Scotia during its last Session, and recommend that the association give some expression of the views entertained by the society in respect thereto.

In accordance with our constitution the officers of the Society go out of office, at the present Annual Meeting, all of whom, however, are eligible for re-election.

I. MATRICULATION PRIZES.

FIRST PRIZE \$20.00. To the Matriculate who shall pass the best examination.

SECOND PRIZE, \$10.00

Open to Candidates from all Schools and Academies. Prizes to be awarded by the Examiners, and publicly distributed at the anniversary exercises of the College in June of each year. Prizes to be awarded to such matriculates only as shall declare their intention of taking the full College Course.

II. SOHOLARSHIP PRIZES.

FRESHMAN CLASS. Prize \$20.

SOPHOMORE CLASS. Prize \$20.

JUNIOR CLASS. Prize \$20.

For the best Scholarship; by which shall be understood the most intelligent mastery of the Subjects embraced in the Course, rather t = 5 be most familiar acquaintance, by rote, with the textbooks use the statement of the subject of the statement of the statem

In this competition such students only shall be held to be members of their respective classes as shall have been in attendance at least two Terms during the year, one of which shall be the third Term.

Each class of ten or more members to award, at the close of the Scholastic year, its own prize.

If there shall be less than ten members in any class, the Faculty shall award a prize, if they deem any member fairly entitled to it; otherwise they shall appropriate the money to the College Library.

Prizes to be publicly presented, through the Alanni Association, at the Anniversary Exercises of the College.

III. ELOCUTION PRIZE.-(Reading and Speaking.)

\$20. To the best Elocutionist.

Open to all Undergraduates who have been in attendance two Terms during the year, one of which shall be the Third Term.

Prize to be adjudged by the Faculty, and publicly presented, through the Alumni Association, at the College Anniversary.

\$25. For the best series of Monthly Essays during the College year.

Open to all Undergraduates. Prize to be awarded by the Faculty, and presented at the Anniversary of the College. The list of subjects to be read at the same time.

V.-ALUMNI PRIZE.

ALUMNI SOCIETY PRIZE, \$40.00. For the best Original Essay, Open to all Undergraduates. Subject to be chosen by the Executive Committee of the Association, and announced by Christmas of each year. No exact limits are prescribed as to the length of Essays, but it is desired that no Essay shall be of a length to exceed 35 minutes in delivery. Competitors to forward their papers to the Secretary, by the first of May. No Essay not delivered to the Secretary by that date to compete. Essays to be distinguished by mottoes, accompanied by letters bearing the same mottoes, and enclosing the writers' names.

Papers bearing evidence of plagiarism shall be rejected. Prize to be awarded by Examiners appointed by the Executive Committee, and publicly presented during the Anniversary of the College.

Prize Essay to be the property of the Association, and to be read by the writer if requested.

VI. THE PRESIDENT'S PRIZE.

A PRIZE of \$20. Given by the President of the Alumni to the student of the senior class having the highest standing at the completion of the full College Course.

VII. CRICKET PRIZES.

FIRST PRIZE, \$20.

Open to Horton Academy and Acadia College Cricket Chubs. One Match between the clubs to be played at the close of the cricket season in the Autumn of each year; and another during the Anniversary Exercises of the College. Umpires to be approved by the Faculty. Prize to be taken by the member of the winning club making the highest aggregate score in the two matches; but any member not attending at least three-fourths of the regular practice of his club shall be ineligible for the prize.

In case of a tie, prize to be awarded to the one who has attended play most regularly. In case of a tie between the Clubs, an over of four-balls shall decide.
