MISUSE OF ONTARIO BANK FUNDS TO EXTENT OF MILLION DOLLARS WILL NECESSITATE WINDING UP

Sensational Happenings in Financial Circles—Bank of Montreal, as Agent for Other Banks, Will Assume Control of Affairs To-Day—Depositors Will Be Fully Protected.

WILL PAY ALL LIABILITIES.
ALEXANDER LAIRD, ASSISTANT GENERAL MANAGER OF THE BANK OF COMMERCE, AUTHORIZED TO MAKE THE FOLLOWING STATEMENT AFTER THE MEETING AT 3 O'CLOCK THIS MORNING:
"A meeting of the representatives of the Toronto banks was held last night to consider what action should be taken in connection with the Ontario Bank."
"Arrangements are now in progress to be consummated on the arrival this morning in the city of the representative of the Bank of Montreal, for securing payment of all liabilities."

A MEETING WILL BE HELD EARLY IN THE MORNING WHICH IT WILL BE SETTLED WHETHER THE BANK WILL BE OPENED. ALL ARRANGEMENTS DEPEND ON THE OPINION OF THE BANK OF MONTREAL.
As a result of financial difficulties, following unfortunate investments or speculations on the part of the general manager, Charles McGill, the Ontario Bank will to-day be taken over by the Bank of Montreal.
Losses to the Ontario Bank, placed in round figures at least one million dollars, have caused this unusual transaction.

The first intimation that the general public, and even very high up financiers, received of the impending trouble was yesterday morning, when a broker attempted to sell some stock of the bank on the exchange. Sales of the stock had been made on Thursday as high as 124, but as yesterday's offerings were scaled down point by point without takers, brokers looked askance and became seized with misgivings. At the morning board the seller of the shares drew his figure down as low as 124-1/2, but still found no one. It was enough to bring about a case of a panic in Ontario Bank shares, and it was useless to make concessions to find purchasers.

Around the street it was impossible to get any inkling as to what was the cause of the absolute want of confidence in the shares of the bank. Numerous innuendoes and insinuations were ventured by individuals who thought they were in the know, but at the head office no word was found who would give out any statement as to what was the cause of the trouble during business hours. The matter scarcely reached beyond the city limits. The strict until late in the day, otherwise there might have been many withdrawals by timid depositors.

By 8 o'clock, however, rumor had gained full play around the city and eager enquiries were being made as to the position of the bank with the public. The wisest statement that could be given was that the fact that officers of the bank could not be found to make an official statement added fuel to the flames of misapprehension and doubt.
In financial circles the necessity for prompt action was recognized and a call was sent out for a meeting of the representatives of all the city banks. This meeting was held at the residence of Duncan Coulson, manager of the Bank of Toronto, on Beverley-street. Laird, assistant general manager of the Bank of Commerce, presided. After a six hours session an official statement was made as given above.

The object of the banks in the present run on the bank and to protect the depositors and this will be done. The general public need feel no anxiety.
As to the position of the stockholders, nothing was announced, but it was rather intimated that their position is not so comfortable.
The Ontario Bank was incorporated in 1867. Its officers are: G. R. R. Cockburn, president; Donald Mackay, vice-president; R. D. Perry, Hon. R. Harcourt, R. Grass, Thomas Walsley and John Fleet.
It has branches in Alliston, Aurora, Bowmanville, Buckingham, Q. Collinswood, Cornwall, Fort William, Holstein, King City, Kingston, Lindsay, Montreal, Mount Forest, Newark, Ottawa, Peterboro, Port Arthur, Sudbury, Toronto, Trenton, Tweed, Waterford and Warsaw.

Funds Misappropriated.
G. R. R. Cockburn was interviewed by The World as to the cause of the trouble. He stated that misappropriation of the funds was the real difficulty, and this had all occurred in the last few months. The bank as a bank was all right, and in a healthy working condition, and the branches so far from being a hindrance were very productive and of great benefit.
The depositors and noteholders, he stated, would be guaranteed against loss by the Bank of Montreal, which was taking over the assets and business of the Ontario Bank. The other banks were guaranteeing the Bank of Montreal in this, the Bank of Montreal thus acting as the agent of the others. Nothing would be settled as to the conduct of affairs until the arrival of the Bank of Montreal officials this morning, when a meeting would be held. Everything remained for settlement until then, which details as the opening of the bank premises and similar matters would be attended to.

ABSORBED.

The Ontario Bank has been absorbed by the Bank of Montreal. The depositors in the Ontario Bank will be protected absolutely by the new combination, that represents the strongest financial interests in Canada.
Any disquietude that might have arisen from the fact that the Ontario Bank had been taken over by another bank will be dissipated by the announcement that the depositors will be fully taken care of, under arrangements made by the Bankers' Association.
The first tangible intimation that the Ontario Bank was in the stock exchange, when the stock was offered at 121 1/2, without buyers—a fall of ten points.
The rumor became busy, and it was stated on good authority that an official of the Ontario Bank had, thru misdirected speculation, jeopardized the funds of the bank.
Funds to the amount of \$750,000 have disappeared, if one story is to be believed. Other stories place the amount lost as high as \$2,500,000, a large proportion of which is composed of injudicious loans.
The name of Charles McGill, general manager of the Ontario Bank, is associated with all the stories of dissipated funds, and the answer to the question, What caused the trouble? is given in the reply, Speculation.

McGill Denies Speculation Says He Invested for Bank

Ex-Manager Makes Brief Statement—His Whole Career Spent in Service of Ontario Bank—Stories of His Alleged Speculations.

NO CAUSE FOR ALARM.
While it is untoward and unfortunate in the highest degree that the position of the Ontario Bank should be made the subject of public criticism, the fact ought not to breed anxiety, much less result in panic.
Its difficulties are undoubtedly due to causes personal to the management and do not reflect on the Canadian banking system or any other of our banking companies.
The public will do well to remember that the surest way of injuring themselves and business generally is to yield to blind and unreasoning fear. More especially would this weakness be unjustifiable when the statement is authoritatively made that the depositors and holders of circulating media of the Ontario Bank will be absolutely protected.
Then in addition it is announced that the Bank of Montreal, whose standing needs no certification, has arranged to take over the business and public liabilities of the Ontario Bank. All risk of trouble and inconvenience to its depositors and customers will thus be obviated.
So far as the general body of the citizens is concerned there is not the slightest cause for trepidation, and the wise and prudent course is to leave the Bankers' Association who have been deliberating upon the situation free to take whatever steps are necessary to relieve the crisis with the minimum of disturbance to the ordinary course of business. It is their interest to do this and to see that the high standard which Canadian banking has deservedly earned is fully maintained.
There is of course no virtue in any system, however admirable, apart from the men who control the fortunes of the institutions established under it, and it is safe to say that the position of the Ontario Bank was not unknown to the banking community, that the denouement was discounted and as far as possible anticipated.
The action of the Bankers' Association and of the Bank of Montreal is accordingly of the most reassuring character and virtually amounts to a declaration that the situation is under control and can be handled in a manner which will restore and confirm public confidence.

FOWLER SAYS "I WON'T" REFUSES TO TELL OF THE \$55,000 ARRAIGNS THE TRIBUNAL

Lively and Prolonged Colloquy Between Witness and Counsel Concludes With a Red-Hot Attack on the Commission, Which, Mr. Fowler Says, Has Been Actuated by Political Vindictiveness—Had Never Been Asked About the Option, He Says.
There were pyrotechnics at the final session of the royal insurance commission in Toronto yesterday when George Fowler, M.P., the witness long desired by the tribunal to tell where that \$55,000 went to.
Mr. Fowler told of the different options he had got from Mr. Ryan—one for \$200,000 and one for \$350,000. The difference he was to have as his profits. Mr. Shepley asked numerous questions, and the witness explained that the property was bought under the conditions that he was to make money out of it, and in good faith because he took one-quarter interest. When the Foresters bought the property they paid \$255,000; it was now worth \$300,000.
"Would you consider it proper to put before your intended partner the statement that you had paid more than \$100,000?" asked Mr. Shepley.
"No," replied witness.
"Did you intend them to believe that you had paid the amount of the \$250,000 option?"
"I won't answer that" was the firm rejoinder.
"Then the option was reduced to \$225,000, which you put forward to your partners as indicating the price you were paying Ryan?" pursued counsel.
"You can put any infection or inference you like on it. I put it forward to indicate what I was paying Ryan."
"Did you suppose they believed that was the correct option?"
"I did not suppose anything. They could believe what they liked. They never asked me and I never told them. If they would have asked me if I was making a profit I would have told them."
"Will you make any further answer?" queried Mr. Shepley.
"No, I won't." The refusal was flat. "Did Ryan pay you the \$55,000?"
"That is between Ryan and myself. I decline to answer."
Judge Says "Must."
Mr. Shepley asked for a ruling, and Judge MacTavish told witness to answer, but he declined again, and Judge MacTavish said: "It is a proper question and must be answered."
Mr. Fowler addressed the commission. This might be subject of litigation. He would not answer it.
"You must yield to the ruling of the commission, that is your duty," said Mr. Shepley, coaxingly.
Mr. Fowler beat around the bush and kept Mr. Shepley sparring for wind until he was asked why the question was a proper one.
"Did Peter Ryan pay you \$55,000?" he asked.
"Not all of it."
"How much does he owe?"
"I don't know."
"Can you get out?"
Mr. Shepley produced certain cheques,

which witness assented to, showing that he received up to the amount of \$4,000. He would find out what \$3000 cheques he had forgotten.
"Who did you pay the money out to?"
"I don't know whether I will tell or not. Why should I tell?"
Mr. Shepley explained very carefully what the enquiry was for. Mr. Fowler argued that the whereabouts of the money was not relevant. He had sold the property to the Great West Land Company, and whether he got a portion or not made no difference.
Mr. Shepley then read Mr. Foster's evidence, which said that Fowler was the agent of the Union Trust Company.
"What do I care what Foster said? I was not agent," declared Mr. Fowler. "Must I be bound by what you say?"
"No."
"I won't waste any more time," said witness.

McBRIDE STILL HOLDS OUT FOR FAVORED TREATMENT ASKS \$1 PER CAPITA

Conference at Deadlock Over British Columbia's Claims—Must Be Unanimous or Question Will Revert to Laurier.

Ottawa, Oct. 12.—(Special.)—The provincial premiers have not yet arrived at an agreement regarding the financial demands embodied in the Quebec resolutions. British Columbia was the one question which monopolized the proceedings of the conference all day today. What Premier McBride holds out for is a sliding scale grant of an increased amount for his province, or to refer the whole matter to a commission. Mr. McBride suggests that British Columbia should get \$1 per capita, and that as the population increased this amount could be gradually reduced to 25 cents when the population reached two and one-half millions, and to remain permanently at that figure.
The conference does not approve of this. What is suggested is that a special additional grant of from \$50,000 to \$100,000 should be given to British Columbia, more than the other provinces. Because of the difficulties connected with the administration of public affairs in that province.
All the other provinces are agreed, but British Columbia is expected to hold out to the end.
The premiers will meet again tomorrow, and if no agreement is arrived at nothing will be done meanwhile.
Sir Wilfrid Laurier has made the pronouncement that a unanimous decision must be concurred in by the provinces, else the whole question for the different provinces will revert to himself for decision.
The special affairs peculiar to the different provinces can be taken up separately with the Dominion government. Take, for instance, the fisheries in which Manitoba, Saskatchewan and Alberta are not concerned. All the provinces with the exception of British Columbia and Ontario have informed the Dominion government that there will be no difficulty in arranging to give control to the Dominion. Mr. Whitney feels disposed to this as far as the great lakes are concerned, but he would like to consult his colleagues first. Mr. McBride admits the principle that Dominion control is desirable but has not agreed to it.

IRELAND'S HOUR IS AT HAND ABOUT TO BE FREE AGAIN BILL IN FEBRUARY
T. P. O'Connor's Prediction at Ottawa—Laurier Heads List and Gathering Raises \$700 for Irish National Cause.
Ottawa, Oct. 12.—(Special.)—Ireland is about once more to be free," said T. P. O'Connor, this evening at a public meeting held under the auspices of the United Irish League. "The hour of Ireland's deliverance is at hand."
The well-known Irish parliamentarian declared that home rule was within sight. Twenty-five years ago he and Mr. Parnell were hooded and spat upon in the streets of Manchester. To-day nine members were returned by that self-same city pledged to home rule.
Hon. R. W. Scott presided at the meeting and Sir Wilfrid Laurier attended. He moved a vote of thanks to Mr. O'Connor, remarking that he was a home ruler.
Subscriptions for the Irish national movement were taken up, and Sir Wilfrid Laurier and P. D. Ross headed the list with \$50 each; \$700 being collected.
Hon. Daniel O'Connor, the aged ex-postmaster-general of Australia, is present, and spoke briefly.
T. P. O'Connor wrote a lengthy editorial for The Ottawa Journal this afternoon on the Irish situation, concluding by saying:
"Next February, we shall, according to all probability, see the measure for the new government of Ireland introduced by Mr. Bryce. Nobody expects that the measure will put the final copingstone on the fabric of Irish self government, but everybody expects that it will lay the foundation broad and deep."

ANOTHER STUDENT DEAD FROM FOOTBALL INJURY

Gwyn Ellis Succumbs Unexpectedly as Result of Injuries Received Wednesday.

As the result of injuries received on Wednesday afternoon while practicing with the Varsity 'H.L. Rugby team, Glyn Ellis, eldest son of Matthew C. Ellis, vice-president of the P. W. Ellis Company, died yesterday afternoon at 4 o'clock. In the midst of play he came into collision with another player, and fainted shortly after. He was assisted off the field into the gymnasium, where Dr. Henry attended to him. He was taken to his home at 15 Elm-avenue, in a cab. Here Dr. Davidson of Charles-street was called. The doctor said that no fatal result was expected, since he rallied immediately after the accident. He admitted that he was injured, but said he was unable to state the exact cause of his death. Only yesterday morning the young man returned from his studies, but the doctor thought he had better remain in bed for another day or so. A clotting of blood which spread and stopped circulation may have been the cause of death.

As a result of Mr. Ellis' death the Athletic Association have canceled the game with McGill to-day. The McGill team came into the city before the news of Mr. Ellis' death reached the directorate, and will return to Montreal to-day. Prof. Mavor said that even before the death of Mr. Paulin from injuries at football last week, the university authorities had decided to have a medical examiner appointed for the gymnasium and to have two physicians in attendance at all games, and that he should not see how many women should participate in any games till he had received a certificate from the medical examiner. HAMILTON HAPPENINGS

BUSTER BROWN'S MOTHER PUTS IN RIDICULOUS POSES

Member of National Council of Women Scores Papers That Publish Supplement.

Hamilton, Oct. 12.—(Special).—At the meeting of the National Council of Women to-day, Mrs. Boomer, London, made an attack on all the papers that published the Buster Brown pictures, because Buster's mother was put in ridiculous positions. In order to suppress trap advertisements that misled girls and women, and to stop the circulation of objectionable literature, the council passed the following resolution: Whereas the members of the council find, in dealing with objectionable publications of all kinds that come thru the mails in Canada, that their work is hampered by being unable to trace these publications to their sources, they suggest that it is most desirable that the postmaster-general be again petitioned to exclude from the Canadian mails all printed matter not bearing the name and address of the publishing house from which it is issued.

Dr. Helen MacMurchy, Toronto, announced that she was collecting statistics for the Ontario government with reference to feeble-minded women, and that the government would take some action as soon as it found out how many there were. Those who took part in the discussion this morning were: Mrs. Burns, St. Louis, secretary of the U. S. council; Mrs. Cory, Toronto; Mrs. Robert Evans, Hamilton; Mrs. Couric, Toronto; Mrs. Horton, Ottawa; Miss Ritchie, Halifax, and Mrs. O. C. Edwards, Montreal.

Persevere for Women.

The National Council of Women was in turmoil this afternoon over the question of the extension of the franchise to women. By vote of 22 to 22, the members declared themselves in favor of political equality for the sexes. The vote was not taken until about every person in the room had made a speech on the subject. Dr. Augusta Stowe Gullen, Toronto, led the movement, and championed the cause of the franchise, which recommended the appointment of a committee on the subject. The minority tried to get action deferred by proposing the appointment of a citizens' committee, but Dr. Stowe Gullen mounted the platform and dared them to split on the term "equality." She declared that one needed to be a philosopher to maintain one's equilibrium when contemplating the results of the legislative bodies, which were like "roses blooming in the desert land." The women, she said, had no cause to rejoice, because the municipal franchise had not been extended to women.

"The problems of the country cannot be solved by the male intelligence alone," she continued, "and could not men recognize that they cannot with impunity deny the rights claimed by themselves? She also took a fling at the Methodist ministers for shutting women out of their conferences, saying that one would expect a keener sense of justice from such a body of men. The council ended by passing this resolution on the subject: Whereas, by the inimitable law of heredity, a race cannot rise higher than its ancestors, it becomes a national obligation that the mothers of the race should have the widest opportunities to develop and to exercise all their faculties, and, no less, and as true lovers of Canada, desire their country to be in advance of all other nations in this regard; Therefore, be it resolved, that at this annual meeting of the National Council of Women of Canada, there be appointed a standing committee upon political equality.

Women in Sports.

Rev. R. Writing presided at this evening's session, near Plumpton, Montreal, gave a paper on the relation of amusement to life. Women, she said, should interest themselves in sports, and should not see how many women had so much time to devote to bridge.

BOLD HIGHWAYMAN ARRESTED.

Hamilton, Oct. 12.—(Special).—Archibald Langhorne, 40 Main-street, was this evening arrested on the charge of being the bold highwayman who held up citizens last night near the Central station at the point of two revolvers. He is only a youth, and, with other youths of a playful disposition, indulged in a game of hide-and-seek, and thought it would be fine sport to give a few pedestrians a scare. His gamboling debt. 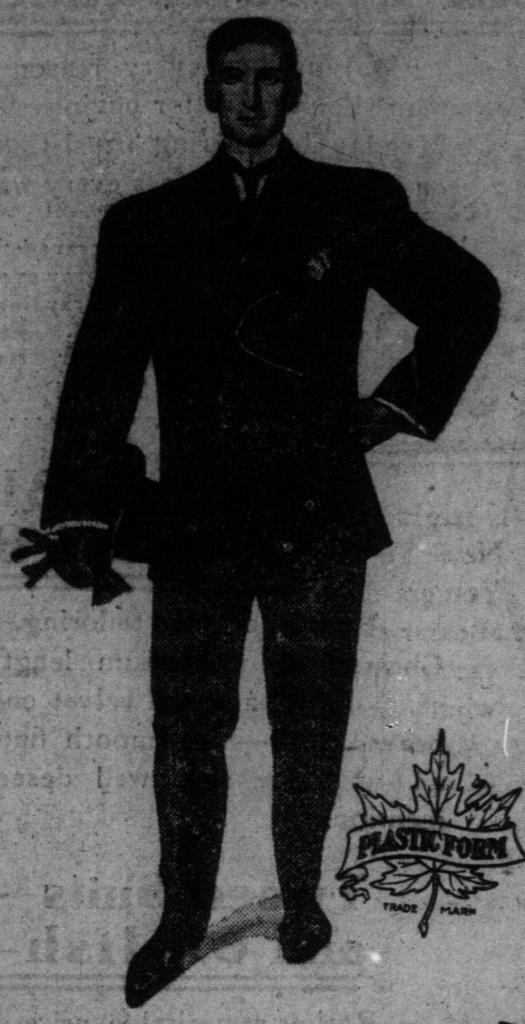

PUBLIC WORKS UP NORTH.

Hon. Mr. Reaume is Back From an Inspection Trip.

Hon. Dr. Reaume and Deputy Minister Campbell returned from Northern Ontario yesterday, where the public works in process of construction or recently completed were inspected. New roads have been built to the extent of 250 miles, and 525 miles have been repaired, the allowance in this department having been \$320,000. Some 4000 men, chiefly settlers, were employed.

The longest single span concrete arch bridge in Canada has been erected at Massey, and at Webwood the Spanish River Bridge of steel and concrete is 60 feet high to allow boats to pass.

The Kakabeka Falls power plant is now marking 5000 horse-power. At Fort Frances the preliminary work is proceeding slowly.

In Rainy River district 750,000 acres have been settled, and the land there is being taken up rapidly. The minister of public works was banqueted at Rainy River and Fort Frances. He left for Windsor yesterday evening.

CONSCRIPTS TO BE URGED NOT TO JOIN THE COLORS

Social Democrats Begin Campaign of Sedition to Augment Disorders.

St. Petersburg, Oct. 12.—The Social Democrats have assumed the direction of the organized movement for the refusal to perform military service which the Constitutional Democrats at their convention at Helsingfors decided to avoid.

At a secret and largely attended meeting of the central committee of the Social Democrats at St. Petersburg yesterday it was decided to begin the work immediately among conscripts of 1906 who to-day were notified to appear for enrollment, and endeavor to induce them to refuse to join the colors.

The presses of the revolutionists are printing thousands of the Social Democrat proclamations and an organized effort will be made to reach every man of this year's list of conscripts.

The organizers of the movement have little expectation of actually preventing the enlistment of recruits and are aware that the conscripts have not adequate means to back up their refusal to join the colors, but they hope to augment the disorders in the interior and send already disaffected contingents to the army.

Criticized by Press.—The halting policy of the Constitutional Democratic convention at Helsingfors has brought upon that party sharp criticism by the press. The late workers' council here has thus far resulted in the discontinuance of the prosecution.

The examination of the witnesses on the subject of the armed rising has been finished without establishing the delegates' actual preparations for a revolt. The purchase and manufacture of arms was admitted, but this was not considered sufficient to establish the participation of the accused in a conspiracy having for its object a general rising. HANLAN'S POINT NEXT YEAR MAMMOTH AMUSEMENT PARK

Great Changes to Be Made—and Numerous Features Added for Next Season.

Wait till you see Hanlan's Point next year!

Plans are now being perfected to make it one of the finest amusement resorts in Canada, transforming the present amusement park into a veritable fairy land. Nearly \$100,000 will be spent before the opening of the season in 1907.

E. E. Gregg, president of the Ingersoll Construction Company of Pittsburg, Pa., who built and has operated the "Figure 8" and "Mystic River" was in town this week and completed arrangements for building an immense scenic railway, which will contain nearly a mile of track and costing in the neighborhood of \$45,000. The entire space formerly occupied by the sample room and ice house all the way from the "Air Ships" to the "Mystic River" will be occupied by the pavilion alone. The track will run through the grounds to the extreme point of the island, forming a loop at the northeast corner, where an immense scenery house will be built nearly 40 feet high. From there the track will turn, following a similar route back, and continuing on past and over the "Mystic River" making a second loop with still more elaborate scenery. The cars will run on an iron track and in five trains of three cars each. Automatic signals the same as used on the New York Central line will be used, precluding the possibility of accident. It will be the longest, largest and most elaborate road ever built.

The "Mystic River" is also to be rebuilt, the course of the channel being

changed, and the entire route will be lined with scenery and grotto. All the large scenes will be lighted automatically.

In addition to this the Ferry Company's plans call for a mammoth dancing pavilion. Its floor surface will contain about 10,000 square feet, highly polished. It will be provided with ladies' parlors, handsome furnished, gentlemen's smoking and lounging rooms, check rooms and other conveniences. This will be used largely by societies, clubs and private parties.

A large merry-go-round has been contracted for to be located over the water near the "Figure 8." Its figures will consist of lions, horses, goats, giraffes, roosters, tigers, etc., a large part of which will be "gallopers" which have provided a sensation in other places.

The pavilion will be large and will be equipped with rockers and easy chairs for ladies and children. Special attention will be given picnic parties. The part of the ground to the left as you enter the island is to be cleared of all buildings and made into a picnic grove. Winding walks will be laid out, fountains installed, flower beds made and a number of pavilions and pagodas erected in various places where families and parties can picnic with all the conveniences of a well equipped kitchen. Swings and rustic seats will be scattered here and there for the convenience and comfort of the public.

All the old buildings throughout the entire park will be removed. A new band stand will be erected, and the best bands of the country will be heard in daily free concerts. Arrangements are also being made to have a number of theatrical acts. These will consist of high wire walkers, trapeze performers, performing elephants and lions, etc., all of which will be given on the hippodrome stage in open air.

Great improvements are to be made in the way of beautifying the entire park. Several thousand incandescent lights are to be added. All the buildings and amusement features will be repainted.

The Ferry Company are now getting out plans for another large boat, which, with their already large fleet, will give the patrons of the island splendid service.

LOCATING POWER LINE.

Hydro-Power Engineer Drives From Guelph to St. Thomas.

Guelph, Oct. 1.—(Special.)—E. Rich, assistant engineer of the hydro-electric power commission, has been in the city to-day conferring with A. D. Lyon, secretary of the Western Ontario Municipalities Niagara Power Union.

He will start from Guelph on a driving tour, going westward as far as St. Thomas, to locate a right-of-way for a transmission line. He will take in Galt, Berlin, Stratford, St. Mary, Woodstock and London.

Mr. Lyon continues to receive applications from various parts of the province for electric power. Among the places which have recently applied is Brantford, which has asked for 3000 horse-power, and Bayfield and Steelton, each for 1000 horse-power.

UNITED TONAPA GOLD MINES.

Reports from the properties of this company continue to show that splendid progress is being made, and that the conditions are favorable in the extreme. The main shaft is over 180 feet deep. The last twenty feet have marked a considerable change and a distinct improvement in the quality of the ore. A number of rich streaks were found running in all directions. The most of them are found along the main dike or ledge that crosses the property, and give evidence of a large ore body, which will be cut by the drift run from the 200-foot level. The formation for some time has been almost identical with that of the famous Mohawk mine, which is making such a sensational record, and as a number of important strikes have recently been made in the vicinity of the Freedom, the indications point strongly for similar results in the Freedom. The superintendent is very enthusiastic over the outlook, and does not hesitate to predict sensational developments in the near future.

A new train to Hamilton is also scheduled, making departure times as follows from Toronto: 5 a.m., 8.45 a.m., 1.15 p.m., 2.40 p.m., 3.55 p.m., 5.20 p.m., and 7.45 p.m. An alteration in train times on the Fort Burwell branch completes the fall list of changes.

AUDITOR'S DISCRETION.

Destroyed Important Evidence and May Be "in Contempt."

Chicago, Oct. 12.—C. H. Davis, general auditor of the Chicago and Alton Railroad, was to-day served with an attachment, requiring him to appear in court and show cause why he should not be punished for contempt of court.

Davis recently admitted on the witness stand that all of the important freight bills by which an auditing company hoped to prove that the Alton Road had granted illegal rebates to many shippers had been destroyed.

Other Heads Charged.
New York, Oct. 12.—The New York Central and Hudson River Railroad Company, represented by counsel, W. W. Harris, appeared to-day before Judge Thome in the U. S. Court, and interposed a plea of not guilty to indictments returned against it this week for alleged violations of anti-rebating laws. Similar pleas were made for the Western Transit Company and C. G. Edgar and Edwin Earle of Detroit, who were indicted in connection with other corporations for violations of this act.

Windsor, Oct. 12.—The assessment for this year, after all appeals were heard, was in round figures, \$7,000,000. The new roll increase this amount by nearly \$100,000. The population is approximately 14,800.

GRAZED BY "BLACK HAND" SHOOT'S SON AND HIMSELF
Chicago, Oct. 12.—Vincenzo Raymond, a teacher of languages, fatally shot his 11-year-old son to-day and then committed suicide.

His widow and several neighbors say that Raymond had for some time been possessed with the idea that he was being followed by the "Black Hand" Society. His mind is believed to have been unbalanced.

ARABS DEFEAT TURKS.

Lively Battle in Which the Casualties Are About 500.
Constantinople, Oct. 12.—The rebellion against Turkish rule in the Province of Yemen, Arabia, shows no sign of subsiding, and whenever a pitched battle is fought the rebellious Arabs seem to be victorious over the unwilling Turkish conscripts sent to subdue them.
Severe fighting has occurred in the district of Asir, between government troops and the tribe of Beni-Hajar, in which the Turks were routed with the loss of 100 men killed and sixty wounded.
The casualties of the Arabs are estimated at 500.

At a secret and largely attended meeting of the central committee of the Social Democrats at St. Petersburg yesterday it was decided to begin the work immediately among conscripts of 1906 who to-day were notified to appear for enrollment, and endeavor to induce them to refuse to join the colors.

The presses of the revolutionists are printing thousands of the Social Democrat proclamations and an organized effort will be made to reach every man of this year's list of conscripts.

The organizers of the movement have little expectation of actually preventing the enlistment of recruits and are aware that the conscripts have not adequate means to back up their refusal to join the colors, but they hope to augment the disorders in the interior and send already disaffected contingents to the army.

Criticized by Press.—The halting policy of the Constitutional Democratic convention at Helsingfors has brought upon that party sharp criticism by the press. The late workers' council here has thus far resulted in the discontinuance of the prosecution.

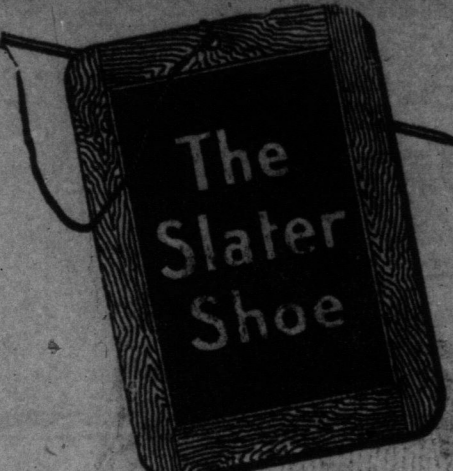

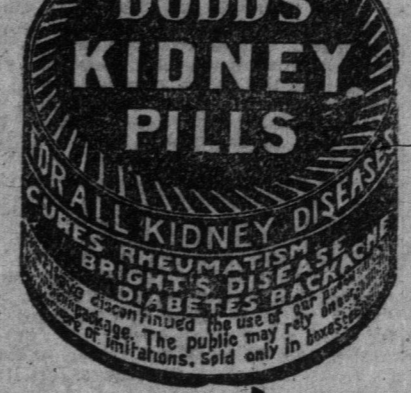

CROWN FORTIFIES ITS CASE VOTERS TELL OF BRIBERY

New Evidence Confirms What Has Been Previously Declared.

While the evidence brought out in the London bribery investigation proceedings yesterday was less sensational than that of Thursday, when J. G. Pritchett told his round, unvarnished tale of rascality in elections, the presentation rolled up a number of additional points from the testimony of a procession of witnesses who had "voted right" and received pecuniary reward.

Oscar Mooton, who is employed in Mr. Hyman's tannery, had seen Sifton, Lewis, Ardy and Milne in the committee rooms. Witness was appointed a deputy returning officer. The magistrate remarked that the appointment of a worker in this way would hardly conduce to a fair election.

Charles White identified Jones as a man to whom Collins had handed an envelope containing \$10, that was to be paid to the witness.

Francis A. Jones, the next witness, said he had been chairman of a committee in a ward sub-division.

Witness explained that Collins had handed him an envelope to be given to White.

Gray, he said, the given \$10 the day before the election by Sifton. Voting Thomas Vanstone said he had been solicited by Collins to vote for Hyman, and had been handed \$9.50 at the Lewis Hotel by Collins. Witness signed a receipt.

Joseph Tait had been promised \$10 by Collins to "vote right."

John A. Norman had been canvassed about his vote by Serviss, Collins and another man. He was told, "if you vote for Hyman, there is \$10 in it for you." The money was given to witness' father, who also received some for himself. He would not have voted without inducement.

John H. Andrews testified that Hardy had told him Collins wanted to see him at Lewis' hotel, where he met Mulloy also. Collins said he would know how he voted. Three weeks later, he called for his envelope, which was given him by a man named Donahue.

James Bone said he was promised \$10 by Lewis to switch from voting for Gray. He got \$10 from Collins in Lewis' hotel.

The testimony of William Goodland opened the afternoon proceedings. Mr. Goodland belonged to the family species of the purchasable voter. He got \$2.50; Collins got 50c. The promise of the money was made in the committee room by Collins and Joseph Hardy. The witness admitted the possibility of his having also received money in the general election, but said also voted. It was on his own initiative.

William Spence, sh., and George B. Hodgins having failed to answer to their names, Edgar Jefferys, an even-tempered young barrister of London, was called. Mr. Jefferys stated that he was secretary-treasurer of the Liberal Club at the time of the election, and had charge of the work of obtaining deputy returning officers. He had recommended Collins, who, he thought, had come to him casually and asked for such appointment. Knowing him to be a Liberal witness, he had done so. Mr. DuVernet remarked that Mr. Collins had told him he had not spoken to witness on the matter, but Mr. Jefferys thought otherwise. He didn't think Mr. Reid had made any recommendation. O'Gorman, whom he knew, had not done so, witness was positive.

Mr. Jefferys explained that it was the practice for him to send out circulars, and receive the names of candidates for the office. Not every nominee was accepted.

"Where do you draw the line?" "In any case where a man has been supposed to have been mixed up in anything crooked. He mentioned one Crowden as being ruled out because it was understood he had been engaged in wrong practices in West Elgin. Mr. Jefferys admitted, however, that

two men, against whom charges of election fraud had been brought previously, had been included in the list.

Jefferys said he had collected all the money for the Liberal Club. He had started to keep an account of the contributors, but had given that up. The money was used only for club expenses and not a cent went towards election expenses.

Mr. DuVernet asked whether witness had not phoned Mr. McIntosh, a clerk in the committee rooms, that Mr. Moore objected to Mr. Collins as a deputy. Witness didn't know whether or not he had so phoned.

Ardy, he said, was a member of the executive for No. 2 Ward, and Sifton was vice-president for that ward. Witness knew Hamilton Ramsey, but had not been seen by the latter about his getting a polling booth. Mr. DuVernet informed the court that Ramsey testified he had gone to the office of the legal firm to which witness belonged, and had been directed to go to Sifton and receive \$10.

Witness certainly slipped up on Mr. Collins, volunteered the witness smilingly, when it was suggested that he had not always shown good judgment in his recommendations for deputies.

Jefferys had known Tom Lewis for years. He testified that the latter had made no suggestions to him as to deputies. He wasn't sure whether Reid was treasurer of the Liberal Association, and denied knowledge of any handing out or receipt of money by the latter. He had sent no bills to Reid.

The Other Side.

Mr. Jefferys was asked if he could give a single instance of corruption, known to him, on the Conservative side.

"I never bothered about the other side. We had cause to believe that men had been tampered with because they stayed away from the polls for no apparent reason. They seemed perfectly O.K. when canvassed, and yet they stayed away."

Mr. Jefferys was about to be permitted to leave the stand, when Mr. DuVernet, in looking over the bundles of cheques, receipts and club papers in general, happened upon a cheque from Mr. Reid, the amount being \$100. Witness explained that the cheque had been received some time prior to the election, and was a contribution towards a "reception" for Mr. Hyman. Witness thought the money had come from Mr. Hyman's secretary. But the money had been received before the election.

"Of course this must occur before election, otherwise it wouldn't be any good," assented Mr. DuVernet ingeniously. He asked who had been Hyman's financial agent.

"I couldn't tell that. I know Mr. Murphy was at one time."

Enquiry was made into the nature of the "reception" for which Mr. Hyman appeared to have supplied the funds himself, and it was explained that Mr. Hyman was there, and there was some music, and the people came up and shook his hand."

Mr. Armour bustled himself with the witness' accounts, and dug up a item of a contribution of \$40 on May 10, 1905. Mr. Jefferys didn't know who had given it, and after some further fruitless researches into his papers he was allowed to go.

"Daniel Home" was the name that was next called, but there was no response. After a short wait, it was decided to adjourn till Monday at 11 a.m.

Mr. DuVernet explained that he had expected Mr. Cory of Ottawa to give evidence yesterday. Mr. Cory is the gentleman whom Premier Scott of Saskatchewan denied having met.

An adjournment was made. Mr. DuVernet complained of the continued absence of William Spence, who has been twice subpoenaed. Mr. Spence is the deputy who was displaced to make room for Jerry Collins as deputy returning officer. Magistrate Denison advised that if Mr. Spence continues absent a warrant be issued to compel his attendance.

Henderson, the president, submitted a toast list, interspersed with a musical program; that bids fair to outdo any similar event of the season, and promises a feast of reason and a flow of soul that will start the guests of the evening on his return journey with happiest recollections of his old comrades. Many of the best speakers and singers of the city, the Whitty boys, will contribute to the program.

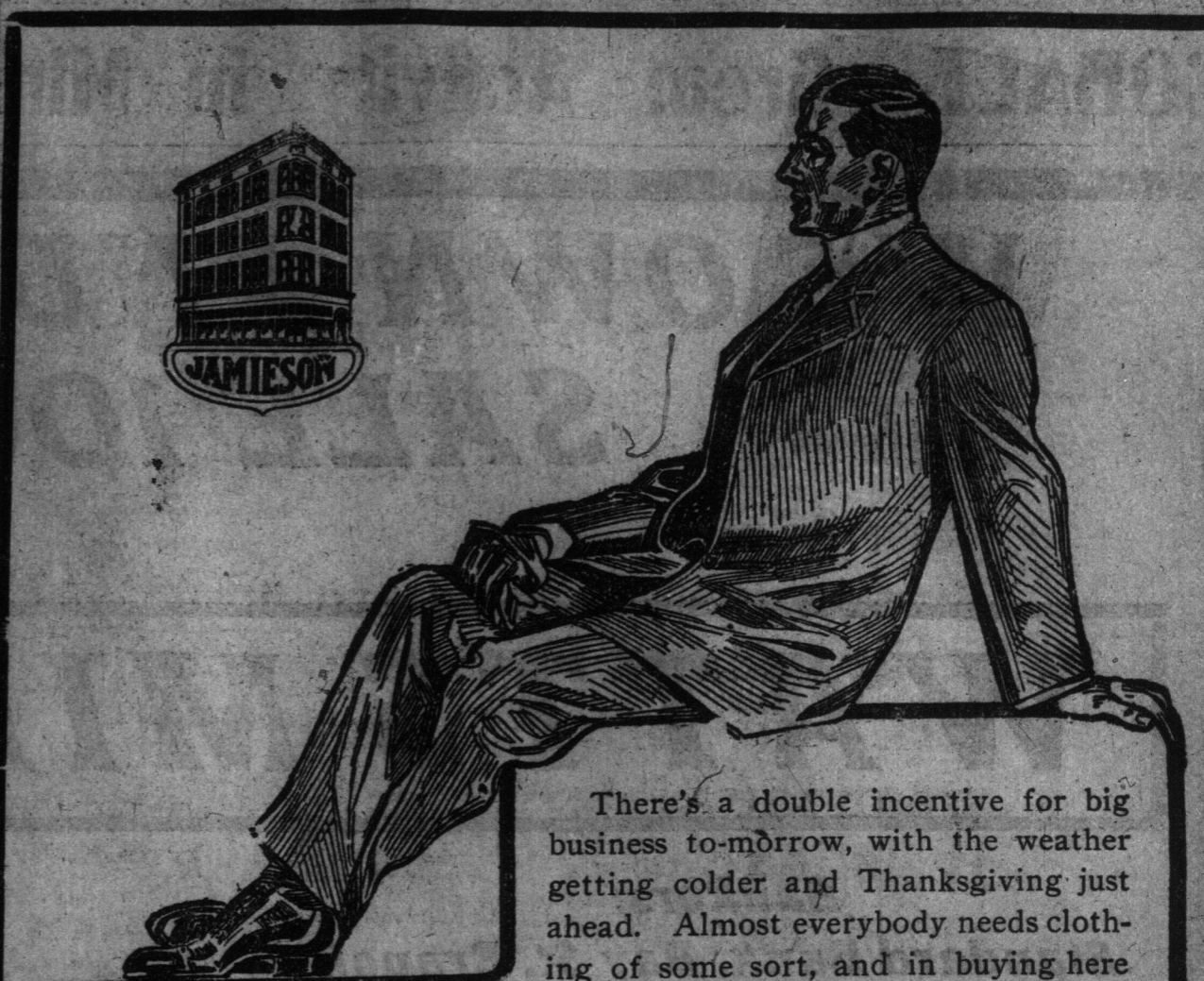

"LUCKY" SCOTT OF NEVADA PURCHASER OF FOSTER MINE

Former Owen Sound Man Says
Wealth of Cobalt is Enormous
—General Camp News.

Cobalt, Oct. 12.—(Staff Special)—Many prominent men have passed the corridors of the King Edward Hotel, Toronto, during the past ten days, but it is doubtful if there has been a more interesting personality there, or one who has attracted more attention, than the new manager of the Foster Mine, Alexander W. Scott.

Mr. Scott made his first visit to Cobalt on Sept. 7, having come to Ontario from Nevada to visit his parents, who live in Owen Sound, where he was born. His wife had accompanied him, and the T. & N. C. Cobalt exhibit at the Industrial Exhibition gave him reasons to believe that the stories that had reached him in Nevada of the prospects of the Cobalt camp were not fair tales.

His fame had preceded him, and he had not been in Cobalt three hours before it was widely known that "Lucky" Scott of Nevada was there, and "looking for something." He made a general visit of the district, heard many people talk of the possibilities of the Foster Mine, saw it, and, with the intuition that one might look for in a Napoleon of finance, rather than in a mining engineer, convinced himself that the property must be his.

exaggerating it when he states that the first carload that has been shipped will bring between \$40,000 and \$45,000 net. This car will likely reach Berger Junction to-morrow night, and as soon as he receives a wire announcing its arrival he will leave Toronto to look after the sampling.

The first step decided upon by him was shipping, and the second the installation of a new plant, both of which are being promptly looked after. Orders have been given to the Allis Chalmers people for two air compressors, fifteen power drills (twelve to start with), three independent hoists, and an electric plant with all that goes with it. The new management has determined to make the equipment and the buildings as complete as any in the camp. Forty men are now employed, and as soon as the new plant is installed they will have seventy working.

"Lucky" Scott is a name to conjure with. In Nevada he got this name by reason of the success that attended the many ventures with which he was connected there. He has mined throughout the west and in Central Africa, having gone to Nevada from there. Altogether he has spent thirteen years in the Western States, and feels satisfied that altho he has many large Nevada interests this new proposition will prove one of the most profitable. He says that at the Foster they have a body of ore blocked out that should contain from 250 to 300 tons of valuable ore, and he expects to ship two cars of high grade ore monthly to start with.

The Watts property adjoins the McLeod & Glendenning, the Silver Cliff, the Nova Scotia, the Nipissing and Violet, and consists of part of lot three, in concession five, in the Township of Coleman, all good propositions. It has been sold. J. F. Eastwood was prominent with Wills & Co. in putting the deal thru by which the Watts Mines, Ltd., secured this property.

The developments so far have been paid for entirely out of the proceeds of the first carload of ore, and an up-to-date plant has been installed. **The Barber Venture.**
Many Cobalt people are interested in the success that has attended the Barber venture, known as the Abitibi-Cobalt Mining Co., which is another proposition that is placing its stock on the Boston and New York curls. Stock was sold in Cobalt and considerable money was made locally. This was one of the first companies to invest in the Portage Bay district, and they secured eight properties there last spring. Steam drills are being put in and ore is being bagged. The company has also two claims in the Lorraine district and one in Harris.



COBALT STOCKS STEADY SOME ISSUES HIGHER

Buyers Holding Off on Account of Gradual Decline—General Mining Notes.

As indicated by the close on Thursday night, the selling wave in Cobalt stocks had nearly all passed its fiercest yesterday morning, but the general decline had the effect of holding off buyers, and the market was less active than for several days. The only news from the centre of the mining district was that development work was being pushed on all the properties as fast as the Cobalt labor market would permit. The market was under the impress of the rumors of a local bank trouble, almost all day, but, despite this, prices throughout maintained steadiness, and in the case of Silver Queen and McKinley advanced were made.

The prospectus of the Watts Mines, Limited, has been issued. The features outlined by the promoters are that there are already exposed on the property seven veins, six of which are producers of native silver, and the seventh a cobalt vein, carrying large values of silver. The width of the veins varies from three to eight inches. At vein No. 1 a shaft 65 feet deep has been sunk and the others, which have been made. One car of ore has been shipped from the property. There is now sacked ready for shipment five hundred bags of ore, and the company hopes to be able to ship one car each month that will net \$30,000. Hand labor, which has been the mainstay of the development work, is to be largely superseded with machinery, and a steam plant, air compressor and stamp mill will be included in this equipment. One hundred thousand shares of the stock of the company are now being offered at \$20 per share.

Why the Low Price for Goldfields.

Canadian Mining and Smelting is selling around \$13. The Gold Fields Syndicate owns 470 shares of Canadian Mining and Smelting, among its other assets. The capital stock of the Canadian Gold Fields Syndicate is \$600,000, while the market value of Smelter stock owned by the company is \$100,000. The other assets of the Gold Fields Co. are placed at \$454,552. Gold Fields stock, on the basis of Smelter holdings alone, if the latter is worth its asking price, should have a market quotation of 10 1/2. Query: Why the low price of Gold Fields?

Transfer Will Be Made by Trust Co.

The necessity for more modern methods in the transfer of mining scrip has been promptly recognized by the Foster-Cobalt Company. Brokers who have bought stock of several companies since the big public investment appeared have been unable to deliver the scrip to clients for several days after the transaction. This has caused much annoyance and has taken away freedom in the mining market that should. The Foster Company has adopted the system of many other prominent joint stock companies, and placed its transfer books with the National Trust Company, which will perform the stock transfer work after this week.

White Bear Looks Promising.

The report of the superintendent of the White Bear mine, Rossland, B. C., is to the effect that development work is likely to proceed for some time yet. During the month a great deal of work has been done on the thousand-foot level, and a fair quantity of ore has been brought up, of a splendid quality. Considerable ore has also been shipped, which assayed about ten dollars a ton net, while the concentrates realized \$24 a ton. The new vein of ore struck recently is in the direction of the Le Rol No. 2, and the owners of White Bear are firmly of the belief that it may not be very long before a richer vein is struck, that may equal the Le Rol. As is well known, the mine immediately adjoins the Kerr and Giroux Lake districts.

Silver Leaf Makes Change.

It is reported that the transfer office of the Silver Leaf Mining Company, which is now located in New York City, is to be removed to Toronto, and the Trusts and Guarantee Company of Toronto will be registered as the stock place of the Trust Company of America of New York City, as in the past. There is also a rumor afloat that a syndicate composed of Canadians are negotiating for the purchase of the controlling interest of the mine.

Specimens From the Mine.

Mr. Clair Hodgson, who has spent the summer on the Silver Leaf property, returned from Cobalt yesterday, bringing with him some very fine specimens of ore which he took out of the 80-foot level of that property. Mr. Hodgson speaks very highly of the Silver Leaf, and predicts that, in the near future, the property will be recognized as one of the leading mines in the Kerr and Giroux Lake districts.

of Mr. Shaw in 1880 Mr. McGill was appointed manager of the Peterboro branch, which position he filled with energy and ability until 1895, when he was appointed general manager of the bank.

"He worked up a large business for the bank here and was always regarded as a shrewd business man of good judgment. He was very popular with all classes, who had every confidence in him, and his removal to Toronto was greatly regretted. He was at one time town treasurer.

"His wife and family have continued to reside here in their beautiful home, 228 Brock-street, Mr. McGill paying Peterboro frequent visits.

"Mrs. McGill and family spent two years in Europe, and have been sojourning the past summer in Muskoka. They have not yet returned here.

"In 1888 Mr. McGill was appointed one of the executors of the estate of the late Charlotte J. Nicholls, who died in 1880. Mrs. Nicholls left an estate valued at over \$1,000,000. This appointment as executor was a testimony to his business ability, and the trust reposed in him by the public. Mrs. Nicholls, in her bequest, left large sums to charity and to the Presbyterian Church. She also gave the city the Nicholls Hospital, the Y.M.C.A. Building and several parks.

Was Very Successful.

"Mr. McGill is an ardent curler, and ex-president of Peterboro Curling Club. He otherwise devoted all his time to business. He was obliging, and, under his direction and that of his successors, the Ontario Bank here is credited with making more profit than any other of its branches.

"News that the Ontario Bank was in financial trouble did not create any excitement in Peterboro, where the bank has two branches, one having been opened in the south end of the city a few months ago, while a branch was also established at Warsaw Village, fifteen miles from here, at the same time.

"The Peterboro agency has always done the largest business of any bank

proprietor of the funds, Mr. Cockburn was not in a position to speak definitely, but admitted that it might exceed \$1,000,000.

"The question of prosecution of Mr. McGill is understood to remain in abeyance.

The Last Statement.

The supplement to the Canada Gazette, Sept. 19, gives in detail the last monthly statement of the Ontario Bank. The following facts are gleaned from that statement:

Capital, \$1,500,000.
Reserve, \$700,000.
Dividend, 7 per cent.
Notes, \$1,242,627.
Balance due government, \$198,600.
Deposits payable on demand in Canada, \$2,318,222.

The Bank of Montreal has a paid up capital of \$14,000,000, a reserve of one million dollars, and a total of all funds at its command of over \$18,000,000. The Ontario Bank compared with this is a matter of almost insignificant character. The old institution will be drawn into the larger and absorbed without causing a tremor in the financial history of Canada.

The banking system of Canada is at present being tested. Bank failures in the States are too frequent to almost comment, but the stability of Canadian banking institutions has earned the reputation by a past experience, extending over many years. The Ontario Bank, an old and prominent institution, is in trouble. General seriousness of the situation is relieved by the interest of its fellow-institutions. The Ontario Bank, with a capital of \$1,500,000, is to be absorbed by the Bank of Montreal, the strongest of Canadian banks, and one of the bulwarks of civilized finance.

The depositors will not lose a dollar. The purchasing bank, it is stated, will take over the Ontario Bank as a going concern, paying therefor the sum of \$150,000.

The financial standing of the bank should show a surplus of assets over liabilities of the capital stock of \$1,500,000, together with the rest account of \$700,000.

The statement which will be issued for valuation purposes by the Bank of Montreal will undoubtedly modify this, and only to the extent of actual surplus over liabilities will the shareholders

here, the number of depositors being large.

It was not likely to be any run on the bank in the morning. W. B. Parker, now of Montreal, succeeded Mr. McGill as local manager in 1895, and three years ago Parker was succeeded by John Crane, who has been in the bank's service for years. The local branch has one of the best banking premises in the Dominion, and about 15 clerks are employed.

Partners Divided.

Some months ago the story was widely distributed that Mr. McGill and his associate had made a heavy win in the big advance which Tennessee Coal and Iron undertook on the New York stock market. It was asserted, however, in connection with this deal that the bank official, after having made a deal of money on the advance, though a vast time to play the stock short, and thereby make a clean up on the downfall in the price of the security.

It was, however, at the time that the strongest movement in the stock occurred, and the two partners in the speculation had their first disagreement. The short seller endeavored to borrow his supposed friend's stock to carry him along until he decided to purchase it back in the market. Considerate thought for this arrangement, but when the stock had made another strong advance the loaned security was called for and repayment had to be made by purchasing in the open market at a heavy loss.

Some of the Losers.

Consolidated Gas, another of the New York specialties, is reported to have been concerned in the downfall and losses of the bank's official. This stock has undergone a remarkable depreciation within a few months, the dividend has been cut, and the price has been reduced from over 200 to below 100.

In stock market circles the official has been held in the highest esteem. He has been looked upon as a gentleman of very high character with one of the most cheerful dispositions; considerate in his thought for others and amiable to a degree. His operations were carried on at one of the principal brokerage offices in the city, but it is said that his various speculations led him into dealings with other local brokerage houses.

Outside of the stock speculation there is also said to have been a venture in a large banana plantation, upon which thousands of dollars have been spent without any return having yet been made. This plantation, it was rumored, was hypothecated to satisfy the demands of the New York market nearly two years ago, when it was put up as collateral, and is still being held for that purpose.

Speculated for Some Time.

These suspicions have been known by the incident around town for several years, and surprise was expressed yesterday that the directorate had not long before this got on to what was being done with the funds of the bank.

The partner of the bank official is at present in New York. It is stated that he got wise to the impending trouble a few days ago, and left town until the crucial stage in the proceeding had been glossed over.

An interesting incident is told around the brokerage offices of a dealing between the two in Ontario Bank stock. When the stock was difficult of sale a couple of years ago the bank official was requested by his friend to take over his holdings to relieve him at that time. This was done, and the stock was subsequently advanced upwards of \$15 per share. At this stage the big operator naively requested that the difference between the taking over and the then market price be paid to him. It is necessary to say that this request was not granted.

Didn't Disturb.

The financial trouble had no disastrous influence on the Toronto stock market yesterday. Business was naturally checked until the full results of the rumors about could be verified or refuted. Aside from a weakening of the financial position of shareholders in the bank, brokers failed to see where any trouble could arise. It was hinted that a big block of General Electric stock, which has been speculatively held for upwards of two years, might be precipitated, and that this would result in very much lower prices for that security.

Altho the details of the transfer will not be known for a day or two guarantee the circulation of the deposits, and the shareholders will receive the balance pro rata.

It is no secret here that the big loss is due to irregularities committed by the general manager.

QUIET AT OTTAWA.

Ottawa, Oct. 12.—(Special).—The following official statement was given out at the Bank of Montreal to-day: "The Bank of Montreal has made an offer to pay all liabilities under certain conditions, and this offer is now under consideration by the directors of the Ontario Bank."

The local branch of the Ontario Bank was doing business up to 3 o'clock, and there was no local excitement. Business went on as usual. It is said here that there are heavy defalcations on the part of some of the Ontario Bank officials, but no amounts are indicated.

The settlement has not been received yet by the government. As there is no official inspector of banks by the government nothing was known at the department of the matter.

SHOULD BE NO ALARM.

In discussing the affair last night a prominent banker said that it would be "a mighty good thing for the public" if the Ontario Bank had been practically obsolete for years.

E. B. Ostler, M.P., of Oshawa & Hamilton said: "The affair of the Ontario Bank will make no difference in the general banking situation. Apart from a few stockholders no one will be affected. There is no ground whatever for any alarm, and unless the newspapers create a scare which is quite unwarranted, the affair will have no appreciable effect upon financial circles."

J. O. Buchanan said: "Depositors and holders of circulating media need have no anxiety. There is not the slightest probability of anyone outside the stockholders. The last published statement of the bank showed a surplus of \$700,000, and if the Bank of Montreal takes over everything everything will be satisfactorily settled."

Seen early in the evening Senator Cox intimated that there was to be a meeting of the Bankers' Association, when the whole matter would be taken up.

"It is understood that the bank has made an offer to pay all liabilities under certain conditions, and this offer is now under consideration by the directors of the Ontario Bank."

"I do not know much about it, but I know that such a statement as that is very wrong," replied Senator Cox. "You should not make such a statement. A great deal of harm is done at a time like this and a great injury to the public when newspapers make statements that are not authentic."

"Has not Mr. A. E. Ames a heavy load of Ontario Bank stock?" was asked, Mr. Ames being out of town.

"I do not know anything of Mr. Ames' affairs, but I don't think that he owns any stock," said the senator.

"There was talk that he was trying to obtain control of the bank in 1902?"

"That is a long time ago and I am sure that he has none now."

TO THE RESCUE.

Bank of Montreal is Now Able to Prove its Policy.

Montreal, Oct. 12.—(Special).—The banking fraternity of this city was startled to-day to learn that a large defalcation had taken place at the head office of the Ontario Bank, and that the capital of the bank had been so impaired that the directors had come to the conclusion that it did were not obtained payment would have to be suspended. With this alternative before them in the face they came to the Bank of Montreal for assistance, the liabilities being about \$15,000,000.

As a matter of fact the Bank of Montreal has made an offer to pay off all the liabilities under certain conditions, and it is understood that the directors have accepted this. This means that the final outcome of the transaction will be the taking over of the Ontario Bank by the Bank of Montreal.

It is well perhaps at this juncture to recall the answer generally given by the Bank of Montreal when accused of keeping too large a reserve in New York to the detriment of Canada. The usual reply has always been that this money is kept there to meet emergencies at home. The case of the Ontario Bank is only another justification
