An Act to increase the Capital Stock of the Sydenham, Harbor Company.

**W**HEREAS the Sydenham Harbor Company have by their Preamble.  
 Petition stated that the Stock of the said Company is limited by their Charter to five thousand pounds, all of which has been subscribed and expended in constructing the said Harbor, and that  
 5 the said sum is not sufficient to construct the necessary works, and they pray that the Capital may be increased and the time extended for the completion of their works,—and it is expedient to grant their prayer; Be it therefore enacted, &c., as follows :

I. The Capital Stock of the said Company shall be increased to Capital in-  
creased.  
 10 twenty thousand pounds, and such additional Stock shall be subscribed for, called in and made payable in such manner and at such times as the Stockholders of the said Company shall direct at a special meeting of the said Company to be called and held for that purpose,—thirty days notice of the time, place, and object of such  
 15 meeting having been first given by publishing the same in one or more newspapers printed in the County of Ontario : Proviso. Provided always, that the additions to the said Harbor shall be commenced within six months, and the Harbor be completed within three years after the passing of this Act.
