BILL.

An Act to revive the Act authorizing the Inhabitants of the Seigniory of Yamaska to regulate the Common of the said Seigniory.

WHEREAS it is expedient to revive and to continue Preamble.
for a limited time the Act hereinafter mentioned:
Be it therefore enacted, &c.,

That the Act of the Legislature of Lower Canada, Act of L. C.
5 passed in the third year of the Reign of His Majesty 3 Geo. 4. c.
King George the Fourth, and intituled, "*An Act to enable* 18, revived.
the inhabitants of the Seigniory of Yamaska to provide
for the better regulation of the Common of the said Seig-
10 *nory,*" the duration whereof was limited to the first day
of May, *one thousand eight hundred and fifty*, shall be and
is hereby revived, and shall, until repealed or altered by
competent authority, be in full force and effect as if
herein repeated and re-enacted; Provido: when the first election shall be held.
15 next Provided always, that the first meeting for the election of a Chairman and Trus-
tees shall be held on the first Monday in next
after the passing of this Act, but such Chairman and Trus-
tees shall go out of office on the first Monday in May,
one thousand eight hundred and fifty-two, on which day and
20 on the first Monday in May in each second year there-
after, a Chairman and Trustees shall be elected in the
manner provided by the said Act.
