MONTREAL PROTESTANT ORPHAN ASYLUM.

THE PROTESTANT ORPHAN ASYLUM has existed in Montreal for twenty-eight years, having been established in the year 1822, under the immediate auspices of the Clergymen of the Protestant Churches, by whom the Constitution of the Society was drawn up. This Charity has since been continued and supported by the voluntary contributions of the citizens of Montreal, aided, since the year 1832, by an

annual Parliamentary grant.

The Directresses have encountered many of the difficulties incident to young and unendowed institutions of a similar nature, in their progress of utility; but, under the blessing of Divine Providence, they have been enabled to keep out of debt, and to receive and provide for over five hundred Orphans since its establishment; it is deemed unnecessary here to dilate on the internal management of the Institution, as the Annual Reports are regularly published, and the Rules enforced adverted to. Suffice it to say that the children are carefully and religiously instructed, and, when about to be placed out, certificates from Clergymen are required that the applicants are persons fit to be entrusted with the care of children. The most serious inconvenience the Society has hitherto experienced, has arisen from the great difficulty of procuring, in a populous city like Montreal, a salubrious and suitable dwelling; and when epidemic or contagious sickness has visited the Asylum, the circumscribed premises occupied by them has been a source of danger and anxiety, both to the children and the Ladies whose duty it is to visit and provide for their welfare.

To obviate these difficulties, it has for many years been the cherished object of the Directresses to obtain the means of erecting a building for the purposes of an Asylum; and, with that desirable end in view, they solicited and procured from the Provincial Legislature in 1843, an Act of Incorporation, authorising them to hold landed estate.

Subsequently they obtained from the Honourable Mr. Justice Smith, the late Duncan Fisher, Esq., Q. C., and the other proprietors of the M'Tavish property, a donation of a valuable lot of land in St. Catherine Street, being a most favourable situation. One lot being deemed insufficient, the adjoining lot was purchased for the sum of £175, and the friends of the Institution then proceeded to solicit

subscriptions towards the erection of such an Asylum as would reflect credit alike on the benevolence and good taste of a city renowned for charitable deeds.

In 1847, the sum of £800 was cheerfully subscribed by many kind friends, and promises of further assistance held out by so many others that the Ladies considered themselves justified in commencing the building, to the extent of their available funds, and at the commencement of the year 1848, contracts were therefore entered into for the mason and joiner work, to the extent of £964.

But in the interval it pleased Divine Providence to afflict this city with unprecedented commercial distress; and several of the subscribers, with the best intentions, were not able to fulfil their promises of aiding in this good work.

Could they have foreseen the great monetary changes which then took place they would have deferred their undertaking; but the above promises, and the then prosperous state of the times, fully authorised the commencement of the building-so that many were the anxieties of the Directresses during the progress of the building, lest the funds on which they depended to pay their contractors should, at the hour of need, not be forthcoming; however, with the generous assistance of other kind friends during the years 1848 and 1849, and by appropriating (as a loan) the sum of £284 from the reserved funds of the institution, they were able to complete the building externally, and do sufficient to the interior to make it tenantable; and on 1st May, 1849, were enabled to remove the officers and orphans to their new home-since when they have done much towards the internal finishing and necessary comforts of such an institution; and although the sum of £1340 14s. 2d. has, up to the 30th December, 1849, being actually expended on the new building, it is still far from being finished as originally intended-and the above mentioned sum of £284, borrowed from the Reserve Fund, as a temporary loan, must be repaid, and placed at interest in the Savings' Bank, as soon as possible, it being destined to supply at an emergency, any deficiency in the annual subscriptions and donations for the household expenditure and support of the orphans; but to attain this end and at same time complete the building, a further sum of £450 is required, and the Directresses now most earnestly appeal to those of their fellow citzens who have not yet contributed, to come forward and lend their aid.

ANNUAL REPORT,

FOR THE YEAR 1848.

THE Annual Meeting of the Corporation of the Ladies of the Protestant Orphan Asylum, of the City of Montreal, was held in the House of the Institution, St. Antoine Street, on Thursday, the 11th of January, 1849, the Revd. W. Bond, of St. George's Chapel, presiding,—when the following Annual Report, and the Treasurer's accounts, were submitted, read and adopted:—

MONTREAL PROTESTANT ORPHAN ASYLUM.

TWENTY-SEVENTH ANNIVERSARY.

The Twenty-Seventh Annual Report of the Protestant Orphan Asylum, which the Directresses have now the honor of laying before the Corporation, will be found, by those interested in its prosperity, to contain subjects of the highest interest to its future welfare.

The long cherished wish of possessing a permanent and convenient residence for the objects of the Society is no longer a matter of speculation, but has been carried into execution, as far as means permitted. The urgent appeals of the last two years to the liberality of our citizens, have been answered as might have been anticipated from a Christian and charitable community, conscious of many home blessings possessed, and anxious to extend them to those who are homeless.

That in times of such well known pecuniary distress as the present, the Society should own a building, covered in, though not completed, is a subject of unfeigned congratulation, and humble thanksgiving to that Being, by whose inspiration the benevolence of so many persons has been excited.

Many have been the anxieties suffered by the Directresses during the progress of the building, even to its present unfinished state, lest the means on which they depended should (not from the want of well-disposed contributors, but from the scarcity of money) fail at the moment of need. But under all discouragements, conscious of the sacred duty they had undertaken, and relying on that Providence which, for twenty-seven years, has never deserted them, they have persevered, and, as above mentioned, succeeded in covering in, and securing against frost, their New Asylum.

But here, this good work cannot rest: very much has been done, but much also remains to do.

The resources of the Ladies not permitting them to enter into new contracts with professional builders, for the completion of the house, they have committed to their Superintendent (himself a workman) the risk of rendering the place merely habitable for the reception of the children next spring, so as to be enabled to give up the lease of their present tenement in St. Antoine Street, and thereby save the house rent of another year.

On the first of May next (D. V.) the children and officers will be removed to the New Asylum, even in its present unfinished state;—and the attainment of the necessary conveniences for such a building must be left to the future benefactions of its friends.

However unfavorable may be the pecuniary state of the times—and it is admitted they are so at this moment—yet there are always in extensive communities like ours, many whose fixed incomes render them less dependent upon the fluctuations of trade, and whose systematic charities are not thereby reduced—to them the Directresses, with respectful confidence, appeal.

This Institution has been, from its origin, generously and steadily supported by the public, and the Directresses believing that the cause of that support, under Providence, has been the conviction of its friends, firstly, of its undoubted necessity and utility; and secondly, that the contributions made thereto, were justly and economically applied, now respectfully court an investigation into its management and direction, as well by reference to its accounts and vouchers, as by visiting the Institutions, both old and new. In the former will be seen how, with very limited accommodation, their young charge are cared for, and in the latter, a good, solid, and unpretending edifice, where the useful has been sacrificed to the ornamental, and where, a comparatively small additional amount of money, will secure to their children, a truly comfortable home.

By the building account produced, it will be seen that (in consequence of the pecuniary difficulties of the times, occurring after the undertaking had been commenced, and which could not be foreseen,)

the Ladies have been compelled to draw on their ordinary funds to complete the required amounts. They have done so, to the full extent deemed safe, leaving only a sufficiency to meet the annual expenditure of the current year, and notwithstanding, it will be seen that there is still a small balance of £29 due to the contractors.

Another cause of anxiety, and which prompts the Directresses so urgently to press the completion of the building, is their desire, in the event of the return of Asiatic Cholera of being able to afford suitable accommodations to such orphans as will be necessarily thrown upon the public protection.

Under all these circumstances, therefore, the Ladies, with confidence, appeal to those of their fellow-citizens whose names are not yet appended to the annexed list of contributors to the Building Fund, in particular, and to the charitable in general, praying their aid and cooperation in the completion of this holy and benevolent work.

Before closing this fervent, but imperfect appeal, the Directresses avail themselves of the opportunity of pointing out to their lady friends how they can most effectually aid in this good work.

There are many among them, whose fortunes will not permit them to contribute towards the Building Fund; but there are very few whose means will not allow them to qualify themselves as members of the Corporation; thereby not only adding to the permanent annual income of the Society, but also—what is of equal importance—to its moral efficiency.

To those generous persons who have enabled them so far to realize their hopes by contributions liberally subscribed in the days of public prosperity, and yet most cheerfully paid in the day of pecuniary adversity, the Directresses tender their most grateful thanks. To Robert Mackay, Esq., Advocate, and Messrs. Gibb & Easton, Notaries, they also have pleasure in offering their acknowledgments for their gratuitous professional services in the execution of the necessary deeds, contracts, and ratifications of title.

Since the last Annual Report, the Directresses have to deplore the loss of a much respected friend and liberal patron of this Institution, in the person of the late Hon. James Reid, formerly Chief Justice of the District, whose consistent benevolence was marked even to the last, by the generous bequest of £100, which, with the kind permission of the Executrix, has been carried to the credit of the Building Fund.

The foregoing important duty discharged, the Ladies proceed to a statement of the domestic affairs of the Asylum for the past year.

The expenditure has been less than during the preceding year, although the number of inmates was greater, showing that a due attention to economy has not been wanting.

The establishment of a School Committee, to superintend the instruction of the children, has had a very beneficial result; and the Directresses feel it their duty to offer their thanks to the Ladies of that Committee, praying a continuance of their care.

The Medical Officer of the Asylum, F. T. C. Arnoldi, Esq., M.D., is requested to accept the kindest acknowledgments of the Ladies for his valued professional services.

The Superintendent and Matron, Mr. and Mrs. Cribb, have afforded the Ladies the utmost satisfaction during the past year, and merit the thanks of the Corporation.

In conclusion, the Directresses respectfully beg leave once more to press upon the members of this Society the necessity of active and combined exertions to render certain the benefits now promised by the completion and occupation of the new Asylum, and to secure for it a permanent revenue by an accession of new members.

If each Lady now interested in the Institution, would, by gentle persuasion, enlist even one new subscriber, (and none can doubt the power, if the will be present,) its revenue from that source would be at once doubled. And is not the object to be attained deserving of such exertions? Can there be a more holy or benevolent cause than that of the Orphan? Is it not one in which every parent must sympathise? Greatly has the Almighty prospered the means thus far used, by unlocking the hearts of those possessed of this world's goods; and will He not be graciously pleased to extend his blessing on our continued labours? Hear his answer in the words of his inspired Prophet, and persevere,—"Fear thou not; for I am with thee: be not dismayed; for I am thy God: I will strengthen thee; yea, I will help thee; yea, I will uphold thee with the right hand of my righteousness."

ANNUAL REPORT,

FOR THE YEAR, 1849.

The Annual Meeting of the Corporation of the Ladies of the Protestant Orphan Asylum, of the City of Montreal, was held in the House of the Institution, St. Catherine Street, on Tuesday, the 8th of January, 1850, the Rev. Alex. Mathieson, D.D., of St. Andrew's Church, presiding, when the following Annual Report and the Treasurer's Accounts were submitted, read and adopted:—

MONTREAL PROTESTANT ORPHAN ASYLUM.

TWENTY-EIGHTH ANNIVERSARY.

The Ladies Directresses, before entering upon the ordinary business of the day, beg leave to offer to the members of the Corporation and their friends, their hearty congratulations on the occasion of this, their first Annual Meeting held within the walls of their own dwelling, and with them, to record their united and humble thanksgiving to that Divine Providence which has thus mercifully spared them to see the fulfilment of their anxious prayers.

This commodious, (though unfinished) edifice was formally taken possession of, at the Monthly Meeting held on the 4th day of June last, when the Directresses, impressed with the above feelings, deemed it their duty to open their first Meeting with that solemnity and reverence due to HIM who had so graciously crowned their humble exertions in providing them with a home, and had so manifestly blessed them during the progress of the work; and, in furtherance of this purpose.—The Rev. W. Bond, the Rev. Alex. Mathieson, D.D., and the Rev. R. McGill, were invited to attend, together with such of the contributors towards the erection of the building, as might find it convenient to be present.

The Rev. Mr. McGill being in the Chair, the Rev. Mr. Bond opened the Meeting with a beautiful and impressive prayer; and both the Rev. gentlemen addressed the Meeting in forcible and

It is true that the sum of £35 can scarcely be called a debt till the work is done, but until that sum be raised, the Institution suffers from the want of its spacious school room—and infirmary, both of which are unfinished, as well as the entrance door.

It is with pleasure that the Ladies mention that the housekeeping expenses of the last year, have been less than the preceding one by £14 16s. 9d. notwithstanding the expenses of removal, and a larger supply of fuel than usual.

Having thus made known their liabilities and wants, the Directresses proceed to shew the state of their means.

Bond and and Out of the several sums paid as above for land, building, and completing, together £1340 14s. 2d.—there has been received from cubscriptions, &c., &c., the sum of £1056 7s. 4d.—leaving a balance of £284 6s. 10d. which was paid out of the reserve fund of the Corporation, placed at interest in the Savings' Bank, and destined to supply any deficiency in the householding expenditure which the annual subscriptions and donations might be inadequate to defray.

In consequence, this reserve fund has been nearly exhausted, as by reference to the Treasurer's Account it will be seen that there is now only a balance of £37 6s. 11d. left in her hands, towards the future support of the Orphans, and the Ladies are compelled to call upon their friends for that active support and assistance, which in former days of pecuniary distress was never wanting.

Where is the heart that can withstand the forcible appeal of the homeless and deserted Orphan, whose temporal, nay more, whose eternal welfare, it is within our power to secure. Let us take up that blessed and inspired volume which has been given us as our guide here on earth, and there behold the light in which our Heavenly Father looks upon the cause of the Orphan, wherein he denounces, to him who shall afflict the fatherless child, that his wife shall be a widow, and his children fatherlesss; but graciously assumed to himself the office of Father to the Fatherless, and a Judge to the widows in His Holy habitation.

Let us then hope on, trusting in Him, that through His blessing, the liberality of our friends, and our own united endeavours, all pecuniary embarrassments may be banished from an edifice thus dedicated to the ennobling cause of Charity.
