An Act to amend the Act for indemnifying Members of the Legislative Assembly for their expenses in attending the Sittings of the Legislature, by limiting the number of days for which such indemnity shall be payable in any Session.

WHEREAS it is expedient to limit the period during which ^{Preamble.} the allowance to Members of the Legislative Assembly to indemnify them for their expenses in attending the Sessions of the Legislature, shall be payable in any Session ; Be it therefore enacted,

5 &c,

That the Act passed in the twelfth year of Her Majesty's Reign, <sup>Act 12 V., c.
33, amended.</sup> and intituled, “*An Act to indemnify Members of the Legislative Assembly for their expenses in attending Sessions of the Legislature,*” shall be and is hereby amended, by adding the following

10 Proviso to the first Section of the said Act :

“ Provided always, that the said allowance shall not be payable ^{Proviso to be added to Section 1.} to any Member for any day's attendance at any Session after one hundred days from the commencement of such Session,”

Which said Proviso shall be read and construed as part of the ^{Not to apply to present Session.} 15 said Act,—but shall not apply to the present Session of the Provincial Parliament.
