## HOME RULE GIVEN INCREASED MAJORITY

**An Ovation Given Premier Asquith After Division of 372 to 271 on the Second Reading—Vigorous Obstruction Tactics Are Planned.**

LONDON, May 9.—(Can. Press.)—The government carried the home rule bill on its second reading in the house of commons to-night by a majority of 372, as against 271 for the first reading. The vote was 372 to 271.  
It was the most largely attended house of the present parliament. Both sides had done their utmost to secure every available vote. Mr. Balfour, former opposition leader, and Mr. Churchill, first lord of the admiralty, returned from Weymouth in order to be present. The announcement of the figures showing an increased majority occasioned enthusiastic demonstrations on the government side, and the prime minister was given a great ovation on leaving the house with his wife and daughter by the crowd assembled outside.  
**Real Fight Coming.**  
The bill was formally referred to a committee of the whole house, but as home rule and Welsh disestablishment are being taken concurrently, it will now be the turn of the Welsh bill. The committee stage of the home rule bill is not expected to be reached until after Whit-tuesday and will probably occupy a couple of months even with a liberal application of the closure rules, as the opposition are preparing an endless list of amendments and will adopt every possible means to obstruct the measure.  
Curiously, the second reading of the home rule bill coincides with the disappearance of the word "conservative" in the official designation of the Tory party. A conference of the conservative and Liberal Unionist parties today resolved upon a fusion of the two parties under the title of "National Unionist Association" and the Liberal Unionists who seceded from Gladstone's party are now in a position to become part and parcel of the Tory party.  
**Will Safeguard Liberties.**  
John Redmond, Nationalist leader, said critics of the bill advanced the remarkable argument that the Irish, being granted a charter of liberty, would show themselves a nation of fools by wanting their own constitution. The moment home rule was granted it would become the highest interest of the Irish nation to safeguard its constitution, to utilize it in moderation, to cultivate the most friendly relations with Great Britain, and for the first time in her history to put her own power to promote the unity, the prosperity, and the welfare of the empire.  
The Irish leader firmly believed that in a very short time all the old party divisions in Ireland would disappear. Responsibility would be placed on the shoulders of the men of all political views. If he had the task of nominating the Irish senate to-morrow, he would put in a large majority of men who had not been on his side in the struggle for home rule in the last thirty years.  
Mr. Redmond said he had been a federalist all his life and welcomed the declaration of the present bill as the first step towards a great system.

## MINERS ARE TO RESIST SOLDIERS

Foreigners of Minersville, Pa., Rush to Buy Weapons, and Ambuscade Is Feared.

PHILADELPHIA, May 9.—(Can. Press.)—The feeling of bitterness engendered among the foreign-speaking miners of Minersville, when three of their countrymen were shot by the state police during a riot, was further kindled late today, when Michael Whelan, one of the trio, died.  
That trouble is brewing is apparent from the amount of firearms being purchased by naturalized foreigners. Several dealers in Minersville have practically sold out and there is also a big demand for firearms in Pottsville.  
Capt. Wilhelm of the state police says there is no way to stop the sale of this kind of arms without the use of martial law. He is not sure that the situation does not warrant such a step at present.  
Others of the state police fear that an attempt may be made to lead their men into an ambush along some of the mountain roads. They believe that the naturalized foreigners are distributing the firearms to their countrymen with this object in view.  
The Minersville town is being made miserable by the presence of a large number of the foreign element 10 hold a big demonstration when their funeral takes place.  
There has been no serious rioting in the coal field today. Some women and boys marched to two warships which were in the harbor, with the intention of driving the employees from their work, but were surrounded by union officials to return to their homes.

## MOVING PICTURE REGULATIONS STRICTER

Theatres Must Have Two Aisles—Chairs to Be Fastened Together and Nailed to Floor—Must Display Censor's Certificate on Bill Boards.

More stringent regulations of moving picture shows will be enforced on June 1, with respect to illumination, supervision of films, width of aisles, and licenses.  
According to the new regulations, theatres with a seating capacity of 500 or under must have two aisles running from the front to the rear, and three feet in width. With accommodation for 500 or under a theatre must have two aisles each 3 1/2 feet wide, and over this capacity two aisles each 4 1/2 feet wide. The exits running across the auditorium must be 3 1/2 feet wide, regardless of the size of the house.  
The regulations do not cover building construction or the number of exits. All this is governed by the Municipal Act.  
**Chairs Must Be Fastened.**  
Another change is in regard to the chairs used in theatres. In many rural towns common splinter chairs are used, which are not fastened to the floor. According to the new order all chairs must be backed together and nailed to the floor.  
There have been many complaints about the lack of illumination in picture shows. The new regulations call for two candle power lights during the performance, which will mean that all people in the theatre can be seen. The screen will not be turned in any way by this light.  
**Censorship of Films.**  
The law will be made more effective in the matter of censoring films. In addition to the stamp of the chairman of the board of supervisors on all films, to make doubly certain that they have the approval of the board, a certificate will be shown on the signs on display in front of the theatre which will check the cases of the board's stamp of approval being transferred from an authorized film to an unauthorized one. When a film is shown which has not been looked over and approved by the board a fine of not less than \$50 and not more than \$200 will be imposed and the film may be confiscated and burned.  
**License Fee Changed.**  
As the result of complaints the board is given power to increase the fee used in connection with lectures and entertainments, where necessary.  
The license fee for film exchanges is changed from \$1 to \$2, and that for peddlers going about the country to sell a film business without paying a license fee. It will also protect the owners in small towns who formerly have had to pay the same rate as city theatres.  
The fee for an operator's license is increased from \$1 to \$5, and provided a license is made to the effect that no licensed operator may handle a machine. A class of apprentices or assistant operators is created, each having to pay a fee of \$1 for six months at the end of which time he will be fully qualified. The license fee for a machine is increased from \$50 to \$75 a year.

## SLAYER OF PORTER TAKEN TO LINDSAY

"I Have No Religion," Ellis' Reply to Warden—Never Drank Liquor Nor Smoked.

LINDSAY, May 9.—Arthur A. Ellis, slayer of Lewis Porter, whom he shot on the road near Minden on April 25, was today brought here from Minden and lodged in the county jail to await trial next fall. There was a crowd at the station when the prisoner, wearing handcuffs and escorted by Constable Welch, arrived and he was hurried into a cell. His face looked haggard and dark circles under his eyes told of sleepless nights.  
In the office of Warden Balfour of the jail Ellis's handcuffs were removed and he was asked a number of questions, to which he returned ready answers. He stated that he was Canadian-born, that his home was in the Township of Lutterworth, where he farmed for a living.  
"I have none" was his reply to the warden's query as to his religion. He added that his parents were Baptists, but that, while he had at times attended the Baptist church, he was not a member. He gave his age as 36.  
"To the question, 'Are you temperate or not?' he replied promptly that he was strictly temperate.  
"I have never used tobacco or whiskey," he volunteered.  
He had never been previously committed to jail, he said.

OTTAWA, May 9.—(Special.)—Rather sweeping reductions in the Canadian tariff are likely to be made by the Borden government in a few days, probably before the elections come off in Saskatchewan. The reductions will be made by an order in council.  
Farmers are likely to get relief in the items of lumber, cement, agricultural implements, clothing, sugar, explosives, fence wire, cotton, coal oil, doors, leather, boots and shoes, rubber goods. The reductions are aimed, it is said, especially at articles produced by combines. Cement is one of these.  
And the farmers of the west, if they cannot get their grain into the American market, are to get relief from trust prices in Canada for what they buy.

**Under the general Customs Act, the government of the day possesses wide powers in the matter of reducing, suspending and refunding tariff duties imposed by parliament. The act confers upon the governor in council the power of "transferring to the list of goods which may be imported into Canada free of duty, any or all articles, whether natural products or products of manufactures, used as materials in Canadian manufactures; any such materials transferred to the free list by such order in council to be free of duty of customs for the time therein appointed for that purpose."**

**The governor in council is also vested with the power of "granting a drawback of the whole or part of the duty paid on articles which have been used in Canadian manufactures, or granting a certain specific sum in lieu of any such drawback."**

**Other specific powers of exemption are vested in the government, such as a power to admit free of duty from the United States Canadian grain grown or Canadian logs sawed in that country, and by the Customs Act of 1906, it is provided that the minister of customs may remove the duty from articles which are not manufactured in Canada in substantial quantities or sold to all consumers on equal terms.**

**This summary is not exhaustive, but it sufficiently discloses the purpose of the bill to vest in the government of the day wide powers in the matter of making specific changes in the tariff.**

**The law, as amended in 1907, gives to the government wide powers in the way of reducing or removing the tariff duty when the article protected by the tariff comes under the control of a trust or monopoly. The governor in council, if satisfied from the judgment of any court or judge in the Dominion that a conspiracy exists to enhance the price of any article upon which there is a tariff duty, may suspend such duty in whole or in part for a time specified. The government may also appoint any superior or county judge to enquire summarily into complaints as to the existence of such a trust or combine and upon receiving such report may put the article on the free list or reduce the protection extended by statute.**

BRITISH NAVY TO BE SUPREME

Must Make It Secure Against Every Danger, Says Asquith — For Defence, Not for Aggression.

LONDON, May 8.—(Thru Reuters's Ottawa agency.)—Premier Asquith was the principal guest last night at the dinner of the Central Association of Bankers.

"I have just come," said the premier, "from witnessing a spectacle to which I suppose there has never been a parallel in the history of the world—the great British fleet which is now assembled under the eyes and in the presence of the King at Weymouth. There never has been, I believe, in the same space of water such an aggregation of the implements of destruction, and as I went around the fleet and inspected at close quarters some of these magnificent, if monstrous, achievements of modern science, the thought could not but occur to me whether the time might not some day arrive, perhaps within the lifetime of the younger generation who are sitting at these tables, when this gigantic expenditure would be diverted into more fruitful and more useful channels and the world be saved from the incubus which at present rests upon some of its best aspirations."

"So far as we are concerned and so far as the fleet of Great Britain is concerned, we know it to be and the world knows it to be the greatest and most aggressive, but of defence, and with the counsel and ever multiplying interests of which we are the trustees and guardians we cannot afford, so long as the world remains in its present temper, to neglect any means for making these interests secure against every danger. The maintenance of supremacy, of our invincible supremacy at sea, is our first and fundamental condition not only of the integrity of the British Empire, but of the life of the British people."

INSURANCE MANAGER DEAD.

WATERLOO, Ont., May 9.—W. H. Riddell, assistant manager of the Mutual Life Assurance Company, died this morning from apoplexy, after a few hours' illness. He was born in Sparta, York County, August 18, 1827, taught school in the counties of Grey and Bruce, and in the '70's was in newspaper work in Toronto, becoming in 1876, John owner and manager of The Toronto Tribune. He joined the staff of the Mutual Life in 1882 as secretary.

WILL BE TRIED AT THE ASSIZES

The brief was refused after a student had been sent to the jail to hear Gibson's story, but Mr. Blackstock has not yet fully decided whether this will prevent him from conducting the prosecution.

WASHINGTON, D.C., May 8.—The Titanic enquiry was reopened by the senate investigating committee to-day to permit testimony by Maurice Farrell of New York City, managing agent of the Dow Jones & Co., stock news service. A number of affidavits and letters were read into the record, including a statement of Dr. F. C. Quilford of Toronto, a passenger on the steamer Mount Temple.

Mr. Farrell claimed that the returning information sent out on Monday, April 15, was virtually all from the White Star offices. One despatch sent out at 8:58 a.m., that all Titanic passengers had left the ship after 2:30 a.m. was from the Boston News Bureau. "Prior to that we had received from the White Star offices, a statement somewhat similar," Farrell said.

The Laffan News Bureau had given the bus for an item of an attempt being made in London to re-insure the Titanic's cargo. He had been too busy to attempt to confirm it. Witness was unable to find in the record of his service a Montreal Star despatch at 9:45 a.m., reporting the Titanic headed for the coast, or one at 8:53 a.m., that Vice-President Franklin had reported the Olympic in direct communication with the Titanic.

## CITY SELLS KING W. CORNER

Toronto Carpet Company Purchase Dufferin and King Site for \$81,000—Factory to Cost \$100,000.

Coming up at last to the city's price, the Toronto Carpet Company have offered to purchase the city's lot at the southeast corner of Dufferin and King-sts. for \$81,000.

The property has a King-st. front of 245 feet, and extends 300 feet on Dufferin-st. Last year the city was offered \$60,000, but refused to accept. The purchasers agree to erect a factory on the east side of Dufferin-st. to be returned to the city at purchase price in case it is wanted for street widening. The purchasers agree also to erect a factory to cost \$100,000 and to employ 150 people. Payments will extend over five years, with a first payment of \$10,000.

The property is almost two and a half acres in extent.

## Changed Name To Fairmount

Finding that some one else had already appropriated the nice name, Westmount Park, for a subdivision, W. N. McEachren & Sons have had to look about them for another appropriate title for their Bathurst-st. offering. They have chosen the name of Fairmount Park as one suitable to the property's location and also in accord with their practice of using the word "mount" in naming all their properties, the altitude of which permits of it. The opening sale of Fairmount Park (formerly Westmount Park) takes place tomorrow.

## AFTER FARMS NEAR WESTHILL

Two Men Seeking Options for Gentlemen Farmers or Radial Railway People—Several Approached.

Seeking options on farms, two Englishmen are much in evidence in the farming district around Westhill and several owners admit having been approached. How much success the men have had in securing properties is not definitely known.

The general feeling is that a move to establish another gentry farmers' colony around Highland Creek is in progress, but it is more likely that the movement is inspired by someone acquainted with C. N. R. or radial plans. At Pickering, five miles further east, where Lord Somers and Lord Hyde last fall bought farms, as reported in The World then, R. J. Fleming, Noel Marshall, W. H. Moore and others closely in touch with railway movements, also secured extensive tracts, which they are this year cultivating after their own fashion.

The land for ten miles along the lake-shore from Toronto east is now owned, except for two farms, by city folk and speculators. It will not be long before they own everything another ten miles east.

## Can't Escape Busy Signs of City's Progress

Just as the lieutenant-governor leaves a scene of smoky toil at King and Simcoe-sts. for an atmosphere of intellectual and social placidity at St. George and College-sts., the city begins tripping up Beverley-st. for a place wherein to lay big watermains, and thereby much marring the southern outlook from the Broad Beardsmore verandahs. And when the lieutenant-governor that is to be moved into the mansion now building at Chorley Park he'll have a fine view of them making bricks to make the city bigger.

## KING ST. DEAL FOR \$8000 FOOT

Purchase Pending of Chop House Property—Childs Would Lease Ground Floor—Bigger Deal Rumored.

Negotiations are on for the purchase of the English Chop House property at 30 West King-st. It is owned by Augustus Thomas, and occupied by Downey & Howell, whose lease has two years to run.

The property has 39 feet frontage. The price at which negotiations are on for is \$250,000, or \$6400 a foot. The owner has lately several times refused \$7000 a foot.

It is also learned that the Childs restaurant people are anxious to make a deal with the purchasers of this property to lease the ground floor. Just who are the purchasers is not given out, but they are probably members of a local financial syndicate.

Rumor has it that the sixty feet just west of the chop-house is also being negotiated for, and while this was given a denial by representatives of the owners, the Crawford Estate, there may be considerable truth in it.

## Western Firm Opens Office

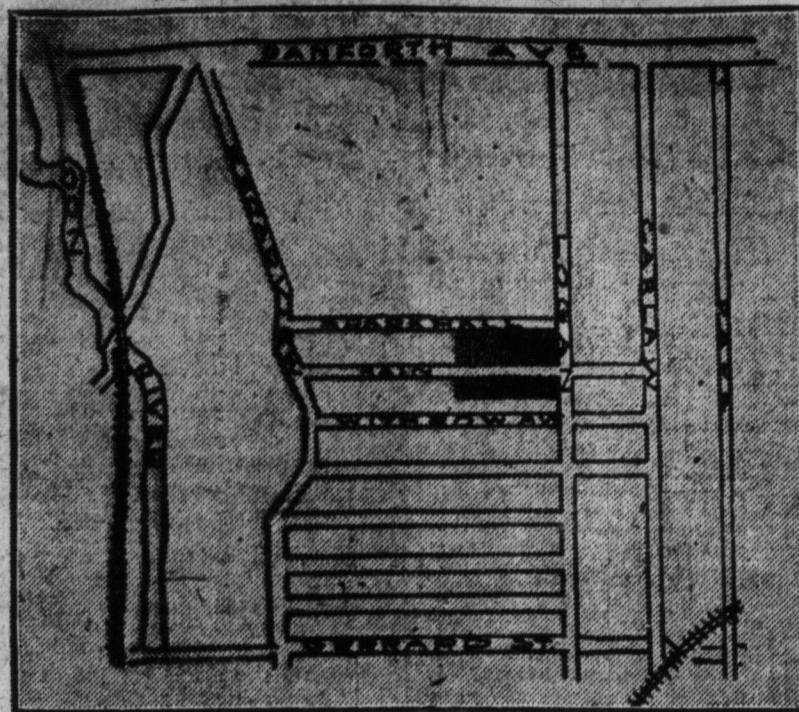

The committee is buying 537 feet on the south side of Sparkhall-avenue and 592 feet on both sides of Bain-avenue. All this land was acquired by the city at tax sales.

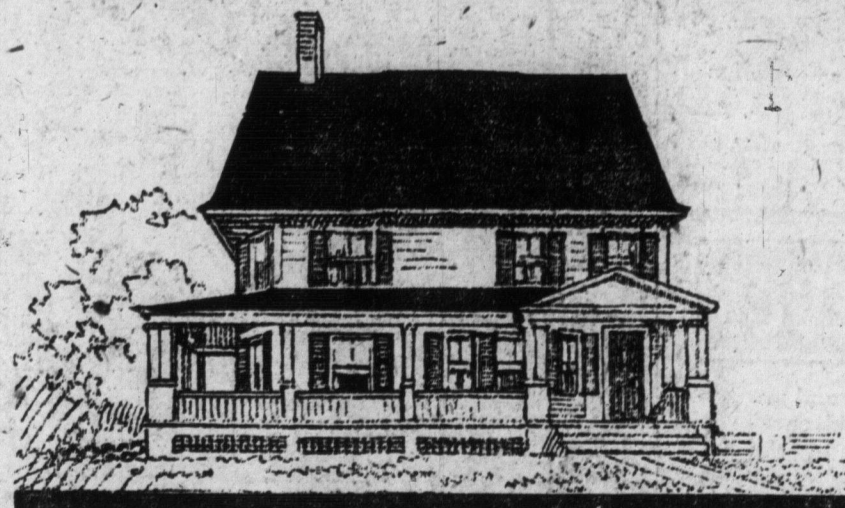

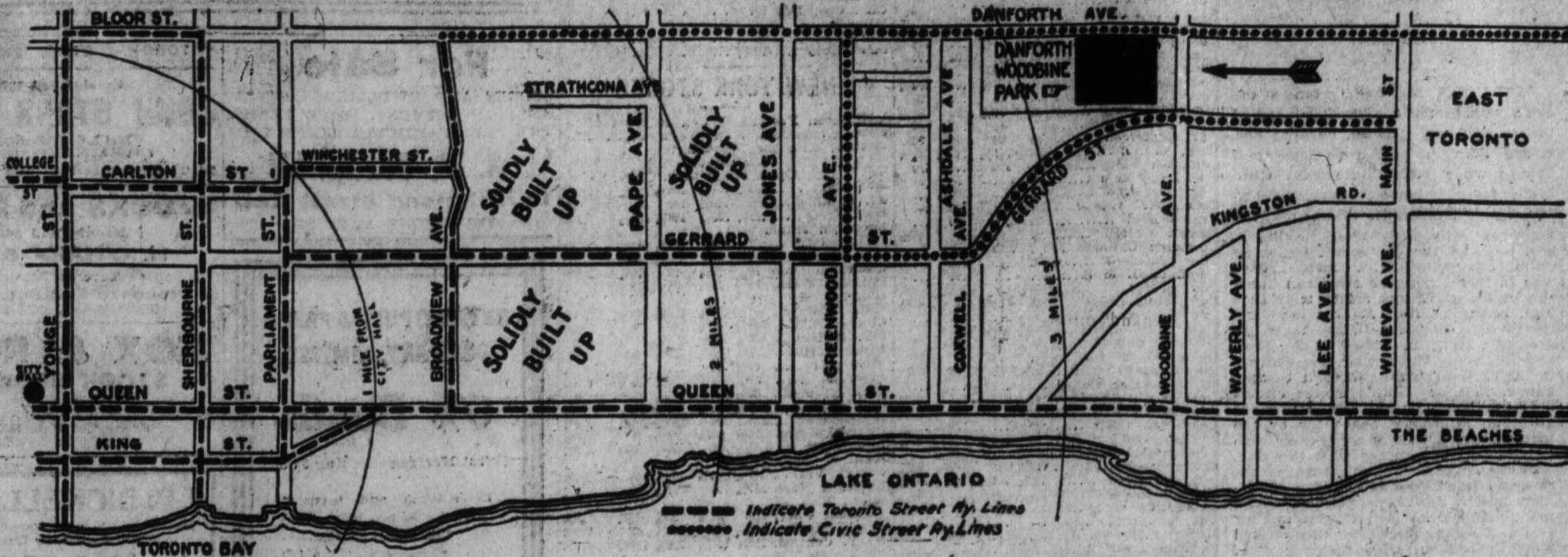

According to the itinerary adopted, the first week will be spent in the Maritime Provinces, and the remainder of the month will be devoted to visiting the leading centres of Ontario, Quebec and practically every important point west of the great lakes.

EARLY ADVANCE IS WIPED OUT

New York Market Helped by Court Decision, But Late Selling Reversed Its Position.

NEW YORK, May 9.—The tone of today's market for the greater part of the session was more steady and strong than at any time since last Friday when prices underwent their first reversal in some weeks. Dealings were again in moderate volume, but the movement was fairly broad, taking in a number of the equipment issues as well as the semi-active shares. There was further buying of American Steel, the preferred shares rising to a new high record of 130. All the standard issues were higher, with the usual decrease in the afternoon when it became known that the United States circuit court in New Jersey had refused to grant an injunction asked for by the federal government in connection with the inquiry now proceeding in this city. In the final hour the entire market reversed itself, beginning with a further decline in the steel shares, which fell to 129 1/4. Its lowest price in four years. A selling movement then ensued which wiped out the greater part of the previous day's advance, leaving the market to minor proportions. The severe break in Illinois Central was attributed to the heavy losses the property is supposed to have incurred as a result of the disastrous floods in the Mississippi Valley.

Bank Rate Was Cut to 3 Per Cent.

LONDON, May 9.—The Bank of England rate has been reduced 1/4 to 3 per cent. The proportion of the bank's reserve to liabilities is now 51.33, against 43.30 per cent. last week. The reduction in the rate of discount was a natural consequence of the bank's stronger reserve brought about through the inflow of gold arrivals and the return of cash from the country. The discount houses lowered the market rates to 3 1/2 per cent., and consequently the Bank of England would have found it difficult to make a 1/4 per cent. rate effective.

Gold Output Of Rand at New Record

LONDON, May 9.—At the annual meeting of the Transvaal Chamber of Mines Mr. H. O. K. Webber sounded a cheerful note of optimism regarding the future of South African mining. The mines of the Rand during the month of March made another record, the production reaching 220,720 ounces, against 176,000 during the similar period of 1911. In summing up the output of last year it was pointed out that the mine yielding the largest profit was the Crown Mines which milled 1,613,400 tons, at a working profit of \$1,572,944, or 15 shillings 9 pence per ton. This tonnage was exceeded by both the East Rand Proprietary and the Rand Fontein Central which milled 2,156,325 tons at a profit of \$213,892 and 2,157,231 tons at a profit of \$262,000 respectively. The record for productivity belongs to the Robinson which yielded 189,000 tons, or 30 shillings 11 pence per ton. This is a notable record, and none the less the whole output has been expanding profits have been contracting, while operating costs show a deplorable tendency to increase in many instances. Operations suffered, in several instances, from what in this country would be called 'shake-ups'.

Steel Will Not Earn its Dividends

NEW YORK, May 9.—A prominent steel interest figure that the U. S. Steel Corporation in the current quarter will show earnings of \$22,000,000, which hardly will cover dividend requirements if proper charges are made for depreciation. This would mean a deficit for the first half of the year of about \$6,000,000. There has been some change as to the average price basis upon which steel deliveries will be made in the current quarter. One manufacturer figures that the advance over the first quarter will be less than \$1 a ton. Many classes of steel have not been advanced at all, and great deal of steel purchased at the very low prices will be delivered in the current quarter. The Steel Corporation over the last fifteen months has issued a balance of \$4,000,000 of bonds, therefore increasing its debt to \$17,000,000 a year. This is what it has cost the Steel Corporation to maintain a five per cent. dividend on the common stock, which calls for an outlay of more than \$25,000,000 a year. There has been a great deal of selling of steel common by holders who believe that a board of directors as conservative as that of United States Steel would hesitate to continue the 5 per cent. rate if the outlook did not promise an improvement in earnings over the first half of this year.

OUR BANKS HAVE 2,715 BRANCHES IN CANADA 2,641

The Canadian chartered banks maintained 2,715 branches at the first of the month, according to figures of the Bank Directory, just published. Of these 2,641 were in Canada, 12 in New Brunswick, 2 in the United States, 2 in France, 14 in the West Indies, and 2 in the West Indies. The statistics by provinces follow: Ontario 1,061, Quebec 430, Nova Scotia 114, New Brunswick 12, Prince Edward Island 7, Manitoba 196, Alberta 230, Saskatchewan 236, British Columbia 218, Yukon 3. In Newfoundland 12 elsewhere 12. Total 2,715. During April 24 new branches were opened in Canada, and 6 closed.

KNITTING ISSUE OVERSUBSCRIBED NEARLY DOUBLE

Messrs. A. E. Ames & Co. state that subscriptions received for the Monarch Knitting Co. preference shares during the one day the books were open were \$1,250,200, as against the \$750,000 offering. The number of subscriptions being 214. Allotment has been made in full to 20 shares on every subscriber, which takes the amount available at most exactly. All subscriptions have been refused since Wednesday afternoon, except those mailed on Wednesday. A lotment notice will be mailed this (Friday) evening.

NEW YORK HEARS STORY ON C. P. R.

Brokers wires from New York carried a statement yesterday to the effect that Canadian Pacific is held by purchasers who bought around 230 with the idea that a segregation of the land holdings of the company will take place in the near future, inferences are drawn in certain ways by others to the same end. Rights going up to dizzy figures are mentioned in case a C. P. R. company, to be called the Canadian Pacific Land Co., were formed under the suggestions supplied.

CROP EXPERTS EXACT ENORMOUS TOLL THIS YEAR

Since the crop specialists took to the field two or three weeks ago the United States has lost over 100,000,000 bushels of winter wheat. Men on whose judgment the grain trade relies figure that with 7,000,000 acres abandoned, at an average of 15 bushels an acre, these men are getting a large measure of confidence when they lay off a quarter of our neighbors' biggest breadstuff crop, at the rate of 5,000,000 bushels a day, counting Sundays. But the market is willing to take them at their word. And so there is no other way than to let out string in order to see price-ticks slip. It is in the third heavens of April winds.

A special general meeting of the shareholders of the Bank of Montreal has been called for Tuesday, the 18th of June next, to take into consideration a bylaw increasing the capital stock of the bank by \$20,000,000, thereby making it \$25,000,000.

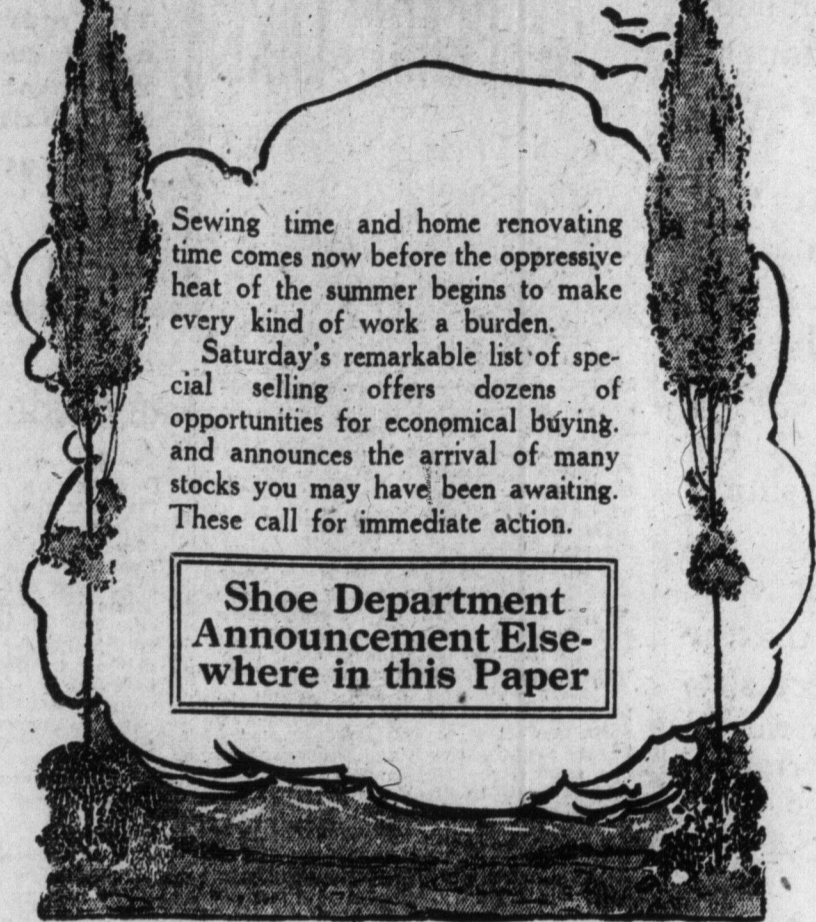
