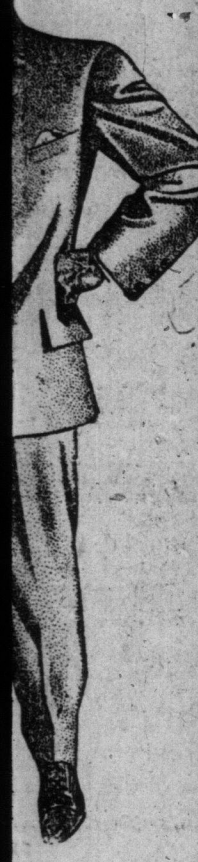

NIAGARA POWER POLICY RECEIVES ONTARIO'S UNANIMOUS ENDORSEMENT

MAY BE AT ROYAL OFF COAST OF IRELAND Lake Manitoba Goes to Assistance of Vessel Closely Answering Description of Missing Boat.

Hope for the safety of the Mount Royal was twice revived yesterday. One was short lived—the other is still to be dispelled. The foundation is told of in the following Liverpool cable: The steamer Lake Manitoba will be despatched at noon Tuesday to the assistance of a steamer, presumed to be the overdue Canadian Pacific Railway Liner Mount Royal, reported 250 miles west of Fastnet. The Manitoba carries special provisions, doctors and towing tackle. The news of a vessel believed to be the Mount Royal was brought to Liverpool Monday by the Spanish steamer Vivina. The steamer sighted answers the main details of description of the Mount Royal. The Vivina's captain says that although indistinct, the name by the sign closely resembled "Mount Royal." The steamer also asked to be reported to some railway company, the name whereof was indistinguishable. The only explanation of her position lies in a breakdown of machinery. She was sighted Jan. 3, the precise location being latitude 51.20 N. longitude 12.55 W. Canadian Pacific officials are confident she is the Mount Royal. Word was received yesterday afternoon from Brier Island, near St. John, N. B., that two four-masted steamers were coming up the Bay of Fundy. One message said that the rear vessel was in tow and flying G.P.R. colors. This was an error, however. The steamer Monmouth arrived last night and the other vessel proved to be the Montemora. S. Ziegler of 95 William-street, caller at S. J. Sharpe's office yesterday and asked if the names of all the passengers were known. When told the list had not arrived, he said: "I expect my mother is on that boat, and I am anxious." Another man who made enquiries said that he thought his brother was a cook on the steamer.

Report at Montreal. MONTREAL, Jan. 6.—A despatch from Mr. A. Piers, manager steamship lines of the Canadian Pacific Railway, Liverpool, says: "A steamer resembling the Mount Royal has been reported in a position 250 miles west of Fastnet Light, west corner of Ireland. The Canadian Pacific steamer Lake Manitoba, which has been held in readiness at Liverpool for the past two days, was immediately despatched to the assistance of the Mount Royal. This latter steamer is now thirty days out from Antwerp, and the Canadian Pacific officials are very hopeful that in a day or two they will be able to announce that the missing ship with her passengers and crew has been safely towed to port. No details are as yet available as to the cause of the delay, but it is generally believed to be due to a breakdown of her machinery or propeller.

Another Ocean Tragedy. NEW ORLEANS, La., Jan. 6.—Capt. Henry Daniel, who brought the steamer Alexandria of Liverpool into port, reports having passed close to a small vessel floating bottom up on Jan. 3, in the Gulf of Mexico. On the same day the Alexandria passed within a short distance of a waterspout.

Two Sailors Drowned. LONDON, Jan. 6.—The British tank steamer Houstonite, Captain Henry, which sailed from Barrow last Saturday for New York, was wrecked on Maiden Rock, off Portland, County Antrim, Ireland, early Sunday morning. Two of the crew were drowned.

BUTCHERS ON STRIKE. Hebrew Meat Sellers Refuse to Meet Wholesaler's Raise.

Twenty-four Hebrew retail butchers went on strike yesterday morning and refused to sell the meat supplied by the wholesale dealers because the price was raised 9 cents per pound. The merchant butchers held a short meeting last night, but decided not to do anything until this morning, when the matter will be discussed again.

DEAD MAN LEFT LETTER FOR EARL Suicide of Young Man Who Asks That Governor-General Be Notified.

NEW YORK, Jan. 7.—A young man, believed to be H. Grey Duberly, son of Capt. James Grey Duberly, R.M., of the Gammon, Westcliffe, Yarmouth, England, was found dead in bed, evidently from the effects of a narcotic poison, in the Hermitage Hotel to-night. Six letters were found in the dead man's room. One of the letters was addressed to his father and another to the Hon. Earl Grey, governor-general of Canada. Another letter was addressed to the manager of the Hermitage Hotel and said: "Kindly communicate with my father, Capt. Grey Duberly, the Cannons, Westcliffe, England, as will detach all expenses. Also communicate with Earl Grey, Ottawa, Canada. I regret, but all expenses will be paid. (Signed) H. Grey Duberly." Duberly arrived on Sunday evening. An examination was made of Duberly's letter to his father, it was opened and read. It said: "By the time you receive this letter I shall be no more. You killed my mother and you have compelled me to commit suicide. Had you treated me as a father should treat a son, things would have been different. I forgive you and I hope God may forgive me. I only hope you will treat the rest of the children better than you have treated me." Duberly is said to be a cousin of Earl Grey's.

DOCTORS CRITICIZED BY GORDNER'S JURY But It's Hard to Detect Between Injury and Intoxication, They Say.

"Andrew Knapp came to his death on the morning of Dec. 25, 1907, from hemorrhage of the brain, the result of a street car accident in Church-street, just south of Shuter-street, between 5 and 7 o'clock Tuesday, Dec. 24, and we are of opinion that cases of this nature are of the opinion too lightly and do not receive proper consideration, and would recommend that a thorough diagnosis of all injured persons be made as soon as possible after arrival at the hospital." This was the verdict delivered last night by a jury under Coroner R. J. Wilson, after hearing a great mass of evidence. Immediately after the accident, Knapp was taken to the hospital. There it was decided that he was merely drunk, and he was removed to the Agnes-street police station. He was taken back to the hospital early Christmas morning, where he died about 8 o'clock. "Is it beyond medical science," asked W. L. Drayton, "to distinguish in a diagnosis between fracture of the skull and drunkenness?" "It frequently is," said Dr. Harrington, "and in my opinion he was sustained by Dr. Johnson."

INGERSOLL, Voting on an Exceptional Case, Only Municipality to Reject Bylaw for Distribution of Niagara Power Procured From Government.

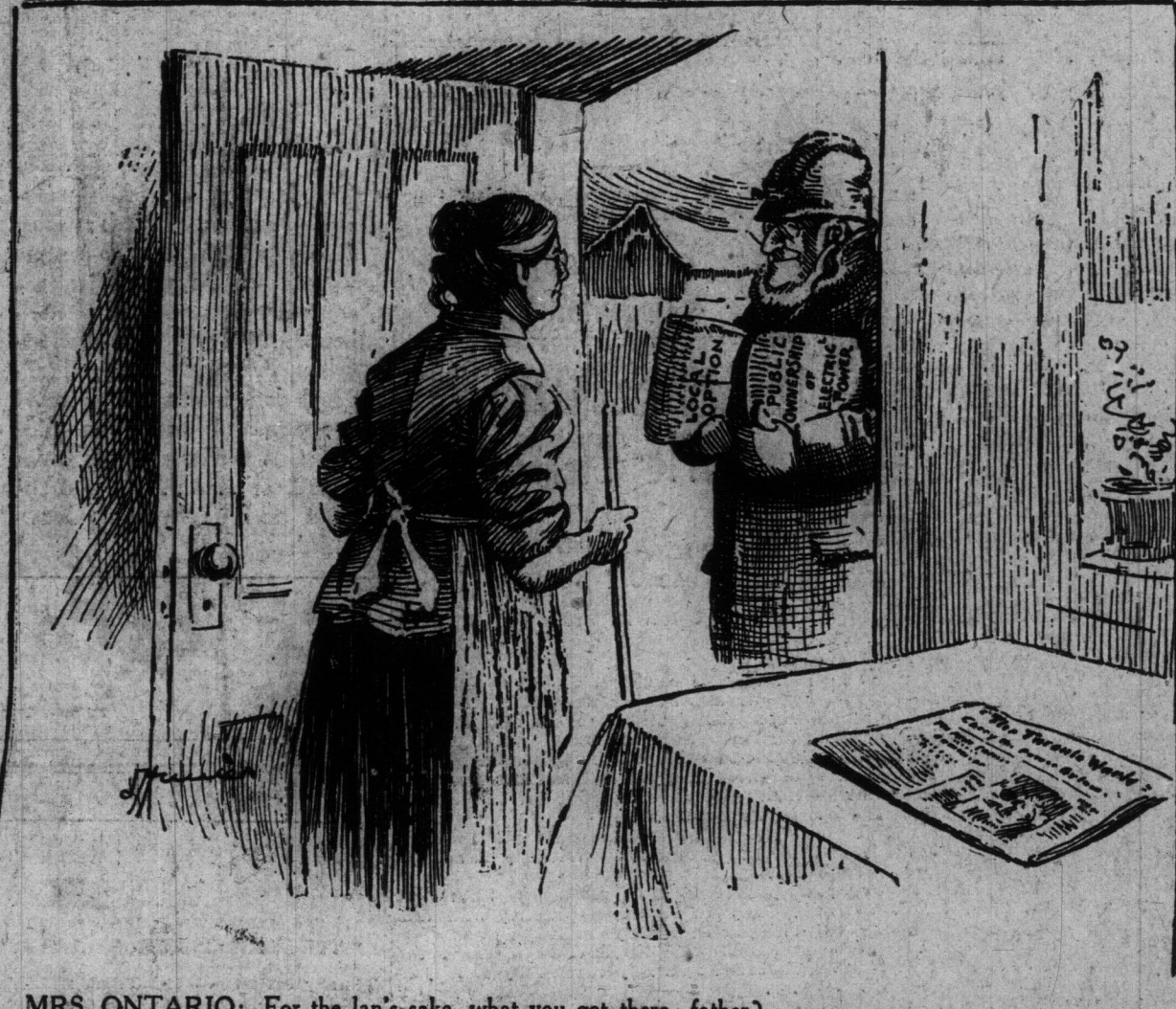
In a dozen cities and towns yesterday the Niagara power bylaw was submitted to the ratepayers, and in every case but one, to be specially mentioned, it was carried with majorities ranging in about the same proportion as in Toronto last Wednesday. London and Waterloo carried it by 3 to 1; Hamilton by 2 to 1; Guelph by 10 to 1; Brantford had 131 to 734; Woodstock, St. Mary's, Hespeler and New Hamburg were all in line. Hamilton bylaw was for \$275,000; London \$235,000; Galt \$66,000; Brantford \$45,000; Guelph \$45,000; St. Thomas \$42,000; Stratford \$35,000; Waterloo, \$10,000; New Hamburg \$10,000. Such self-realization on the part of the people rarely comes without a long struggle, but five years' education and the pressing urgency of the situation taught them this lesson. The people have been apt pupils in their own interests, and the result is a great big win. It is a notification to the rest of America that Ontario is a country where the people know their rights and will defend them. It is an endorsement of the Whitney policy of giving the people their own money when they want it. They have been jagged in the fight, and in some quarters where assistance should have been hearty and ready it was lukewarm and slow and even held back. The people know their friends and have been making notes of the merely professing allies.

Mr. Beck's Statement. Hon. Adam Beck was at the Queen's Hotel last night, and heard the result with pleasure. In an interview with The World he said: "Notwithstanding the strongest kind of opposition against the power bylaw this great question has triumphed. Misleading literature, hired men who canvassed from door to door, and who manned the polling booths, did not deter the people from being true to themselves. There can be no doubt the ratepayers have expressed their approval and confidence in the scheme, and put the policy into practice. I proceed with and carry into successful operation this great provincial project. Premier Whitney was informed of the result by The World. 'It seems to be very satisfactory,' he remarked.

They Want Power. The declaration yesterday's polling gives of the people's desire shows that the hydro-electric power policy was a correct interpretation of feeling in Ontario. The people want Niagara power. They won't be happy till they get it.

It is an intimation to the government to get ahead as fast as they can and put the policy into practice. It is understood that the contract for power at \$10 per horsepower produced to \$10 as soon as 25,000 horsepower is used. This amount will probably be surpassed by the time in two or three months, that the transmission lines are built, and the distributing

WHITNEY ON THE REVIEWING STAND.

After the splendid victory of yesterday, Mr. Whitney will now have time to take stock of the situation and to review his list of friends. He will have discovered by this time that greater even than the revolution of feeling against the Ross government in the election of 1904 is the strength of public opinion in favor of the principle of public ownership, applied to the distribution of electrical energy under the Hydro-Electric Commission Act. There never was such a clear expression of opinion from a great section of the community, and almost irrespective of party faith, in favor of any measure as there has been in this case. And it was all straight from the people — no party inspiration, no party leadership, simply the clear voice of all the people. And the clear voice of the people all in one way — we want cheap energy for light, power and heat; and we are willing, as municipalities, to incur the necessary liability therefor, and we are willing to endorse any expenditure that you, Mr. Whitney, may recommend to the legislature to complete the service. There is in this province, it is clear, no issue comparable with this one in interest, or in unanimity of public support. So much for the policy.

Now, let us come to Mr. Whitney's friends. There were some lukewarm supporters, there were some quite antagonistic friends. They came to him with hints, and they came to him with threats. They hated public ownership; they loved better the private corporations that sought to set up the public in unjust contracts, high prices and other entanglements. Mr. Whitney knows quite a number of such men. Then, as to the newspapers: He had The Mail, which fought the Beck policy at every turn, the professing to be the chief organ; The Hamilton Spectator, another power organ, that had nothing but scorn for the Whitney-Beck policy and admiration for Hon. J. M. Gibson and his works; The Toronto News, that you'd imagine had been expressly started to steer Mr. Whitney thru the devious temptations of government, and to keep him in the only path of political rectitude — this paper saw fit to show itself as nothing but a power organ, and actually saying that Mr. Whitney was both immoral and dishonest in connection with the question. And there were others. Mr. Whitney can now appreciate the strength of his policy, realize the unreliability of certain friends, and the faithfulness of journals that professed loyalty to the cause of the people.

And he can see how anxious the people are that he go right ahead with the realization of his public power policy.

It is not surprising, therefore, that the intelligent citizens declined to spend \$50,000 for an article not half so good. A similar result with similar lessons for the corporations was arrived at in Weston. There a bylaw was submitted for the purchase of the Stark Telephone, Light & Power Co. It was defeated. The people are leary when it comes to buying second-hand plants with first-hand cash. A bylaw to buy out the Toronto Electric Light Company's plant for anything over its assessed value would undoubtedly meet every year as ordinary business men would not purchase. It is good business to write off depreciation every year as ordinary business men do. When a plant is for sale, reasonable prices are then satisfactory. Toronto has nothing to delay about in proceeding to deal with the question. Now that the province stands solid for Niagara power, and the new mayor and council must realize this and take the earliest opportunity and means of maintaining and confirming the leading position the city has so far held in the power campaign. It is not a local, but a national issue, not a political, but a popular vote. Premier Whitney and Hon. Adam Beck are to be congratulated in being the agents thru whom the people have found a voice.

The World long ago started to preach public ownership—and once having taken it up, never for a moment hesitated in its mission, to it encountered all kinds of opposition, all kinds of ridicule, sometimes loss of business, and nearly always had sinister motives imputed to it. And yet The World has won.

The World has seen the false friends and the pretended friends of public ownership sorted out and found out. The World has, we are glad to acknowledge, also seen the friends and advocates of public ownership grow steadily in numbers and solidity.

The house of commons started in to jeer at it and then to vote for it. Public ownership is everywhere in the air and is the one clear answer to the arrogance and lawlessness of the corporations and the overcapitalization of the new get-rich-quick-at-the-public-expense school of finance.

Public ownership must now be reckoned with all along the line and a new day has dawned for the people in regard to public utilities.

The political parties must now salute it in the public way—and then grab it if they can.

The foolish talk of public ownership as "hyterics," as a "South Sea bubble," as a "fad," and its advocates as "freaks," had better cease.

Public ownership means new legislation in the direction of public rights, means an end to the insolent attitude of the corporations, for instance, of the Toronto Railway toward the citizens of Toronto, and means that in the case of Toronto the legislature will grant the right of expropriation of the railway any day the city cares to ask for it.

Public ownership is here and the man or corporation that refuses to recognize it and accommodate himself to it is a fool.

importance of the issue, and they know that if the people are to continue to be free, the rights of corporations must be strictly defined.

In Ontario a railway and municipal commission board has been constituted by the government, with less popular authority it is true, than the New York commission, but with similar intention.

Another and similar attempt is in contemplation by the same order of financiers that have been scheming to sew up the electrical supply of the city and suburbs of Toronto.

Some time ago the Toronto Railway agreed to run their cars to Keele-street by the Dundas line. Recently on a tripping pretext the railway has refused to proceed with the execution of this agreement.

The Suburban Railway, which is controlled by the same electric ring, the legally a separate entity, is attempting to lay hands on the privilege of occupying this portion of the track.

Those who know the situation are very well aware that the anticipated annexation of Toronto Junction to the city is one of the main causes of the present manoeuvring.

Another and even more potent motive is the situation that will develop when the electric light and street railway franchises expire. The companies are becoming very much alive to the fact that no renewal of these franchises will be given, and they are now concentrating their efforts on obtaining perpetual running rights for the radial railways, which ought, with the city lines, to form a publicly owned and operated transportation service.

This scheme must be nipped in the bud, and it is up to the provincial railway commission to do it. At bottom the street and radial railways question is one of the same with the power issue.

Cheap transportation is dependent on cheap power and the elimination of the factor of private profit. Toronto and its suburbs must have that cheap power, and no franchises must be granted, directly or indirectly, and nothing done otherwise to hamper or restrict the absolute freedom of the citizens to re-arrange the urban and radial transportation service in the public interest.

The wisest efforts will be made during the present year to steal from the public the valuable franchise of their street rights for radial railways. To make a foundation for a claim, to bolster up such a claim, to gain grounds for litigation, to encroach upon the public property, and plead possession; in some such way or another the railway corporations are preparing for their grab game by making the most of their present opportunity.

Money is no object to the corporation when it is a matter of hiring the cleverest legal talent and the slickest brains to pervert the intention of the lawmaker and change it into a weapon against himself.

In New York State matters reached such a pass that the people had no alternative but to adopt the method of the autocrat as the only way to deal with insolent and unscrupulous corporations. They appointed a commission and gave it the powers of an autocratic ruler. They endowed it with supreme authority over public service corporations, enabling it to compel the execution of contracts and agreements, or when the intention of these was clear and the phrasing doubtful, to give effect to the intention; or when by error or stupidity the rights of the people were improperly taken, to restore them.

As a matter of fact The News has not proved any repudiation and it has proved its blind eye.

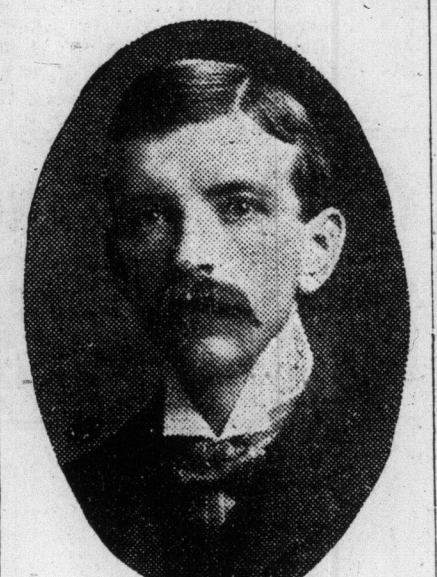
