It affords me great satisfaction to report that during the past term our beloved Order in this jurisdiction has been in a healthy and prosperous condition, and with few exceptions, so far as I have known, regular and harmonious in its workings. The reports received from Deputies D. G. W. P., on the whole concur in assuring me that the Order is established on a firm basis, that many distinguished for their christian graces, moral worth, and ardent love for our cause, are enlisted in our ranks; and those who have lately identified themselves with the Order bring with them enthusiastic hearts, devoted to the relief of human sorrow. With few exceptions the Subordinate Divisions show promise of a cheering revival; the great principles of our Order were never so well understood, nor so firmly maintained by the great body of our members, as at this hour; and whilst our increase has been encouraging, we have fewer expulsions and suspensions than formerly to report.

It is gratifying to find that so many new Divisions have been instituted since our last meeting together, and which are now in active operation in defence of our great principles; this cheering success is attributed to the valuable exertions of our brothers far and near, and to the high estimation in which our beloved Order is held as a thorough stable Temperance organization. Especial praise is due to the brethren of the Palermo Division No. 143, and to brother A. M. Crook, D.G.W.P., for their efforts in extending our Order, three Divisions having been organized in Halton County, and A. D. Huckins, D.G.W.P., has succeeded in establishing two more; brother W. Williamson, D.G.W.P., has been equally successful, having added four more Divisions to those already established in the County of Simcoe. It is pleasing to learn that our worthy brother in the cause, A. Morse, D.G.W.P., has succeeded in instituting St. Ann's Division in the County of Lincoln; whilst many other valued brothers have not forgotten their pledge to diffuse the principles we love.

The efforts to procure the passing of a Prohibitory Liquor Law for this Province have again been unsuccessful, and although we have been unable to gather the golden fruit of Prohibition, still the records of the present Legislature show that the question of Intemperance and its cure has occupied much of the attention of the House, directly or indirectly. We learn that the all engrossing subject has been before the House of Assembly no fewer than twenty-three days of the session besides the attention given to it in the Legislative Council. An act to diminish the number of tavern licences in Upper Canada has become law. We find from the following list of petitions presented to the Legislative Assembly, that no less than 298 Divisions of the Sons of Temperance forwarded petitions in favor of the righteous enactment of a Prohibitory Liquor Law, which shows that the order in this jurisdiction is sound upon this subject, and it also evinces its efficiency as an organization prompt and decisive in action. I would strongly recommend to the Divisions to hold frequent public meetings, and to rely more on local talent and effort, whilst we should at all times encourage Temperance Lecturers who come properly accredited, and who will infuse into our ranks renewed enthusiasm and zeal. Still it is local effort upon which we must depend to bring in recruits and to retain them in the fold.

The suggestion made by our friends in Montreal, that a Provincial Convention be soon held for the prosecution of our great reform, in concert with other organizations, I would recommend to your consideration, and would further recommend that a Committee be appointed to draft an address to His Royal Highness the Prince of Wales, which should be presented upon his arrival, at such place and in such manner as this Grand Division may determine.

The success of other Grand Division Jurisdictions of late is unparalleled in the history of the Order. In Massachusetts during the past year the Order has increased from 5,000 to 36,000 members, and from the large and enthusiastic session of the National Division lately held at Portland, we gather that the prospects of the Order were never more encouraging, not only in the neighboring States and British Provinces, but also in Great Britain and Ireland; we also find that our beloved Order is in the hands of men thoroughly devoted to their work, and that this Order is destined to fulfil the fruition of our hopes and wishes.

Although the Order has suffered somewhat from our brothers dividing their attention with other organizations, still it is universally conceded that their "first love" is deserving of all their care. I would advise the members of our Order to content themselves by devoting all the time, talents and means they have at their disposal, to their Divisions, for I am firmly of opinion that our beloved Order is destined to redeem this fine Province from the blasting, withering curse of Intemperance.

We regret to learn that parties have been so uncharitable, if not viciously disposed, in making false statements prejudicial to Divisions lately instituted, consequently our brothers have been compelled publicly to repel such slanders and ridiculous misrepresentations. I would fain pass over this matter, knowing that the most perfect organizations on earth must meet with opposition; and we may well feel an honest pride in the lofty and influential position which our noble Order occupies in this Province, and it must advance, for we have the power that will turn back the tide of sin and wrong, in spite of slander and abuse. Different organizations for the extermination of this cruel traffic in strong drinks may have different modes of compassing the death of the tyrant Alcohol, and with all such we would be banded together to meet the common foe, but it is expected that courtesy and brotherly kindness should distinguish our actions towards each other, otherwise the bond which should bind us, becomes "a rope of sand."

We deplore to find that after the greatest efforts ever put forth by the Temperance friends in the British Isles (at the head of which stands pre-eminently conspicuous "The United Kingdom Alliance,") they have been unsuccessful in defeating the unwise measure of the Chancellor of Exchequer, to set up a new class of drink shops for the sale of cheap wines, which will assuredly increase rather than abate the vice and misery, and the long catalogue of woes inflicted upon the people by gin and beer drinking.

We view with alarm the license to sell wines in shops up to "40 per cent." of

liquid fire, for the draught will be alcoholic poison in the insidious form of wine. Already has this cheap wine delusion extended to our sister Province of Nova Scotia. There the Legislature has resolved to admit foreign cheap wines. Fatal delusion—if it is expected that this unhappy introduction of mild and cheap wines will promote Temperance. Let our brothers be watchful to guard this fine Province from such contamination and misery that would be the consequence of the common use of alcohol in this seductive shape.

I am happy to know that our accessions are from all the professions, avocations and conditions of life, from the workshop and the farm, and that our organization is adapted to all and should receive all our care and devoted attachment. How many cases of peculiar interest could we revert to—the lost and wandering restored to parental confidence and love. The once intemperate father and husband now lives in the smiles of his beloved and happy family. How many thousands, tens of thousands of happy wives and blessed little ones, have been made happy through the instrumentality of the Sons of Temperance, time can never know, Eternity may disclose it. Brothers, let us cherish our loved institution and guard well its purity.

The importance of the Juvenile Temperance movement demands your serious attention. This Grand Division I am aware has from time to time given much study to this subject; at last session it recommended Divisions to encourage "Bands of Hope," and has at considerable outlay published a suitable ritual and books for "Sections of Cadets." The latter organization appears to me better adapted to youths more advanced, and is exclusively for boys, while the "Bands of Hope" are suitable for children of both sexes. I would recommend this Grand Division to co-operate with the "Central Band of Hope Committee," lately formed in Montreal, in the promotion of an object so desirable. In this connection I would make mention of the thirty-one Sections of Cadets in union with this Grand Division, which are working harmoniously and well. From late returns we find that 1,550 Cadets of Temperance are enrolled in membership with the Sections.

It is with much pleasure I can testify to the great benefit of lady visitors in our Order: they are the means of strengthening many a father, husband and brother—yes, and sister—in keeping their pledge, while many a poor wanderer from the path of sobriety is encouraged by lady visitors to unite with the Champions of Temperance. May God bless the lady visitors, and make them more and more a blessing to our Order. For the statistics of the Order I refer you to the Report of the indefatigable Grand Scribe, and for the state of our finances, which are in a healthy condition, to the Report of the Grand Treasurer, which will soon be laid before you.

Brothers, representing as we do the thousands included in the fold of our Divisions scattered over the length and breadth of the land, bound together in the bonds of Love, Purity and Fidelity, it is right that our hearts should flow out in gratitude to Almighty God for the blessings so richly bestowed upon us during the past half-year, and our earnest and sincere prayer shall be that He will continue to prosper our efforts, and to inspire our hearts with zeal and energy to work on, while life shall last, in the cause of suffering humanity.

The Grand Scribe presented his semi-annual Report as follows:—

TO THE GRAND WORTHY PATRIARCH, OFFICERS AND REPRESENTATIVES OF THE GRAND DIVISION OF THE ORDER OF THE SONS OF TEMPERANCE, CANADA WEST:

Brethren—In compliance with the Constitution, I now present for your consideration my semi-annual Report of the state of the Order within this jurisdiction, and the principal transactions during the past term.

You will feel pleased to find that, with few exceptions, harmony and brotherly love continue to prevail throughout your widespread jurisdiction; that the Order of the Sons of Temperance maintains its ground and proud position as the advanced guard in the Temperance army; and that a much larger number of new Divisions than formerly has been instituted during the past term.

In regard to the condition and progress of the Temperance Cause in general, it may be safely affirmed, that never has our great and benevolent reform occupied so large a space in the thoughts and hearts of the people of this Province, East and West, and of the civilized world, as at the present time.

It is cheering to learn that this great movement is rapidly extending and is assuming gigantic proportions in the British Isles, and I believe that I but repeat the sentiment of this Grand Division when we say, from this exalted position, representing the intelligent and devoted friends of total abstinence and prohibition, "God prosper every effort put forth to annihilate the traffic in intoxicating drink."

Shortly after the Annual Session petitions were prepared by the joint committee, and, with circulars of instructions, were forwarded to each Division; and I feel happy to report that the Divisions under this jurisdiction responded cheerfully to your recommendation: they forwarded, in an incredibly short space of time, 298 petitions to the Legislative Assembly, and others were afterwards sent subsequent to the Report of the Parliamentary Committee. It is thus apparent that our Divisions are not only reliable, but are also earnestly and thoroughly in favor of prohibition of the iniquitous liquor traffic.

The Journals of the Proceedings of the Annual Session were completed with expedition and forwarded to the Order; and we would here express our obligation to our esteemed Brother W. H. ORR, P.W.P., who prepared such an excellent synopsis of our proceedings for the press in short hand.

The new form of Quarterly Returns has been issued, a quantity of new Charters has been procured, and other requisites, including blank By-Laws with late amendments to the Constitution, have been supplied as required. The Quarterly Passwords have been printed in circular form and forwarded with usual punctuality.

I have much pleasure in reporting the following 24 new Divisions instituted since the Annual Session, which, we find, is nearly double the number of Divisions instituted the preceding term :

Communication from the Editors of "The Crusader", the organ of the Order, soliciting increased support.

I am happy to state that there is a prospect of the Juvenile Temperance Movement receiving a fresh impetus by the formation of Bands of Hope. I have corresponded with Brother W. J. PATTERSON, the talented and active agent of the Montreal Temperance Society, and who is Secretary of the Central Committee of the Bands of Hope, to procure all the information necessary to lay before you, so as to enlist your sympathies and obtain your support to the movement.

The Cadets of Temperance in connection with this Grand Division are doing a good work, and their numbers are gradually increasing. We have now upwards of 1,550 youths enrolled in 31 Sections of Cadets, and we could point out several earnest and devoted Sons who have graduated in those excellent training schools of morals and goods habits.

The seventeenth annual meeting of the National Division just terminated was in session from the 7th to the 13th instant, and was altogether a most deeply interesting session. Our esteemed Brother JAMES BREAKENRIDGE, G.W.A., was the only Representative from this Grand Division present, and will, I have no doubt, give an account of the principal transactions of that august body.

I beg to quote a few sentences from the admirable Report of the Most Worthy Patriarch:

"No other philanthropic or benevolent institution ever formed in this country has probably accomplished so much good in a corresponding period of time as the Order of the Sons of Temperance has within the last twelve years. Even the American Bible Society, formed in 1816, patronized by all the leading denominations of Protestant Christians, and with the counte-

nance and support of all the good and virtuous who desired the bread of life scattered broadcast in the earth, even this great National Society, with its immense publishing establishment in the city of New York, and its agents and agencies constantly and systematically employed in all the States and Territories, and even in foreign countries, has not kept pace with this Order, as its receipts will show, but has fallen short of our collections at least a million of dollars during the last twelve years, the receipts of that association being, since 1848, \$4,086,714, and ours being, as before stated, \$5,084,477.

“The Order is stronger to-day, in every respect, than ever before, with the cheering prospect of more brilliant triumphs in the future than any that have marked their past career, the increase of 1859 having been some four hundred new Divisions and fifty thousand members, male and female.”

That Brother W. J. PATTERSON, of Montreal, who is now present in this city, and being eligible to a seat in the Grand Division of Canada East, be admitted, by dispensation, as a visitor to this Grand Division. Carried.

Brother W. J. PATTERSON was then introduced by the Grand Conductor and obligated.

TO THE GRAND WORTHY PATRIARCH, OFFICERS AND BRETHREN OF THE GRAND DIVISION OF THE SONS OF TEMPERANCE, C.W.

Your Committee on Appeals beg to report that they have examined the Appeals of C. B. PIKE and D. L. WILLIAMS against certain action had respecting these gentlemen by Franklin Division No. 82. Your Committee find it difficult to come to a direct conclusion respecting the matter of the appeal of those gentlemen. The papers and extracts from the minutes of proceedings of the Division respecting this matter are somewhat confused. But from what your Committee are able to infer therefrom, it would appear to them that the whole of the proceedings had respecting the matter of this appeal are singularly irregular. In the first place it would appear that one of these brothers came forward and acknowledged having partaken of Ginger Wine, when it was moved that the "confession" be thrown under the table, which was carried. At another meeting it was moved and carried "that a rehearing be had of the said motion." It was then moved that "his name be erased from the Constitution, and that he be requested to resign," which was carried. At the next meeting it was moved and seconded "that a re-hearing on the acknowledgment of C. B. PIKE be taken," which was carried. When it was moved that the Recording Scribe be instructed to place the names of said Brothers (PIKE and WILLIAMS) on the Constitution, and that they be considered as members of good standing—which was carried, only one member of the Division, the Recording Scribe, protesting against

the motion as being unconstitutional. At another meeting a motion was carried "that the Brothers who acknowledged drinking Ginger Wine be allowed two weeks to come forward and re-sign the Constitution Book." D. L. WILLIAMS is then reported to have come forward and acknowledged having used Ginger Wine; and it was thereafter moved "that his name be erased, and that he be reinstated by re-signing the Constitution," which was carried. At the next meeting it was moved "that the subject be referred to the Grand Worthy Patriarch, the Division and the offending Brothers to abide by the decision," which was also carried—C. B. PIKE and D. L. WILLIAMS objecting. Then it was moved "that C. B. PIKE and D. L. WILLIAMS, in consequence of not complying with the motion made and carried, that if they do not re-sign the Constitution Book, nor abide by the decision of the Grand Worthy Patriarch, that they be expelled," which was carried, and the gentlemen expelled accordingly. Such seems to be the curious position of this matter. No dates are given.

To your Committee it is clear that the use of Ginger Wine by a Brother is a violation of Article 2 of the Constitution; and the Constitution provides that four weeks shall be allowed an offending Brother to re-sign the Constitution before being expelled. And in view of all the facts pertaining to the case, your Committee are of the opinion that Messrs. PIKE and WILLIAMS be leniently dealt with; that they be not so summarily discarded as the majority of the members of Franklin Division have decided, but that the Division be instructed to proceed against the offenders anew, according to the prescribed form, and that the Brothers be allowed to re-sign the Constitution. At the same time your Committee hope these Brothers will repent and improve.

Your Committee have had also under consideration the Appeal of Brother JACKSON against the action of Orillia Division, in deciding that it was legal and constitutional for Female Visitors to belong to other Temperance Societies. Your Committee believe the action of Orillia Division to be perfectly correct, and would recommend that the appeal be dismissed.

The Resolution of Nithburg Division has also engaged the attention of your Committee, which requests that measures for the admission of females to full membership in Subordinate Divisions, to take part in the business, and share the honors and labors of office, be adopted by this Grand Division. On this Resolution your Committee would report that the request is one not at the disposal of this Grand Division, and would refer the Brothers to the head of the Order, the National Division.

Several Communications referred to your Committee require no comment, as the subjects referred to therein pertain more to the past than the future.

The prospectus of "The Crusader", a national organ of our Order, edited by General CARY and JOHN MOFFATT, has been laid before your Committee. No copy of the journal has yet appeared, but from the well-known literary and scientific attainments of its editors, your Committee have no hesitation in recommending it to the attention of the members of our Order in Western Canada. One of these Brothers has special claims upon our consideration, which should not be lightly regarded.

1st. To the members of this Grand Division and of the Order, those papers which are doing battle for the Temperance Cause; and your Committee recommend the members of this Order to give their countenance and support to "The Life Boat": but especially would we recommend "The Canada Temperance Advocate" to the attention and support of this entire body. The Advocate is the oldest and most fearless temperance journal in our land.

2nd. Your Committee would also recommend that the members of this Grand Division, as well as the members of all Subordinate Divisions of this jurisdiction, do use their best endeavors to organize and keep in working order "Sections of Cadets", as well as "Bands of Hope"; and we would also recommend that the Constitution of Cadets be amended, so as to admit girls over ten years of age to join the Sections as members, as the training up of our youths in temperance principles is of the highest importance and the best means of obtaining that for which we are all earnestly contending, the total abolition of the liquor traffic.

Your Committee gratefully concur with our head officer in acknowledging the continued favor of Almighty God upon our benevolent enterprise, and the cheering proofs of success attending the labors of the friends of temper-

ance as seen in the increased number of Divisions opened during the first half of the present year, and particularly with the pleasing indications of permanent success evidenced by the large number of resuscitated Divisions and the diminution of the numbers suspended and expelled.

We note with grateful interest the prosperity attending the labors of Brethren honorably mentioned in the Report.

The Petitions for a Prohibitory Law, though unsuccessful in the degree desired by your Committee and the public generally, have had a salutary influence upon the Legislature and the country generally, in the amount of information communicated upon the question, and will ultimately result in good.

Your Committee earnestly call attention to the recommendation of the Grand Worthy Patriarch to hold public meetings, relying, if need be, upon local talent, availing yourselves of accredited agency when obtainable.

We heartily endorse the recommendation of the Grand Worthy Patriarch with reference to the desirableness of holding a Provincial Convention of all the different organizations, fully convinced that the individuality and power of these bodies, as such, will be rather augmented for the advancement of the cause by such a combination of effort, and we respectfully recommend the appointment of a Committee of seven to confer with other organizations in Canada, East and West. The approaching meeting of the Grand Division of Canada East we think should be improved as an opportunity for maturing plans in the carrying out of our object, and we recommend the appointment of a deputation from this body on that occasion; and further, that the Provincial Convention be held at such time and place as the Committee may, after due consultation with other bodies, appoint—the said Committee having full power to consider and mature all plans for the presentation of an address to His Royal Highness the Prince of Wales, acting with all co-operating temperance organizations.

And we further suggest that, if practicable, the assembly of the Convention and the presentation of the Address be appointed to take place at some central point in the Province where a large attendance may be secured.

With reference to the recommendation of the Grand Worthy Patriarch upon the subject of juvenile temperance organizations, your Committee beg to urge that all proper encouragement be given to such institutions, and that, when practicable and consistent, they be also formed, as in Great Britain, in connection with the Sabbath Schools of our land.

Your Committee would, we consider, be guilty of delinquency did we not enter our protest against that wretched progeny of ignorance and vice recently brought into existence by the provisions for the sale of cheap wine in England, and the facility afforded the cursed traffic in these Provinces by the last tariff, in the reduction of the duties upon foreign wines; and we earnestly trust that the enlightened public sentiment of our beloved country will prevent any further facilities being provided for such a pernicious movement.

Your Committee would here express our high sense of the able manner in which our Grand Worthy Patriarch has conducted the duties devolving upon him since his appointment, and the excellent suggestions contained in his able Report; and particularly his recommendation that, as Sons of Temperance, we concentrate our influence in the furtherance of the cause, working by the means ordinarily employed by this body.
