



OTTAWA, April 26, 1918.

J. U. VINCENT, Esq., K.C., B.A., L.Ph.,
Deputy Minister of Inland Revenue,

Sir,—I beg to hand you a report upon 179 samples of Sugar purchased by our inspectors during October, November and December of last year. This inspection was made upon your suggestion (L 184989 of F 111100) with special reference to the illegal use of dyes in refined sugar.

An Order in Council of August, 1914, (published as Circular G 1135) defines Sugar as follows:—

SUGAR.

1. Sugar is the product chemically known as Sucrose (Saccharose) and is at the present time found in commerce as obtained from Sugar Cane, Sugar Beets, Sorghum, Maple and Palm.
2. Sugar whether sold as granulated, loaf, cut, milled or powdered sugar shall contain at least 99.5 (ninety-nine and five-tenths) per cent of sucrose, and shall be free from any artificial colouring matter.
3. Icing sugar is a powdered sugar specially prepared for baker's use, and may contain starch, not to exceed five (5) per cent by weight.

The employment of a dye in refined sugar is forbidden only when such dye is added for the purpose of giving the sugar an appearance of whiteness not due to the actual refining of the article, that is, the separation of those tintorial matters which are characteristic of raw sugar. Such use of a dye is held to violate the requirements of section 3 (h) of the Act, which establishes as adulteration the colouring, coating, polishing or powdering of any food stuff, so as to conceal damage, or to make the article appear better, or of greater value than it really is. The colouring of crystals of sugar, as in the case of rock-candy, cannot, I think, be held to be forbidden by G 1135. In this case, the purchaser is made fully aware that a dye has been used, and he is not deceived.

Sugar is very extensively sold in a partially refined condition, and is then known as *soft sugar*. Its water content approximates 4 to 5 per cent although occasionally higher percentages are found. The colour varies from shades of brown to nearly white, and manufacturers seek to standardize, as far as possible, the particular tint under which they place their product upon the market. In some instances a dye is used, as affording an easy means of securing the standard shade desired. There can be no doubt that the public regards the particular shade of colour in soft sugar as an indication of the degree of purity of the article; and it may be held that the use of a dye constitutes adulteration, under Section 3 (h) of the Act.

Under an Order in Council of January 9, 1915, (published as Circular G 1167) it is permitted to employ certain dyes in a limited number of specified foods without declaration of the fact. Soft Sugar is not included in this list, and if a dye be used, the fact of such use must be declared upon the label, or otherwise. Of course this procedure assumes that the purchaser is not defrauded by such action, since, in that case, there would be violation of Section 3 (h) of the Act, which necessarily takes precedence of all regulations made under authority of the Act.

Forty-two (42) samples of the present collection are sold as Soft Sugars; and the actual sugar (sucrose) content in these varies from 83.22 (No. 70766) to 95.8 (No. 79320).

The cane sugar content of 42 samples of Soft Sugar is as follows:—

While refined sugar is an article of very well marked character, soft sugars vary greatly as to the degree of purification which the raw product has undergone in their manufacture. The colour is a fairly good indication of this and together with apparent moisture or dampness, is the main evidence available to the buyer. More or less reducing sugar is always present and in the samples now reported, varies from about 1 per cent to over 8 per cent. A portion of this reducing sugar is usually uncrystallizable, is indeed molasses; and it is to this more or less caramelized component of the soft sugar that its peculiar flavour as well as its colour is due. Any attempt to standardize colour and thus imply a constant degree of refining, should be carried out only by actual purification to a constant degree, by recrystallization, and other treatment. The use of a dye with soft sugar is very questionably to be justified; and, when the essence of the dye is not declared to the purchaser, must be regarded as adulteration under Section 3 (h) of the Act.

These soft sugars are ordinarily sold as Brown, Yellow, or White and these descriptive terms should correspond to varying degrees of purification of the raw material. A glance at the accompanying results of analysis will show that no very definite relation exists between the special name under which the article is sold, and its actual sucrose content. Of 42 samples of soft sugar herein reported, 7 are sold without any specially descriptive name; 15 are sold as *brown sugar*, 15 as *yellow*

sugar, and 5 as white sugar. The average content of cane sugar, reducing sugar and moisture for each of these sub groups is shown in the following table:—

Seven samples are sold as Ieing Sugar. Departmental standard permit starch, not in excess of 5 per cent by weight, to be present in this variety of refined sugar. One sample (No. 78207) shows 7.80 per cent starch. All the remainder meet legal requirements.

I beg to recommend publication of this report as Bulletin No. 397.
