Dillon Assails the Bill. LONDON, March 28.—Mr. Dillon followed Mr. Balfour. He said this bill would never pass into law. [Irish cheers]. If he believed the people of England were capable of sanc-tioning the measure, he would give up for ever the hopp fof seeing the Irish and the English shake hands. The Irish people would be slaves indeed if they submitted to it. Either he would have a country where no.—Irishnan could live unless he lived like a slave, or, if the people were willing, he would be proud and happy to lead them in battle. NEW YORK, March 22. —There was a sudden revival in speculation down town to-day. All the markets, which have been very dull for two or three weeks, became very active. There was 402,000 shares of stocks, 1,000,000 bushels of wheat, 212,700 bales of cotton and 119,760 bags of coffee dealt in. Cotton and coffee have not been so active before this year. Prices were very strong. Fifty five stocks advanced i to 2 per cent. Wheat closed i cent higher. 


