ANOTHER LIBERAL VICTORY. Russell has fallen into line with Kent, Mississippi, L'Assomption and Dorchester. It crosses a series of brilliant liberal victories. It completes an unbroken record of Liberal triumphs since unrestricted reciprocity was made the chief plank in the Liberal platform.

The victory in Russell is more surprising than those in the other counties because of its peculiar location and reputation. Until the last general election, the county of Russell had never elected a Liberal in a straight party fight and only once by a minority vote against two conservatives. The county had the reputation of being a conservative stronghold, and it rolled up enormous conservative majorities. At the last elections the Liberals stormed and carried this stronghold; and yesterday they retained it by a majority increased nearly one hundred.

Russell county stretches from Ottawa city, which for Dominion electoral purposes, it includes one ward—that of New Edinburgh in which Rife's Hall is situated—for a considerable distance both inside and down the Ottawa river several suburban districts of Ottawa are also in the county; and in these suburban districts, such as Billings Bridge, as well as in New Edinburgh ward, scores of Dominion Tory civil servants live. The influence of this Tory civil service vote is shown in New Edinburgh ward, where the Tory candidate had 68 more majority yesterday as against a Liberal majority nearly as large in the same polling subdivision in 1878.

Russell county is mixed in its character. There is a large urban and suburban residential vote belonging to Ottawa city, and the balance of the electors are farmers and men engaged in lumbering, besides small traders. Outside of Ottawa there are very few villages of any size or importance in the county. The unrestricted reciprocity cry has manifestly captivated the farmers; and even the French-Canadians, who were said by the Tories to be opposed to unrestricted reciprocity, gave the liberal candidate nearly one hundred more majority when he declared boldly and unequivocally for unrestricted reciprocity than they did in the former contest when the issue was not so distinct. The adoption of this policy would benefit the lumberman and farmers enormously, and they voted where their interests lay.

The victory in Russell, following so closely preceding in the other counties named, shows that the liberal party is gaining strength in the country, and that "the unrestricted reciprocity" issue is a potent one. Already there are signs that those who have been trimmers in the hour of liberal disappointment are now plucking up courage to stand by principle; but the staunch liberals know where the weak timber is to be found.

The tide of liberal reaction is setting in. At the general elections it has not quite strong enough to storm the citadel, and after the contest there was a slight ebb. But now it is flowing onward again and by a steady adherence to principle, by a bold aggressive policy; by standing firm to the men who have been staunch and aggressive in the hour of dependency, the liberal cause and liberal principles will soon triumph all over the dominion.

COALITION WITH PRINCIPLE. Premier Mercier's example in Quebec should be imitated elsewhere. Mr. Mercier was a few years ago the leader of the opposition in the Quebec legislature. He, however, subsequently took office with a wing of the conservatives supporting him. This was not blameworthy, because a partially liberal administration was preferable to a wholly conservative one. But Mr. Mercier stood by principle and he refused to allow the conservative wing of his supporters to obtain more than their proportionate share of representation in the cabinet and in the distribution of patronage. By standing firm and insisting that his administration should be mainly liberal, Mr. Mercier has actually won strength. The liberal, instead of being alienated and sending him remonstrances from every county, are firmly attached to his government. The liberal press, instead of being neutral, is actively liberal. Liberal editors, instead of being driven by senseless persecution and injustice into a passive attitude, or even hostility, are his heartiest allies and supporters. In other words Mr. Mercier has insisted throughout, that inasmuch as the liberal form the majority of his supporters, they must be considered and respected as such. In dominion politics Mr. Mercier, through leading a coalition, will have no relations, secret or otherwise, with the dominion Tory philistines. He defies them and uses all his influence to secure the defeat of their candidates in federal bye-elections; and in spite of his opposition to federal rule, his government appears to thrive instead of daily growing weaker and weaker. Mr. Mercier has not only doubled his majority in the legislature since last session, but he has actually obtained a majority in the legislative council within the same period, notwithstanding that his minority appeared hopeless. Mr. Mercier has done all this by standing firm to principle; by not betraying his friends; by a bold aggressive policy; and by not being afraid to squarely oppose the dominion government when it is wrong instead of trimming and hedging when he looks Ottawa-ward! His success in pursuing a bold policy should be a hint to any politicians who desire to trim.

MR. HALE'S TREACHERY.

Our demand that Mr. Hale, M. P. for Charlton county, should be honorable enough to resign and consult his constituents as to his altered course, appears to have met with the unanimous approval of liberals in his constituency.

It may be interesting, therefore, to explain precisely what it was Mr. Hale declared by his vote in parliament he wished to see continued.

In 1845, with a population of twenty millions of people, and the necessity of maintaining an army and a navy, the United States spent \$23,919,000 for all controllable services. In 1888, with less than five millions of people, and with no army or navy to maintain, Canada requires about \$37,000,000 for controllable services. The net debt of the Dominion has increased by \$88,000,000 in ten years; the total annual expenditure has increased by \$13,000,000 within the same period; the increase of debt and of expenditure is altogether disproportionately in excess of the increase of population within the same period; the present taxes are in excess of the imperial taxes per head levied in Great Britain; the rich are lavished by the present tariff against the poor; and therefore a reform is needed in all of these respects, especially as the tendency of taxation is downwards in the United States. Mr. Hale voted against these propositions and their too plain deductions, and declared his opposition with the existing state of affairs.

Mr. Hale has chosen his position and he must abide by it. If he is an honorable man he will resign and contest his constituency under the altered circumstances.

Years ago, within the memory of the present generation, English and French men of war bombarded Chinese ports until the Chinese abandoned their policy of exclusion and opened certain ports to the outer barbarians. Hundreds of writers have dwelt with condemnation upon the policy of exclusion which governed China's relations for centuries to the west; but was China's policy after all the true one? The United States and Canada have both adopted legislation to exclude the Chinese, and for our part we feel the same logical difference between the Chinese excluding the foreigners and this continent excluding the Chinese. But then the Americans and Canadians are civilized, and the Chinese are ignorant Pagans.
